1 Morgan County School District Chromebook Procedures and Information Policy

2 The mission of the 1 to 1 program in the Morgan County School District is to create a collaborative
3 learning environment for all learners. This environment will enable and support students and teachers to
4 implement transformative uses of technology while enhancing students' engagement with content and
5 promoting the development of self-directed, lifelong learners.

6 Students will transition from *consumers* of information to creative *producers* and *owners* of knowledge.
7 Technology immersion does not diminish the vital role of the teacher. On the contrary, it transforms the
8 teacher from a director of learning to a facilitator of learning. The Board of Education, district staff and
9 community members will all play a key role in the development of effective, high-quality educational
10 experiences.

11 **Checking Out Your Chromebook**

- 12 ● Each student will have an assigned charging station at their home school.
- 13 ● **Each in school student will have an assigned charging station at their home school.**
- 14 ● Determined by the school, the charging station will be placed in the student's homeroom, 1st
15 period classroom, or library.
- 16 ● Each student will be responsible for checking out their Chromebook from their assigned charging
17 station at the beginning of the school day on a daily basis.

18 **Returning Your Chromebook**

- 19 ● Before the end of the school day the student's responsibility will be to return the Chromebook to
20 its assigned charging station and port. Each night the Chromebooks will be charged and ready
21 for next day use.
- 22 ● ~~At this time, Chromebooks are not to leave the home school campus.~~
- 23 ● MCCTC Students will have access to a Chromebook to be checked out when needed at the
24 MCCTC.
- 25 ● Students whose Chromebooks are unaccounted for may be subject to disciplinary action.

26 **Taking Care of Your Chromebook**

- 27 ● Students are responsible for the general care of the Chromebook they have been assigned.
- 28 ● Chromebooks that are broken, or fail to work properly must be taken to the Home School
29 designated Help Desk as soon as possible so that they can be taken care of properly.

- 1 ● Students who incur multiple damage incidents may be subject to disciplinary action.

2 **General Precautions**

- 3 ● No food or drink is allowed next to your Chromebook while it is in use.
- 4 ● Cords, cables, and removable storage devices must be inserted into and removed carefully from
- 5 the Chromebook.
- 6 ● Never transport your Chromebook with the power cord plugged in.
- 7 ● Never store your Chromebook in your carry case or backpack while plugged in.
- 8 ● Students should never carry their Chromebooks while the screen is open.
- 9 ● Chromebooks must remain free of any writing, drawing, or stickers
- 10 ● An identification label with the student's name is acceptable on the Chromebooks.
- 11 ● Vents CANNOT be covered.
- 12 ● Chromebooks must have a Morgan County School District asset tag on them at all times and this
- 13 tag must not be removed or altered in any way. If tag is removed, disciplinary action will result.
- 14 ● Chromebooks should never be left in an unsupervised area.
- 15 ● For screen adjustment, do not grasp screen by wrapping hand around screen, your thumbs will
- 16 shatter the screen.

17 **Screen Care**

- 18 ● The Chromebook screens can be easily damaged!
- 19 ● The screens are particularly sensitive to damage from excessive pressure on the screen.
- 20 ● Do not lean or put pressure on the top of the Chromebook when it is closed.
- 21 ● Do not store the Chromebook with the screen in the open position.
- 22 ● Do not place anything near the Chromebook that could put pressure on the screen.
- 23 ● Do not place anything in a carrying case or backpack that will press against the cover.
- 24 ● Do not poke the screen with anything that will mark or scratch the screen surface.
- 25 ● Do not place anything on the keyboard before closing the lid (e.g. pens, pencils, or disks).
- 26 ● Clean the screen with a soft, dry microfiber cloth or antistatic cloth.
- 27 ○ Be cautious when using any cleaning solvents; some individuals may have allergic
- 28 reactions to chemicals in cleaning solvents and some solvents can even damage the
- 29 screen.
- 30 ○ Try to always use water dampened towel or a highly diluted solvent.

31 **Backgrounds and Password**

- 32 ● Inappropriate media may not be used as a screensaver or background. Presence of guns,
- 33 weapons, pornographic materials, inappropriate language, alcohol, drug, gang-related symbols
- 34 or pictures will result in disciplinary actions.
- 35 ● Take care to protect your password. Do not share your password.

36 **Account Access**

- 37 ● Students will only be able to login using the mcsed.net account. Students should always use the
- 38 Chromebook with their own account.

- 1 ● Students and teachers will use the Google Classroom and suite for classroom material and video
2 interaction.

Managing & Saving Your Work with a Chromebook

- 3 ● Google Docs includes a suite of products (Docs, Presentations, Drawings, Spreadsheets, Forms)
4 that lets you create different kinds of online documents, work on them in real time with other
5 people, and store your documents and your other files all online.
6 ● With a wireless Internet connection, you can access your documents and files from any
7 Chromebook, anywhere in the world. All items will be stored online in Google Cloud
8 environment.

9 Repair Center/Technical Support

- 10 ● Each school will have a designated Helpdesk/Technical Support Center.
11 ● At the Helpdesk Center they will perform basic troubleshooting of the Chromebook.
12 ● If the Chromebook cannot be repaired at the school, the Helpdesk attendant will report the issue
13 with the Morgan County Schools Technology Department.
14 ● Loaner Chromebooks may be issued to students when they leave their Chromebook for repair at
15 the Helpdesk.
16 ● Students using loaner Chromebooks will be responsible for any damages incurred while loaning
17 the Chromebook.
18 ● Student will pay full replacement cost if the loaner device is lost or stolen.
19 ● Each new Chromebook has a 1-year manufacturer's warranty that will fix or replace any items
20 that would not make the computer function, i.e., screen not working, Chromebook not booting,
21 battery not charging, wireless not working, etc.
22 ● If the Chromebook does not work and shows no physical damage, Morgan County Schools will
23 replace or fix the Chromebook with no charge of the student.

24 Major Damages and Replacement Cost

- 25 ● Major damages are defined as damages to the machine that make it unusable for the student to
26 conduct classwork.
27 ● Incidents may include a broken/cracked or shattered screen, cracked case, broken keys
28 on keyboard, headphone jack broken, charger plug broken or broken inside of the
29 Chromebook, or any unreparable items not included under warranty.
30 ● ~~If major damage occurs, the student should return the device to their Helpdesk attendant, a loaner
31 may be issued, and the device sent to the MCS Technology Department.~~
32 ● ~~If possible, repairs will be made to the device and
33 an invoice is sent to the home school in the student's name for the repair costs not to
34 exceed \$50 per repair item.
35 the repaired device will be returned to the home school to be re-issued to the student upon
36 the return of the loaner device.~~
37 ● ~~If the device is not repairable, a new Chromebook will be issued to the student, who will be billed
38 at the current new purchase price.~~

- 1 ● Students are responsible for the loaner device as if it was their originally issued device. Students
2 are responsible for any damage to this device during the loan period.
- 3 ● If any device has been deemed to have major damage, a maximum \$50 deductible will be charged
4 per incident to repair the device.
- 5 ● Once deemed by the MCS Technology Department that the Chromebook has major damage,
6 payments may be arranged at the home school.
- 7 ● When payment is made, a loaner may be borrowed until the repair is made and returned to the
8 student. Students are responsible for the loaner device as if it was their original issued device.
9 Students are responsible for any damage to their device during the loan period.

11 **Acceptable Use Policy**

- 12 ● Students will have access to all available forms of electronic media, communication, apps, and
13 extensions which are in support of education and research and in support of the educational goals
14 and objectives of the Morgan County School District.
- 15 ● Students are responsible for their ethical and educational use of the technology resources of the
16 Morgan County School District.
- 17 ● Access to the Morgan County School District technology resources is a privilege and not a right.
18 Each employee, student and/or parent will be required to follow the Acceptable Use Policy.
- 19 ● Transmission of any material that is in violation of any federal or state law is prohibited. This
20 includes, but is not limited to the following: confidential information, copyrighted material,
21 threatening or obscene material, and Chromebook viruses.
- 22 ● Any attempt to alter data, the configuration of a Chromebook, or the files of another user, without
23 the consent of the individual, building administrator, or technology administrator, will be
24 considered an act of vandalism and subject to disciplinary action in accordance with the student
25 handbook and other applicable school policies.

26 **Privacy and Safety**

- 27 ● Do not go into chat rooms or send chain letters without permission. If applicable, teachers may
28 create discussion groups for communication among students for educational purposes.
- 29 ● Do not open, use, or change files that do not belong to you.
- 30 ● Do not reveal your full name, phone number, home address, social security number, credit card
31 numbers, password or passwords of other people.
- 32 ● Remember that storage is not guaranteed to be private or confidential as all Chromebook
33 equipment is the property of the Morgan County School District.
- 34 ● If you inadvertently access a website that contains obscene, pornographic or otherwise offensive
35 material, exit the site immediately.

36 **Legal Property**

- 37 ● Comply with trademark and copyright laws and all license agreements. Ignorance of the law is
38 not immunity. If you are unsure, ask a teacher or parent.

- 1 ● Plagiarism is a violation of the student policy. Give credit to all sources used, whether quoted or
- 2 summarized. This includes all forms of media on the Internet, such as graphics, movies, music,
- 3 and text.
- 4 ● Use or possession of hacking software is strictly prohibited and violators will be subject to
- 5 discipline. Violation of applicable state or federal law, including the Tennessee Personal and
- 6 Commercial Computer Act of 2003, will result in criminal prosecution or disciplinary action by
- 7 the District.
- 8 ● The Chromebook device is the property of Morgan County Schools and is subject to audit and/or
- 9 examination at any time.

10 E-mail Electronic Communication

- 11 ● Always use appropriate and proper language in your communication.
- 12 ● Do not transmit language/material that may be considered profane, obscene, abusive, or offensive
- 13 to others.
- 14 ● Do not send mass e-mails, chain letters or spam.
- 15 ● E-mail & communications sent/received should be related to educational needs.
- 16 ● E-mail & communications are subject to inspection by the school at any time.

17 Consequences

- 18 ● The student in whose name, system account, and Chromebook hardware is issued will be
- 19 responsible at all times for its appropriate use.
- 20 ● Non-compliance with the policies of this document or the Responsible Use of the Internet/TSD
- 21 AUP, will result in disciplinary action.
- 22 ● Electronic mail, network usage, and all stored files shall not be considered confidential and may
- 23 be monitored at any time by designated district staff to ensure appropriate use.
- 24 ● The district cooperates fully with local, state or federal officials in any investigation concerning
- 25 or relating to violations of computer crime laws.
- 26 ● Contents of email and network communications are governed by the Tennessee Open Records
- 27 Act; proper authorities will be given access to their content.

29 Remote Learners Assigned a Chromebook

30 Remote Learners is defined as students who have choose the at home remote learning option, or a
31 student who will be required to be at home for a period of time due to medical reasons or concerns.

- 32 ● Students will be assigned by the Media Specialist a take home Chromebook.
- 33 ● All Chromebook procedures will apply to remote learners.
- 34 ● Issues with Chromebooks will be handled with the schools Helpdesk/Media
- 35 Specialist/Technical Support team.
- 36 ● Connectivity issues such as internet issues should be resolved by the internet provider.
