- 551.0821** Personally identifiable information of Public School Students.
- 551.083** For the purpose of considering the standards, guidelines, terms or conditions the Board will follow, or instruct its representatives to follow, in consultation with representatives of employee groups in connection with consultation agreements provided for by Section 13.901 of the Texas Education Code.
- 551.084** For the purpose of excluding witness or witnesses from a hearing during examination of another witness.
- 551.087** For the purpose of considering economic development negotiations

Should any final action, final decision or final vote be required in the opinion of the Board of Trustees with regard to any matter considered in such closed or executive meeting or session, the final action, final decision or final vote shall be either:

- (a) In the open meeting covered by this Notice upon the reconvening of the public meeting; or
