

BACKGROUND INFORMATION

The canvass is the official tally of votes for any given election. The purpose of the canvass is to account for every ballot cast and ensure that every valid vote cast is included in the election totals. The canvass accounts for every ballot cast on Election Day, every on-time absentee ballot, every accepted provisional ballot, and every on-time overseas and military absentee ballot.

The Texas Secretary of State May 2, 2026 Election Law Calendar states that the local canvass for the May 2, 2026 General Election must be held not earlier than the third day after election day, Tuesday, May 5, 2026, and not later than the eleventh day after election day, Wednesday, May 13, 2026.

ADMINISTRATIVE CONSIDERATION

Pursuant to Texas Election Code Section 67.004, the Local Canvassing Authority, Mission CISD, will canvass the results for the May 2, 2026, Board of Trustees General Election on May 13, 2026.
