HPC Schools-Mr. Brown

Every Student! Every Day! Every Way!

1. Summer Projects, New Fiber Optic Line was put into the west building at Polk at the end of July, streets are painted, inside doors are being installed at Clarks, bus and vehicle inspections and services are all done, except for Kelly's bus #17. They are still waiting on parts for it. The HPC Staff and ATS staff has all the building ready to go. Thank you to all of our staff and the ATS for a great job getting our facility and grounds ready to go!!
2. HPC has been awarded our annual REAP Grant for the 2025-26 school year. The award amount is \$19,347.00. These funds will be designated for technology needs.
3. The REAP Grant was awarded in the middle of July. Schools that are comparable to the size of HPC get \$7,500.00. It has gotten much tougher from the Federal Government and the NDE to get this money for our CTE programs for staff training and equipment. I had to simplify for one training for our staff members. I put the rest of the money to be invested or put towards a skidster for our CTE Programs.
4. Back To School In-Service Days are scheduled for August 8th, 11th-13th. New staff is coming in on August 8th with their mentors and the administration. The entire staff will be back on August 11th-13th. Back-to-school night is on August 12th. School gets going on August 14th with a 1:30 dismissal. We hope the board can join us for breakfast on August 11th at 7:30 and we will get everything going at 8:30 with the speaker.
5. Administrator Days was July 23-25th in Kearney. I focused on the financial sessions, the Rule 10 assurances, and transportation sessions. We were notified that we have Rule 10 Assurances visit this year. That will be an in-depth visit on our accreditation for our academics, teaching, certification, instructional hours, and a focus state standards being taught in the classroom.
6. Transportation update, Mike found a new suburban to buy. It is not in yet. It is being shipped in to Tonniges Chevrolet. I learned at Admin. Days that our Chevy vans will need to be removed from our fleet. We need continue to look for a bus to replace Justin's bus. Possibly look to get a 14 passenger bus.
7. We have a cart of computers at the elementary school that are 10 plus years old and we also have some students computers that are older. I need to look to replace some more computers. The REAP money from this past year is about gone, I may have to use other funds to get us some more computers, Ipads and flat panels for classrooms.
8. Budget update, I have the budget done. I am just waiting on the property valuations. I have been notified by four of our 5 counties that they are doing digital releases of the valuations on the 20th on their websites. I am unsure what Polk County will do. I am assuming the mail. I also got a projection from York County on August 6th. The valuations in York County were up 16%, with an increase of about 25,000,000.00 in total taxable valuation.
9. Extra-duty assignments are almost complete. I will bring a form with the duties that are assigned so that you can view them.

Grading Policy

Progress reports for MS/High School students must be generated and into the office on or before the end of the last day of school for the week. **Prior to a progress report with a failing or near failing grade, communication with parents and students should have occurred.**

MS/High School grades are given as a letter or percentage as requested by the building principal. No incomplete or condition grades will be given, but grades may be changed by request of the classroom teacher to the principal. If a student fails the first semester and passes the second semester, a classroom teacher may pass a student for the full year.

The elementary, grades K-6, utilize a standards based grading system of four proficiency levels. Student learning is assessed through clearly defined priority standards, using at least three data points per standard for accuracy, and focusing on progress toward proficiency. Student progress is communicated to students and families through standard-specific proficiency scales and through quarterly report cards.

Grading and reporting at the secondary level play a vital role in supporting our college and career readiness initiative. Students should receive ongoing, meaningful feedback aligned with priority standards for each learning objective. Staff will document reflective and accurate data points in Infinite Campus to clearly communicate student progress. To effectively meet the diverse educational needs of all learners, grades should be updated in Infinite Campus twice per week.

A student is to be graded on academic performance. **A student's grade is not to be reduced for discipline.** Prejudice or favoritism has no place in grading a student. All grading should be explained in simple, understandable terms to the student.

Classroom teachers should provide students and parents with frequent updates regarding the student's progress during the quarter.

At the conclusion of each quarter, students will receive an end-of quarter report card.
