INTERLOCAL COOPERATION ACT AGREEMENT

This Agreement entered into this 14th day of February 2022, by and between **Saunders County School District 78-0001, a/k/a Ashland-Greenwood Public Schools**, hereinafter referred to as “Ashland-Greenwood Public Schools,” and between **Sarpy County School District 77-0037, a/k/a Gretna Public Schools**, hereinafter referred to as “Gretna Public Schools.”

WHEREAS, Ashland-Greenwood Public Schools is a political subdivision and a Class III school district under the laws and statutes of the State of Nebraska; and

WHEREAS, Gretna Public Schools is a political subdivision, and a Class III school district under the laws and statutes of the State of Nebraska; and

WHEREAS, Neb. Rev. Stat. §§13-801 to 13-827, also known as the “Interlocal Cooperation Act,” and other Nebraska laws encourage political subdivisions to make the most efficient use of their powers, and enable them to cooperate on the basis of mutual advantage and on a basis that will best serve the needs and desires of both parties, in the development and running of local government units;

WHEREAS, Ashland-Greenwood Public Schools has English Language Learner (ELL) students (ELL Students) enrolled in that School District for the 2021-2022 school year; and,

WHEREAS, Ashland-Greenwood Public Schools does not currently have for the 2021-2022 school year an ELL program sufficient to address the educational needs of the ELL Students; and,

WHEREAS, Gretna Public Schools has in place for the 2021-2022 school year an ELL program sufficient to address the educational needs of the ELL Students; and

WHEREAS, Ashland-Greenwood Public Schools and Gretna Public desire to contract services to the mutual advantage of both school districts.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises contained herein, the parties to this Agreement do hereby agree as follows:

1. **Term of this Agreement.** This contract for educational service for the ELL Students shall be for a term, which commences on February 14th, 2022 and ends on May 24, 2022. Either School District shall have the right to terminate this Agreement as to each individual ELL Student in the event that an ELL Student ceases enrollment in the Gretna Public Schools. The Ashland-Greenwood Public School District shall be obligated to notify the Gretna Public School District of the ending of the enrollment of such ELL Students. To exercise such right of termination, the School District exercising such right shall deliver a written notice of termination to the President of the Board of Education of the other School District within 10 calendar days of being notified of the ending of the ELL Student’s enrollment.

2. **A-GPSD Applications for enrollment of ELL Students** – Ashland Greenwood Public School District (A-GPSD) may apply to the Gretna Public School District (GPSD) to enroll ELL students in GPSD English Language Learner (ELL) school programs; provided the number of ELL students does not exceed six (6) students. In the event the A-GPSD would require services for more than six (6) students, GPSD will consider the applications based on capacity and staffing of the GPSD ELL program. The determination of capacity shall be made by GPSD, whose decision is final.

3. **Costs of Educational Services and Transportation.**

3.1 Educational Services. Ashland-Greenwood Public Schools shall pay to the Gretna Public Schools the sum of ONE HUNDRED DOLLARS (\$150.00) per scheduled school day of attendance of the ELL Students for educational services provided to each such ELL Student residing in the Ashland-Greenwood Public School that is enrolled as a student in the Gretna Public Schools under this Agreement. The ELL Students shall be deemed students of the Ashland-Greenwood Public Schools, subject to the Ashland-Greenwood Public School academic standards, and reported to the Nebraska Department of Education as Ashland-Greenwood Public Schools students.

3.2 Transportation Costs. Transportation and related expenses for travel from the residence of the ELL Students in the Ashland-Greenwood Public Schools to the Gretna Public School facility to which the ELL Students are assigned shall be provided and paid for by the Ashland-Greenwood Public Schools.

3.3 Payments. Ashland-Greenwood Public Schools shall pay the amounts provided herein to Gretna Public Schools monthly, with the first payment due February 20, 2022, or in such amounts and on such dates as otherwise agreed from time to time. It is further agreed that the school districts may maintain a Shared Resources Ledger and that set-offs and credits may be made on the financial obligations of the school districts under this Agreement, and that such set-offs and credits may be made in lieu of payments.

4. **Educational Program, Supplies and Support Staff.** The Gretna Public Schools shall determine and provide appropriate curriculum, instruction and facilities, and supplies, testing materials, equipment and support staff (e.g., teachers, para-educators and other staff) to provide the necessary educational services to the ELL Students. The cost of supplies (for example, testing materials), equipment and support staff which benefit both school districts shall be paid by the Gretna Public Schools.

5. **Applicable Policies and Resolutions of Conflicts.** In the provision of the ELL services to the EL Students shall operate under the policies of Gretna Public Schools, and shall be under the direction and supervision of Gretna Public Schools.

6. **Operations.** No separate legal or administrative entity is created under this Interlocal Agreement. Other school districts or entities, which qualify as public agencies under the Act, may enter into this Agreement by amendment hereto executed and approved by all parties.

7. **Indemnification.** The Parties shall indemnify and hold each other, and its Board members, employees and agents harmless, from any claims, expenses (including attorneys' fees and litigation expenses), damages or losses either may suffer as a result of any claims made under, in the administration of, or regarding the validity of this Agreement or the effect of this Agreement on the expenditure or revenue authority of the Parties, including but not limited to liability, or taxpayer or regulatory claims.

8. **Amendment of Interlocal Agreement.** This Agreement may only be amended in writing. This Agreement will not automatically extend beyond the initial term unless the parties enter into a subsequent written agreement. The Superintendents of each school district shall notify the other, on or before May 1, 2022, of their intent to extend the term of the agreement for the subsequent year.

Topic: ESSERS Funding Update

The ARP (American Rescue Plan) ESSER (Elementary and Secondary School Emergency Relief) Funds provide direct money to support areas impacted by the disruption of COVID 19. Funds must be targeted to:

- Continuing to provide services while schools are closed such as remote learning
- Developing and implementing plans to return to normal school operations
- Addressing loss of learning and instructional time

There have been three rounds of ESSERS funds thus far. These are formula (not competitive) grants. If districts meet the application requirement, they are eligible for an amount of funds based on district enrollment and demographics.

ESSERS I - \$88,318

Grant award: 5/2020-9/2022

Final Claim: 12/2020

Grant primary purpose: Coordination of Response Efforts

AG used funds for:

AG Preschool Update

Our AG Preschool is open to all children who turn 4 before July 31st. All resident families with 4 year olds are mailed a parent letter describing our preschool program and an application. We recently mailed 86 letters for the 22.23 school year.

- 86 children are eligible for preschool as 4 year olds
- 14 are currently verified for special education with a recommendation of a center-based placement

All families are encouraged to apply, however, due to limited space there may be a waiting list. If space is available, some exceptions will be made for children that turn 3 years old by July 31st. Children who are eligible for kindergarten may not attend our early childhood program.

Classes are held for approximately 3 hours, 4 days per week for a minimum of 450 hours over the school year. We have two sessions: 8:00 a.m. – 11:20 a.m. and 12:00 p.m. – 3:20 p.m. Each session includes 15 children for a total of 30 preschoolers.

The cost to operate our preschool program is funded through parent fees (sliding fee scale), NDE Early Childhood Grant funds and district funding. The school also receives state-aid for children who are 4.

With our increasing number of preschool age children and the opening of the preK-2nd grade school next year, we are exploring expanding our preschool to two classrooms for the 22.23 school year. NDE provides an Early Childhood Education Grant Program to help fund center-based programs. AGPS applied and received this grant to start-up our preschool program several years ago. An expansion grant is also available to assist schools in expanding preschool opportunities. This grant awards schools up to \$100,000 as a matching grant. We recently applied for this grant.

Expanding the preschool program would require us to hire an early childhood preschool teacher and locate a temporary classroom space until the new primary school is open.

22.23 Kindergarten Preparations

We have mailed 87 letters to families with children who are eligible for kindergarten. Our AGES Kindergarten Round Up event will be held in April.

There are 12 additional children who are eligible for early entrance to kindergarten. These are children that turn 5 between August 1 - October 15. Parents have been mailed information on the early entrance process. They will need to complete an application, request an assessment and meet qualifying scores to be considered for early entrance.

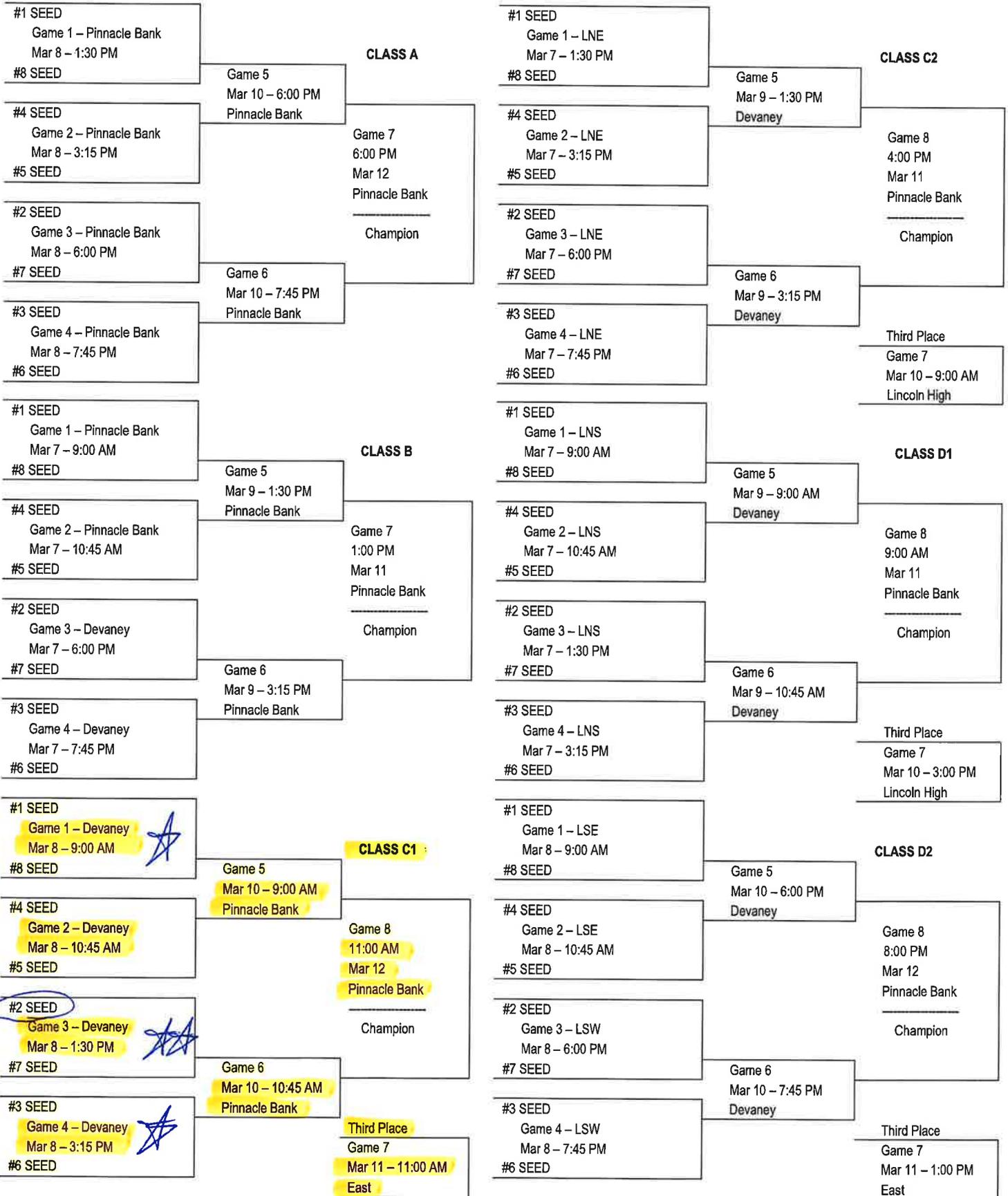

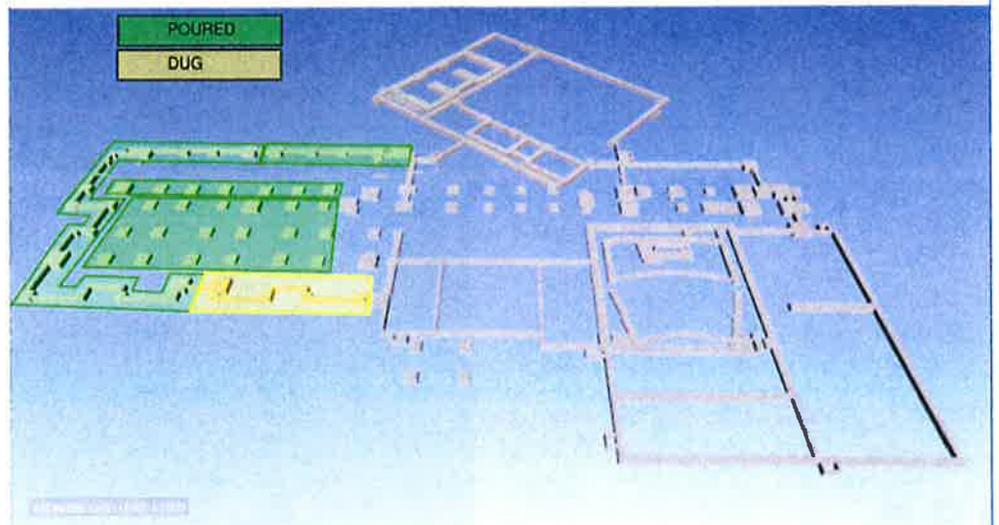

3013 Emergency Closings

School shall be held on the dates set forth on the official calendar, and shall not be closed or dismissed except when superintendent or his or her designee determines that it is impossible or impracticable to hold school. When school is closed there will be no school-sponsored activities held without the permission of the superintendent or building administrator.

In addition, the policy of the Ashland-Greenwood Public Schools is that the administration shall minimize to the extent possible the impact on instruction of athletic and other extra-curricular activities. The district recognizes, however, that dismissing school for state events contributes to furthering student pride in their school, improving community support of the school, and rewards students for their accomplishments.

Therefore the Superintendent of Schools shall:

- 1) Dismiss school for state athletic spectator events where Ashland-Greenwood Public Schools participates. Spectator events to be those events that normally have spectators attending and where admission is charged and arrangements are made to accommodate spectators during regular season contests.
- 2) Have the discretion to dismiss school for other state events or other activities that may have, in the opinion of the Superintendent, a serious negative impact upon instruction or district resources. (Including necessary staffing, buses, facilities, etc.)
- 3) Submit annually a school calendar to the board of education that is flexible enough to provide for school dismissals under this policy and still plan for at least 175 days of instruction and meet the statutory requirement for hours in attendance.
- 4) Have the authority to dismiss school early, start school late, cancel school or schedule staff in-service work provided he or she gives as

much advance notice as possible to students and parents regarding the school calendar.

- 5) Have the discretion to determine whether dismissal for state athletic spectator events is necessary for all, a portion, or none of a school day.
- 6) Have the discretion to assign staff to other duties including but not limited to providing supervision of students when going to, coming from and/or while attending state events

The district recognizes that running schools on different calendars can create hardship and confusion for parents. It is therefore the district's policy to dismiss all schools when dismissing for school activities except in extraordinary situations.
