An Inside View of Education w/ Mrs. Dominy:

Due to COVID restrictions, I was unable to do the Inside View Meetings in November. As a reminder, Inside View meetings are held with the parents from each kindergarten classroom. I show a video of what kindergarten instruction looks like today and we compare and contrast it with instruction when we were all in kindergarten. This is a fantastic opportunity for me to build relationships with parents and give them a glimpse of what Seward Elementary is all about. I am hopeful I can still do these meetings with the kindergarten parents this spring. If this is not possible, I will plan on doing both kindergarten and first grade next fall.

Mid-Year Assessments:

We are currently in the process of taking mid-year assessments at Seward Elementary. Students in grades kindergarten and first grade will take the MAP Fluency assessment, which is our literacy screener for early childhood. Students in grades second through fourth will take the NWEA growth assessment for both reading and math. Both of these assessments measure student progress from the beginning of the year and will be utilized when making decisions about intervention and enrichment opportunities. Students in all grades will also complete their mid-year writing assessments. During our PLC meetings on December 17th, we will discuss data from these assessments in order to improve instruction. Our goal is to have these

discussions prior to winter break so we can hit the ground running in January when students return!

SES December to Remember:

I feel very fortunate to have such a dedicated staff at Seward Elementary. As a way to thank the staff for their hard work this semester, we have special days happening in December. Snacks, games, and jeans days are a part of this celebration. I can't say enough about how our teachers are going above and beyond and I am so thankful for them.

The Seward High School staff will continue the tradition of adopting a family through the local Blue Valley Community Action Program. This is a great way for us to give back to those in need as a staff. Donations from staff members are pooled together in order to make the purchases for our assigned family.

P.R.I.D.E. Recognition Rally

The Term 2 P.R.I.D.E. Recognition Rally is scheduled for Tuesday, December 22nd at 9:00 am. We plan to use Striv TV to stream the live event into individual classrooms. The alumni speaker will be Sarah Garbers (SHS '10).

Classroom Observations

It's hard to believe that there are just 10 days of school left before the end of the first semester and the holiday break!

Looking back across the past month, time was once again spent on state reports that needed to be completed. During November those reports included an 1% State Test alternate assessment justification report for special education students, a count related to the number of students living in the OMNI Group Home that impacts Title One funding and a count connected to the number of non-public and homeschool students that qualify for special education services.

On November 24th letters were mailed to each family that has had a student participating in Remote Learning due to a personal or family medical issue concern asking for an update on their planned learning format for their student(s) for third quarter. A response by December 4th was requested and as of today, zero requests for a move from remote to face to face learning have been received. At this time the number of remote learners stands at 33 district wide. Our current homeschooling number is now at 22 which is down by one as a student recently returned to face to face learning at the elementary.

On December 2nd, the HAL Leadership team met and identified 10 students across the areas of math, science and language arts. Another 11 students were placed on monitor until mid -March of 2021. There are now 131 high ability learners identified in our district across grades 3-12.

With these reports and the HAL nomination period completed, time can now be spent on completing special education and Title one teacher walk throughs and a study of student accommodations outlined on school aged IEP's.

Instruction

This month I asked our teachers to find opportunities to implement stories of grit into their curriculum. We often showcase stories of success for our students, but we rarely tell the tough stories of failure, trying again, and staying focused toward a goal even when it is difficult. Every content area has examples of grit among the content itself, or through the students and teachers in the classroom.

Staff Development

Our November Staff Development Day was cancelled, but our work in staff development still goes on through the professional development communities. This year our staff is reading about Grit from Angela Duckworth. As we read teachers are sharing strategies with their colleagues related to developing grit. This past week our High School teachers made calls to parents using "grit language," several of the calls were positive affirmations while other calls were encouragement to stick with it and complete the course successfully.

Assessment

This is the time of year that we are preparing for upcoming assessments by applying for accommodations on the ACT test as well as attending virtual trainings on the various assessments that are given in our district. As I shared with you previously, assessment in

Nebraska this year is going to look very different than it has in the past. We will have consistent data points for our Seward students through the use of NWEA data.

Food Service/Wellness

We have started to offer breakfast at the High School, I am appreciative of Mrs. Messersmith's work in ordering supplies, arranging staff, and preparing menus. I am also thankful for the high school administration and their flexibility while we have been trying the breakfast program. On most mornings, we provide 20-30 breakfasts at the High School.

Share Your Grit Story!

Greetings Staff! I hope that you had a nice Thanksgiving and you are ready for everything the next three weeks will bring. As always, I am awed by your work with our students and greatly appreciate all the work that you do to ensure that our students have every opportunity to learn in the classroom or remotely.

We have the following action step in our strategic plan:

- *Identify systematic opportunities to integrate the growth mindset, resiliency, and grit into our curriculum.
- * Promote a culture of "Telling your story" to share examples of grit and resilience.


I think the idea of "Telling your grit story" is something that could be implemented at every level in every subject area. When we work with students, I do believe that it is crucial to first define what Grit is. A team of Seward teachers came up with the following definition: **The ability to sustain focus and effort over the long term in the face of challenges.**

During College Week, it was very natural for us to share our college story and it is much easier for us to share our successes than it is our failures. Our students, however, could learn just as much, if not more from hearing stories of our failures and examples of determination to sustain focus and effort while facing those challenges.

We all have a grit story, and our students need to hear these stories from us, there are also countless grit stories in our country today. Once you have modeled what a grit story looks like. I could see elementary teachers making this part of their writing assignment after highlighting a character in a book that modeled grit. Middle school teachers could implement this in any subject by thinking about their content and highlighting grit. Students could use ipads record their own Grit story. This also fits every high school content area and I recently saw students telling their own Grit story using the 6 word strategy that you are all familiar with.

Grit Can be Learned

Some people are naturally grittier than others. Some of that grit comes from genetics, and some comes from the way a person is raised. Duckworth assures readers that those who score low on the Grit Scale today needn't be too worried. Grit is a skill, which means it can be taught and learned. Like a muscle, it grows stronger the more it is used.

Duckworth gives the example of a little girl taking ballet lessons. The little girl doesn't want to go to class on this particular day, but she manages to get dressed and get there on time. She makes a "breakthrough" during her lessons—maybe something small, such as figuring out where to place her arms—which causes a feeling of pride. She goes back to class the next week and tries a little harder and feels proud again. This creates a virtuous cycle where the child is emotionally rewarded for working hard, which makes her want to work even harder in the future, even during unrelated tasks. The little bit of grit she showed at the first lesson manifests itself into something bigger.

Duckworth says the key to fostering grit in children is to be both demanding and supportive. By demanding, she means parents, teachers, and coaches should have high (but not unreasonable) expectations for what a child can accomplish. The goal is to get them to stretch themselves to achieve just a little bit more than the time before. At the same time, adults need to support children in their endeavors. The right kind of support depends on the child. Some children need adults who push them to stick with challenging things and offer reassurance as needed. Others need freedom to achieve their goals in their own way. This type of "wise parenting" doesn't work on just children—it can also be used by mentors, supervisors, and other leaders to instill grit in adults.




