

May is always an exciting time of year, with graduation and the end of the school year. In special services, many reports are due and must be finalized before the end of the school year.

The Special Education Targeted Improvement Plan (TIP) was due May 1st. Our TIP focuses on reading and what we are doing as a district to improve reading scores for our students who receive special education services. We aligned our TIP plan with our District Strategic Plan and will focus on strengthening our interventions and enrichments through MTSS. All students should have access to quality Tier 1 instruction, and then, by using flexible grouping, we will be able to differentiate for students based on their individual needs. Preliminary results indicate that we have made solid gains in reading for students on IEPs.

The 2022-2023 PEaK (Promoting Engagement and Knowledge) grant was also due May 1st. We use money from this grant to support our work on our Targeted Improvement Plan. Specifically, we use the funds to send staff to conferences such as LETRS and MTSS and to compensate staff for work time on MTSS.

Dr. Dominy and I met with representatives from our Non-Public schools on April 20th for our consultation meeting. The documents from this meeting needed to be turned in to NDE by May 1st.

Jocelyn Gray and I met and completed our Annual ELL Program review. We then sent the document to our ELL committee for review. ELL is a component of our Strategic Plan. Currently, very few students are eligible for ELL services, but we want to have a plan for expansion if we need it in the future.

Maintenance of Effort (MOE) needs to be submitted to NDE by May 10th. The term "Maintenance of Effort," often shortened to "MOE," refers to the requirement placed upon many federally funded grant programs that the State Education Agency (SEA) and Local Education Agencies (LEA) demonstrate that the level of local and state funding remains relatively constant from year to year. Districts must expend more or equal regional or local/state funds from a previous year's highest level to meet the MOE requirement.

The Seward County Sixpence Grant is due May 30th. We are working to complete the grant application for the 2024-2025 school year.

By the end of May, our preschool staff will complete the GOLD assessment on each preschool center-based student (peers and students with IEP) and the birth to three children on IFSPs. NDE requires this assessment twice a year. We have since growth in all areas for our preschool students.

Thank you again for all you do to support our students and staff.



## May 2024 Board Report for Curriculum and Staff Development

---

Board Members,

Our students and staff have been busy completing assessments, going on field trips, participating in activities and creating memories that will last a lifetime. May is a special month for schools, and we are certainly maximizing the month!

### **Curriculum**

We were pleased to share with you our recommendations for social studies last month. At this meeting we will ask for your approval to make the recommended purchases. As a reminder we are recommending TCI for the Elementary and Middle School and McGraw-Hill for the core classes at the high school. This summer we will be creating our curriculum guides for social studies using these instructional materials to help guide this process.

### **Instruction**

This winter we implemented the On To College program with our Junior students. Informal conversations had with students indicated that they felt much more prepared to do well on the ACT test. Our data also indicates that this program was beneficial to students as several of them had possibly life-changing score increases. I am grateful to the High School Admin for finding a way to address some of the challenges with the ACT, especially related to the English section. I am also very proud of the teachers for their implementation of the program.

### **Staff Development**

Every month a staff development newsletter has been sent out to staff to continue the professional development that we are doing on our PD days. This year my focus has been on Artificial Intelligence, MTSS, staff engagement, and the American Civics holidays. The continued focus on our professional development topics has led to further discussion regarding the topic as well as a common understanding of terms and the research. I do use a SMORE newsletter for the staff development newsletter and get a few analytics regarding how many times the newsletter is opened, etc. The newsletter is well-read and I will continue to send this out in the future.

**Assessment**

We are just completing the last assessments for the school year. I am thankful to the teachers and administrators who put so much work into ensuring a successful testing experience. While these tests are one small measure of our success, they are an important tool to give us information about our programs, curriculum, and the individual needs of each child.

Be where your feet are. Be mindful in the moment. Live in the present, instead of always worrying about the future and rehashing the past.


When you're on the path to success, focus on the process, one step at a time, to reach your destination.






