



### **Special Education**

There are a number of reports that are due by the end of the school year.

ESSA Title IA Non-Public School Consultation and Special Education Non-Public School Consultation Meeting are scheduled for Tuesday, April 15th at 3:30 in Room 110 at Seward Elementary School. The purpose of this consultation is to meet with the leaders at our non-public schools and determine what special education and equitable services will be provided for the 2025-2026 school year for the non-public students who attend non-public schools within Seward School boundaries. Both Dr. Dominy and I will participate in the meeting.

"Maintenance of effort" (MOE) is a requirement for many federally funded programs. It ensures that states and local agencies continue to provide a certain level of funding for the program even when federal funding is received. Maintenance of Effort (MOE) is due on April 16th, 2025.

Our Targeted Improvement Plan (TIP) is due to NDE on May 1st, 2025. The goal of the TIP is to help schools build capacity to scale up the MTSS framework by having a system to review student data and establish a Targeted Improvement Plan (TIP). Each TIP is required to have (a) a focus for improvement, (b) a measurable goal with annual targets, (c) a student-centered, evidence-based strategy to affect the outcomes for students with disabilities, (d) a level of implementation ratings, and (e) descriptions of data used for decision-making. The TIP must be aligned to the overall general education improvement activities being implemented at the district. Our TIP is aligned with our Strategic Plan, specifically the MTSS action plan.

Our PEaK (Promoting Engagement and Knowledge) Project is also due to NDE on May 1st, 2025. The PEaK project is a way to secure funding from NDE to support the implementation and evaluation of our Targeted Improvement Plans (TIPs). Funds must be used to assist with the deep

implementation of evidence-based practices designed to improve the outcomes of students with disabilities.

I have applied for and received a summer grant from Vocational Rehab (VR) that will allow us to provide some summer experiences for students ages 14-21 for work-based readiness and experiences. We are starting to compile a list of students who are eligible and will be sending information to their families regarding this opportunity. I will share more information as it becomes available.

## April 2025 Board Report for Curriculum and Staff Development

Board Members,

I hope this report finds all of you well. I am writing this board report the day of the ACT test, so assessment is clearly on my mind as I write. As a reminder, we gave our 11<sup>th</sup> grade students the opportunity to take the ACT with reportable scores in October. We are excited to see how our students perform after a year of quality instruction and On To College test prep that was generously provided by the Seward Foundation for all Seward Juniors.

### **Curriculum**

We are at the point where we are ready to make our final recommendations to you regarding math curriculum. We have completed professional development, analyzed the standards, studied both print and digital materials and we have identified the materials that are most suitable for our students here in Seward. More information will come during this meeting.

### **Instruction**

As you know we have been doing a great deal of work related to MTSS this year. All three buildings have had great conversations and identified processes that support MTSS in their building. Next year, we plan on focusing on our Tier I instructional supports available to all students by reviewing the Marzano Instructional elements. We will also take some time to review and revise our MTSS process through the strategic plan action planning process.

### **Staff Development**

Our March staff development day was devoted to a variety of professional learning opportunities from MTSS leadership meetings to information related to our HumanEX culture survey. The teachers also had time for action planning as well as training regarding our upcoming assessment administration.

**Assessment**

I shared with you above that the ACT test will be taken on April 8<sup>th</sup>. Parents and students will get the results about 3 weeks after the test, but we will not have data to share regarding the ACT test until the data is released in the Fall. We also started our NSCAS growth assessments this week for grades 3-8. These assessments are important, but they are one small piece in how we document student achievement in our school district.


### **Why Did You Become an Educator?**

Teaching gives educators a strong sense of purpose, knowing they are contributing to the future. Shaping the next generation provides a deep sense of fulfillment and pride.




## Math Curriculum


