February Risk Alert

School Transportation Guidelines



Nebraska school districts and ESU's have many rules and regulations to remember, and the topic of transportation is no exception. Over the past few years, 15 passenger vans have been the subject of many transportation safety discussions. ALICAP would like to provide some clarification on a few transportation guidelines.

- Schools may utilize vans originally manufactured as 15 passenger vans, which have been modified to a 10 passengers + 1 driver vehicle, until June 7th 2011. If the vehicle is set up to hold 12 persons or more, this vehicle is no longer considered a "small vehicle" and the vehicle must meet the rules and regulations of a school bus requiring stop arms, rollover protection and emergency exits.
- If a 15 passenger van is modified, it must be done by the manufacture or dealer which sold the vehicle to the school district/ESU. Also, if modified, proper paperwork must be provided and stored in the vehicle confirming the modification. This paperwork is suggested to be kept in the vehicle's glove compartment.
- Note your calendars for June 7, 2011, as all 15 passenger vans will no longer be legal for schools to utilize as pupil transportation vehicles regardless of modifications.
- It is no longer necessary to have vehicles marked or labeled with the words "School Students."

As per the Nebraska Department of Education, it has been brought to our attention, there are some vehicles being manufactured by Ford and Chevy which are utilizing the extended frame, just like a 15 passenger van was prior. Be aware these extended frames are unacceptable as of June 7, 2011.


Dear Mr. DeWaard and School Board Members,

SUPERINTENDENT'S REPORT

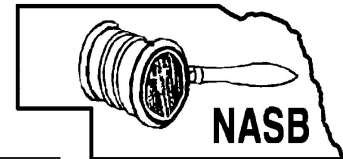
March 14, 2011
