Critical issues course description

Course Description:

This course is one of the core requirements for the Master's of Curriculum and Instruction. The course contents will primarily revolve around the question "What are schools for?" and will address the critical philosophical, political, socioeconomic, and moral issues relating to schooling and curriculum. Central to this course are the Doane College Teacher Education Outcomes:

- The developing professional uses classroom management and motivational strategies to create a positive learning environment.
- The developing professional applies knowledge of effective communication techniques.
- The developing professional utilizes effective planning techniques.
- The developing professional understands and uses a variety of formal and informal assessment strategies.
- The developing professional is a reflective practitioner who actively seeks out opportunities to grow professionally.
- The developing professional fosters relationships with school colleagues, families, and agencies in the larger community to support students' learning and well being.

Dev. Appropriate practices

COURSE DESCRIPTION

Recent research on best practice in the early years has developed into a framework called developmentally appropriate practices (DAP). It builds on the knowledge base of child development, suggesting effective strategies for working with young children. Developmentally appropriate techniques for facilitating communication with parents and communities are also addressed.

CLASS OUTLINE

This course will combine researched-based information in relation to DAP and apply this newly gained knowledge into classroom practice. Students will research and analyze DAP as it relates to best practices in early education and the primary grades' curriculum content areas. They will assess their own knowledge base and current

educational practices, develop a plan that integrates current practice with new information and implement this plan into an educational environment.

Developing a positive learning environment

Course Description:

Students with social and behavioral issues can disrupt the classroom, repeatedly end up in the principal's office, and experience failure on a daily basis. In this course, designed for both general and special education staff, participants will examine real life case studies of students with attention deficit disorder, autism spectrum disorder, and behavioral disorders. Students will learn how to incorporate a variety of intervention strategies for disruptive students and develop plans for the creation of supportive school communities for all students.
