**Board Meeting During COVID-19 Pandemic**

Pursuant to the Governor Abbott's Temporary Suspension of Open Meetings Laws issued on March 16, 2020 and subsequent orders related to Covid-19 and limiting congregations of persons, the Board will live stream their meeting so that members of the public may virtually attend the meeting. The Office of the Governor is in receipt of OAG's request to temporarily suspend certain open-meeting provisions of Texas law. As required to give the public written notice before holding a telephonic or videoconference meeting. See, e.g., TEX. GOV'T CODE §§ 551.041, 551.043-551.044, 551.125(c), 551.127(d), 551.141. A governmental body would still have to provide the public with a recording of the telephonic or videoconference meeting. See, e.g., id. §§ 551.125(e), 551.127(g), members of the public are entitled to participate and address the governmental body during the telephonic or videoconference meeting. Statutes require a quorum or a presiding officer to be physically present at the specified location of the meeting; provided, however, that a quorum still must participate in the telephonic or videoconference meeting o TEX. Should you wish to do so you must sign up to address the board no later than 10:00 AM on the day of the scheduled board meeting. Please identify yourself and the topic you wish to discuss. Please be aware that due to space limitations and physical distancing requirements, members of the public will only be allowed to enter one at a time to address the board. Additionally, you may be screened for a temperature and for other symptoms of Covid-19 before entering the building. You must also comply with mask requirements while on Dilley ISD property.

The open portions of this meeting will be recorded and made available to the public upon request. The subjects to be discussed or considered or upon which any formal action may be taken are listed below. Items do not have to be taken in the same order as shown on this meeting notice. Texas Government Code Section:

551.072 Discussing purchase, exchange, lease, or value of real property.

551.073 Discussing negotiated contracts for prospective gifts or donations.

551.074 Discussing personnel or to hear complaints against personnel.

- 551.075 To confer with employees of the school district to receive information or ask questions.
- 551.076 Considering the deployment, specific occasions for, or implementation of, security personnel or devices.
- 551.082 Considering discipline of a public school child, or complaint or charge against personnel.
- 551.083 Considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.
- 551.084 Excluding witnesses from a hearing.

Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
