**Superintendent's Report**

**July 2015**

Superintendent Gronseth - I want to start by officially welcoming our new Assistant Superintendent, Amy Starzecki. She was most recently Superintendent and K-12 Principal for ISD 698 in Floodwood, MN. In that capacity, she served as a member of the MN North Regional Implementation Project, a leadership team for MDE in the implementation of PBIS in Minnesota. She worked in partnership with teacher union leadership to develop a teacher evaluation system that meets MN statute and established and facilitated professional learning communities focused on instructional best practices. Amy's experience includes Adjunct Professor for Saint Mary's University in Minneapolis, Principal for King Elementary in Deer River, Special Education Coordinator for Northern Lakes Cooperative in Coleraine, Area Leader of the Special Education Department at Burnsville High School, and School Psychologist. As a principal, Amy established

Response to Intervention (RTI) and PBIS frameworks, served as Title Coordinator and Chair of the Curriculum, Instruction and Assessment Committee. She worked on the MDE Equity Committee Project to help create a toolkit for districts to evaluate and improve policies, practices, facilities, curriculum and other school areas to become more inclusive and ensure that all students have access to high quality education. She holds a District Superintendent License, K-12 Educational Administration License and Special Education Director License from Saint Mary's University in Minneapolis. She earned a Master of Arts and Certification in School Psychology from Northern Arizona University in Flagstaff and a Bachelor of Science in Biology and Psychology from the University of North Dakota in Grand Forks. Welcome, Amy-- and it has been a great first few weeks since you have started.

Last month, a delegation of ISD 709 students and staff boarded a plane, headed to a to Dalian, China. You may recall last year high school students from Dalian travelled to the Northland. Their visit was part of a visionary project organized by retired assistant superintendent Ed Crawford over two years ago after meeting with representatives from the High School Associated with the Dalian University of Technology and forging the beginnings of an exchange program. Last month, it was our turn to send a delegation to China to help Duluth students expand their understanding of a global society, the Mandarin language, experience another culture and help us further explore a long-term partnership with the Dalian school. This was an incredible opportunity for our students and staff. In addition to staying with host families and going to school, the visit included exploring the Forbidden City in Beijing, climbing the Great Wall and trying new foods. The hospitality we received was heartwarming and our connections with these generous people made the trip especially memorable. While there we continued to work on building a partnership with the school and we can look forward to future opportunities. This fall 39 students will travel from China to the Northland. Our school district will host 10 students at Denfeld and 10 at East, Two Harbors school district has agreed to host another 10 and I'm working with area superintendents to make arrangements for 9 others. We're looking for people across the city to volunteer as host families. We'd love to have local businesses host events for the Dalian students – experiencing local cuisine and entertainment is an important part of their visit and we'd like to match the incredible generosity that Duluth students and staff experienced in Dalian. If families are interested in hosting a student, or if there are area businesses that would like to host an event for our visitors, they can contact my office.

Termination of Certified Probationary (Non-Tenured) Staff

WHEREAS, during the first three years of consecutive employment all teachers in the public schools in cities of the first class are deemed to be in a probational period of employment during which period the School Board may renew, or not renew, any teachers' annual contract as the School Board shall see fit. The term "teacher" includes every person regularly employed, as a principal, or to give instruction in a classroom, or to superintend or supervise classroom instruction, or as a placement teacher and visiting teacher.

NOW, THEREFORE, BE IT RESOLVED by the School Board on Independent School District No. 709, St. Louis County, Minnesota, as follows:

**Board members wills strive to improve public education, and to that end should: 1. Attend all regularly scheduled board meetings insofar as possible, and become informed concerning the issues to be considered at those meetings; 2. Recognize that board members should endeavor to make policy decisions only after full discussion at publicly held board meetings, rather than pledge their vote prior to the discussion; 3. Render all decisions based on the available facts and independent judgment; 4. Encourage the free expression of opinion by all board members while refusing to predict school board action. *Refrain from disparaging remarks about other board members*; 5. Work with other board members to establish effective board policies and to delegate authority for the administration of the schools to the superintendent; 6. Seek public input from *other board members*, parents, students, staff, and the community at large, and communicate such input to other board members and the superintendent; 7. Keep informed about current educational issues; 8. Support in an impartial manner the employment of those persons best qualified to serve as school staff; 9. Keep the office as a board member separate from the board member's private business or profession, avoid soliciting business or patronage from employees or others doing business with the district, and avoid being placed in any other position of conflict of interest; *Board members; like District Administration, and District Staff, and District employees; will refrain from participating in any issues involving family members.* 10. Take no private action that will compromise the board or administration; 11. Respect the confidentiality of information that is privileged under applicable law; 12. Promote the educational welfare of all the students attending the public schools; and 13. Adhere to all *District Policies, Minnesota and Federal statutes.***
