COMMITTEE OF THE WHOLE REPORT

1. *Consent Agenda*
 - a. The only thing to approve on the consent agenda is the board minutes and payables.

3. Review of Policies 1001, 1002, 1003, 2001, 2003, 2004, 2006
 - a. Highlights of the policies
 - i. 1002 – Board will review all policies every three years. In order to do that we will need to review at least 7 policies a month. This is state statute.
4. Buses:
 - a. At this time this can be either a discussion item or an action item. We are currently using vans for routes, which we should not be doing. I am recommending we look at purchasing two 15 passenger yellow buses to transport our preschool children. We should be able to purchase the buses for \$70,000 - \$80,000 a piece. I recommend this is a discussion item only and while at the NASB conference we can meet with representatives of busing companies to get a better idea of what we want. We will probably not be able to have the buses until late spring or summer.
5. Resignation of Redwing Thomas
 - a. Recommending to accept the resignation
6. Policy 2007 Reimbursement and Miscellaneous Expenditures
 - a. We need to add a section to this policy to reflect what we are actually doing, most of the time. With the addition to the policy when we travel each person going to the conference would be given the IRS rate and then you would just need to sign an expense sheet that shows how much you were given. You would not be required to provide and receipts or return any unused monies. It was recommended by the auditors for us to add this language.
7. Authorized Signatories:
 - a. We need to have Sherri Henry added as a signatory for the bank.
8. Four Day week.
 - a. In evaluating the four day week during August we felt it was very successful, and would like to start the discussion on maybe trying a 4 day week pilot starting this spring, or trying it for the year next year. I have examples of what a four day week might look like for this spring if we kept the school days the same length and just added days to the calendar. Another option would be to add some time to the schedule. I think there are a lot of options we could explore utilizing a four -day week. I am excited about potentially extending the school year for our students, which could improve academic performance. I believe we could get creative with the calendar if there is any interest in pursuing this further.

Overview:

The purpose of this report is to provide an overview of Isanti students current performance on two achievement measures; 1) Nebraska Student-Centered Assessment System (NSCAS) and 2) MAP testing.

NSCAS is the Nebraska statewide assessment that tests students' performance in reading, mathematics, and science. Tests are administered in the spring, districts receive results in the fall. Due to the COVID-19 pandemic these tests were not administered in Spring of 2020. An updated version of this assessment was administered in Spring, 2021. Since we are looking at different tests we are unable to provide longitudinal data at this time.

The MAP assessment is given three times a year (beginning, middle, and end) in the Santee Community. This report focuses on MAP tests based on a continuum of skills in Mathematics and Reading from low skill levels to high skill levels. MAP assessments help teachers identify the instructional level of the student and also provide context for determining where each student is performing in relation to local or state standards and national norms. MAP reports allow teachers to better target instruction based on students' strengths and needs.

Results

Strengths:

- At the elementary level on NSCAS we met the 3% improvement SIP/ Priority plan goal.

Areas for Improvement:

- Too many students' achievement continues to be below grade level. We have to implement strategies that accelerate growth.
- Mathematics is an area of concern, K-12.

Next Steps:

- Continue to implement the gradual release of responsibility framework, focusing on clear learning intentions and success criteria for every lesson.
- Implement the integrated math resources at the high school level.
- Implement number talks at elementary to help students think more fluently and flexibility about numbers so they can solve problems more easily.
- Complete the math curriculum revision process at the elementary level. Materials will be piloted in the second semester so they can be adopted for the 2022-21 school year.
