**7.1. Recommendation to Adopt a Boys and Girls Tennis Team Proposal as a Student Extracurricular Activity**

Patron comments were allowed with five individuals speaking in support of a Gering tennis program. Matt Palomo of the Gering Junior Tennis Club, who has unofficially voluntarily coached local students in the sport, also addressed the board with his recommendation of support. President Brunner asked Activities Director David Pauli to address concerns that Winn has. Those concerns included pre-existing coaching positions being cut, which was determined to be due to lack of student participation rather than the budget. The Board expressed its appreciation of Palomo's past contributions; however, because he is not a Gering certified employee, he would need to be accompanied by a certified employee from the district when traveling, thus adding to costs. Pauli stated that non-certified staff can obtain coaching certification by participating in a two year process to complete three available classes. Winn also inquired as to the status of the district's budget and asked if the district can afford another sport? Pauli explained that, in comparison to whole budget, tennis would require a very small percentage that would fund all travel expenditures, as well as expenses related to coaching. Winn then asked if the City of Gering would

continue their maintenance contributions. Hague confirmed that the courts are property of the school district; however, the City does contribute financially to their upkeep. Peters informed the attendees that he was vocally against the tennis program proposal last year due to spending scenarios within the legislature, but he will be voting in support of it this year. Peters informed the patrons that by district policy the coaching position would be offered internally first. Hague reminded the Board that this is a sport where the district already owns the needed facilities so there would be no added costs in that area.

**BIST Presentation**

Lincoln Elementary Principal George Schlothauer introduced the district's BIST team to the Board. All, with the exception of one, have visited schools in the Lincoln district and each serves as the BIST representative at their individual buildings. The presentation focused on a general overview of the BIST program. Specific topics covered included program beliefs and what is taught at the building level. Additional topics included school-wide goals, basic principles, life goals for students, gateway behaviors and early intervention, the triage process and indicators, substitute training, expectations, safe seats, think sheets, buddy rooms, recovery rooms, process criteria, number of participants, national time frame statistics, parental behaviors, replacement behaviors, protective plans, transition plans, team focus, staff responsibilities, future program goals and a typical day at Lincoln Elementary. The program is run in grades kindergarten through Jr. High. The program entails a three to five year process for full staff training.

Chris Boden, the Education Consultant from Outreach Program of Ozanam, provided handouts and a website for their parent organization in Kansas City, Missouri. The website offers links for sites where printed research materials can be downloaded. It also provides evidence based data & research studies. New staff and para educator training is provided internally through in-services. Substitutes and bus drivers are also offered training. Each building has its own goals that stem from data from the previous year. At the end of each year, the plan is evaluated to see if their goals were met. This program has significantly reduced Principal referrals. The district's BIST visit team started this year and will share new ideas within the district.

We have audited the financial statements of the governmental activities, the business-type activities, the aggregate discretely presented component units, each major fund, and the aggregate remaining fund information of Scotts Bluff County School District No. 16, Gering Public Schools for the year ended August 31, 2011, and have issued our report thereon dated November 7, 2011. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards and, if applicable, *Government Auditing Standards* and OMB Circular A-133, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated September 1, 2011. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Findings

*Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Scotts Bluff County School District No. 16, Gering Public Schools are described in Note 1 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended August 31, 2011. We noted no transactions entered into by the governmental unit during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the District's financial statements was:

Management prepares budgets based on prior experiences and future expectations. Management uses these estimated revenue and expense items to measure against actual amounts and identify areas of concern in revenue production or expense overtures. Management additionally uses budgets to comply with state statutes and determine property tax needs. We evaluated the key factors and assumptions used to develop the above in determining that it is reasonable in relation to the financial statements taken as a whole.

The School District presents its financial statements on the cash basis of accounting. As such, outstanding debt required to be repaid in future periods is not presented in the financial statements. Note 4 to the financial statements discloses total outstanding debt of the district as well as future debt service requirements.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements.

#### *Disagreements with Management*

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated November 7, 2011.

#### *Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the governmental unit's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

#### *Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the governmental unit's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

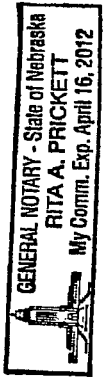

It shall be the responsibility of the parent to notify the student's attendance center as soon as the parent knows the student will not be attending school on that day. The principal may request evidence or written verification of the student's reason for absence. This issue is specifically addressed in the student handbook which is approved every year by the Board of Education.

It shall be the responsibility of the superintendent, in conjunction with the principal, to develop administrative regulations regarding this policy.

Children in the school district community will be allowed to enroll in the school district's regular education program beginning at age five. The child must be age five on or prior to July 31<sup>st</sup> October 15 to participate in the school district's kindergarten program ~~or beginner grade, or be admitted under exceptions provided by state statute.~~

The board shall require evidence of age and residency in the form of a birth certificate or other evidence before the student may enroll in the school district's education program. It shall be within the discretion of the superintendent to determine what is satisfactory evidence for proof of age.

Prior to enrollment, the child must provide the administration with proof of a physical examination and immunizations as required by law and the respective policies of this district. Failure to provide this information shall be reason for denying admission to the student.

The parent/guardian of any child younger than six years of age prior to January 1<sup>st</sup> of the current school year who is enrolled may discontinue that enrollment according to procedures provided by the district.

## EARLY ADMISSION ASSESSMENT PROCEDURES

Gering Public Schools may admit into kindergarten a child who will reach the age of five years on or after August 1 and on or before October 15 of such school year if the parent or guardian requests such entrance and the child has demonstrated through the procedures set forth below that the child is capable of carrying the work of kindergarten. Families who seek early admission of their child into kindergarten must obtain a *Written Request for Early Admission* form from any of the four elementary buildings. This form must be completed and returned to the Gering Public Schools Central Office no later than March 1 of the spring before fall enrollment to allow the interview and assessment to be completed.

An initial parent interview will be held prior to testing. If the child passes the initial interview, the process below must be followed:

1. Parents must request, schedule, and make their child available for an Early Kindergarten admission assessment prior to (DEADLINE).
2. The Early Kindergarten admission assessment will be completed (as further explained below) by district personnel.
3. The Early Kindergarten admission assessment results will be given to the parent with the staffs' recommendation and the Superintendent's decision.

The ESU 13 Regional review found two assessments to be appropriate for the purpose of Early Admissions. Gering Public Schools has chosen to use the following as their assessments:

- **BASC-2 Behavioral and Emotional Screening System (BASC-2 BESS)**
  - Authors: Randy W. Kamphaus, PhD, Cecil R. Reynolds, PhD
  - Description:
    - Brief, universal screening system for measuring behavioral and emotional strengths and weaknesses in preschool children which can be an effective tool in promoting student success. The BASC-2 Behavioral and Emotional Screening System offers a reliable, quick, and systematic way to determine behavioral and emotional strengths and weaknesses of children and adolescents in preschool through high school. This comprehensive screening system consists of brief forms that can be completed by teachers, parents, or students, providing one of the most comprehensive and efficient tools available today.
- **Young Children's Achievement Test (YCAT)**
  - Authors: Wayne P. Hresko, Pamela K. Peak, Shelley R. Herron, and Deanna L. Bridges
  - Description:
    - This test identifies young children (from preschool through first grade) who are at risk for school failure. It yields an overall Early Achievement score, plus individual subtest scores for General Information, Reading, Writing, Mathematics, and Spoken Language. Results are provided as standard scores, age equivalents, and percentiles. Because the subtests can be given independently, the YCAT permits flexible testing sessions, which are easier on both the examiner and the youngsters being tested. Normed on a representative sample of 1,224 children from all over the United States, the YCAT offers substantial evidence of validity. In addition, YCAT items were

examined to eliminate bias in regard to gender, disability, race, socioeconomic status, and ethnicity.

- The YCAT Assessment will be administered first. A child eligible for Kindergarten entrance would require a score equal to or higher than that the 80<sup>th</sup> percentile for a child 5 years 0 months on the YCAT.
- If the child receives the required score on the YCAT Assessment, the BASC-2 Assessment will be administered. Gering Public Schools will take at-risk and/or clinically significant scores on the BASC-2 into consideration before allowing eligibility admission.
- If a child is within  $\pm 3\%$  points on the assessments, an observation day may be required. If an observation day is required, the parents must bring their child for observation at a school designated by the district or allow school personnel to attend and observe the child at the preschool where the child is enrolled.

The final decision regarding entrance will be made by the superintendent with recommendations from the test administrator and student services director.

### **1. District Report Card & Goals**

The Curriculum Committee looked at the 2010-2011 goals and the results. These goals dealt with the ACT Series at grades 8-12, the Nebraska State Assessments for grades 3-8, and 11, the Terra Nova assessments at grades 3-8 and the DIBELS results for grades K-2.

The discussion focused on why goals were met or not met as well as whether the goals should be continued into the next year. With the new ACT District Choice State Testing where all students will be participating in the ACT for the first time, it was determined this goal should be continue and reviewed again next year. The committee would like to see data from the John Baylor Test Prep Program that was implemented during the 2010-2011 school year.

The Nebraska State Assessments will be in place for reading (in year three), math (in year two), and science (in year one) during the 2011-2012 school year. Baseline data has been established. Plans to show growth from the baseline data have been implemented into the curriculum and instruction. We will continue to monitor each of these tests.

The Terra Nova goal for the 2010-2011 school year was met by having all norm-referenced scores above the 50th percentile.

Suggestions for the 2011-2012 Curriculum/Assessment Goals were developed. Work has already begun on many of these goals. Both Martin and the Committee will continue to review the goals.

### **2. Travel and/or Conference Requests received during the month of November, 2011.**

There were no questions regarding the travel requests submitted during the month of November. It was noted that many of the requests were for conferences held in the Panhandle.

### **3. Budget Reviews**

There were no questions regarding the Assessment, Curriculum or Perkins Grant budgets for the month of November.

Topics of discussion included: demand charges on the City bill, which was previously included in electrical payments, energy efficient lights at Northfield and Geil, a free audit of district buildings by the City, High School windows, Verizon cellular fees, software for the PERK grant and reimbursement of taxes on district purchases. Copsey suggested utilizing a credit card vendor that provides an end of year report that can be used for tax crediting. A copier contract with Connecting Point was discussed, as was miscellaneous charges. Two local sanitation providers were given the opportunity to streamline the districts custodial process but did not follow through. Copsey questioned a charge to the Job Corp crew, who works custodian jobs and was told that both Hague and Meisner had met with their supervisors to increase their quality of work. The district partners with them to provide jobs, otherwise one custodian would be needed full time. Bottled water usage was questioned. Copsey asked if the district does a vehicle analysis for mileage each year and was told that they do. Carpooling is also being utilized when traveling east. Internet fees were explained by Meisner. Brunner expressed interest in having the district's computer system reviewed since a virus recently infected various users.

### **2. Personnel Issue**

Hubbard explained a recent situation involving a teacher/coach. Hubbard and Pauli met with the teacher and shared with her their displeasure of her actions. The committee expressed their desire to ensure that character and proper behavior are traits that need to be upheld with district coaches

### **3. Girls Basketball**

Pauli addressed a citizen letter that was submitted to the editor of the Gering Citizen pertaining to a student who had been cut from a sports team. The student was cut due to a lack of playing time and was offered the student manager position on the team. She did not accept that position. Pauli supports his head coach's decision. The letter did not reference the team manager position being offered

### **4. Student Drug Testing**

A letter from the public requested that the district re-visit this issue. The Facilities Committee was in full favor of implementing such a policy. Principals can currently test a student if they have reasonable cause. Hubbard stated that there was no community support in the past so it had not been implemented. Hubbard addressed extra co-curricular students being tested as well. Hubbard would like all students to volunteer to be included in the pool and offer weekly incentives for their participation. Parents also have the ability to option their child into the pool. The committee is aware that the public may challenge this proposal. Gering students who participate in Sea Cats are already being tested. Costs are estimated to be \$11,700. Another concern for Pauli is the follow up time and protocol if a student does test positive. Pauli referred to two studies that had been emailed to the full board. Districts that currently drug test are Mitchell, Scottsbluff, Chadron and Gordon/Rushville. Hague suggested putting it on the December agenda for full board discussion and requested that Hubbard and Pauli be present to address questions and/or concerns. Pauli would like to see coaches tested as well. The committee would like a list of the extracurricular clubs that will be in the pool.

### **5. New District Hires**

Due to resignations, one custodian was hired at Geil Elementary and a part time Administrative Assistant was hired for the Director of Curriculum and Assessment.

### **6. Review of Personnel Committee Goals & Timeline**

Committee goals were reviewed. The Superintendent's job description, review and formal evaluation schedule was reviewed. The committee discussed basing pay increases on merit rather than strictly on cost of living. Hague would like to consider cost of living, comparability in the district's array and individual performance. Hague stated that he will develop a spreadsheet that includes such info for each staff member that he supervises. A summary would then be provided to the Personnel Committee with justifications. The committee would like all

evaluations to be provided by May so Hague's proposal can be approved at the annual June Board Meeting. This system would also eliminate the need for retro pay.

## **7. Recognition of Principals as Negotiating Unit**

Hague encouraged the committee to share information received from the district attorney with the representing Principals.

### **7.1. Discussion on Administrative Group**

Sample contracts were discussed, including annual versus addendums. Miles requested that the Personnel Committee review the Superintendent's Administrative Salary recommendation every June. The job description review, performance summary and completed evaluations need to be submitted by May each year. The committee will also be notified at that time if all classified evaluations have been completed and turned in.

## **8. Staff Evaluation Process**

The evaluation schedule was reviewed and various options for pay increases were discussed. Pay increases will be merit based, as well as cost of living and schedule.

## **9. Updated Comparability Study on Teacher Salary**

A comparability study on teacher's salaries was handed out. An updated copy will be provided soon from one of the district's attorneys. The committee noted that Lexington was not included on the list.

## **10. Discussion on Current Review/Evaluation Schedule for all District Employees**

The committee will share a comparability study with the negotiating team in their next meeting. A new evaluation rating system was discussed.

## **11. Superintendent Evaluation Form Discussion**

A discussion was held detailing the differences in the NASB Superintendent Evaluation Tool and the Lincoln Public School District's evaluation model. They were determined to be very similar. Hague's current evaluation tool will be emailed to the full board on Friday of this week with the Superintendent's Friday Note and Rolling Calendar. Hague stated that he appreciates the six-month evaluation process as it helps to determine focus and targets for the next 6 months. An Executive Session has been scheduled for December 19th to discuss the Superintendent's evaluation. The committee recommends that Bruner and Peters meet every 6 months with Hague and submit a formal report including goals, timelines and a summary of what was discussed for their review.
