Notice of the meeting was given in advance by publication in accordance with the Board approved method for giving notice of meetings. Notice of this meeting was given in advance to all members of the Board of Education and published on January 5, 2021 in the McCook Gazette. Availability of the agenda was communicated in the publicized notice and a current copy of the agenda was maintained as stated in the publicized notice. All proceedings of the Board of Education, except as may be hereinafter noted, were taken while the convened meeting was open to attendance of the public. The meeting was held in Conference Room B at the high school to accommodate social distancing due to the coronavirus pandemic.

1. Call to Order

Superintendent Grant Norgaard called the January 11, 2021 MPS Board of Education meeting to order at 6:32 p.m. Roll call with the following members being present: Dennis Berry, Tom Bredvick, Loretta Hauxwell, Brad Hays, Mike Langan, and Teresa Thomas; Absent: None.

Mr. Norgaard reminded those present of the Open Meetings Law on the entryway table and asked all to stand and join him in reciting the Pledge of Allegiance.

Mr. Norgaard then administered the Oath of Office to the three incumbent board members that were re-elected. Those board members are Tom Bredvick, Brad Hays, and Teresa Thomas

2. Election of Officers

Superintendent Norgaard, by board policy will chair the election of the President, then newly elected President will preside over the other elections. 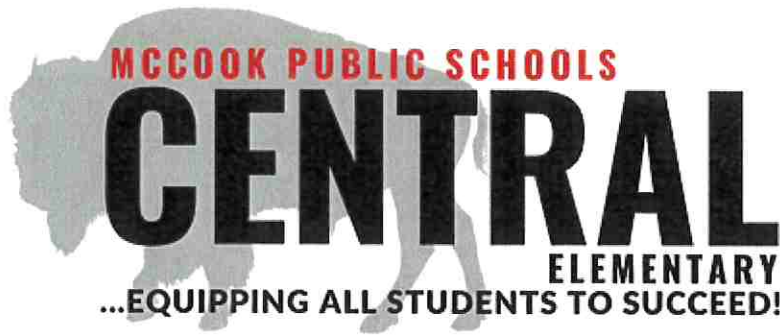

She will be a great fit for our team. I'm very proud of our 4th grade team the past few years. They've matured and grown as professionals. They work very well together and ensure that all students learn.
- We are planning our N-SCAS testing out for March and April. There are some N-SCAS testing changes coming that we are trying to work through and plan accordingly. Science is usually our shortest assessment but now will be 90 minutes long.
- We still have a SPED opening at Central. This may continue to be open for the next few weeks where we may have to get creative in filling.
- Our 5th grade team is working on some plans to begin our WIN time at the end of the day safely. We use that time to target students with small group/1:1 help on the essential standards. We feel that we can do it very safely.

Curriculum

- February 15 will end up being a vertical PLC day each grade level. We will split up into grade level bands. I'm considering using Zoom to guide the discussion and split into 'breakout rooms' to discuss with grade levels before/after each grade level. Discussion will be held on their pacing guides in regards to previous years, essential standards, mastery of those standards, etc.

- 1) Caitlin Holthus, Preschool Teacher, and I selected the students to be able to get into the Little Bison preschool classes next year. Lots of 4 year olds, and much fewer 3 year olds this year than past years. Usually we have an AM class of 3 year olds and a PM class of 4 year olds, but this year we have the 15 already enrolled kids from the AM class say they plan to continue, but we also have approximately 20 more new students...and approximately 15 of those 20 new students that have applied are 4 year olds. It doesn't make sense to turn those 15 away, and only have a class of 5(ish) 3 year olds, so we are planning on taking 10-12 of the new 4 year olds, and have a mixed class of 3 and 4 year olds, and Mrs. Holthus and her staff will differentiate instruction. That way we only have to turn away approximately 5 students because of capacity restrictions.
- 2) I had a zoom meeting with Senator Hughes as part of my attendance at the virtual NE SPED Supervisor's legislative conference held last week. Good visit with him about sped funding and issues.
- 3) The NDE office of Special Education has recently released new SPED eligibility guidelines for all of the 13 different disability categories...it will take the school psychologists and I some time to compare the old with the new to see what changes, if any, are included in the new eligibility guidelines.
- 4) As stated in last month's board report, Alex Hopkins, who was a sped resource para at the High School, has accepted the additional technology para position with the district. Melissa Hock, who has been a JH para for the past 4-5 years, has moved into the high school para position to replace Alex. We have hired Sara Frank, substitute para, to be a permanent para at the JH to replace Melissa.
- 5) Congratulations to Haley McRae, newly hired para this year at Central, for passing the "ParaEducator.Now" assessments that make her "highly qualified" now.
- 6) Southwest Area Training Services (SWATS) reached out to Mrs. Kinne and I and asked if we could send some of Lynne's high school life skills students over there once a week for two hours to help put together/complete a large order of pieces that need to be assembled. We agreed to send 4-5 students over there every Monday, with parent permission for a couple hours. SWATS representatives were very grateful. This is done for school credit, our students can't get paid while in school, but this opportunity may lead to a summer job for these students.

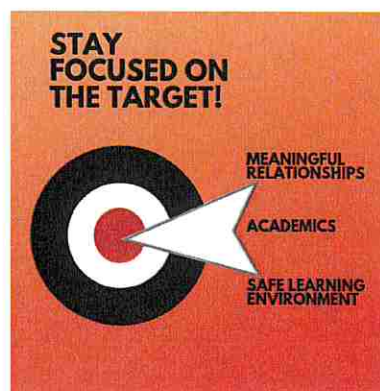
