Melissa Carey spoke to the board concerning the 2nd draft of Nebraska state health standards. She still believes that there is language in the draft that refers to CRT and believes these need to be scrapped. She is very thankful for the power of local control.

Brad Randel spoke to the Board and reiterated what Mrs. Carey had said concerning the health standards. He wanted to thank the board for having masks optional. He is requesting that masks remain optional and that we do not mandate them. Statistics show the effect on children and he is hopeful that we remain optional. 2. Curriculum/Instruction

- a. READS letters are getting completed this week.
- b. Discussions have taken place in grade levels regarding math gaps and how to help keep math in focus with interventions as well as the reading.
- c. Fall testing is beginning to wrap up and we will be looking at results in the coming weeks.
- d. Our PRti process works. Following our READS intervention list over the past 3 years we have been able to reduce our list of students needing interventions by $\frac{1}{2}$ each year since 2018-2019. Our process has also identified students with learning disabilities as well to make sure these students receive the instruction that best fits their needs. Our teachers work extremely hard not only teaching our essential standards to mastery but also teaching remediation to help students master these skills as well.
