



Dear Platte County Board of Supervisors,

I am requesting approval for both Victim Unit's employees, (i.e. Kassy Grant and Erika Pflapsen) to attend the National Organization for Victim Advocacy (NOVA) training to be held in San Francisco, California July 22nd-25th, 2025. This training will include inspirational speakers addressing a range of substantive topics for Victim Assistance employees as well as dynamic workshops, and valuable network opportunities for both of us. This event will lead to learning about new and emerging trends, collecting tools and resources, and will enhance our knowledge and skill level.

In 2021 you approved our office to attend this national training conference in Orlando, FL. Ms. Hoffman and I gained an increase in knowledge of the various resources available to victims of crime. We networked with other individuals and met other victim assistance personnel including one from Kearney, NE, that we utilized for advice and comparisons of our units on what can be done better to improve services to victims of crime. We listened to inspirational survivor stories and how advocates supported them throughout their journeys to safety. We learned about teen dating violence and ways to keep children safe online. We also learned about the Cortex Flo camera which is a camera that will document injuries and bruising beneath the surface of someone's skin. The camera use has since been discussed through multiple meetings to make it possible for our local hospital and law enforcement to utilize the camera for evidence collection in sexual assault, domestic abuse, and strangulation cases. This will play a vital role in prosecution of these types of cases.

Our VOCA grant funds through the Nebraska Crime Commission do not allow for reimbursement of out-of-state travel, thus, I am making this request to you for approval to attend. The Nebraska Crime Commission has no objection to both employees being out of the office for this training. The cost for "early bird" registration for NOVA training is \$1,300 for both employees. The deadline for early registration is March 31, 2025, and we will save \$150 if we register early. Our Victim Assistance Unit has unused travel expense funds for this fiscal year available totaling \$1,000, unused Registration Training funds totaling \$1,000, as well as additional funds from mileage (\$786.27) and meal allowance (\$1,000). These unused funds will be used for registration for both employees and airfare reservations costing approximately \$1700. Other training conferences we attended this fiscal year were free since we are members of the MDT - Platte County Child Abuse Prevention Team, so there was no cost to the County. Because we did not use the budgeted money to attend other training conferences, we anticipate a budget surplus at the end of June 2025.

Letter of Engagement for Budget Preparation

This agreement/engagement is between J13 Enterprises, LLC, herein referred to as “I” and Platte County, herein referred to as “You”.

This letter is to confirm our mutual understanding of the services to be provided to Platte County. This agreement is comprised of three pieces.

The first is a rebuild of Platte County’s budget for the purposes of making its structure workable to the methodology that J13 Enterprises, LLC uses. The cost of this service will be \$1,200.00.

The second is any amendment/correction work pertaining to the 2024-2025 budget for Platte County will be billed at \$100.00 per hour not to exceed \$5,000.00 without prior consent of the Platte County Board of Supervisors.

The third is I will prepare the annual budget document and the summary of significant forecast assumptions for Platte County for the fiscal year ending June 30, 2026. This will adhere to the form prescribed by the Nebraska Auditor of Public Accounts. The compilation of your annual budget document will be comprised from the information and data received from your various offices relative to the information needed to compile your budget document and the summary of significant forecast assumptions. The cost of this preparation will be \$8,800.00

My Responsibilities:

The objective of this engagement is to:

- 1) Prepare the budget document in accordance with the format prescribed by the Nebraska Auditor of Public Accounts.
- 2) Assist you in the presentation of the budget document without undertaking an obligation to provide any assurance that there are no material modifications that should be made to the budget document in order for it to be in accordance with the format prescribed by NAPA.
- 3) I will email or otherwise coordinate with your various departments and supervisors the preliminary budget worksheets to be completed by the respective individuals with the expectation that these worksheets will be returned to me in order to compile the budget document.
- 4) I will not be required to, and will not verify the accuracy or completeness of the information the county and its various representatives will provide me for the engagement or otherwise gather evidence for the purpose of expressing an opinion or a conclusion.
- 5) My engagement cannot be relied upon to identify or disclose any budget document misstatements, including those caused by fraud or error, or identify or disclose any wrongdoing within the entity or non-compliance with laws and regulations.
- 6) I reserve the right to refuse to perform any procedure, or take any action that could be construed as assuming management responsibilities.
- 7) I will prepare the budget document and its necessary documents which include but may not be limited to its worksheets, schedules & resolutions.

- 9) I will coordinate with your various county officials and/or assigned point of contact, such as the County Clerk, regarding meeting times and publishing deadlines in order to have the annual budget submitted to the Nebraska Auditor of Public Accounts in accordance with the deadline of September 30th.

Your responsibilities:

The engagement to be performed is conducted on the basis that you acknowledge and understand that my role is to prepare the budget document and assist you in the presentation of the budget document.

You have the following overall responsibilities:

- 1) The selection of the cash basis of accounting as the financial reporting framework to be applied in the preparation of the budget document.
- 2) To ensure that your various offices provide me with their completed budget worksheets and requested funds for operations, as it relates to the initial compilation of the budget document, in a timely manner. **In the event these completed worksheets have not been delivered by the deadline agreed upon by Mr. Johnson and the County Board, the prior year's approved budget figures will be used as the initial budget request.**
- 3) The design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the budget document.
- 4) The accuracy and completeness of the records, documents, explanations, and other information, including significant judgments, you provide me for the engagement.
- 5) To provide me with access to all information of which you are aware that is relevant to the preparation and fair presentation of the budget document, such as records, documentation, and other matters.
- 6) To provide me with additional information that I may request from your county for the purpose of compiling the budget document.
- 7) To provide me with access to persons within the entity of whom are necessary to make inquiries regarding matters pertaining to the compilation of the budget.
- 8) To assign or designate a point of contact person within the County for the purpose of providing accurate information to me with regard to completing the budget document.
- 9) To acknowledge that the County and its officials are responsible for all management decisions and responsibilities, as well as designating an individual or individuals with suitable skills, knowledge, and experience to oversee the bookkeeping services as it relates to the preparation of your budget documents. You are responsible for evaluating the adequacy, accuracy and results of the services performed and accept responsibility for such services.

Other Relevant Information

J13 Enterprises, LLC, managed by Caleb W. Johnson, is responsible for the engagement of these services.

The board acknowledges that Mr. Johnson is not an accountant or a CPA.

Unless unforeseen circumstances arise, my fees for these services, as aforementioned, will consist of the one-time fee of \$1,200.00 to rebuild and reconfigure the department worksheets, as discussed previously, any amendment/correction work in fiscal year 2024-2025 will be billed at a rate of \$100.00 per hour not to exceed an amount of \$5,000.00 without the prior consent of the Platte County Board of Supervisors, and a fee of \$8,800.00 to compile the budget document for fiscal year 2025-2026. *In the event that unforeseen circumstances, such as, but not limited to, amendments, or other regulatory changes by the State or other governing body do arise in 2025-2026, a mutually agreed upon rate between both parties will be agreed upon before such services are engaged and performed. Similarly, if the board wishes to have Mr. Johnson physically present at an LB644 requirement hearing, the cost of this service will be the hourly rate of \$100.00, plus required travel expenses. In the event Mr. Johnson assists in the presentation at an LB644 Hearing, via Zoom or teleconference, this rate would be included in the \$8,800.00*
