RESOLUTION 2025-11
PLATTE COUNTY BUDGET DOCUMENT
RESOLUTION OF ADOPTION AND APPROPRIATIONS OF AMENDED BUDGET

WHEREAS, A proposed County Budget for the Fiscal year of July 1, 2024 to June 30, 2025, prepared by the Budget Making Authority, was adopted by the Platte County Board of Supervisors on or about the 24th day of September, 2024, and

WHEREAS, Platte County has worked diligently to correct a number of issues primarily caused by miscoded and mislabeled information, and

WHEREAS, Platte County has 3 funds which did not include beginning balances for Fiscal Year 2024-2025 and shorted the spending authority by the following amounts: Fund 2851 – Casino Fund - \$293,740.41, Fund 2965 – District Probation - \$6,883.54 and Fund 3700 – Highway Bonds Fund - \$925,713.88, and

WHEREAS, Expenditures would exceed the budgeted authority within these funds, and the budget must be amended to comply with state statutes, and

WHEREAS, Information from the Federal Grant #1 Fund for Fiscal Year 20232024 was omitted from the original budget document and needs to be included in the budget document, and

WHEREAS, The Platte County Board of Supervisors wish to amend the budget for the current fiscal year.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Platte County, Nebraska as follows:

SECTION 1. That the budget for the Fiscal Year July 1, 2024 to June 30, 2025, as categorically evidenced by the Budget Document be, and the same hereby is, adopted as the Amended Budget for Platte County for said fiscal year.

SECTION 2. That the offices, departments, activities and institutions herein named are hereby authorized to expend the amounts herein appropriated to them during the fiscal year beginning July 1, 2024, and ending June 30, 2025.

SECTION 3. That the income necessary to finance the appropriations made and expenditures authorized shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and tax levy requirements for each fund.
