**Subject:**           **Designation of Desired Candidates to fill positions on Ingham ISD Board**

**Recommendation:**

It is recommended that the Board of Education designate candidates Mrs. Mary Thadden and Mr. Rudy Wilson to fill two (2) six-year terms of office on the Ingham Intermediate School District Board of Education.

**Statement of Purpose:**

To designate the candidates for which the district's designated electoral representative will cast votes in the biennial election of Ingham Intermediate School District on June 4, 2007.

**Budget Impact:**

None.

**Background Information/Historical Perspective:**

Recent revisions to Section 614 of the Revised School Code require constituent districts of an ISD to designate the candidate or candidates to be voted on by their designated representative. There are two (2) six-year terms open. The district was advised of candidates interested in running for the Ingham ISD Board. They are:

- Mr. Charles Allen, regular six-year term
- Mrs. Mary Thadden, regular six-year term
- Mr. Rudy Wilson, regular six-year term

The only information sent to the superintendent's office was from candidate Charles Allen. We did not receive information from the two incumbents.

**Rationale for Recommendation:**

The relationship between Ingham ISD and Waverly has been very positive. There is no reason not to recommend the current incumbents to continue on the ISD Board of Education.
