This is an agreement entered into by Elm Creek Public School district, and the Contractor Alpha Rehabilitation, P.C. here after known as contractor.

WE, the undersigned agencies, agree to the following conditions:

CONDITION I:

The Contractor shall provide instructional services and programs for the student referred for Occupational and/or Physical Therapy education services in accordance with the State of Nebraska Department of Education and in accordance with state laws governing such services and delivery thereof (Rule 51).

CONDITION II:

The contractor shall provide services in accordance with Elm Creek Public Schools instructional procedures.

CONDITION III:

The cost of the above services will be paid to the Contractor and shall be the actual costs incurred in providing these services and programs. Payment of those actual costs will be determined and paid in the following manner:

- A. The Contractor shall provide the District with an invoice within (30) thirty business days from the end of the month for the actual costs incurred in the month. Actual costs will be based on a daily rate determined from the actual costs and in accordance with Department of Education standards.
