RESOLUTION OF THE BOARD OF EDUCATION OF KEARNEY COUNTY SCHOOL DISTRICT NUMBER 50-0503, A/K/A MINDEN PUBLIC SCHOOL DISTRICT REGARDING THE REMOVAL OF BOARD MEMBER KATIE SINSEL

BE IT RESOLVED THAT:

WHEREAS, on April 26, 2021, the Board of Education of Kearney County School District Number 50-0503, a/k/a Minden Public Schools, passed a resolution to formally acknowledge the vacancy created by Katie Sinsel's consecutive unexcused absences; and

WHEREAS, Katie Sinsel was subsequently absent from the Board's May 10, 2021 regular meeting; and

WHEREAS, the Board of Education of Minden Public Schools reaffirms, ratifies and adopts the April 26th resolution in its entirety and as if stated fully herein and hereby incorporates into said resolution by this reference Katie Sinsel's unexcused absence from the May 10, 2021 regular meeting; and

WHEREAS, due to Katie Sinsel's consecutive unexcused absences, the Board needs to appoint a legal voter of the School District to fill the vacancy.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of this School District, pursuant to Neb. Rev. Stat. § 32-570, that, based upon the ballots publicly cast by the members of the Board of Education, the Board of Education should and does hereby appoint Darcie Reed, a qualified registered voter of the Kearney County School District Number 50-0503, a/k/a Minden Public Schools, to fill the vacancy created by Katie Sinsel's consecutive unexcused absences; said appointment is effective upon the passage of this resolution and shall commence upon administration of the oath of office, and shall continue for the remainder of the unexpired term.
