One School, One Book-

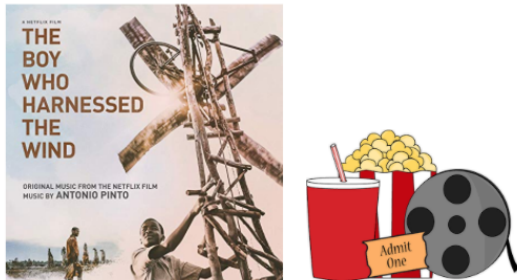

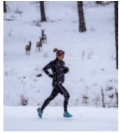

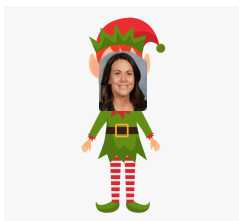

MHS is sailing through the first semester. It seems as though we get to Thanksgiving Break and blink - the semester is over. Student athletes are transitioning to winter sports and with the break in seasons, our fine arts programs and various clubs keep everyone busy. Our doors are always open if you would like to stop by and visit or just say hello.

FCCLA November Activities:

FCCLA took two members to a “Mind Bending” conference in November hosted by UNMC and Behavior Health Education Centers of Nebraska. This conference introduced students to career opportunities in counseling, mental and behavioral health as well as informed students of the risks associated with risky health choices.

Veteran’s Day Program:

FCCLA also hosted the annual Veteran’s Day Breakfast and we had the decorated commons full of veterans and spouses. It is an honor for our students to serve the brave men and women of our community. Following the breakfast the Student Council’s from both the high school and C.L. Jones organized a program to continue our celebration. Sandy Pohl, East Elementary and Minden Public Preschool Principal

Providing a strong foundation through early childhood education is a goal at the forefront of Minden Public Schools and especially those directly involved with Minden Public Preschool. Sara Anderson and Alyssa Schneider are currently in the process of being approved for “Getting Ready”. Getting Ready is a child- and parent-focused, strengths-based intervention aimed at enhancing the school readiness of young children. Sara and Alyssa will use the skills through Getting Ready in interactions with families which will support the curriculum of home. Support for Getting Ready reflects that children who have parents and teachers using these skills have increased social-emotional competencies, better self-regulation, and greater language and early literacy skills. Parents communicated with through Getting Ready have a greater degree of warmth and sensitivity, support for their child’s learning, and appropriate guidance and directives for their child.

Alyssa Schneider offers speech screenings to all preschool children whose parents give permission to assess. By doing this, concerns in speech are addressed earlier in an effort to correct at a younger age. Twenty-five percent of preschool children currently receive speech services. Following the screenings, thirty-five percent of children assessed were recommended for a re-screen in three to six months and five percent of children were strongly recommended for a full speech evaluation.

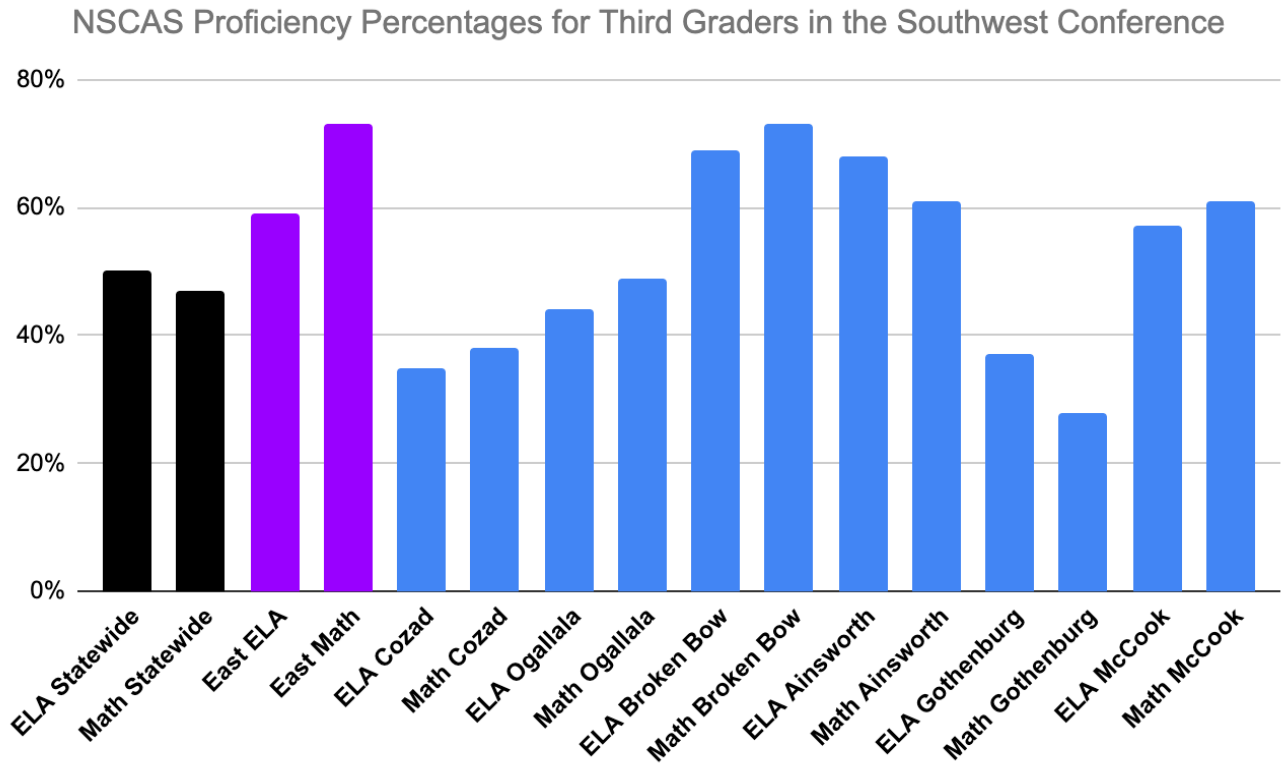
The second and third grade musical was held on December 9th at the Minden High School auditorium. The performance, under Mrs. Rowley’s direction, is always a must-see annual event.
