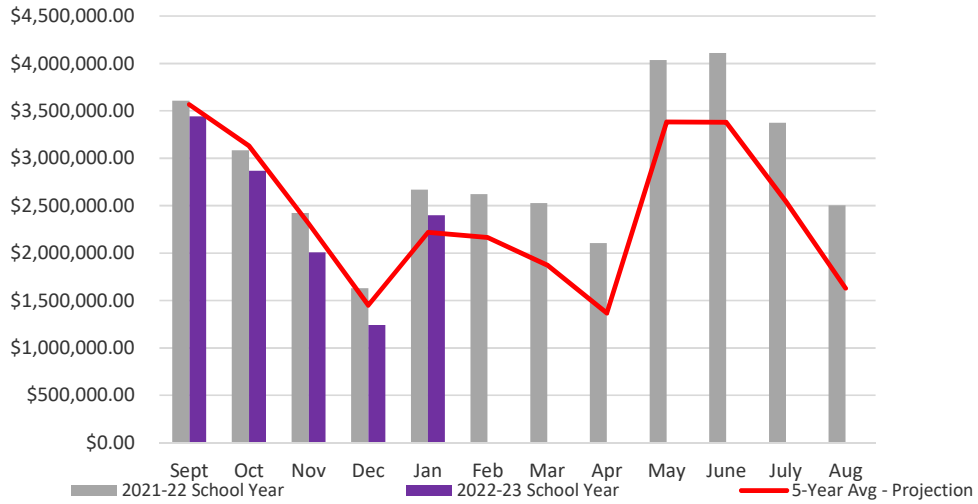

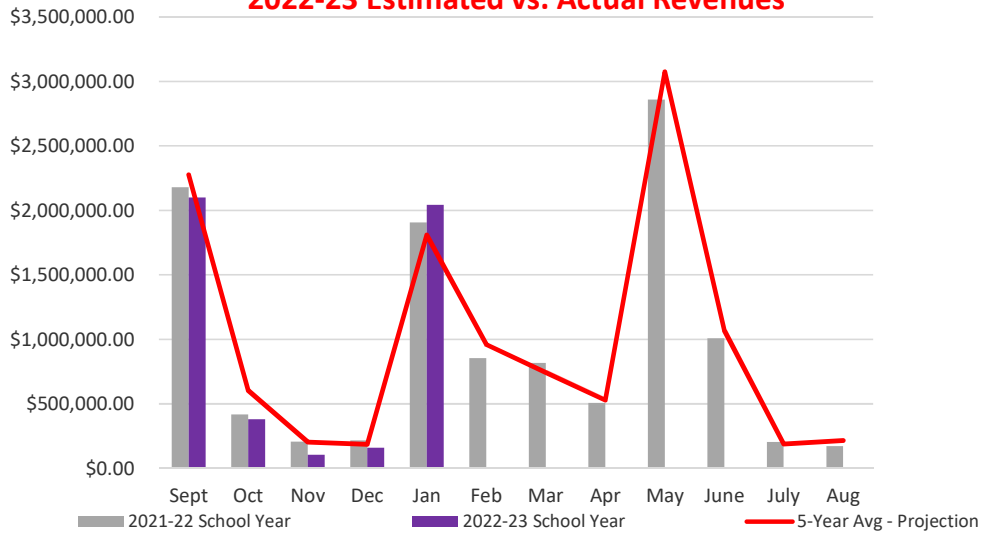

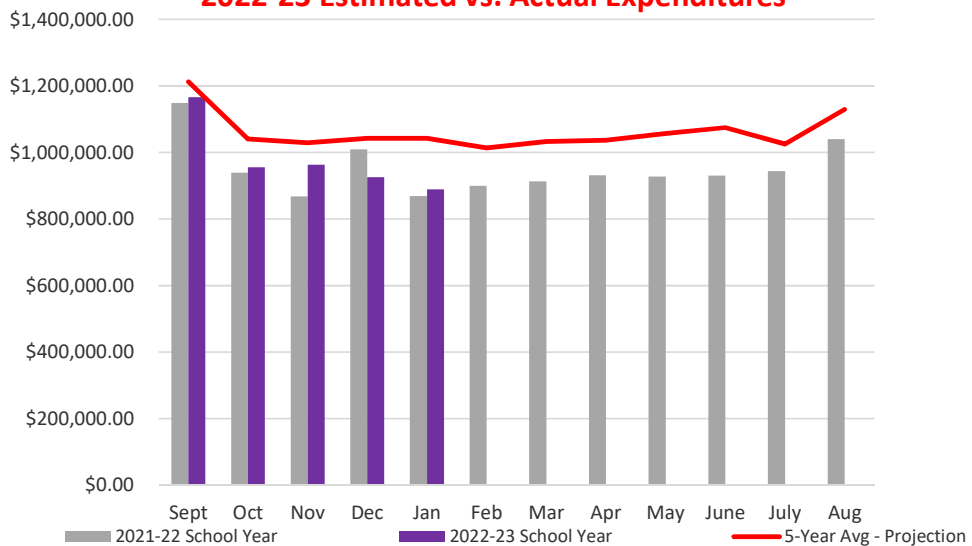
2022-23 Estimated vs. Actual General Fund Balance

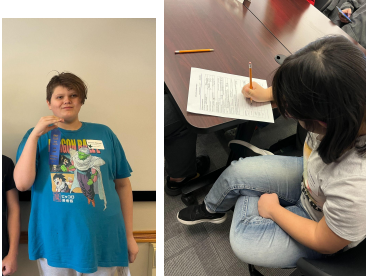

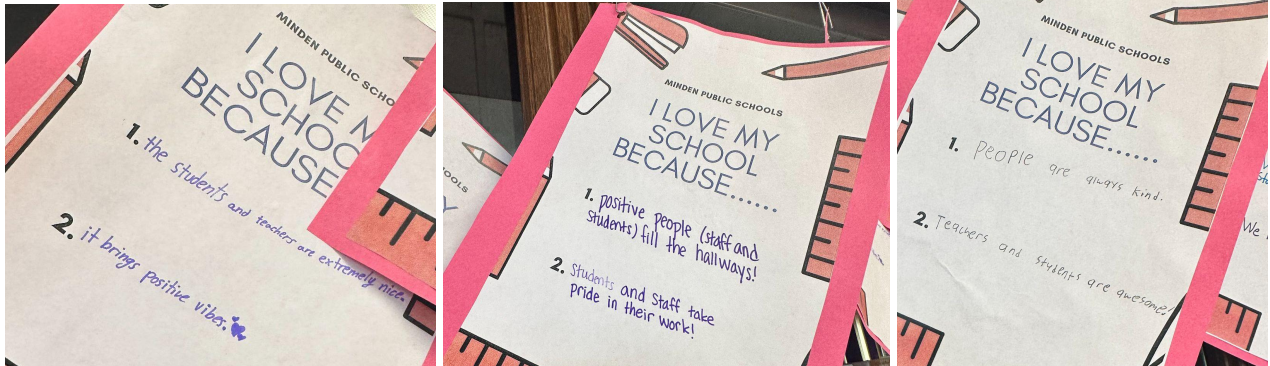
ESU 11 Transition Quiz Bowl-

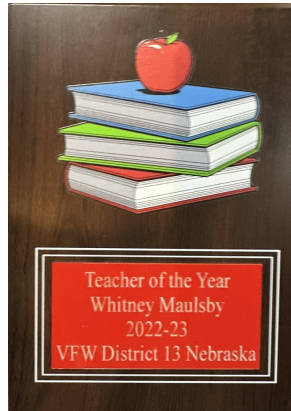

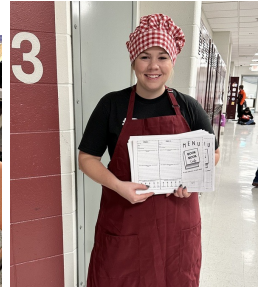
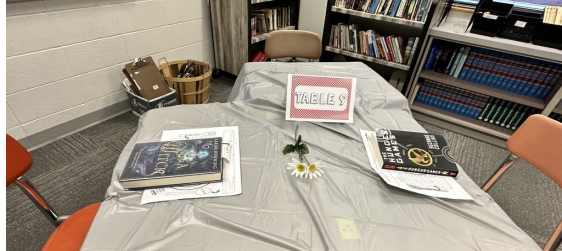

Speech Report from Mr. Horner:

The speech team is 37 members strong and has been competing at invitational meets starting on January 7. The team competes at eight invites through the months of January and February. After the first four meets, the team has brought home 75 medals. One exciting aspect of this season is the creation of a new event. Speech has included nine total NSAA events since the beginning of speech team competitions in the 1970s. This year, a new event called Program of Oral Interpretation was started. This event is part of a national competition and has trickled down to Nebraska speech. In addition to this event, speech includes humorous prose, serious prose, oral interpretation of drama, oral interpretation of poetry, duet acting, informative speaking, persuasive speaking, extemporaneous speaking, and entertainment speaking. The team schedule includes the Adams Central Invitational, Central Nebraska Forensics League Tournament #1, Broken Bow Invite, Central Nebraska Forensics League Tournament #2, Aurora Invitational, Minden Invitational, Loup City Invitation, and Holdrege Invitational. We then will move on to the Southwest Conference meet in Cozad, the district B-5 meet in Broken Bow, and finally the state meet at Kearney High. Speech is coached by Jeffrey Horner, Taylor Majerus, and Jeremiah Holmes.

Seniors (some starting/some already done) complete their scholarships, commit to colleges, and experience some monumental "lasts". Underclassmen go through testing and choosing classes for next year. EARLY ENTRY COLLEGE CLASSES

Minden High School juniors and seniors have access to college courses that can be taken during high school. This is the list of all the classes Minden High School students either took last fall or are currently taking this spring from Central Community College with the number of students taking the class.

American History 1 (1), American History 2 (1), Cultural Geography (1), Developmental Psychology (1), English Composition 1 (3), Intermediate Algebra (1), Intro to Music (1), Intro to Psychology (9), Intro to Sociology (3), Math for Elementary Teachers (1), Nursing Assistant (1), Public Speaking (15), Structure and Function of the Human Body (1), and Western Civilization to 1700 (1).

Mr. Egenberger's Science Classes

Earth Science (9th) & Earth Science (11th & 12th)

The goals of Earth Science is to have a better understanding of Earth's structure, properties, and processes, how those processes interact, and the role humans play on those structures, properties, and processes. This is the second year of transitioning 9th-grade students taking Earth Science rather than Physical Science. The transition was made in order to have exposure to Earth Science state standards. Students still experience the Physical Science standards in Chemistry, Physics, and eventually Physical Science. Next school year, we will offer a Physical Science course for 11th and 12th-grade students that don't want to take Chemistry or Physics. In the 2023-24 school year, freshmen will take Earth Science, sophomores will take Biology, and then the students will have the option to take Advanced Biology, Physical Science, Chemistry, or Physics as their 3rd required year of science credits.

For Earth Science (9th), Mrs. Soelberg and I each teach a semester of the curriculum. I focus on the history of the earth, Earth's atmosphere, weather, climate, Earth's role in our solar system, and other phenomena in space.



Right now, my crew of freshmen are learning the layers of Earth's atmosphere and the characteristics unique for each layer. For a good portion of the 4th quarter, we will talk about Earth's position in our solar system and space. Space usually is a fun unit for the 9th graders, because they are so curious about what is out there. I implement multiple research projects throughout the semester to try and make portions of the class inquiry-based. To end the semester, Mrs. Soelberg and I collaborate on a final research project on the positive or negative impact humans have on any of Earth's systems. We carried this project out last school year and I thought it worked well. Mrs. Soelberg and I also had the 9th grade class attend Science Field Day in Holdrege for the second year in a row. This is a great opportunity for students to see career opportunities that include various topics discussed in all disciplines of science. The University creates stations for students to explore topics that include agriculture, entomology, botany, meat science, and more.


