Changing the schedule would greatly harm our family's schedule. We both have to work daily and can't take a child with us. Grandparents are still working or too far away to watch a child on a continual basis. We trust very few people to watch our children so we would not be able to hand them off to just anybody. Daycares are extremely limited here, fill up fast, and do not take part-time kids.

**How would changes to the calendar make it more difficult for you to arrange childcare outside of school hours.**

Again, since both parents work full-time jobs, we would not be able to take off multiple days every single week to watch our child. We also don't have family around to watch. Daycare where our younger kid goes has already made it clear that they can't accept part-time kids. If SEM made this change, we would have to pull our child out and put them in a different full-time preschool.

I hope this letter finds you well. I am writing to express my strong support for maintaining a full-time, five-day-a-week schedule for preschool in our district. As a parent of a child currently enrolled in the program, I have seen firsthand the positive impact that consistent, full-time preschool education has on young learners.

Preschool is a critical time for early childhood development, where children build foundational skills in literacy, numeracy, socialization, and emotional regulation. A five-day schedule offers the structure and consistency that young children need to thrive. Consistent attendance not only helps children develop a sense of security but also maximizes their opportunity for learning and growth. However, I strongly believe that investing in early childhood education is one of the most effective ways to ensure the long-term success of our students. Additionally, administrators can pair a Verkada camera with any sensor, providing a layer of visual evidence to see exactly what happened. For locations, such as bathrooms, cameras can be placed outside these private areas, giving administrators a non-invasive way to monitor these incidents.
