A Annual Meeting of District Electors was held on September 16, 2025, at 7:00 PM in the Indian Trail High School & Academy Auditorium, 6800 60th St., Kenosha, WI 53144.

**I. Call Meeting to Order and Statement by School Board President**

The meeting was called to order at 8:25 p.m. by the School Board President, Mary Modder.

**II. Election of Chairperson for the Annual Meeting**

Carl Bryan nominated Mary Modder for Chairperson. There were no other nominations. The nomination carried.

**III. Adoption of Rules of Order and the Agenda**
