Administrative Rule 383.2
Dogs on Campus
4/19/2023

Allowing dogs, and other animals, in school facilities or on school grounds property is strictly regulated, to ensure the health, safety, and positive experience of those attending and participating in activities.

Outdoor Campus:

The District shall post signage at locations on campus indicating where animals are not allowed, and under what circumstances.

The District administration reserves the right to require an animal to be removed from District grounds and/or facilities if it becomes a health and safety concern and/or displays disruptive behavior.

In any instance when a domesticated pet is permitted on school grounds or in facilities, it must strictly adhere to the following conditions:

- The pet must be under the control of an adult at all times and wear clearly labeled tags indicating current vaccination and ownership.
- The pet must be on a leash no longer than 6 feet in length, controlled by an adult.
- Pet owners must immediately remove waste and dispose of it in a sealed, non-absorbent, leak-proof container.

Animals are not allowed on the school campus during the school day, as the priority use of the space is for students and their activities.

Athletic Events:

Dogs are not allowed in fenced-in athletic areas, such as the football stadium, baseball and softball fields, track, tennis courts, or soccer fields.

To ensure the safety of the spectators and athletes and to minimize distraction or disruption, dogs are not allowed on school grounds during a school event, game, activity, or practice.

Inside Facilities:

Advance notice and authorization must be granted by the superintendent or designee to permit animals (domestic pet) within a school facility, in accordance with Board Policy 383 – Animals in School.

Service Animal Exception:

Service dogs, as well as other service animals, may be allowed on campus if all criteria are met in Administrative Rule 383.1 – Service Animals. An emotional support or companionship animal is not a service animal and is not allowed.

Law Enforcement Exemption:

Dogs trained and certified to accompany and assist police and other state and federal agencies shall be exempt from the terms of this policy.

Board Policy 723.6

Inclement Weather - Outside Activities

Last Revised 5/11/2023

The Board of Education recognizes that weather conditions change each day which affects student recesses, lunch periods, and other times where children may be scheduled for outside activities.

Therefore, the building principal in charge is responsible for determining if weather conditions are such that prevent students benefiting mentally, physically, or socially from participation in scheduled outside activities under the following guidelines.

Elementary

- A. Guidelines for Early Childhood through 5th grade that prevent outside activities shall be:
1. Actual temperature and/or wind chill of ~~-10~~ 0F degrees. Temperature and wind chill may be determined by one of two methods:
 - a. Temperature and wind chill as calculated by the District weather station, if one is in operation for instructional or administrative purposes.
 - b. Wind chill as reported by the Weather Channel or the National Weather Service (NWS).
 2. Based upon the judgment of the building principal, students may be prevented from these outside activities when weather conditions are less severe than stated in A. 1. above.

Middle and High School

- B. Guidelines are reasonable judgment by the building principal in charge by considering the activity schedule and age of students.

Outside recesses and activities may also be limited by National Weather Service (NWS) Alerts, including Heat Advisories and various Watches.

The District Administrator has the authority to not allow outside activities based upon weather or other reasons.
