BACKGROUND: Austin Public Schools has partnered with the City of Austin and Mower County to offer 5 year tax abatements for new construction of single and multi-family homes to provide incentives to encourage the construction of new owner occupied and rental residential housing units, and to encourage replacement of dilapidated housing structures within Mower County. The term of this agreement runs December 31, 2022 through December 31, 2025. Qualifications are detailed in School Board policy 724 – Tax Abatement Policy.

RATIONALE:

Available housing is important when trying to grow a community and their public schools. Offering this 5 year tax abatement on new construction not only encourages the construction of new homes but when residents move into the newly constructed homes/rentals, they are quite possibly making another home/rental available for a potential resident.

RECOMMENDATION:

I recommend the approval of the six tax abatement applications.

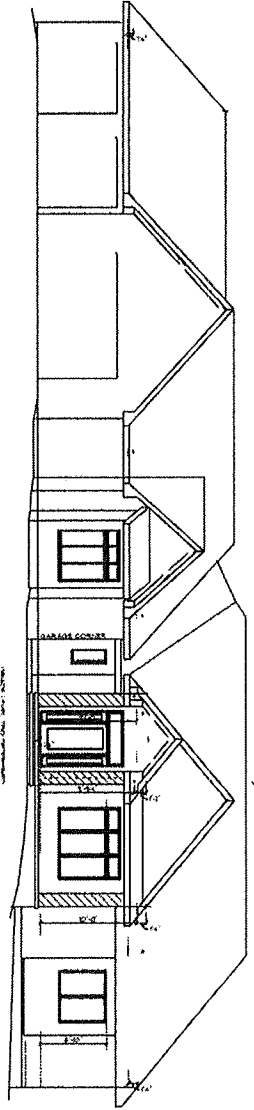

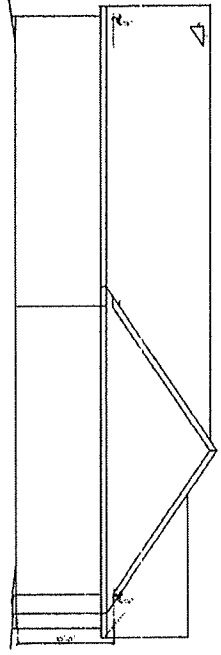

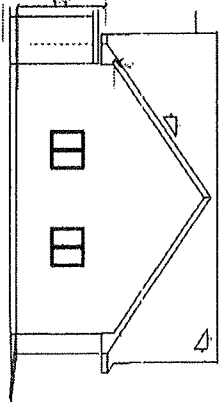

BACKGROUND: Austin Public Schools has over 50 enrolled American Indian students by the state ethnicity definition. Districts with ten or more enrolled American Indian students must have an advisory committee made up of predominantly Native American parents, who are required to complete the annual concurrence process. As part of this process, the district's Native American Parent Advisory Committee (NAPAC) provided feedback to the school board about how the academic and cultural needs of Native American students can better be met. The board must reply to the committee in writing within 60 days.

RATIONALE: Increased communication and collaboration between multicultural parents and the district improves educational outcomes for students.

RECOMMENDATION: It is recommended the School Board approve the proposed written response to the NAPAC's feedback to the board.

Overview:

Austin Public Schools was presented with a letter of non-concurrence on February 26, 2024, by Ms. Amanda Schramm, Chair of the Native American Parent Advisory Committee (NAPAC) and Austin Public Schools Native American Success Coach. Ms. Schramm, representing the NAPAC, outlined three areas of concern. The district takes these concerns seriously and has outlined a plan of action below to address the concerns brought forward. We hope to work closely with NAPAC to better meet the needs of our students and families.

Areas of Concern and Response:

1) CURRICULUM

Summarized from the letter of non-concurrence, the committee would like all students to learn from a balanced, truthful curriculum using a variety of resources and perspectives that is inclusive of Native American perspectives, history, and role models.

The Teaching and Learning Office has been working with departments and grade levels to review and implement the new Minnesota standards as they are adopted. These standards include the contributions and perspectives of American Indians. Alongside the implementation of new standards, we also adopted a curriculum. When adopting a curriculum, we may choose a specific curriculum to serve as the foundation of the learning but recognize that supplemental materials may also need to be adopted to meet the standard expectations. The Teaching and Learning Office works with departments and grade levels to provide access to materials that will represent diverse perspectives, including American Indian perspectives. Various resources are available through content organizations, the Minnesota Historical Society, the Minnesota Department of Education, and other organizations. The Offices of Teaching and Learning and Equity and Integration are working to identify resources aligned to standards and content that reflect various perspectives. This will be an ongoing endeavor. The Teaching and Learning Office would happily partner with NAPAC to help support these efforts. In collaboration with the NAPAC, the Equity and Integration Office has purchased literature showcasing Native American characters and perspectives. These texts are available now, and we are working on a system to share these resources with our teachers. We have recently hired a new district media specialist and will work with them to ensure that American Indian perspectives are represented in media center collections.

Teachers and staff in the district are continually learning. Professional development can help us all learn more about the communities we serve. Recently, some staff from APS attended a professional development opportunity to learn how to include American Indian contributions and perspectives into their curriculum. The Shakopee Mdewakanton Sioux Community presented the professional development. As professional learning opportunities become available, we will share them with staff so we can continue our learning.

We invite members of NAPAC to attend district meetings such as the World's Best Workforce, where they can further participate and share their perspectives on district initiatives and how they may impact the American Indian community. This is an opportunity to partner and share ideas.

2) CULTURAL IDENTITY

From the letter of non-concurrence, the committee wants to ensure that children are proud of their culture and identity without stereotypes, microaggressions, and insults from other school community members.

APS strategic priority number 1 is to ensure a safe and welcoming learning environment. We want all students to feel physically and emotionally safe attending school. The school board has established policies around harassment and behavior that support a safe learning environment. If at any time a student or family has an experience that makes them feel unsafe, we want to know so that it can be addressed. Please contact your child's principal or district office to report a concern. There is also an opportunity to report a concern on the district website. All concerns will be taken seriously and addressed. Cultural competence training is a licensure requirement for all licensed staff in our district and must be completed every five years. This training helps staff learn about the diverse experiences of our students and families and how to support them in the educational environment. Professional learning opportunities are provided to staff throughout the year, focusing on a welcoming and supportive environment.

Additionally, to help support students and families, an American Indian Success Coach has been added to the equity team. This role is important for our district as it provides a cultural liaison to connect with families and support them and their connections with the school district. This role will also help provide feedback to the district on how we can support American Indian students and families.

3) CURRENT ISSUES IMPACTING AMERICAN INDIANS

Summarized from the letter of non-concurrence, the committee wants members of the school community to be aware of current issues impacting Native Americans, such as MMIW, boarding and residential schools, food security, the local movie Killers of the Flower Moon, and environmental stewardship and water protection.

To create an open dialogue about current issues important to our American Indian families, the Teaching and Learning team members will attend NAPAC meetings. These meetings will also provide an opportunity for open dialog about curriculum implementation and resources being used in the classroom.

It is important to think about the impact that some issues have on our American Indian families. Through open dialogue, we can continue to learn and provide meaningful professional development for our staff through cultural competency training and other professional development opportunities. Through these professional development opportunities, we hope to develop an informed staff that can meet the needs of our learners and families.

Conclusion:

We appreciate the contributions of the Native American Parent Advisory Committee. Your partnership is essential as we work together to create an educational environment that honors all students' diverse perspectives and experiences. We are committed to fostering open communication and collaboration and look forward to our continued work together.

TITLE: Academics and Administrative Services

TYPE: Information

PRESENTER(S): Katie Baskin, Executive Director of Academics and Administrative Services

BACKGROUND:

The Office of Teaching and Learning oversees curriculum, instruction, staff development, and Federal Title programs for the district.

The Human Resources Office is responsible for employee recruitment and orientation, contract negotiations for all bargaining units, employee relations, student and employee data practices, and staffing with building/program administrators.

Support and resources to ensure a safe and welcoming learning environment

- **Principal Professional Development:** Principal professional development in May will support three main themes: Leadership of PLC's, Literacy professional learning for administrators and leadership for principals in 24-25, and continued development of a professional development plan for teacher evaluation. Principals and Instructional Coaches will continue their collaboration in learning how to lead PLC's and support PLC development with colleagues in leadership from Owatonna Public Schools.
- **Teacher Mentorship:** T&L has held April meetings with year 1, 2, and 3 teachers. Our Year 1 teachers continued learning about the SIOP looking at comprehensible input and 10 strategies to help make learning clear. Year 2 teachers continued learning about differentiate instruction. This month the focus was on differentiating by using learning preferences and student choice, using choice boards, tic tac toe, and RAFTS. Our year 3 teachers continue learning about thinking routines specifically looking at the use of thinking maps. All groups met together for the May meeting where we reflected on the year, celebrating successes and feedback was gathered to ensure that we are meeting the needs of our new teachers.
- **Human Resources:** HR staff are working with building principals and hiring managers to plan and staff the organization for the 24-25 school. This includes analyzing student enrollment and student academic measures.

Packer Profile for all learners

- **Grow Your Own:** The Grow Your Own Future Teacher Club has been busy with different activities. Many of the students are signing up to help as volunteers with the elementary summer school. This time will give them experience working with students and teachers in a classroom. The time they spend helping will allow them to earn volunteer hours. Join us on May 21 where will be celebrating our seniors who are planning for a future career in education.
- **Packer Profile Task Force:** The most recent task force meeting resulted in great planning and alignment conversations through the PK-12 system. The group worked to develop a scope and sequence for collaboration, feedback and communication with our community stakeholders. This includes a quarterly PK-12 Task Force, student focus groups, a community Packer Profile Advisory Committee, and multiple community presentations to ensure our team is able to continue design work that is in fact meeting the needs and desires of our stakeholders.

District-wide multi-tiered systems of support for all learners

- **MTSS Implementation:** The district team is working to align academic and behavior supports for students and staff across the system. They are working with instructional coaches, behavior interventionists and student support professionals to align the decision rules and programming to clarify the gaps and successes within the system.
- **READ Act:** The Local Literacy Plan report is due June 15. This is revised requirement from MDE to include legislative mandates regarding the READ Act. This report will articulate our screening, professional development, and instructional approach for literacy work.
- **Gifted and Talented Programming:** Austin Public Schools is proud to announce the winners of the Minnesota Institute for Talented Youth scholarships to attend the Expand Your Mind Camp this summer. Annabelle Kasel, 8th grader at Ellis Middle School and Landen Andersen, 8th grader at Ellis Middle School, will represent Austin Public Schools. These two students will choose a two-week class they are interested in attending at Macalester College. These scholarships are offered through a partnership between Austin Public Schools and The Hormel Foundation. Congratulations to Annabelle Kasel and Landen Andersen!
- **EL Department:** The EL Program Review is complete and the finalized report will be shared in late May along with recommendations to support staff, students and families. Summer school for newcomer students is in the process of development to best meet the emerging needs in math and literacy. The goal is to ensure ongoing language support throughout the summer to help students gain the skills to support transition next school year.

Excellence in Resource Management

- **Teaching and Learning:** Science teachers K-5 and 9-12 have narrowed their curriculum selections and are working to gather quotes and make final decisions.

TITLE: Information Services

TYPE: Information

PRESENTER(S): Corey Haugen, Director of Information Services

BACKGROUND:

The mission of the Information Services department is to support the district mission and strategic priorities by building capacity through research, evaluation and the application of data to inform school improvement for student success. We provide support and expertise to schools and staff through:

- Providing expertise in the area of measurement and delivering accurate and timely information to building and district staff
- Providing support to district and schools through a systematic evaluation process of district programs
- Reviewing and summarizing data related to student learning and instruction
- Providing professional development on assessment practices, data analysis and interpretation

Support and resources to ensure a safe and welcoming learning environment

- Information services is working with all K-12 sites on building out 24-25 rosters and schedules. Here is a brief summary of the process for KG-06 class rostering.
 - **Teacher input is obtained** – teachers provide student feedback through a documentation process that provides targeted notes on students. These teacher inputs include student constraints, students that work well together and students that should be rostered together for specialized services.
 - Information Services takes all the **teacher feedback** and loads it into a **data structure** including data points from the following domains:
 - ✓ Demographic Information
 - ✓ S1 Life Skills Grades
 - ✓ S1 Reading Grades
 - ✓ S1 Math Grades
 - ✓ Attendance Data
 - ✓ Behavior Data, Both Infinite Campus/SWIS
 - ✓ Assessment Data: STAR CAT & CBM's, ACCESS, CogAT
 - Overall – there are **90+ variables** that go into the **algorithm** for balancing rosters.
 - Information Services builds out **balanced classroom rosters** and then site leaders review the rosters with staff to gather **additional feedback and updates**. This is an **iterative process** and will go back and forth until we get the approval from all staff at the site.
 - Once stakeholders have approved the rosters, we load the students into the Infinite Campus Student Information System for 24-25 access.

Packer Profile for all learners

- Information Services has been actively working with all our sites to make sure we are prepared for Schedule and Rosters due to K-4 realignment and new course offerings at the 5-12 levels. We **audit and maintain all courses taught throughout the district** and report student-level grade detail to MDE annually through the MN Common Course Catalog (MCCC) reporting requirements.
- Information Services is working this spring/summer to onboard a new college and career readiness platform called **Schoolinks**. SchoolLinks is a complete set of tools for college and career readiness to enable districts to improve student performance and empower educators. We are excited to employ Schoolinks as part of our Packer Profile work. You can learn more about Schoolinks here: <https://www.schoolinks.com/>

District-wide multi-tiered systems of support for all learners

- **MN STATEWIDE ASSESSMENTS (MCA/MTAS) 2023-2024**
 - Teachers and students throughout the district have been working hard throughout the month of April and early May to complete statewide accountability assessments. **Final results from this spring 2024 administration will be available later this summer.** I can however, tell you that as of May 3, 2024 we have completed in total 2,477 MCA-III Mathematics assessments, 2,582 MCA-III Reading assessments, plus, 79 MTAS Assessments. All told, 5,138 Math and Reading assessments have been completed through May 3. Science testing is scheduled to conclude on May 10. Testing has been going very smooth this year, both from a technical and administrative perspective and we are currently beginning to review embargoed preliminary results. I would like to thank all the district students, staff and administration for their attention to detail and hard work through another statewide testing season.
 - **STAR Benchmarking Window** opened April 29 and will continue through May 17. This end-of-year assessment period is used to determine year-long growth metrics and help teachers and students see the impacts of their teacher and learning throughout the whole year. We are excited to see positive results later in May when final results are available after May 17.

Excellence in Resource Management

- The Consolidated Appropriations Act, 2023 authorized a permanent, nationwide **Summer Electronic Benefit Transfer (S-EBT)** program for eligible families beginning in 2024. The state of Minnesota, in a joint effort between the Minnesota Department of Education (MDE), the Minnesota Department of Human Services (DHS) and Minnesota IT Services (MNIT) is pleased to announce plans to implement this new federal Summer EBT program in summer 2024. **The Summer EBT program provides families with school-aged children eligible for free or reduced-price school meals \$40/month per child (\$120 total) during the summer months to purchase healthy foods with funds placed on EBT cards.**
 - On 05/07/2024, Information Services loaded 3,608 individual students into the S-EBT portal for access to the S-EBT program. Families will have S-EBT benefit cards mailed directly to their home to support nutrition during the summer.

TITLE: Special Services Department Update

BACKGROUND:

The Special Services Department includes oversight of the following:

- Special Education Services
- School Health Services
- Student Support Professionals (School Counselors, School Social Workers, School Psychologists)
- Mental Health Supervision and Supports (internal and external)
- Oversight of education at Nexus Gerard's New Dominion School
- Oversight of education at the Austin Albert Lea Area Special Education Cooperative (AALASEC)

Support and resources to ensure a safe and welcoming learning environment

- We are remaining fairly steady with 9 unfilled special education paraprofessional positions currently, although we do have several resignations which take effect at the end of the school year, which will boost our number of openings.
- Our Special Education Advisory Council (SEAC) met on May 7. This month's topic of study was Coteaching. In an effort to provide more inclusive programming opportunities for students with disabilities, we are working to provide more coteaching and push in programming options for students next school year.
- At their April 8 meeting, our Student Support Professionals (School Counselors, School Social Workers, School Psychologists) discussed updates from the Assessing Risk and Safety Plan Subgroup, as well as reviewing LGBTQ practices.
- County Collaborative/Gerard Mental Health Initiative: 247 referrals processed so far this school year as of 5/6/24.

Packer Profile for all learners

- Our Austin Transition Program students will be participating in a team building day at Ironwood Springs on May 15.

District-wide multi-tiered systems of support for all learners

- Most of our Cohort 1 elementary SPED staff in LETRS training have completed their coursework and are fully certified; we are hoping the entire cohort will be complete in the next few days.
- Our District MTSS Team has been working on end-of-year processes for building-level teams to ensure information is retained for fall.

Excellence in Resource Management

- We have submitted our preliminary budget to the business office for FY25.
- We are working on our applications for state and federal special education funding for FY25.

- We have submitted our application for setting aside federal special education funds for payment of tuition bills, a strategy recommended by the special education finance specialist at MDE

TITLE: Technology Services

BACKGROUND:

Technology Services designs, implements, and supports the technology infrastructure and resources in this district. This includes: network and communications, hardware and software, and technology training and integration.

Technology Advisory Team

- At the May meeting, the team approved the final draft of the APS Technology Plan that will go before the School Board on May 13. This plan has been the culmination of hard work on the part of this Team and other district stakeholders. I'd like to specifically thank the following community partners for their hard work on this project: Shawn Martin, Riverland; Eric Christians and Julie Clinefelter, Austin Public Library; Jeff McDonald PhD, Hormel Institute; Marc Oleson, Austin Utilities; and Afi Adjouwi, APS Alumnus.

Support and resources to ensure a safe and welcoming learning environment

- **Key Card Access** – Our Facility and Technology Services Departments are collaborating on substantial updates to our infrastructure, enhancing the monitoring of secure door access through key cards and fobs. These upgrades will improve security by ensuring that only authorized individuals can access our sites. The new software is also equipped for future enhancements, including advanced door monitoring and detection capabilities powered by AI.
- **Elevator Modernization** – Elevator upgrades across the district are scheduled for December 2024. These improvements will include secure access via keycards and restrict elevator use to students only with them. Moreover, all elevators will have safety phones that remain operational during power or network outages.
- **Security Monitoring Stations** – By the end of 2024, every building will have at least one security workstation capable of viewing, reviewing, and storing footage from all on-site cameras. This system will support monitoring several cameras simultaneously, enhancing surveillance of multiple hallways and doorways.
- **Phone Voice over Internet Protocol (VoIP) System** – This July, we're completely overhauling the district's phone system, which involves replacing all desktop and classroom handsets and introducing several new features. These enhancements will

ensure compliance with the latest e911 legislation and include mobile and Microsoft Teams integrations to facilitate communication from any location.

- **Digital Signage** – We are upgrading digital signage across the district to ensure uniformity and multifunctionality. Each display will feature consistent district-wide messaging and content specific to each building. The new hardware will also support security alerts like our Standard Response Protocol and weather announcements.

Packer Profile for all learners

- Tech Services is working with the Teaching and Learning department to align resources for the new instructional coaching model. This involves supporting current and new instructional coaches with the tools they need to support teachers in using technology tools to support daily curriculum and learning.
- We have been working with AHS, the Packer Profile Coordinator, and Info Services on exploring and selecting software to support students in their Packer Profile work 9-12. After much research, the team has selected School Links as a platform that can be used for students during their high school years but also after they graduate.

District-wide MTSS for all learners

- Banfield, Neveln, Southgate, and Sumner became Common Sense Schools this year – this honor is given to schools who have supported students and parents in how to be safe and responsible online. Next year, this work will continue and expand to include all of K-12. As APS continues to support this learning, we hope to become a Common Sense District by the end of 2024-2025. What is the Common Sense Recognition Program?
 - *The Common Sense Recognition Program provides a road map to implement digital citizenship and create a positive culture of digital learning and life. Using Common Sense's free resources and following three steps - professional development, teaching lessons, and engaging families—this program will help lead responsible and effective tech use in your school communities and build your practice along the way.*

Excellence in Resource Management

- Work is well underway in our office to prepare devices for the 24-25 school year. There are going to be significant changes in how we manage staff laptops, so Tech Services is collecting all staff laptops at the end of the school year – which is a departure from past practice. This will allow us to ensure that inventory and replacement cycles are accurate and more closely monitored, plus it will allow us to transition to a different remote management software that is much more convenient and safer for users.
- As we transition to Grades 5-6 keeping their laptops at school, starting in the 24-25 school year, we are preparing charging carts for classroom storage. These will allow students to pick up their fully charged devices in the morning and return them for overnight charging in the afternoon. Our team is also crafting materials to share with families during the summer so that they are prepared for this change.

BACKGROUND:

The Finance Department includes payroll, employee benefits, accounts payable, accounts receivable, accounting and fixed asset management. The Executive Director of Finance and Operations also oversees Facility Services, Food & Nutrition Services and Transportation Services.

Support and resources to ensure a safe and welcoming learning environment

- StopFinder
 - Next year, we will add an all-in-one parent/caregiver engagement app to our transportation services.
 - With Stopfinder, a parent/giver will:
 - Know the schedule of their child's bus
 - Receive push notifications related to their child's bus schedule and any changes, such as bus number or driver changes
 - Get real-time information on the location of their child's bus by creating their own alert zones with the upgrade to GeoAlerts
 - Notice bus substitutions because they are clearly indicated – reducing misinformation and confusion
 - Track multiple buses, an excellent feature if their children don't ride the same bus.
 - Know exactly when their children arrive at school or home
 - Enjoy two-way communication with the transportation office
 - Provide parents and caregivers with multilingual options in the app
- The number one priority of our Austin Public Schools is to provide support and resources to ensure a safe and welcoming learning environment. We are implementing critical measures to enhance the safety of all our facilities. Here are some significant updates we will undertake in the upcoming months:

Member schools must develop and publicize administrative procedures to address eligibility suspensions related to Student Code of Responsibilities (Bylaw 206.2) violations for students participating in activity and athletic programs by member schools.

The above Resolution was adopted by the Governing Board or Entity of this school or district and is recorded in the official minutes of said Board and hereby is certified to the State Commissioner of Education as provided for by law.

The following is taken from the MSHSL Constitution:

208.00 LOCAL CONTROL

208.01 Designated School Representatives
At the beginning of the League's fiscal year, the governing board of each member school shall designate two (2) representatives who are authorized to vote for the member school at all district, region and section meetings and on mail ballots where member schools are called upon to vote.

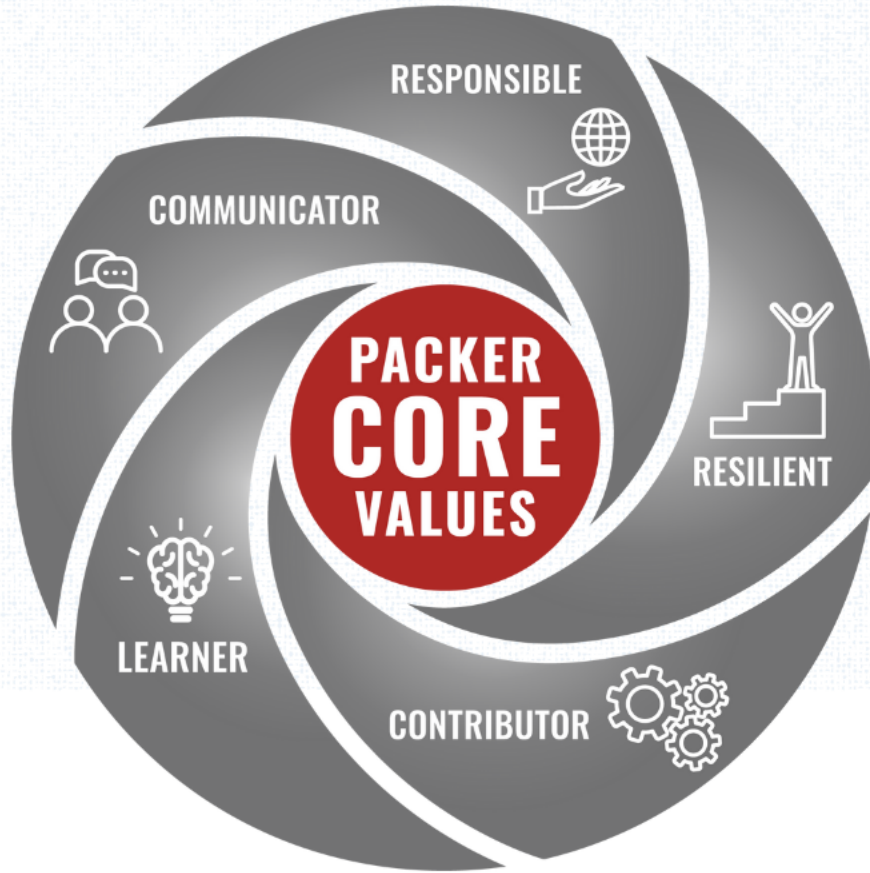

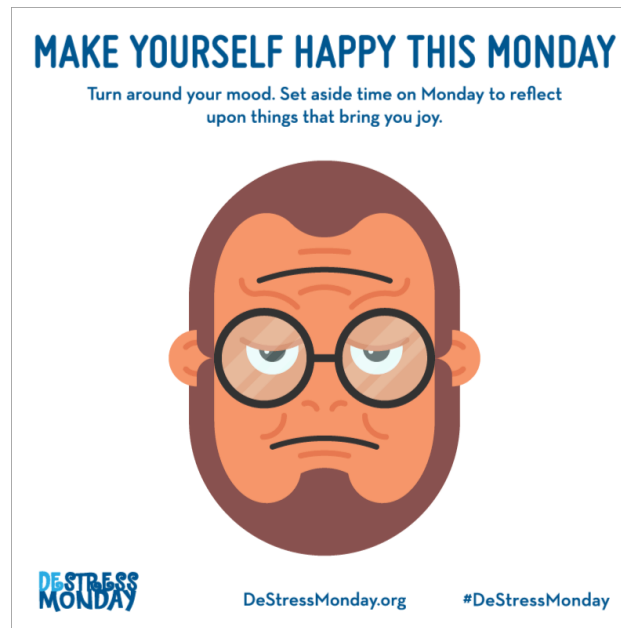

Once accepted, a gift shall be the property of the school district unless otherwise provided in the agreed upon terms.

BACKGROUND: Over the course of the last school year, the Technology Advisory Team and various district and community stakeholders have developed a 3-year Technology Plan that outlines objectives and goals that align with the district’s strategic priorities.

RATIONALE: APS uses technology to inspire, empower, and accelerate students to become lifelong learners and productive global citizens. It is important that the district provides equitable and secure access to technology that facilitates learning for all.

RECOMMENDATION: The school board received a draft of the Technology Plan at the regular board meeting on April 8 and completed a read-through and discussion at the work session on April 22. I recommend that this final draft of the APS Technology Plan be officially approved today.

3-Year APS Technology Plan – 2024-2027

District Mission: Inspire, Empower, and Accelerate

District Vision: Preparing all learners to make a difference in the world.

District Technology Vision Statement: APS uses technology to inspire, empower, and accelerate students to become lifelong learners and productive global citizens. Technology enhances learning, fosters inquiry-based and hands-on experiences, supports collaboration and communication, and prepares our students for future careers. We are committed to providing equitable and secure access to technology that facilitates learning for all.

Data Analysis

Bright Bytes Survey – The district conducted a Clarity CASE Framework survey in the spring of 2023 to identify areas of strength and need in classroom technology, technology access, technology skills, and environmental supports for technology. This survey provided a district wide score of 1081, which places us in the "proficient" category. However, as you can see from the chart below, we scored lower overall and in specific categories than we did in previous years.



CISA Survey and Review -- The district engaged the Cybersecurity and Infrastructure Security Agency (CISA) to conduct two reviews during the 22-23 school year: a Ransomware Readiness Survey and a Cyber Resiliency Review. These surveys revealed areas of preparedness and opportunities for improvement to prepare APS for future cyber events.

Facilities Survey – The Facilities Department of Austin Public Schools engaged ISG to conduct a study of APS facilities, part of which included an analysis of the physical technology and security structures.

Staff Input – Formal and informal conversations between staff and their tech coach or staff and the Director of Technology.

APS Desired Daily Experience

APS Priority: Support and resources to provide a safe and welcoming learning environment

Technology Objective: Develop and implement technology policies and practices that safeguard data, privacy, security, and accessibility.

Goal #1: By the fall of 2024, create a centralized technology documentation center accessible through the School District website. This should include the following resources/links.

- *The APS Technology Plan*
- *Acceptable Use Policy(ies)*
- *Digital Learning Ecosystem - description*
- *Student, Staff, and Parent/Family Support Documents and Links (password protected where necessary)*

Goal #2: Starting in the 24-25 school year, with a goal of full implementation by the end of 26-27, develop a district team that will oversee data governance:

- *Group policies and access controls*
- *Identity management*
- *Account data retention policies*
- *Standards for community partner and vendor technology access*

Goal #3: Using the CISA CRR results and the guidelines of the NIST framework, advance all CRR categories into Domain 1 by the end of the 2028 School year. This should include:

- *By summer 2025, use the NIST Security Framework 2.0 worksheet to assess current cybersecurity practices and establish clear long and short term goals for improvements.*
- *Under the guidance of local, state, and national cybersecurity experts, invest in appropriate tools to improve the district's cybersecurity posture – this may include but is not limited to: SIEM, SOC, EDR, and MDR resources.*
- *Continue to receive weekly MS-ISAC security alerts and participate in the monthly MI-ISAC member web meeting at least six times per year.*
- *Seek out and apply for federal, state, and local grants and programs that can support an improved cybersecurity posture – this includes but is not limited to yearly eRate.*
- *Starting in the fall of 2024, implement a data privacy analytic to assure student and staff privacy is monitored and reviewed regularly.*
- *Partner with District Security Team to conduct once yearly cybersecurity table exercises.*
- *Require once yearly Internet Safety training for all staff and share monthly Cybersecurity micro lessons in the staff newsletter.*
- *Provide technology skills and safety assessments for students at appropriate grade levels and transitions.*
- *In partnership with the Technology Advisory Team, District Leadership Team, and other district stake-holders, review and update the district's Acceptable Use Policy and student/staff filtering practices by the end of the 24-25 school year.*

Goal #4: Partner with APS Departments to ensure safe and welcoming practices with technology.

- *APS Facilities Department: Update crossover servers and technology by the end of the 25-26 school year.*
- *Activities, Facilities Depts: By the fall of 2025, select and implement an events/facilities reservation system that protects the privacy of organizations and events.*

- *Human Resources Dept: By the fall of 2024, ensure that accounts, keycard, and device assignments and collection are included in the staff on- and off-boarding processes.*
- *Cross-Departments: Deploy upgraded VOIP telephony system by the fall of 2024.*

APS Priority: District-wide multi-tiered systems of support (MTSS) for all learners

Technology Objective: Equip educators and families with the knowledge, skills, and learning resources needed to promote safe, effective, and responsible use of technology for all students.

Goal #1: In partnership with the Office of Teaching and Learning and Info Services, provide appropriate coaching and learning platforms for professional development – to be in place by the beginning of the 25-26 school year. The following components are desired:

- Establish clear roles and responsibilities for educational technology integration and support.
- Update the APS Essential Technologies Outcomes document to reflect current information and technology literacies. Prioritize the following:
 - Alignment with standards and curriculum
 - Sequenced according to child development and technology access
 - Components that support the district's core values
- Provide regular opportunities for technology-specific professional development that aligns with the District's Strategic Priorities, Enterprise Systems, Instructional Model, and Essential Technology Outcomes.
- Deploy a staff resource and learning platform that includes:
 - a variety of in-person, online, and self-paced options for learning
 - ability to easily track success and completion
 - Training and support for Artificial Intelligence (AI) literacy
- Appropriately leverage Microsoft 365 for file sharing, collaboration, and other productivity tasks.
- Determine methods for measuring the effectiveness of adopted software tools and incorporate those metrics into coaching and curriculum cycles.

Goal #2: Foster strong relationships and communication among school, family, and community regarding student technology behaviors and safety at school, at home, and in the community. Approaches should include:

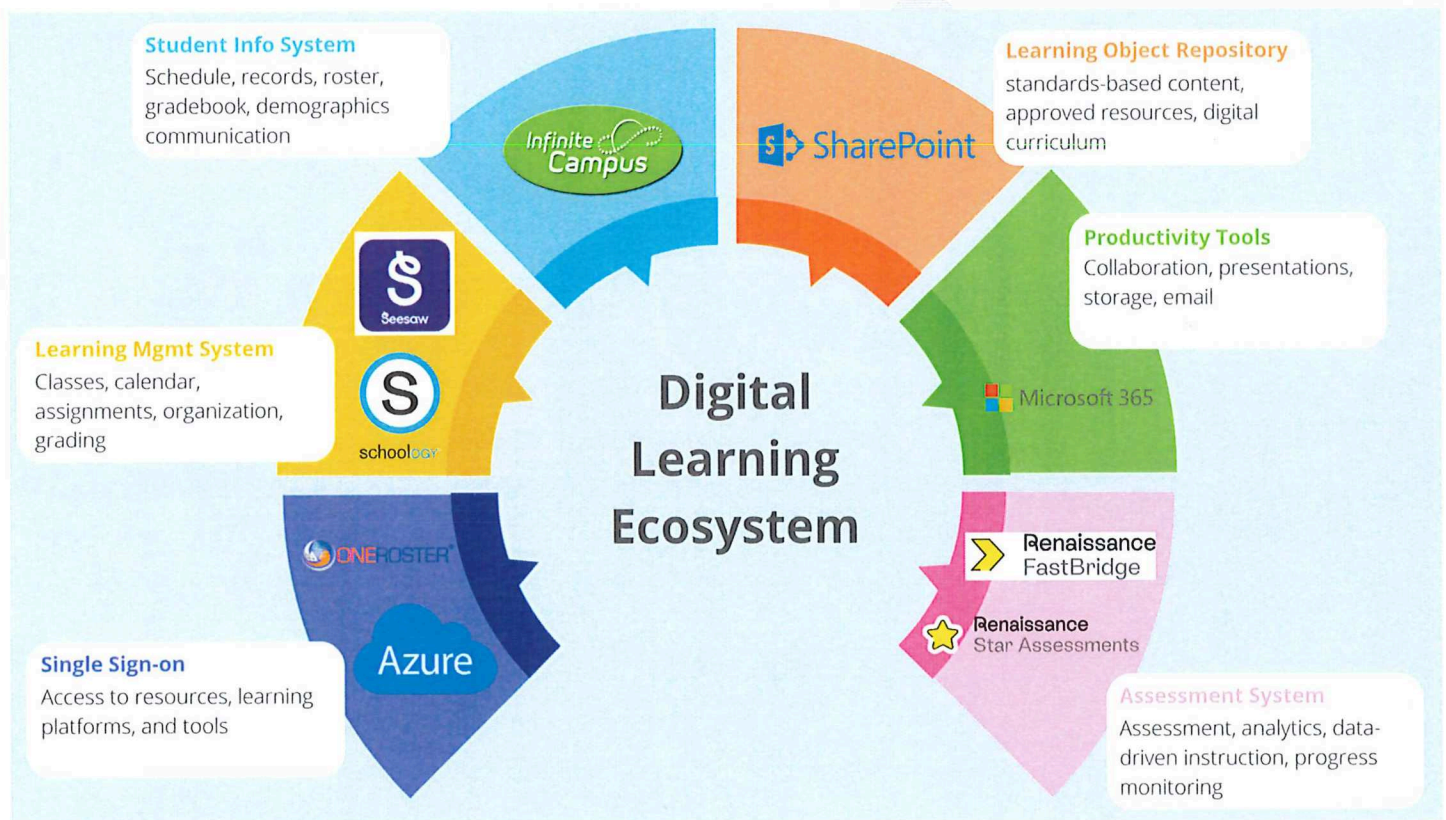
- Provide at least quarterly family technology-communication in the district's Austin Packer Bulletin.
- During registration and other appropriate checkpoints, provide families with technology-related information that supports school and home use.
- Engage with local partners/guest speakers to sponsor and promote safety events and information sessions related to internet safety at least once per year.
- Collaborate with District Leadership team to leverage technology tools to further focus community and family communication into fewer "touchpoints"; prioritizing language support for non-English speakers – to be in place by fall of 2025.

Goal #2: Ensure that all students have the technology skills and opportunities needed for their Pathway and Portfolio work for when the Packer Portfolio is fully implemented in the 26-27 school year.

- Determine evidence/artifacts required for support of Packer Portfolio K-12 and how current (or future) tech tools can help to gather and store these artifacts.
- Incorporate Essential Technology Outcomes into Packer Profile instruction.
- Grow use of technology that reflects real-world experiences and encourages career readiness.
 - Ensure equitable access to technology resources
 - Use technology tools for collaborating with partners in the community and beyond.
 - Assist with alignment of 5-12 computer science/technology-focused courses
 - Support technology-related extracurricular activities in K-12

APS Priority: Excellence in Resource Management

Technology Objective: Establish a cost-effective technology management strategy that prioritizes efficiency, maximizes ROI, and minimizes maintenance and support costs.

Goal# 1: Ensure that all technology assignments, cycles, and management practices enhance the goals of the district and make responsible use of district funding.

- *Develop standard technology device assignments and cycles for positions and locations, to be approved by fall 2024.*
- *By the fall of 2024, establish and communicate technology management and support practices to all sites.*
- *By the end of school year 24-25, outline and communicate how all hardware and software is selected, how often it is re-evaluated, and when it becomes end-of-life.*
 - *When possible, prioritize hardware and software tools that fulfill multiple needs in one tool.*
- *Adjust student technology devices and/or ratios to better align with the district's strategic priorities, to be fully in place no later than the 27-28 school year (See Appendix B).*

Goal #2 -- Maintain and improve practices that reduce district costs for support, maintenance, and repair of devices.

- *Regularly evaluate technology fees and fines for students and staff.*
 - *Develop, communicate, and follow through on procedures for staff and student laptop damage and fees – to be fully realized by fall 2025.*
 - *At the beginning of each school year, appropriately communicate all technology related fees and fines to staff and students/families.*
- *Starting in the fall of 2024, provide structured device care training for students and staff when they are issued their brand new take-home device.*
- *To be fully in place by the 26-27 school year, develop a "digital skills and responsibility" assessment that must be completed before students use devices at home.*
- *Continuously ensure that vendors for repairs and parts are competitive in pricing; give priority to local vendors when possible.*
- *Continue to be a licensed repair office for student laptops and, by fall 2025, transition from purchasing iPad warranties to instead find an iPad repair solution.*

TITLE: APS VOIP/Telephony Upgrade
TYPE: Action
PRESENTER: Director of Technology, Amy Thuesen

BACKGROUND: The current VOIP/telephony system used by the district is 10+ years old and is due to be replaced. During this year the Technology Department examined a variety of replacement solutions and selected Fortinet's Fortivoice services.

RATIONALE: The VOIP system is critical for communication within the district and between the district and members of the community. This VOIP upgrade will help improve district security, complying with new e-911 laws and allowing for more mobile communication.

RECOMMENDATION: The school board received a description of the VOIP upgrade proposal at the work session on April 22. I recommend that the upgrade of the district's telephony services officially be approved today.

APS VOIP TELEPHONY UPGRADE – Summer 2024 Proposal

APS Tech Services proposes partnering with [Fortinet Unified Secure Communications](#) to replace our 10+ year-old telephony system.

APS Priority: Support and resources to provide a safe and welcoming learning environment

Technology Objective: Develop and implement technology policies and practices that safeguard data, privacy, security, and accessibility.

Goal #4: Partner with APS Departments to ensure safe and welcoming practices with technology.

APS Priority: Excellence in Resource Management

Technology Objective: Establish a cost-effective technology management strategy that prioritizes efficiency, maximizes ROI, and minimizes maintenance and support costs.

Goal# 1: Ensure that all technology assignments and cycles enhance the goals of the district and make responsible use of district funding.

Why? The on-premises Cisco phone controller is end-of-life and replacement costs have moved to a yearly subscription model for Cisco licensing. Additionally, there are new laws for 911 services that we need to comply with. In exploring a replacement pricing from various vendors, Fortinet provided the most competitive pricing and feature set.

- eFax (will allow us to consolidate services)
- Voicemail to email transcription
- Final sunseting of plain-old-telephone-service (POTS) lines

Year One Costs:

Equipment = \$118,350

Installation = \$29,700

Every three years after:

Licensing renews every three years - approximately \$32,000-\$35,000 depending on their pricing fluctuations.
