Student:Counselor Ratios

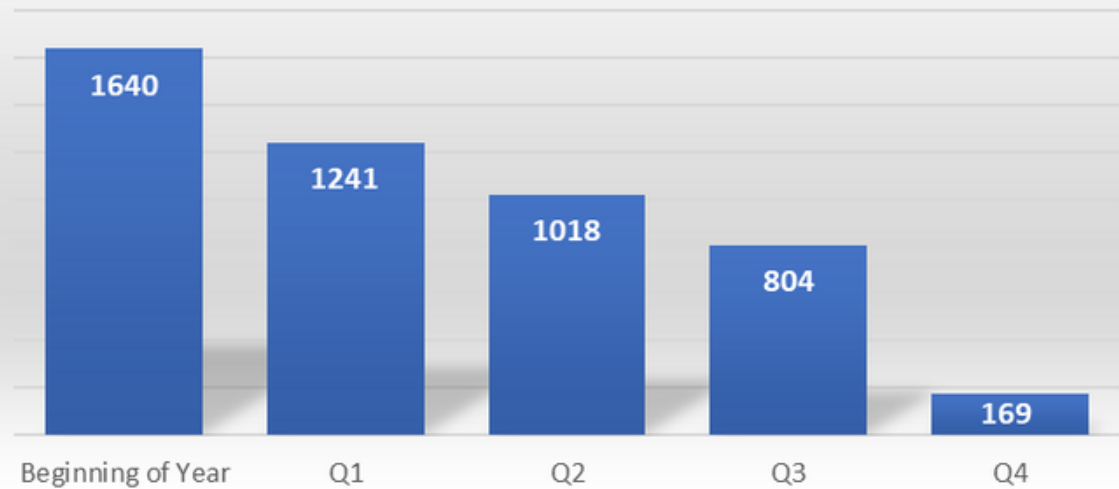

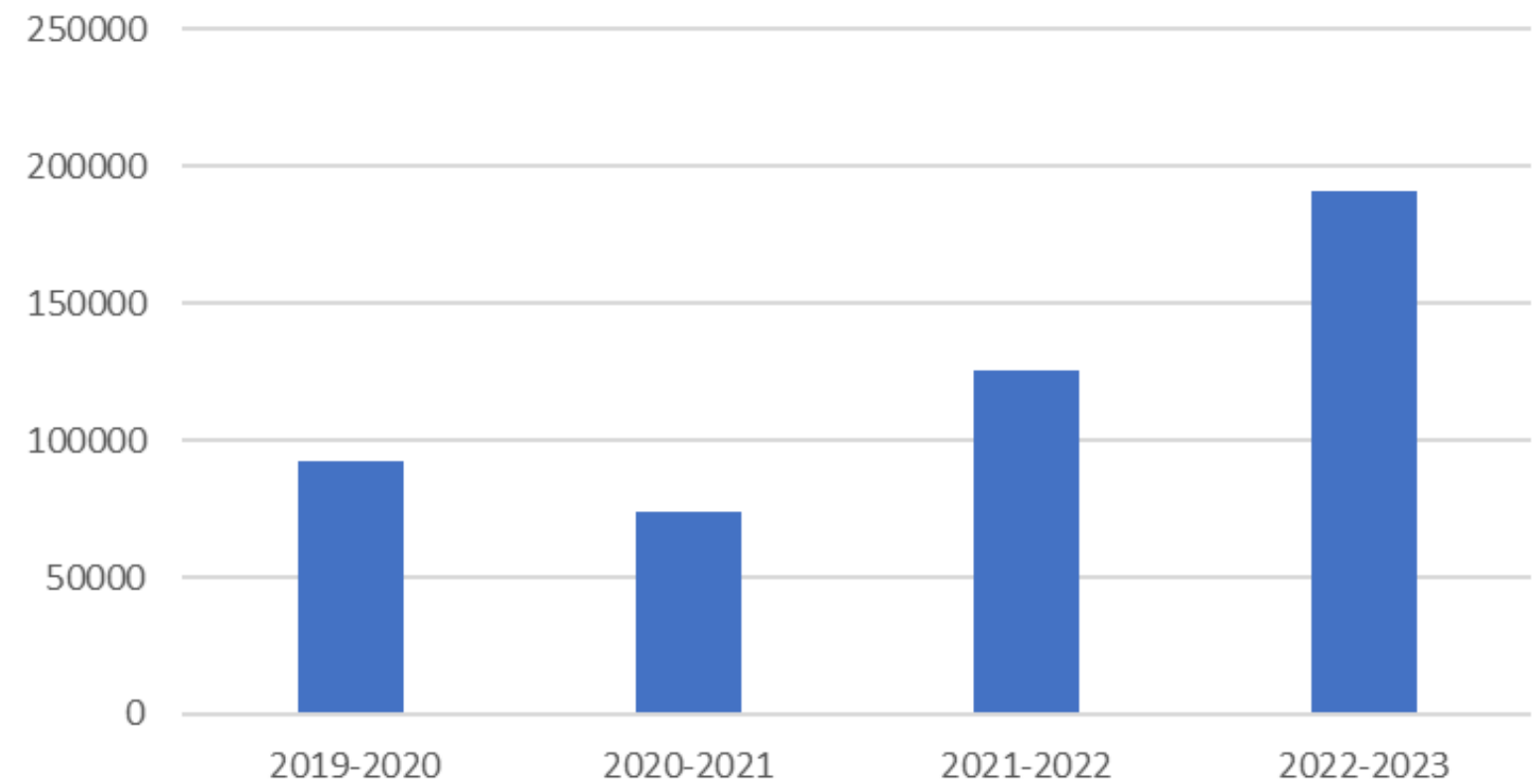

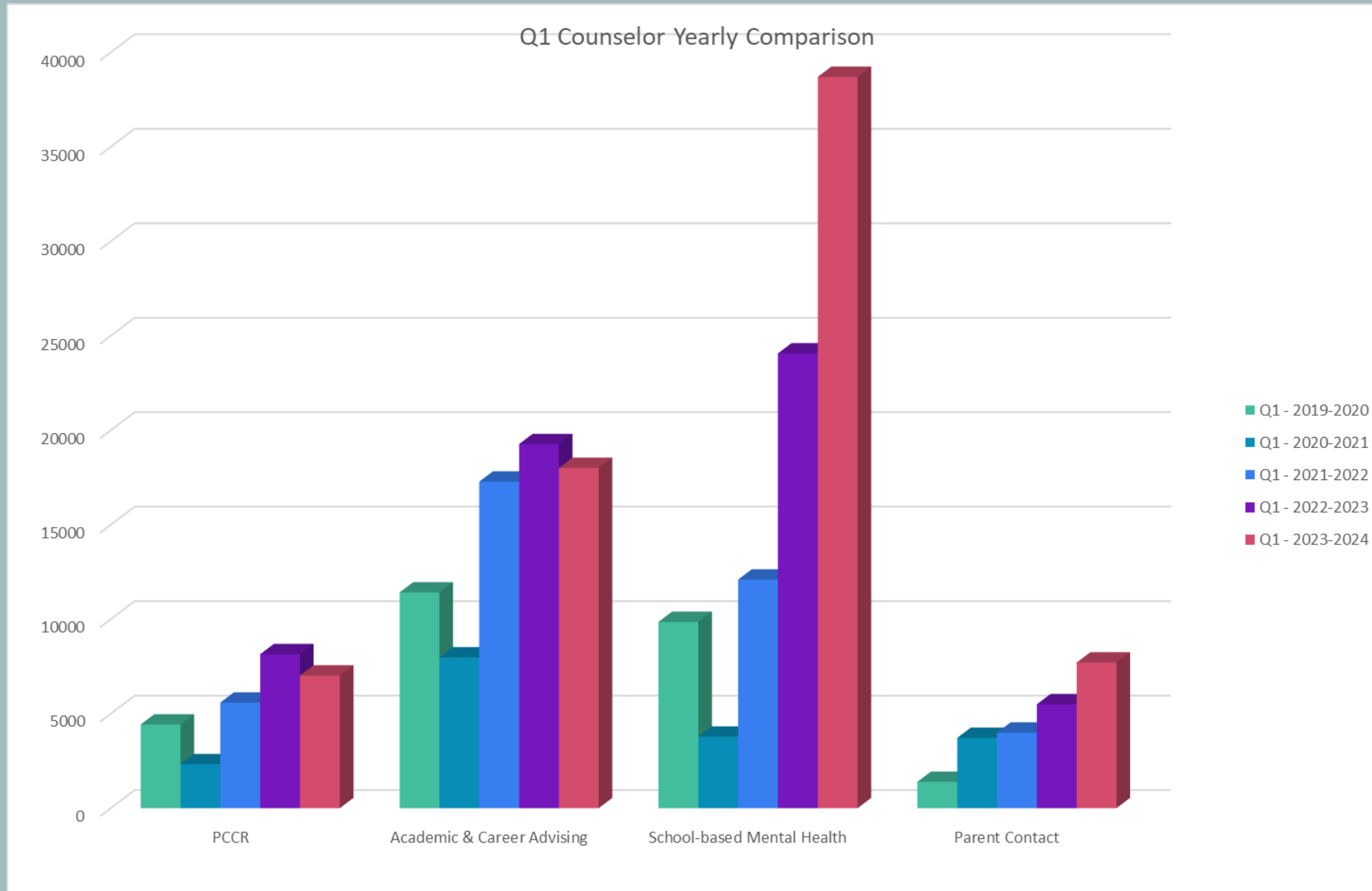
Number of Seniors Off Track for
Graduation



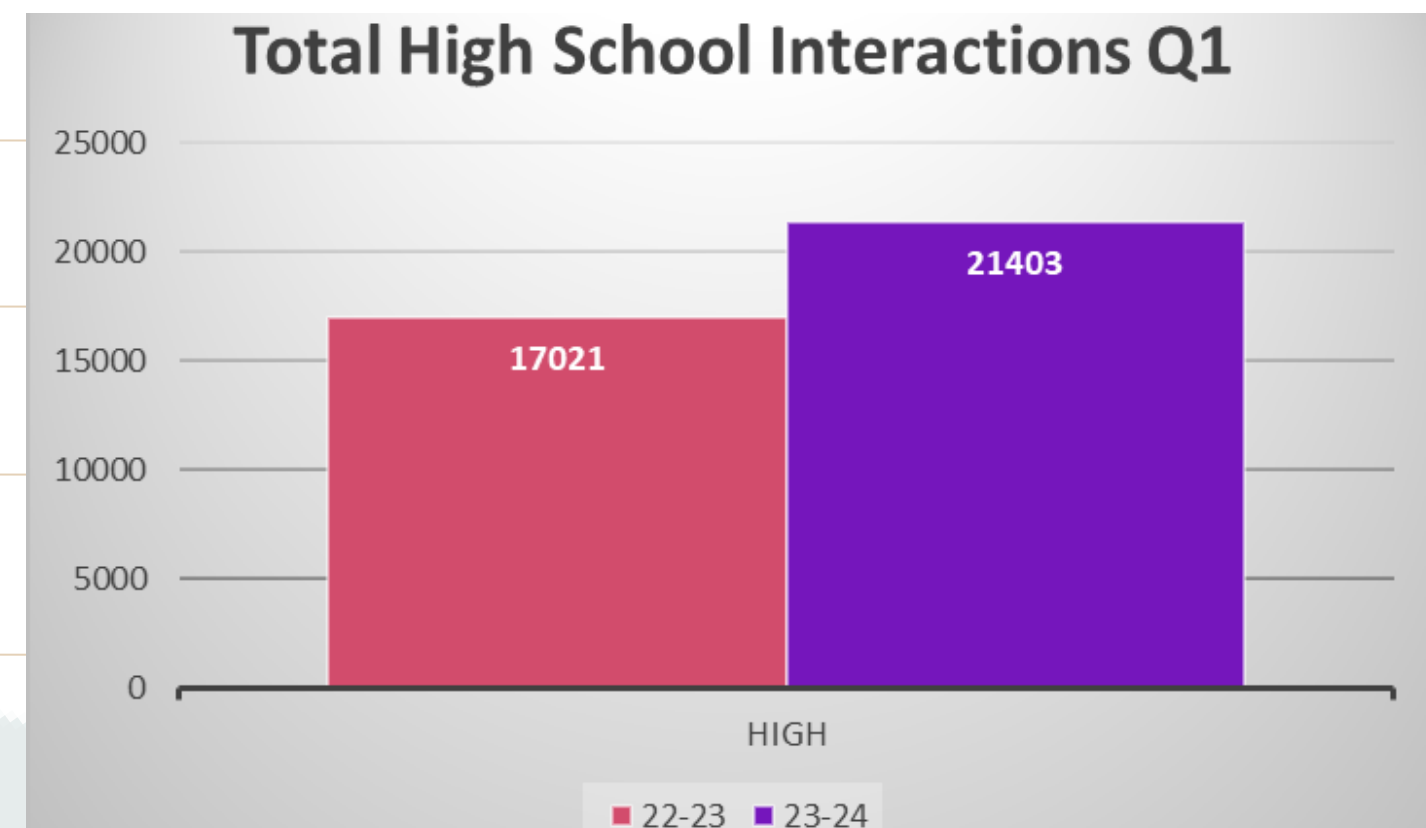
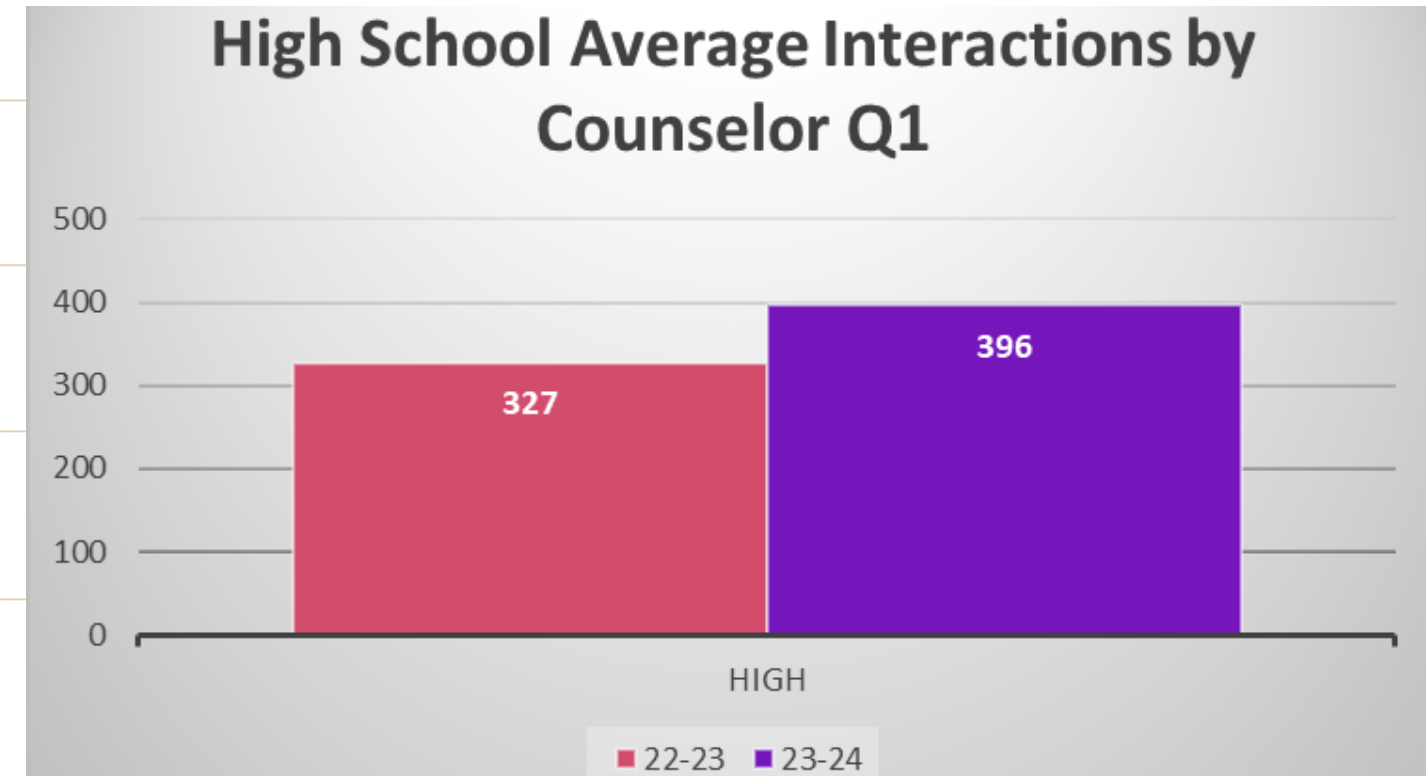
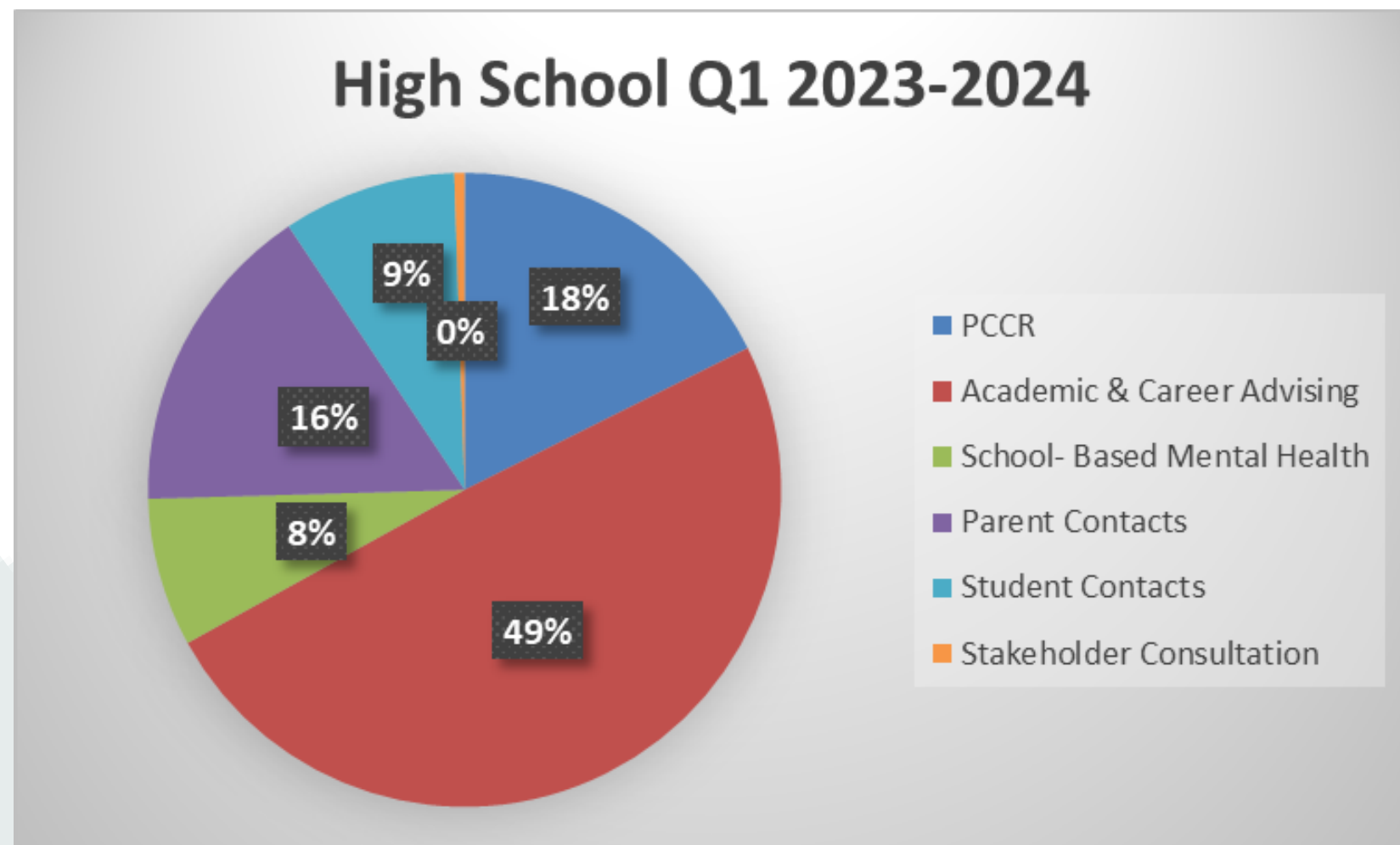
Total Student & Counselor Interactions

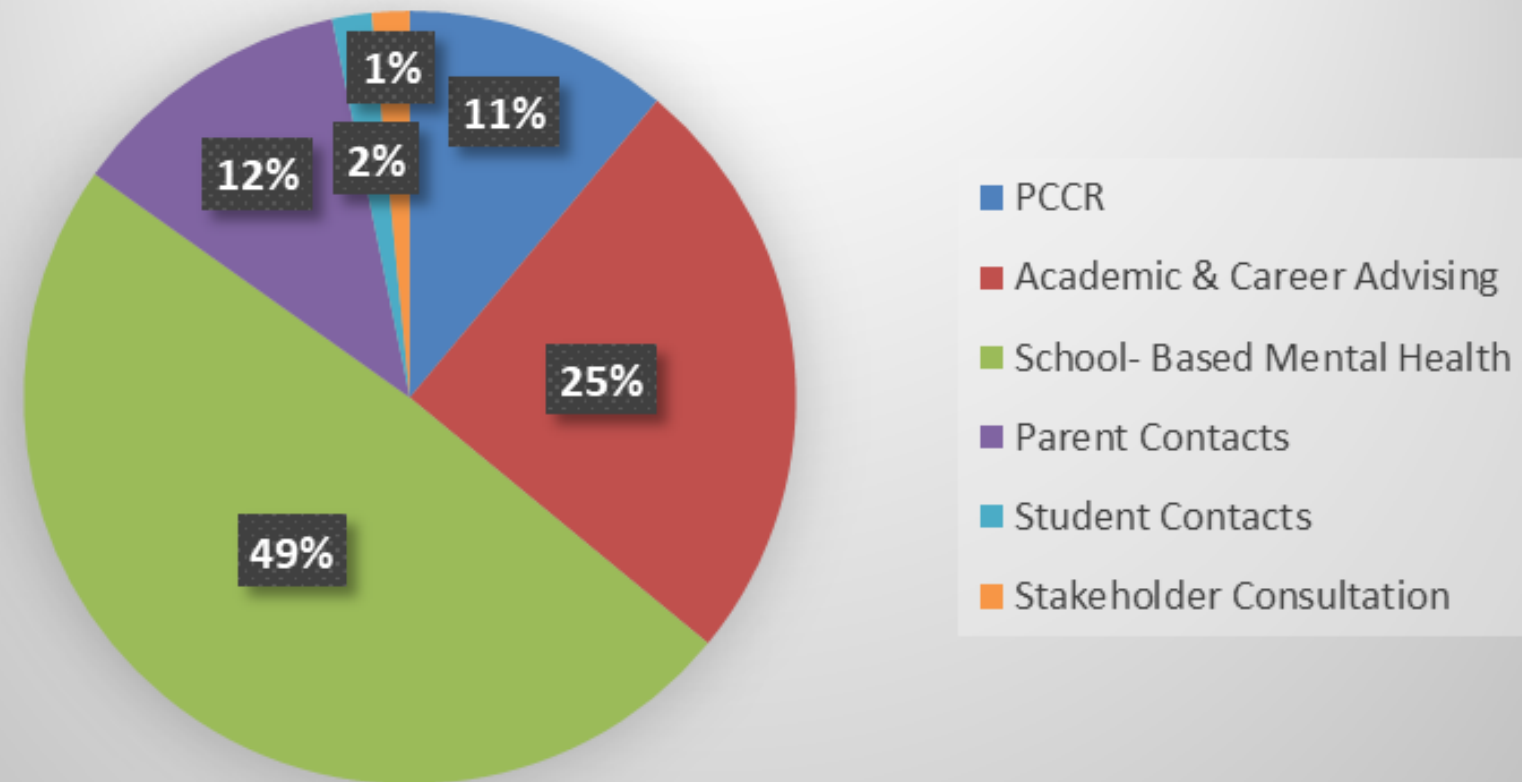


High School Counselor Data

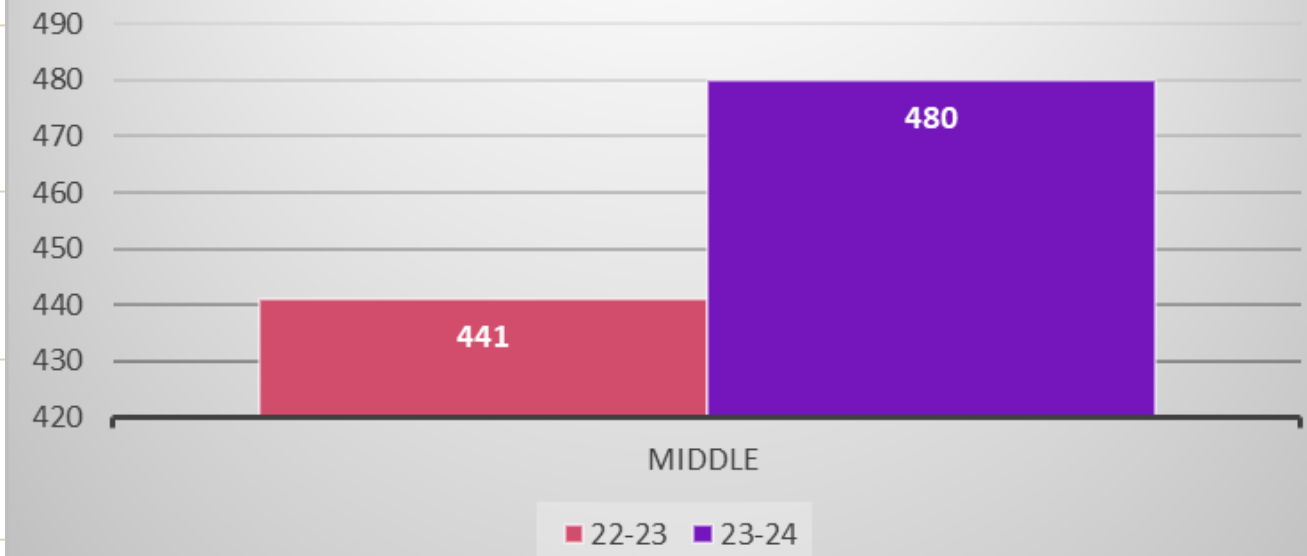


Middle School Counselor Data

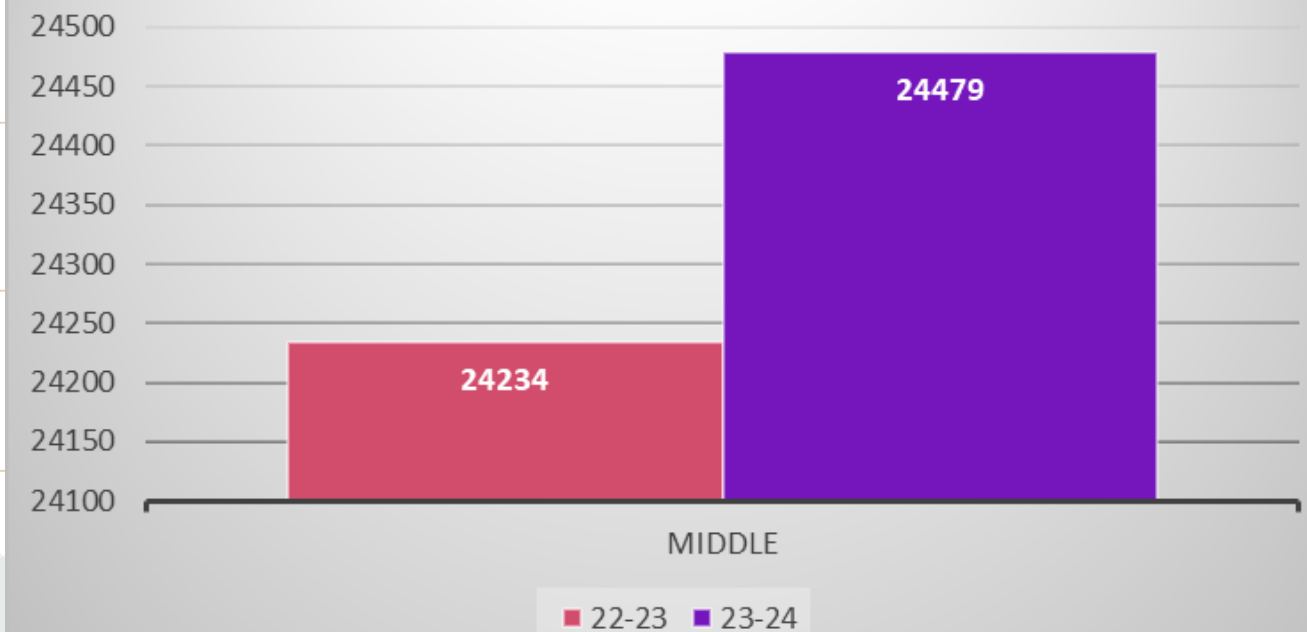
Middle School Q1 2023-2024



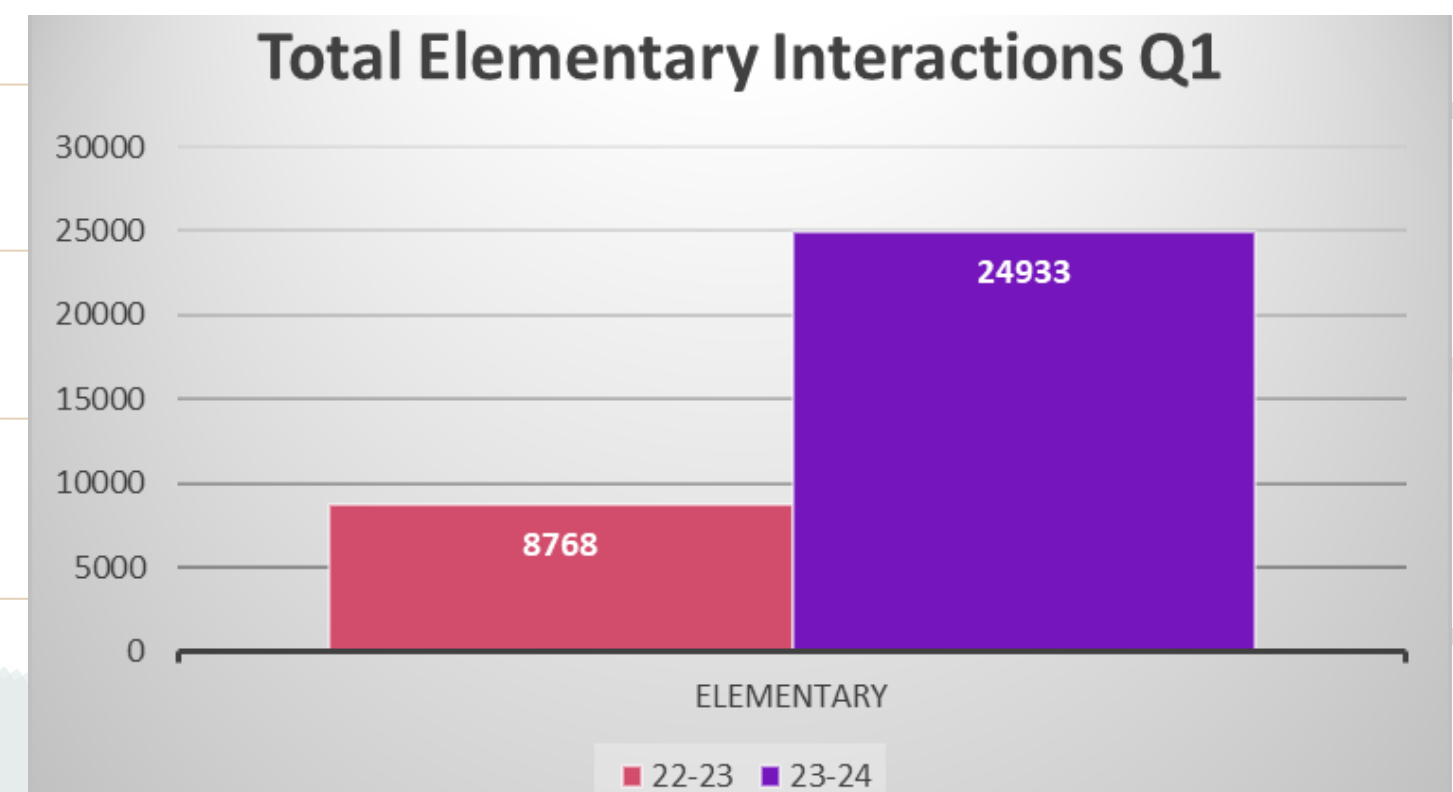
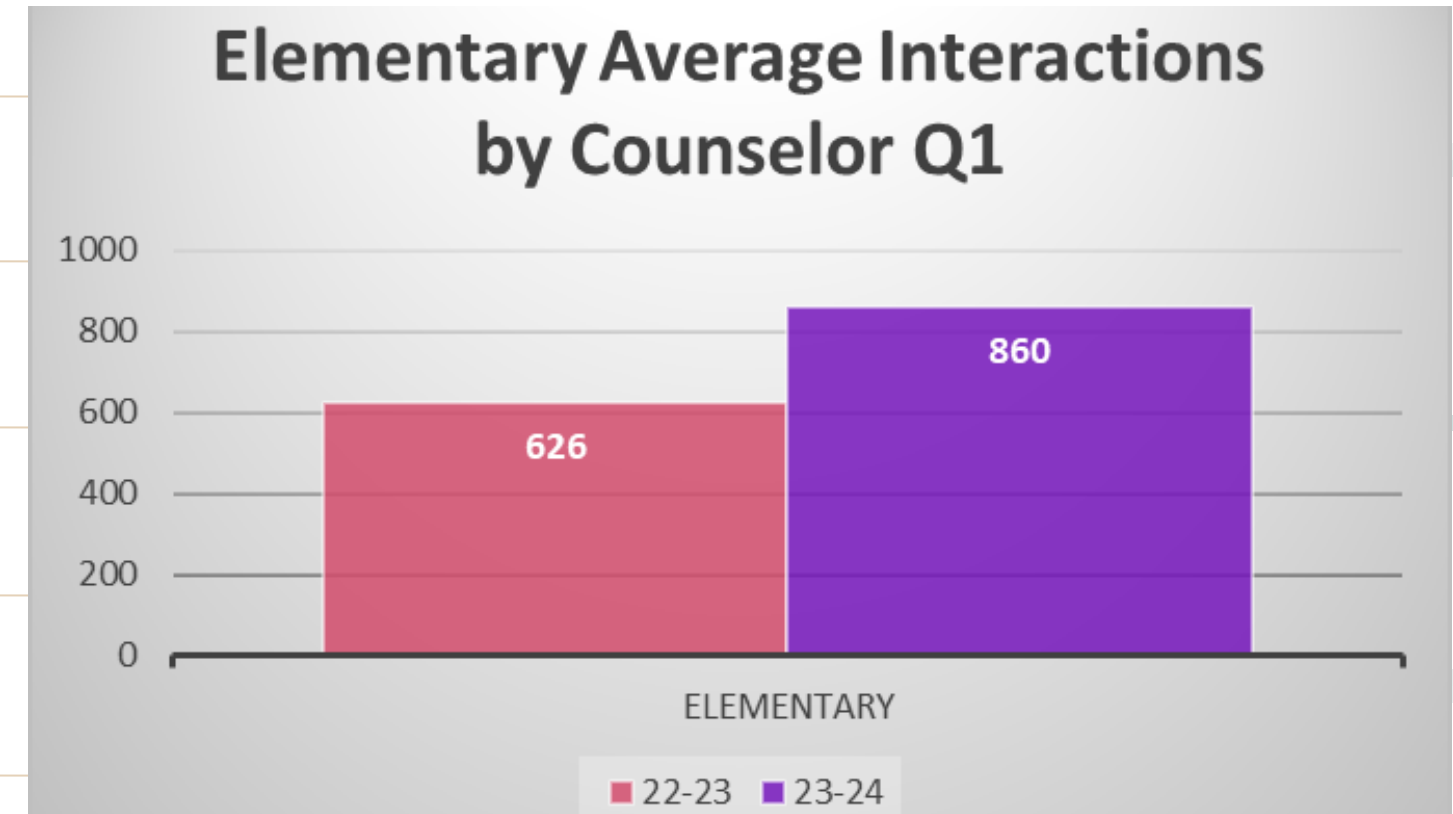
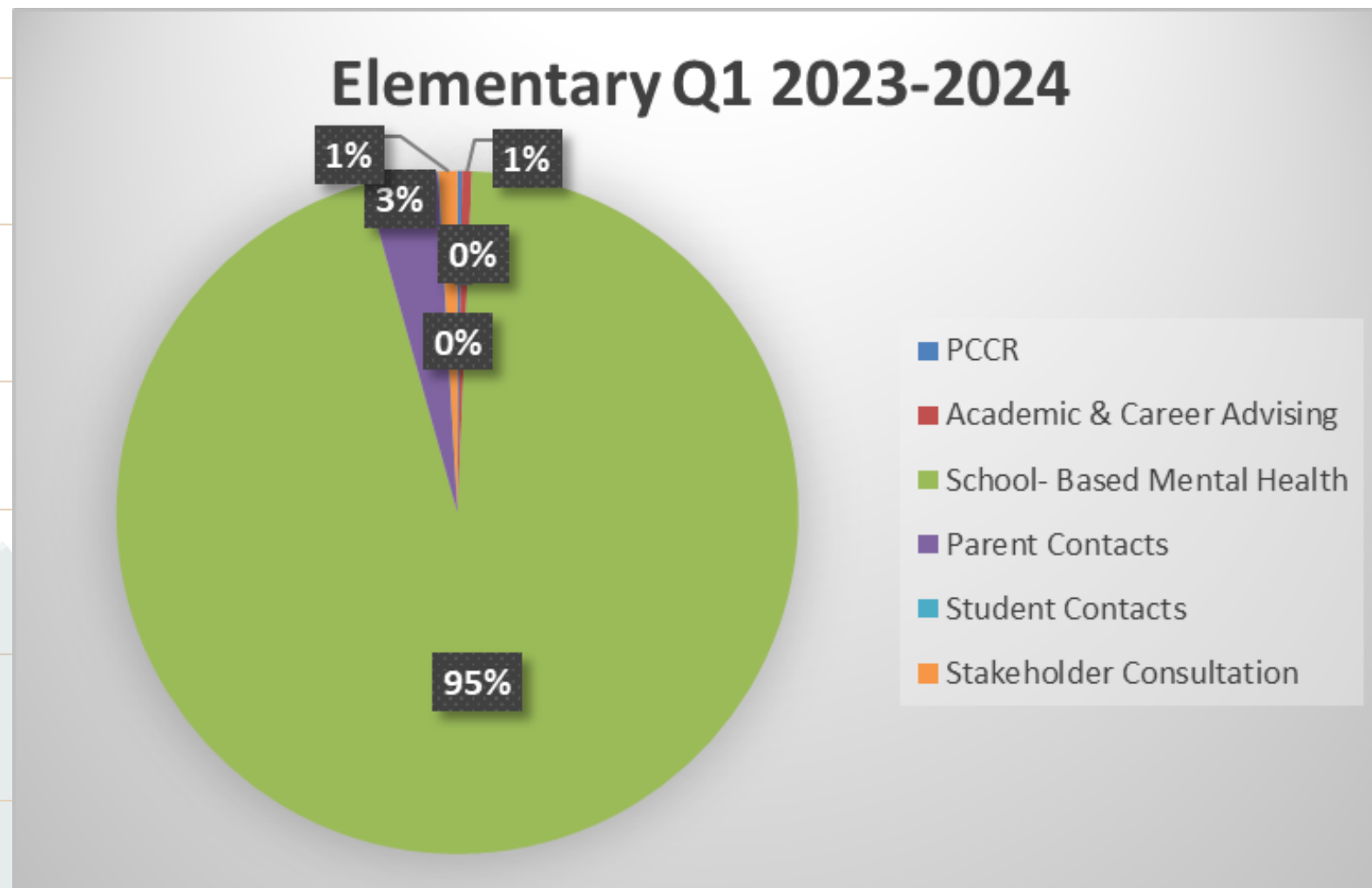
Middle Average Interactions by Counselor Q1



Total Middle School Interactions Q1

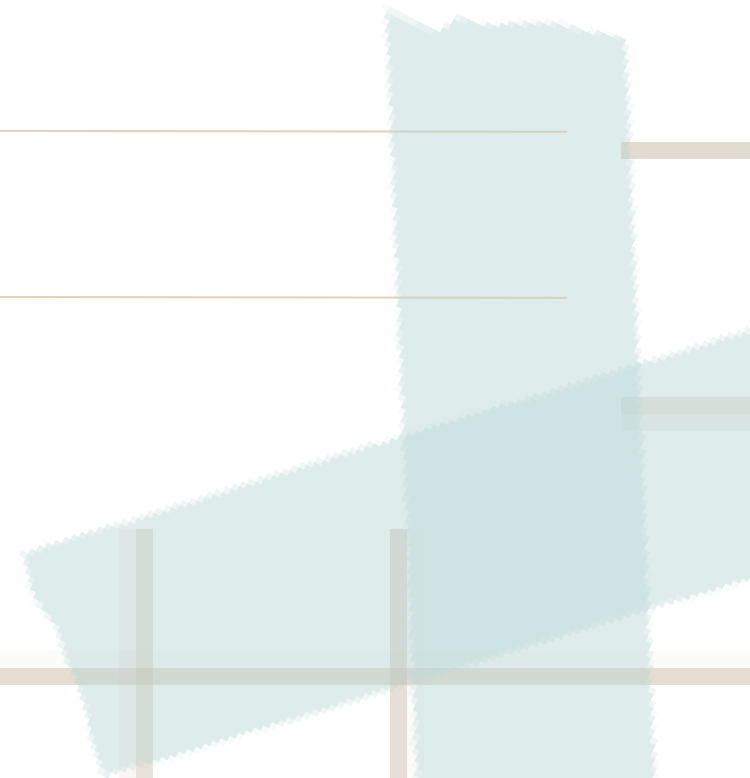
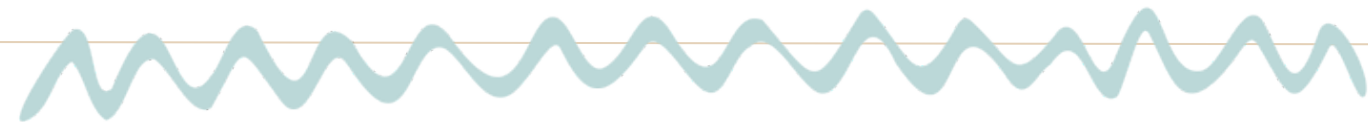

MINUTES OF BOARD OF EDUCATION MEETING
November 28, 2023

The Board of Education of Jordan School District met in study, general, and closed sessions on Tuesday, November 28, 2023, beginning at 4:03 p.m. at JATC South (Board Conference Room), 12723 S. Park Avenue (2080 West), Riverton, Utah. The sessions were also provided electronically via YouTube.

President Miller presided and conducted. The Board of Education met in a study session to discuss the following:

A. Portrait of a Graduate Presentation

President Miller introduced Board members to Education Elements consultants, who were invited to be virtual presenters in the meeting. She gave a brief review on the progress of Portrait of a Graduate and expressed appreciation for the unbiased professional perspective Education Elements offers and the tremendous work the team has done thus far.

Education Elements Consultants Lauren Schulten, Miriam Cohen, and Brian Seay, introduced themselves, gave a presentation on the process of developing Jordan's Portrait of a Graduate and Strategic Plan, and shared a timeline for completion. They highlighted the great community engagement effort, noting over 20,000 participants completed the survey and 229 people participated in focus groups.

Each focus group was asked "What do you hope is true of every Jordan School District graduate?" Using feedback and survey results, a draft of the following six competencies was developed: curious thinker, creative problem solver, engaged citizen, empathetic communicator, resilient lifelong learner, and responsible teammate. They described characteristics of each competency and explained accountability measures will be developed to track growth and student success.

Mr. Dunford arrived at 4:22 p.m. and joined the meeting in session.

Board members requested the raw data for further analysis and gave positive feedback for the work Educator Elements and the steering committee have done. The consultants invited Board members to the virtual “design day” on December 5, 2023 where initiatives will be aligned with focus areas and said they welcome additional feedback on the work done so far once Board members have thoroughly reviewed it.

B. Discussion on Administrative Policy DE 501 Curriculum Adoption and Review Committee

Carolyn Gough, Administrator of Teaching and Learning, said recent Utah legislation (SB55) regarding public school instructional material requires the District to update policy to align with the law. She shared a draft of Policy DE501 that gives direction on all learning materials, both primary and supplemental. It also gives guidelines regarding the establishment and responsibilities of a Curriculum Advisory Committee.

Board members discussed the number of members to serve on the Curriculum Advisory Committee and some wording changes.

Ms. Gough said her team is keeping track of curriculum expiration dates and watching for changes that might necessitate the beginning of an RFP process for obtaining replacement curriculum. The procurement and bidding process was discussed and President Miller noted there is ample opportunity for thorough review and public comment on curriculum bids.

President Miller recommended this item be placed on a future study session agenda for further discussion.

C. Update of Security Protocols

Dr. Godfrey recognized the new School Safety Coordinator, Matt Alvernaz, who he said is a tremendous asset in the District. He said Mr. Alvernaz has varied and deep training in law enforcement and communicates well with local government officials.

Mr. Alvernaz introduced himself, highlighting his past work experience, and said he is passionate about school safety. He reported he recently revised the District Safety Manual to align with current Standard Response Protocols and has conducted trainings to educate District personnel on the changes. He explained the following protocols and their uses: hold, secure, lockdown, evacuate, and shelter, and said additional training for schools will align with monthly drills.

Mr. Alvernaz further explained that safety announcements will be uniform across the District, families will be informed about drills, and timely and accurate communication will follow any incident.

It was decided that Board members will receive Standard Response Protocol training in a future Board meeting.

Due to time constraints, President Miller said discussion on Agenda items D through F will continue after the general session.

At 6:16 p.m., the meeting adjourned. The general session started at 6:34 p.m.

Board Member Recognitions

Lisa Dean recognized the hard work of everyone involved in school musical productions. She congratulated those who were selected to be a part of the Middle School Honors Band and Orchestra.

Marilyn Richards attended the Bingham High School musical “42nd Street”, describing it as amazing. She said she is impressed by the improvements made in School Community Council meetings she has attended.

Tracy Miller also attended Bingham High School’s musical and said it was very well done.

Superintendent's Recognitions

Superintendent Godfrey recognized National Education Support Professional (ESP) Day on November 15, 2023 and expressed gratitude for the tremendous work done by Jordan ESPs, which represent more than half of the District's workforce.

He also recognized Student Government members in Jordan high schools and was especially appreciative for all the work they do at this time to prepare for and execute their charitable drives. Dr. Godfrey reported that Utah Jazz player Jordan Clarkson and Phoenix Suns player Devin Booker worked with the Utah Jazz and Heartland Elementary School to distribute free Thanksgiving meals.

I. Public Comments

A. Comments by Elected Officials

No mayors or elected officials were in attendance.

B. Patron Comment on Proposed K-3 Early Intervention Reading Software Program

President Miller asked if any patrons would like to speak to the Board about the Proposed K-3 Early Intervention Reading Software Program. No patrons signed up to address the Board on this item and no audience members accepted the invitation to speak.

C. Patron Comments Regarding Non-Agenda Items

Haley McCall, teacher and parent at Aspen Elementary School, expressed support for a Spanish DLI program at Aspen Elementary School. She said she was concerned about timing and asked the Board to reconsider approving a DLI program soon.

Elijah Webb, a student, requested that the Board consider more opportunities for students to become bilingual. He expressed the benefits of beginning in kindergarten to learn another language.

President Miller invited Mr. Larsen, business administrator, to read comments submitted to boardcomments@jordandistrict.org from the following individuals, whose comments are summarized below:

Rebecca Kirkman wrote that she is grateful for her freedom and appreciates the work being done by school librarians. She expressed concern that rights will be limited by the adoption of a new book review policy.

Kimberly Ottley expressed support for a dual language immersion program at Aspen Elementary School.

Alyson Ludlow, a former teacher, is supportive of a DLI program at Aspen Elementary School. She noted the benefits for native Spanish speakers, who she believes represent a significant population in that area of the District.

Corinna Ramirez expressed support for a dual language immersion program at Aspen Elementary School.

Kylee Gonzalez expressed support for a dual language immersion program at Aspen Elementary School.

Hector Domingo Oller, a Spanish teacher, said he is supportive of adding a DLI program to Aspen Elementary School. He said it would provide diverse educational opportunities and foster cultural awareness among students.

Whitney Glassman expressed support for a dual language immersion program at Aspen Elementary School. She said it would be a way to support refugees and native Spanish-speaking students.

Kristofer Work, a teacher, said he appreciates the value of Artificial Intelligence programs in schools, but is concerned about District funds being spent on AI programs instead of more pressing educational and staffing needs.

Yolanda Pastor Fernandez wrote in support of implementing a Spanish DLI program at Aspen Elementary School. She urged the Board to consider the enduring positive effects a DLI program would have on students, parents, and the community.

Kaylin Tausinga expressed support for a dual language immersion program at Aspen Elementary School.

Chelsie Garcia expressed support for a dual language immersion program at Aspen Elementary School.

Bethany Alston expressed support for a dual language immersion program at Aspen Elementary School. She said this could help increase respect among those with differing backgrounds, cultures and needs.

Kelcey Murdoch wrote in favor of Aspen Elementary School offering a Dual Immersion Spanish program. She said her child has many students in her classroom who do not speak English and a DLI program would be a great benefit to these students.

Ashley Iverson expressed support for a dual language immersion program at Aspen Elementary School.

Emma Calderwood wrote about the benefits of DLI programs and asked some questions about the proposal of adding a dual language program at Aspen Elementary School.

Samantha Clements requested the Board survey parents in the Aspen Elementary School neighborhood about their interest in offering a Spanish DLI program at the school. She said the community would welcome and benefit from this opportunity.

Purpose: To provide an AI platform for use by teachers and students in school classrooms under the direction of Digital Teaching & Learning.

Budget: Superintendent's Budget

Recommendation: It was recommended awarding the contract to School AI as the highest scoring, responsive and responsible proposal. This is a one (1) year contract with four (4) annual renewals.

MOTION: It was moved by Darrell Robinson and seconded by Bryce Dunford to approve the bid for Classroom AI Solutions for Digital Teaching & Learning, as recommended.

Jared Covilli, Digital Teaching & Learning Administrator, said the AI platform will be beneficial to all population groups, but would be of particular benefit to teachers in helping to reduce their workload. He specified that the bid is a very reasonable amount that is guaranteed for a period of up to five years. He said students will need the skills that can be developed using AI and noted the program includes internal and additional District filtering systems to protect students from inappropriate content.

Darrell Robinson and Brian Barnett added their support as they had an opportunity to witness voluntary teacher training on the product this past summer and were impressed at its capabilities.

Dr. Godfrey added that the platform is being paid for with the flexible funds previously allocated by the Board.

President Miller called for a vote on Classroom AI Solutions for Digital Teaching & Learning and the motion passed unanimously.

MOTION: It was moved by Brian Barnett and seconded by Marilyn Richards to approve Proposed Boundary Changes for Sunset Ridge Middle School, Joel P. Jensen Middle School, West Jordan High School, and Copper Hills High School.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

Niki George and Darrell Robinson expressed the need for more information about growth in the area in order to make an informed decision.

SUBSTITUTE

MOTION: It was moved by Darrell Robinson and seconded by Lisa Dean to table this special business item until more information can be obtained.

Busing and permit issues were discussed as well as the enrollment forecast for Sunset Ridge Middle School. Ms. George requested the Board continually monitor enrollment numbers at the affected schools.

President Miller requested a vote on the substitute motion. The motion failed by a vote of two to five as follows:

President Miller requested a vote on the original motion. The motion passed with a vote of five to two. Ms. Dean and Mr. Robinson cast the dissenting votes.

Mr. Dunford asked administration for an updated enrollment forecast and Dr. Anderson agreed to send it to Board members by the end of the week.

B. Recommendation to Adopt the Annual Comprehensive Financial Report (ACFR) for Fiscal Year Ended June 30, 2023.

Bryce Dunford recognized Accounting staff, auditors, and Mr. Larsen for their efforts on the ACFR. He emphasized the importance of being good stewards of public funds and noted the District's former financial surplus has been strategically managed and brought to an acceptable level.

Business Administrator John Larsen gave a reminder that although the property tax dollars in the general fund show an increase, 87 percent of this amount is set aside by the state. He expressed appreciation to Squire & Company auditors for their professionalism.

Kyle Greene, independent auditor with Squire & Company, stated there were no issues of non-compliance and the firm issued an unmodified (or clean) opinion that the District financial statements accurately reflect the business that has taken place this past year and the ACFR was presented fairly. He said the firm also issued an unmodified (or clean) opinion on federal dollars and State compliance.

Mr. Dunford expressed concern that the student average attendance is at ninety-three percent since the pandemic. He highlighted the fact that teacher salaries have increased \$20,000 over the past seven years.

Mr. Larsen said the ACFR will be made available to the public tomorrow and can be found on the District website. He mentioned it will also be sent to the State auditor and State Board of Education.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

MOTION: It was moved by Bryce Dunford and seconded by Brian Barnett to approve the Annual Comprehensive Financial Report (ACFR) for Fiscal Year Ended June 30, 2023. The motion passed unanimously.

C. **Recommendation to Approve Land Exchange Agreement for Daybreak Village 9**

Marilyn Richards explained that Village 9 is the potential building site for the next District school. She said an even trade was made to exchange land with the Daybreak development. Mr. Rostrom verified this information, stating both plots are 12.006 acres.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

MOTION: It was moved by Bryce Dunford and seconded by Brian Barnett to approve the Land Exchange Agreement for Daybreak Village 9. The motion passed unanimously.

D. **Recommendation to Approve Amendment to Timeline for Ivory Land Development Property Trade Agreement**

Marilyn said Ivory Homes requested a three year extension to the development timeline as things are progressing slower than originally projected.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

President Miller called for a vote on the Recommendation to Approve Amendment to Timeline for Ivory Land Development Property Trade Agreement. The vote was unanimous.

E. **Recommendation to Approve Administrative Policy DP380 *Maternity/Parent Leave***

Dr. Anthony Godfrey said the Board led out on this policy and other districts have followed. He said the recommended change releases a resigning employee from repaying compensation received for maternity/parent leave beyond the current contract year.

Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

A copy of Policy DP380 is attached at the conclusion of these minutes (Attachment 2)

MOTION: It was moved by Niki George and seconded by Darrell Robinson to approve Administrative Policy DP380 *Maternity/Parent Leave*. The motion passed unanimously.

FOLLOW-UP

MOTION: It was moved by Bryce Dunford and seconded by Darrell Robinson to make the effective date of Administrative Policy DP380 July 1, 2023. The motion passed unanimously.

V. **Information Items**

A. **Superintendent's Report**

Superintendent Godfrey expressed gratitude to all of the experts working in Jordan School District, calling them great people who bring a lot of experience to their jobs.

VI. **Discussion Items**

A. **Committee Reports and Comments by Board Members**

Lisa Dean reported that Salt Lake County Parks and Recreation is sponsoring a “My County Rec Pass” program which will give all children, age five to eighteen years old who live in Salt Lake County, free access to county recreation facilities.

Marilyn Richards, Facilities Committee Chair, said Utah High School Activities Association is looking to sanction E-Sports in the 2025 school year.

Bryce Dunford, Finance Committee Chair, said the committee plans to ask the new internal auditor to examine the District’s P-card process to ensure it is protected from fraud.

Darrell Robinson reported on the Literature Review Ad Hoc Committee which continues to look at the book review process and terminology regarding book challenges.

Niki George, Government Relations Committee Chair, gave a reminder about the Legislative Breakfast that will be held December 6, 2023 at Hidden Valley Middle School at 7:30 a.m.. She described the agenda and asked Board members to contact her if they have any additions.

President Miller asked Board members if they would like to make changes to the Board room décor, proposing pictures of students and good things happening in the District be added to the walls. Board members agreed with this recommendation.

President Miller reported on attending the national ExcelinEd conference which was focused on policy. She said social media and cell phones in schools will be discussed at future summits on education. She congratulated Niki George, John Larsen and Lisa Dean for finishing their Master Board Certification, which she also completed.

Reporting on the Jordan Education Foundation, President Miller gave a reminder that the annual Christmas for Kids event is Saturday, December 9, 2023. Those who wish to sign up as volunteers can do so at: jefchristmasforkids.org.

At 9:18 p.m., President Miller declared the meeting adjourned and announced that the Board would return to study session.

President Miller presided and conducted. The Board of Education continued its study session to discuss the following:

D. Board Newsletter

Sandy Riesgraf, Communications Director, used samples from local districts to design mockups of a Jordan newsletter. She suggested sample titles, content, and options for distribution.

Board members decided on the title and format, and that content will be directed by the Board. The newsletter will be posted on the District website, on social media, and sent quarterly to parent and employee emails beginning in January and then again in April. The District will purchase an email list for residents older than twenty-five years old, without children, who live within District boundaries and the newsletter will be sent to them as well. There will be a clear “unsubscribe” option for those wishing to opt out.

E. Update on Summer Projects

Dave Rostrom, Director of Facility Services, introduced Ian Roberts, Capital Outlay manager, and shared a list of capital projects with estimated costs.

Bryce Dunford said the Finance Committee recommends a spending threshold of \$13 million and Board members were asked for input regarding top priorities.

It was decided to drop item number eight and item number one, an awning over Kauri Sue School sidewalks, from the list and approve all other projects. Board members recommended a temporary solution for Kauri Sue, obtaining additional snow removal equipment, until the time this project is approved.

MOTION: It was moved by Bryce Dunford and seconded by Darrell Robinson to move forward with obtaining bids for all Capital Summer Projects except for items one and eight and to allocate up to \$500,000 of Capital funds to Kauri Sue Hamilton School for snow removal equipment.

Mr. Rostrom said he believed snow removal equipment could be obtained for less than \$100,000 for the school.

SUBSTITUTE

MOTION: It was moved by Bryce Dunford and seconded by Darrell Robinson to move forward with obtaining bids for all Capital Summer Projects except for items one and eight and to allocate up to \$100,000 of Capital funds to Kauri Sue Hamilton School for snow removal equipment. The motion passed unanimously.

One of the listed capital projects pertains to an access project in Herriman City. The Board gave direction to Mr. Larsen to notify Herriman City that the Mountain Ridge High School access project is being put out to bid.

Mr. Rostrom said he expects to be ready to report on all bids at the February 2024 Board general session.

F. Revisions to Board Policy GP110 *Public Participation at Board Meetings*

MOTION: It was moved by Tracy Miller and seconded by Darrell Robinson to table Agenda item F, Revisions to Board Policy GP110, until the next Board study session. The motion passed unanimously.

MOTION: At 10:47 p.m., it was moved by Marilyn Richards and seconded by Darrell Robinson to go into closed session. The motion passed unanimously.

President Miller presided and conducted. The Board of Education met with Jordan District area legislators. Breakfast was provided by the Nutrition Services and Hidden Valley Nutrition departments. Board members and legislators participated in discussions regarding the following:

A. Welcome and Acknowledgments

President Miller welcomed everyone, thanked them for coming, and invited Board members and legislators to introduce themselves. She expressed appreciation to the Hidden Valley Middle School administration for hosting the meeting and Nutrition Services/Hidden Valley Nutrition for providing breakfast. Shawn McLeod, Principal at Hidden Valley Middle School, introduced the school's student body officers who greeted those attending the meeting.

President Miller acknowledged that Board members have met with legislators in previous smaller meetings during the past few months. She said this meeting will discuss educational priorities and report on how the District uses the legislative funds provided.

B. Board of Education Legislative Priorities for the 2024 Legislative Session

Niki George, Board First Vice President, presented the Board's legislative priorities:

- 1) Competitive Pay Through WPU Increase
- 2) Study High Growth Funding Mechanisms
- 3) Fully Fund Special Education

4) Funding for Counselors and Behavior Specialists

Ms. George reported that 100 percent of 2023 unrestricted legislative funding went to employee compensation and she asked elected officials to consider innovative ways to address high growth needs. She also stressed the importance of special education funding and noted the great benefit of hiring additional counselors and behavior specialists in the District.

C. Portrait of a Graduate Information

Ms. George mentioned the Board felt it was valuable to create a "Portrait of a Graduate" model to strategize about ways to prepare students for the needs of today's world. She explained the District has hired Education Elements, a company providing neutral input which specializes in assisting districts across the nation with the process of composing individualized Portrait of a Graduate and Strategic Plans.

Ms. George explained that the process began with a survey that garnered almost 21,000 responses from parents, students, and stakeholders. She said over 229 people in focus groups are also giving feedback. She highlighted the following survey statements that received above average positive feedback:

- The District communicates well with families
- Students in Jordan District feel safe at school
- Jordan District is responsive to the needs of families
- Students' mental health needs are addressed
- Students' academic needs are being met
- Students receive an appropriate level of rigor
- Jordan District represents the values of the community
- Respondents are satisfied overall with Jordan School District

D. Financial Update

Brian Barnett, Board Member, shared the annual budget book with legislators and gave an overview of important points. He said Jordan passed the annual district audit, indicating that the financial report accurately reflects the fiscal activity and financial status of the District. He added that the District's financial reserve has been brought to an acceptable level.

Mr. Barnett said Jordan accounts for 58,000 or 8.5 percent of the students in Utah and he feels Jordan's taxpayer dollars are some of the most well-spent, sharing information to substantiate this statement, namely:

- LEA costs per student at Jordan are below the State average
- Jordan is above the State average in teacher salary across all districts (not only is more allocated for teacher salaries, but non-teacher related expenses are lower than other states)
- Although some areas of the District are growing, the enrollment forecast for Jordan projects enrollment will hold steady with current numbers overall. One elementary is being built and one is in the planning stages, but the District is exploring the possibility of a boundary change to balance growth.
- Almost 100 percent of recent tax increases have gone to teacher salaries and teacher supports. Mr. Barnett thanked legislators for their support. Starting teacher pay has steadily increased over the past eight years, increasing from approximately \$34,000 to \$58,000.
- In response to Representative Strong's question about supports for families, Board members and Superintendent Godfrey pointed out the new maternity/paternity leave policy, Jordan Family Education Center, additional counselors in schools, and the Cook Center for Family Connection.
- Jordan's tax yields per student stay competitive with other districts

Mr. Barnett explained how an increase in WPU funds could be used to cover anticipated needs for the upcoming year: a 3.8% increase would cover steps and 1% salary increase for employees, a 2.0% increase would cover elimination of school fees, and a 0.8% increase would cover maintenance and operation cost increases.

E. Virtual School Panel

Tracy Miller, Board President, said Hidden Valley Middle School houses the District virtual schools. She welcomed the following individuals who were asked to represent virtual schools in this meeting:

Ammon Wiemers, Principal, Kings Peak High School
Lauren Skipps, Teacher, Kings Peak High School
Kai Miyake, Student Body Vice President, Kings Peak High School
Adynn Jones-Wahlquist, Student Body President, Kings Peak High School

Mr. Weimers said there are 260 full-time students and 100 part-time students at Kings Peak and he explained how the school functions. He said there is a high level of flexibility with in-person instruction and support, recorded classes, and student-created schedules. He highlighted educational opportunities, including AP and college credit courses, and options for students to participate in activities at their boundary school.

Ms. Skipps said the classes feel more personal and can be rigorous. She teaches PE, Health, and Driver Ed and said the school accommodates students with a variety of needs. She invited Adynn Jones-Wahlquist and Kai Miyake to share their experience at the school.

Adynn and Kai both spoke highly of Kings Peak High School, noting the great support, personal instruction, opportunities for leadership, and flexibility with schedules. Adynn said she participates in debate at Bingham High School and Kai has had the opportunity to prepare for a career as a pilot, using his flexible schedule to log 800 simulator hours thus far.

Mr. Weimers said there are approximately 20 out-of-district students at Kings Peak and students are allowed the freedom to learn in their own timeframe, but supported to meet deadlines and complete make-up work. Dr. Godfrey said that during the pandemic, Kings Peak had a higher course completion rate than other schools. He said the virtual school has high graduation rates, maximum flexibility, and an equal measure of accountability. Darrell Robinson added that virtual schools mirror the way things are done at college.

F. Discussion

President Miller closed the meeting in the interest of time. She thanked everyone for attending and invited Legislators to let Board members know how they can be of help.

At 9:12 a.m., the meeting adjourned.

ATTORNEY-CLIENT ENGAGEMENT AGREEMENT

The Attorney-Client Engagement Agreement (“Agreement”) is entered into by and between _____ [District Name] (“Client” or “District”) and Wagstaff & Cartmell, LLP and its co-counsel Beasley Allen Crow Methvin Portis & Miles, P.C., Goza & Honnold, LLC, and Kirton McConkie PC (“Attorneys” or “We”), and encompasses the following provisions:

1. CONDITIONS

This Agreement will not take effect, and Attorneys will have no obligation to provide legal services, until Client returns a signed copy of this Agreement.

2. SCOPE

Client hires Attorneys to provide legal services in connection with pursuing claims for damages associated with social media litigation, including against Facebook, Meta, Instagram, Snapchat, TikTok, YouTube, and Google, as well as other defendants Attorneys determine appropriate and in the best interests of Client (“Action”).

3. DUTIES AND RESPONSIBILITIES OF PARTIES

All professional work performed under this Agreement shall be performed by Attorneys in accordance with existing professional standards. Attorneys shall exert their best efforts and use their best judgment in review and analysis and preparation of opinions and memoranda and representation in such proceedings. Client will cooperate with Attorneys and their representatives at all times and comply with all reasonable requests of Attorneys in the prosecution of this matter on a timely basis. Client agrees to be truthful at all times with Attorneys, to provide whatever information is necessary (in the Attorneys’ estimation) in a timely and competent manner, and to provide immediate information as to any change in Client’s status which may have any impact on the prosecution of the Action. At the end of this Agreement Client shall designate a “District Representative” as the authorized representative to be the primary individual to communicate with Attorneys regarding the subject matter of Attorneys’ representation of Client under this Agreement.

4. LEGAL SERVICES SPECIFICALLY EXCLUDED

Unless otherwise agreed in writing by Client and Attorneys, Attorneys will *not* provide legal services with respect to (a) defending any legal proceeding or claim against the Client commenced by any person unless such proceeding or claim is filed against the Client in the Action or (b) proceedings before any federal or state administrative or governmental agency, department, or board. With Client’s permission, however, Attorneys may elect to appear at such administrative proceedings to protect Client’s rights. If Client wishes to retain Attorneys to provide any legal services not provided under this Agreement for additional compensation, a separate written agreement between Attorneys and Client will be required.

5. FEES

- a. Client will pay Attorneys’ fees (“Attorneys’ Fees”) of:
 - i. For any monetary settlement or recovery, or any non-monetary recovery, that Attorneys obtain for Client, Attorneys shall be entitled to twenty-five percent (25%), including twenty-five percent (25%) of the value of any non-monetary settlement or recovery, provided that such fee will be paid only by money recovered from defendants. However, if money recovered from defendants is less than twenty-five percent (25%) of the value of any non-monetary settlement or recovery, Client is not responsible for paying Attorneys any money other than what has been recovered from

defendants.

ii. Client understands and acknowledges that Attorneys are co-counsel in this Action and are entitled to share in the Attorneys' Fees. Client understands that this Agreement will not increase the total amount of attorneys' fees owed to Attorneys by Client. Client understands and acknowledges that the Attorneys' Fees will be shared as follows:

1. Wagstaff & Cartmell, LLP	25%
2. Beasley Allen Crow Methvin Portis & Miles, P.C.	25%
3. Goza & Honnold, LLC	25%
4. Kirton McConkie PC	25%

- b. For determining the Attorneys' Fees as outlined in paragraph 5(a), the date of recovery shall be the date that monies are paid or non-monetary value conveyed by defendants as a result of the Action, whether through settlement, judgment, or other means, rather than the date such monies are promised, agreed, or ordered to be paid.
- c. Contingency fee rates are not set by law but have been negotiated. If no recovery is made, no fees will be charged.
- d. The contingent fee is calculated as a percent of any settlement or recovery prior to the deduction of any expense or cost, i.e., the "Gross Recovery," unless prohibited by law or Court rule. If Client and Attorneys disagree as to the fair market value of any non-monetary property or services included in the Gross Recovery, Attorneys and Client agree that a binding appraisal will be conducted to determine this value.
- e. The Gross Recovery shall include, without limitation, any monetary payments, or the fair market value of any non-monetary property and/or services to be transferred and/or rendered for the benefit of the District, agreed or ordered to be made by the adverse parties or their insurance carriers as a result of the Action, whether by settlement, arbitration award, court judgment (after all appeals exhausted), or otherwise. Any statutory attorneys' fee paid by defendants shall be included in calculating the Gross Recovery.
- f. If, by judgment, there is *no* monetary recovery and District receives nonmonetary or "in kind" relief, Attorneys acknowledge that District is not obligated to pay Attorneys' Fees from public funds for the value of the in kind relief. In the event of in kind relief by judgment, Attorneys' sole source of recovery of contingent fees will come from a common fund or court ordered attorneys' fees.
- g. District agrees the defendants shall pay all attorneys' fees in a settlement that includes only nonmonetary relief. Client understands that Attorneys have and will invest resources into prosecuting this action on behalf of the Client and Client agrees to make a good faith effort to include attorneys' fees for Attorneys as part of the terms of any settlement or resolution of the Action.

6. FEDERAL MDL AND STATE COORDINATION FEE ASSESSMENTS

- a. In the event there is a Court ordered assessment or agreement for fees and costs required to be paid to any current or future Federal Multidistrict Litigation (MDL) or any State Court coordinated proceedings, which typically ranges from 6% to 9% of the gross proceeds, any such assessment will be paid from Client's share of any recovery proceeds as part of the costs and expenses advanced, unless otherwise ordered by the Court or prohibited by law or Court rules. At this time, Attorneys

cannot determine what Court ordered assessment, if any, will be paid to an MDL or to a State Court coordinated proceeding.

- b. District understands that additional Attorneys' Fees and/or litigation expense reimbursement(s) may be received by Attorneys from common benefit fund(s) or plaintiff's steering committee discretionary funds from an MDL or State Court coordinated proceeding, Attorneys' representation of other claimants in this litigation, or from other sources. District agrees and understands that the Attorneys' Fees set forth above in Section 5 shall be recoverable to Attorneys in addition to and notwithstanding such other fees, and that Attorneys' Fees are calculated prior to the assessment of any Court ordered assessment, i.e., from the Gross Recovery.

7. SETTLEMENT

Client has the authority to accept or reject any final settlement amount after receiving the advice of Attorneys. District understands settlements are a "compromise" of its claim, and that Attorneys' Fees, as outlined in Section 5 above, apply to settlements. For example, if a settlement is reached, and includes future or structured payments, Attorneys' Fees shall include its contingent portion of those future or structured payments.

8. ASSOCIATE COUNSEL

- a. District agrees that Attorneys may, in their discretion, employ associate counsel to assist in prosecuting District's claim, and District agrees to the participation of any lawyers that Attorneys may choose to involve in District's case. With the exceptions set forth below, payment of Attorneys' Fees to any such additional counsel will be the responsibility of Attorneys and will not increase the total Attorneys' Fees to be paid by District. Appropriate costs and expenses incurred by any such additional counsel on District's behalf, however, will be chargeable to District on the same terms (set out in this Agreement) as costs and expenses incurred on District's behalf by Attorneys.
- b. In some instances, it may be necessary for Attorneys to retain special outside counsel to assist on matters other than prosecuting District's claim for damages. Examples of such instances include the following: a defendant may seek bankruptcy protection and District seeks bankruptcy counsel that affects District's claim; or a complex, group settlement may require an ethics opinion from outside counsel; or special action in probate court may be necessary. District understands that Attorneys do not specialize in these areas of the law and agrees that Attorneys may retain such special outside counsel to represent District when Attorneys deem such assistance to be reasonably necessary. District understands that the fees for such counsel will be deducted from District's share of the recovery.

9. REASONABLE FEE IF CONTINGENT FEE IS UNENFORCEABLE OR IF ATTORNEY IS DISCHARGED BEFORE ANY RECOVERY

In the event that the contingent fee portion of this agreement is determined to be unenforceable for any reason or the Attorneys are prevented from representing Client on a contingent fee basis, Client agrees to pay a reasonable fee for the services rendered. If the parties are unable to agree on a reasonable fee for the services rendered, Attorneys and Client agree that the fee will be determined by arbitration proceedings before a mutually agreed upon neutral affiliate with the Judicial Arbitration and Mediation Services (JAMS); in any event, Attorneys and Client agree that the fee determined by arbitration shall not exceed twenty-five percent (25%) of the Gross Recovery as defined herein.

10. NO GENERAL FUND PAYMENTS

Notwithstanding any other provision in this Agreement, in no event will the Client be required to pay legal fees out of any fund other than the monies recovered from defendants in this litigation. Under no

circumstances shall Client's own funds be obligated to satisfy the Attorneys' Fees as a result of the Action or this Agreement.

11. COSTS AND EXPENSES

In addition to paying Attorneys' Fees, Client shall reimburse Attorneys for all "costs/expenses," which include but is not limited to the following: process servers' fees, fees fixed by law or assessed by courts or other agencies, court reporters' fees, messenger and other delivery fees, parking, investigation expenses, consultants' fees, expert witness fees, travel expenses, and other similar items incurred by Attorneys. The costs/expenses incurred that Attorneys advance will be owed in addition to Attorneys' Fees and Client will reimburse those costs/expenses after Attorneys' Fees have been deducted, unless prohibited by law or Court rule. If there is no recovery, Client will not be required to reimburse Attorneys for costs/expenses. In the event a recovery is less than incurred costs/expenses, Client will not be required to reimburse Attorneys for any costs/expenses above and beyond the recovery.

12. SHARED EXPENSES

Client understands that Attorneys may incur certain expenses that jointly benefit multiple clients, including, for example, expenses for travel, experts, and copying. Client agrees that Attorneys shall divide such expenses equally, or pro rata, among such clients, and deduct Client's portion of those expenses from Client's share of any recovery.

13. DISBURSEMENT OF PROCEEDS TO CLIENT

- a. The proceeds of any settlement, judgment or recovery on District's behalf under the terms of this Agreement shall be disbursed to District as soon as reasonably practicable after receipt by Attorneys. At the time of disbursement of any proceeds recovered on District's behalf under the terms of this Agreement, District will be provided with a detailed disbursement sheet reflecting the method by which Attorneys' Fees have been calculated and the expenses of litigation which are due to Attorneys from such proceeds. Attorneys are authorized to retain out of any monies that may come into their hands by reason of its representation of District the fees, costs, expenses and disbursements to which they are entitled as determined in this Agreement.
- b. It is possible that payment to the Client by the adverse parties to the Action or their insurance carrier(s) or any third-party may be deferred, as in the case of an annuity, a structured settlement, or periodic payments. The Attorneys' Fees will be paid out of the initial payment if there are sufficient funds to satisfy the Attorneys' Fees. If there are insufficient funds to pay the Attorneys' Fees in full from the initial payment, the balance owed to Attorneys will be paid from subsequent payments to Client before there is any distribution to Client.

14. LIEN

In the event any third-party attempts to lien any proceeds recovered in this Action, Client hereby grants, and agrees, to the extent permitted by law or Court rule, that Attorneys hold a first priority and superior lien on any and all proceeds recovered from defendants in the Action in the amount of the Attorneys' Fees and costs that the Attorneys are entitled to under this Agreement. This lien right is limited to only those monies recovered from defendants and in no way affects any other rights of Client in any way whatsoever.

15. DURATION

This Agreement shall cover the period from date of execution until the termination of the Action or termination of the legal services rendered hereunder, whichever is sooner. This Agreement may be terminated by District upon at least 10-days' notice, and in the event of such termination, neither party shall have any further rights against the other, except that in the event of a recovery by District against the

defendant(s) subsequent to termination, Attorneys shall have rights in the nature of *quantum meruit* to recover fees, costs and expenses reasonably allocable to its work prior to termination. In the event of termination of this Agreement for any reason, Attorneys shall immediately return to District all materials and documents of every kind and nature, including but not limited to District documents and computer disks, relating to this Agreement and the Action. Attorneys may withdraw as District's attorneys at any time if they determine, in their sole discretion, that District's claim lacks merit or that it is not worthwhile to pursue District's claim further.

16. DISCLAIMER OF GUARANTEE

Nothing in this Agreement and nothing in Attorneys' statements to Client will be construed as a promise or guarantee about the outcome of Client's matter. Attorneys make no such promises or guarantees. Attorneys' comments about the outcome of Client's matter are expressions of opinion only.

17. MULTIPLE REPRESENTATIONS

- a. District understands that Attorneys do or may represent many other individuals/entities with actual or potential claims in the Action. Attorneys' representation of multiple claimants at the same time may create certain actual or potential conflicts of interest in that the interests and objectives of each client individually on certain issues are, or may become, inconsistent with the interests and objectives of the other. As attorneys, Attorneys are governed by specific rules and regulations relating to Attorneys' professional responsibility in Attorneys' representation of clients, and especially where conflicts of interest may arise from Attorneys' representation of multiple clients against the same or similar defendants, Attorneys are required to advise Attorneys' clients of any actual or potential conflicts of interest and obtain their informed written consent to Attorneys' representation when actual, present, or potential conflicts of interest exist. By signing this Agreement, the District is acknowledging that they have been advised of the potential conflicts of interest which may be or are associated with Attorneys' representation of District and other multiple claimants and that District nevertheless wants Attorneys to represent District, and that District consents to Attorneys' representation of others in connection with the Action. Attorneys strongly advise District, however, that District remains completely free to seek other legal advice at any time even after District signs this Agreement.
- b. With regards to only Kirton McConkie PC ("Kirton"), Kirton is a law firm with a broad practice representing a large and diverse client base in Utah. Kirton's clients span a wide range of matters and industries. If a Kirton client takes a position that is adverse to you, it is possible that a conflict of interest might arise that would limit Kirton's ability to represent you. In order to be fair to all Kirton clients, you agree that you will not object to Kirton's representation of parties with interests adverse to you, and Kirton may represent other parties, in matters that are substantially unrelated to Kirton's services to you, and you hereby consent to any actual or potential conflict of interest arising out of such existing or future matter. This consent does not extend to any conflict that is not waivable under the Rules of Professional Conduct. In addition, Kirton agrees that the firm will not disclose or use any confidential non-public information received from you except in connection with the specific matter for which such information was provided, and you agree the actual or possible possession by Kirton of your confidential information shall not be the basis for the disqualification of Kirton from representing other parties. The District agrees that Kirton may represent an existing or new client, even if the matter requires that we take a position that is or might be directly adverse to the District or an affiliate of the School District (such as an Interlocal Agency), provided that the engagement is not prohibited by law, is not substantially related to the subject matter of any services we are providing to the District currently or have provided to the District in the past, and will not require disclosure of any of the District's confidential information.

18. AGGREGATE SETTLEMENT

Often times in cases where Attorneys represent multiple clients in similar litigation, the opposing parties

or defendants attempt to settle or otherwise resolve Attorneys' cases in a group or groups, by making a single settlement offer to settle a number of cases simultaneously. There exists a potential conflict of interest whenever attorneys represent multiple clients in a settlement of this type because it necessitates choices concerning the allocation of limited settlement amounts among the multiple clients. However, if all clients consent, a group settlement can be accomplished and a single offer can be fairly distributed among the clients by assigning settlement amounts based upon the strengths and weaknesses of each case, the relative nature, severity and extent of injuries, and individual case evaluations. In the event of a group or aggregate settlement proposal, Attorneys may implement a settlement program, overseen by a referee or special master, who may be appointed by a court, designed to ensure consistency and fairness for all claimants, and which will assign various settlement values and amounts to each client's case depending upon the facts and circumstances of each individual case. District authorizes Attorneys to enter into and engage in group settlement discussions and agreements which may include District's individual claims. Although District authorizes Attorneys to engage in such group settlement discussions and agreements, District will still retain the right to approve, and Attorneys are required to obtain District's approval of, any settlement of District's case.

19. ENTIRE AGREEMENT

It is expressly agreed that this Agreement represents the entire agreement of the parties, that all previous understandings are merged in this Agreement, and that no modification of this Agreement shall be valid unless written and executed by both parties.

20. SEVERANCE CLAUSE

It is expressly agreed that if any term or provision of this Agreement, or the application thereof to any person or circumstance, shall be held invalid or unenforceable to any extent, the remainder of this Agreement, or the application of such term or provision to persons or circumstances other than those to which it is held invalid or unenforceable, shall not be affected thereby; and every other term and provision of this Agreement shall be valid and shall be enforced to the fullest extent permitted by law.

21. COUNTERPARTS

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which, taken together, shall constitute one and the same instrument. Facsimile or PDF versions of this Agreement shall have the same force and effect as signature of the original.

The above is approved and agreed upon by all parties.
