The Board of Education of Jordan School District met in study, general, and closed sessions on Tuesday, December 12, 2023, beginning at 4:03 p.m. at JATC South (Board Conference Room), 12723 S. Park Avenue (2080 West), Riverton, Utah. The sessions were also provided electronically via YouTube.

President Miller presided and conducted. The Board of Education met in a study session to discuss the following:

**A. Comprehensive Guidance Report**

Stacey Worthen, secondary counseling consultant in Student Services, presented the annual report on the Comprehensive Guidance Program in the District. Ms. Worthen shared statistics from quarter one of the 2023 school year, highlighting the student to counselor ratio, the number of student counseling sessions held, and the types of visits for each level. She emphasized the increase in student to counselor ratio, pointing out the exceptional 1:1,192 ratio at the elementary level and the 1:302 at the secondary level. Ms. Worthen noted there were 24,933 elementary and 45,882 secondary school counseling visits so far this year, with a focus on school-based mental health for elementary students and career advising for secondary students.

Ms. Worthen said the focus on mental health has made a difference, especially in multilingual learners. She explained that the Guidance department works with parents to provide students with help and resources.

Mr. Dunford arrived at 4:19 p.m. and joined the meeting in session.

**B. Review of Administrative Policy AA447 Out-of-District Student Enrollment**

Brad Sorensen, Administrator of Schools, said Policy AA447 was last revised in 2009 and is largely irrelevant. He said it refers to the Wasatch Front Consortium which no longer exists and relevant portions of the policy have been addressed in other policies or can be found on the Student Services website.

Dr. Godfrey said the District follows State Board Rule regarding out-of-District student enrollment and Board members agreed to retire the policy and to add this item to the January 23, 2024 Board meeting agenda for a vote.

**C. Discussion on Administrative Policy DE501 Curriculum Adoption and Review Committee**

Carolyn Gough explained that the first draft of policy DE501 was updated to align with recent Utah legislation (SB55) and to reflect Board members suggestions from the previous study session discussion. The policy gives direction for both primary and supplemental learning materials and gives guidelines regarding the establishment of a Curriculum Advisory Committee.

Board members discussed the balance of staff and community members on the Committee and suggested wording revisions. Ms. Gough said she hopes to begin implementation in the spring with training teachers on policy expectations.

After discussion, Board members agreed to the current version of the policy with a few minor wording changes. The revised policy will be brought to the January 23, 2024 Board meeting for a vote.

**D. Discussion on Timeline for Potential Boundary Change for Aspen Elementary School**

President Miller said a request for a Spanish DLI program was discussed in the October 2023 Board study session. The next step was to send out an interest survey to the community near Aspen Elementary School. It was decided to table the DLI discussion at this time due to the fact that a new school in that area may result in a boundary change.

Dr. Anderson said enrollment is growing in the Aspen Elementary School area and said the potential boundary change notification had been sent recently to families in the following boundaries: Aspen Elementary School, Bastian Elementary School, Herriman Elementary School, Oak Leaf Elementary School, and Silver Crest Elementary School. The notification was also sent to Herriman and South Jordan Cities and Salt Lake County.

The Board discussed potential timelines, boundary decisions affected by a DLI decision, the needed time to prepare for a school DLI program, busing for DLI students, and the potential of adding a DLI program to another school in that area.

**MOTION:** It was moved by Niki George and seconded by Marilyn Richards to take from the table the motion regarding a survey about a possible Dual Language Immersion (DLI) Program at Aspen Elementary School. The motion was approved unanimously.

**FOLLOW-UP**

**MOTION:** It was moved by Bryce Dunford and seconded by Marilyn Richards to direct staff to move forward with a DLI interest survey to the net they deem appropriate.

Dr. Godfrey clarified that the survey would ask if there was interest in a DLI program at Aspen Elementary School. However, survey results could determine where the program would be placed. He added that there is a need to create a balanced enrollment in a DLI program.

Mr. Dunford suggested including the new elementary school on the survey as a possible choice for a DLI program. He made the following motion:

**AMENDED**

**MOTION:** It was moved by Bryce Dunford and seconded by Darrell Robinson to direct staff to move forward with an interest survey regarding adding a DLI program at either Aspen Elementary School or the new elementary school to the net administration deems appropriate.

Lisa Dean said she prefers listing only Aspen Elementary School on the DLI interest survey since Aspen Elementary School Community Council members requested the program. She made the following motion:

**SUBSTITUTE**

**MOTION:** It was moved by Lisa Dean and seconded by Marilyn Richards to direct staff to move forward with an interest survey regarding adding a DLI program at Aspen Elementary School to the net they deem appropriate.

President Miller said that the School Community Council for Aspen Elementary School could also be assumed to include the new elementary school. She called for vote on the substitute motion. The motion failed with a vote of five to two. Ms. Dean and Ms. Richards cast the dissenting votes.

President Miller called for a vote on the former amended motion. The motion was unanimously approved.

Board members agreed to sending out a DLI interest survey as soon as possible with results to be brought back to the January 9, 2024 Board meeting.

**E. Continued Discussion on Funding Options for New Elementary School in South Jordan**

Bryce Dunford, Finance Committee chair, gave a reminder that Board members were given a funding tool, created by Business Administrator John Larsen, to assist them in making an informed decision about funding options for the new school.

Mr. Larsen said a lease revenue bond would be a very appropriate funding option and Mr. Dunford and Ms. Richards agreed.

**MOTION:** It was moved by Bryce Dunford and seconded by Marilyn Richards to direct staff to move forward with a lease revenue bond for the new elementary school in South Jordan.

President Miller said a lease revenue bond would eliminate the need to raise taxes and Mr. Larsen specified that this type of bond can only be used for large projects or new buildings, but less restricted money could be used on other projects.

President Miller called for a vote on the motion regarding moving forward with a lease revenue bond. The motion passed unanimously.

Mr. Larsen said he will begin working with a financial advisor and bond counsel, but there will be several other discussions, votes, and a public hearing before it is finalized. He commended the Board for using "very appropriate" lease revenue bonds in the past, which have saved tax payers a lot of money.

**F. Revisions to Board Policy GP110 *Public Participation at Board Meetings***

President Miller said this item had been discussed in a previous Board meeting and has been revised per Board members' suggestions.

The Board discussed time allotted to elected officials and when it would be appropriate for these individuals to address the Board. It was decided to add their group to item C1 which mentions patron comment being allotted "first to residents of Jordan District, students, parents/guardians of current

students, and current employees of the District.” Elected officials will also be given the standard three minutes to address the Board.

President Miller said the revised Policy GP110 will be brought for a vote in the January 23, 2024 Board meeting.

At 6:07 p.m., the meeting adjourned. The general session started at 6:35 p.m.

Reverence was given by Derreck Sorensen, a student at JATC South.

### **Celebrating Jordan Academy for Technology and Careers (JATC)**

Julia Freire Sabino, Student Council President of JATC North; and Chayse Robison, Student Council President of JATC South, presented information to the Board about the good things happening at these schools and reviewed some of the programs and activities in which students and faculty members participate.

### **Board Member Recognitions**

Darrell Robinson recognized Herriman High School Cross Country Team for making history as the first team in Utah ever to place first in the Nike Cross Nationals in Portland, Oregon. Team coaches Doug and Teresa Soles thanked the athletes, their parents, and Principal Todd Quarnberg for their support. The team members introduced themselves and were applauded for their efforts: Jack Beckstrom, Jonah Tang, Tayshaun Ogomo, Max Hofheins, Micah Tang, William Steadman, and Hyrum Wood.

Lisa Dean attended the Majestic Arts Academy Winter Gala and said it was extraordinary. She attended the opening of the District’s second Family Engagement Center at Joel P. Jensen Middle School and highlighted the English classes that are taught to newcomer families.

Tracy Miller visited the Copper Mountain Middle School Family Engagement Center and the Majestic Arts Academy Gala. She said she was honored to be a judge at the “We the People” competition at South Jordan Elementary School and recognized the efforts of all those involved. She also attended the Hidden Valley Middle School production of “Frozen” and said it was great that, with two separate casts, so many students could be involved.

### **Superintendent’s Recognitions**

Dr. Godfrey recognized all the efforts to make the Jordan Education Foundation’s annual “Christmas for Kids” event a tremendous success. He emphasized it helps students in need while creating connections between them and volunteers. He called it “life-changing” for everyone involved.

Shauna Robertson, a teacher, wrote that teachers should be trusted as professionals to develop meaningful, rigorous, and inclusive curricula for students.

Aimee Rodriguez Dinehart, a teacher, disagrees with those who are advocating for a dual language program at Aspen Elementary School. She does not believe it will help English language learners and said additional volunteers, bilingual teachers, and community-building activities would be more beneficial.

#### IV. **Special Business**

##### A. **BUDGET HEARING: Recommendation to Approve Amended Budget for the 2023-24 Fiscal Year**

Business Administrator John Larsen pointed out that the 2023-24 revised budget reflects items that are being carried over from last year in the following areas: TSSA, Trust Lands, grants, and federal ESSER funding. Five areas of the budget were amended, namely: 1)The “unassigned” balance that was moved into the instruction area has been moved back to “unassigned”, 2) carry-over funds are included, 3) grants have been updated to show revenues and expenditures, 4) District initiatives are included, and 5) there was an increase in the school postage budget.

Mr. Larsen recognized Jason Mott, senior accountant, and thanked him for his work on the amended budget report.

##### Public Comment

No patrons signed up to address the Board regarding this Special Business item and no patrons accepted the invitation to speak.

**MOTION:** It was moved by Bryce Dunford and seconded by Lisa Dean to approve the Amended Budget for the 2023-24 Fiscal Year. The motion passed unanimously.

#### V. **Information Items**

##### A. **Superintendent’s Annual Report to the Board of Education**

Superintendent Godfrey presented his annual report to the Board, noting the responsibility of serving over 9000 employees, 50,000 students, families and stakeholders. He highlighted the recent Portrait of a Graduate survey which garnered over 20,000 responses which were largely very positive. He said his goal is to create an environment where everyone can be at their best. He expressed deep admiration and respect for those he works with, including Board of Education members.

Dr. Godfrey gave the following highlights for the year:

- The efforts to create a JSD Portrait of a Graduate and the positive feedback received
- Hiring a new General Counsel
- The success of the Supercast podcast, which received 1.8 million visits this year
- Expanded student opportunities including DLI programs, CTE Pathways, School AI, CTE and IB programs, and virtual learning
- Hiring a new School Safety Coordinator and training on revised emergency protocols

Dr. Godfrey pointed out that graduation rates over the past five years are higher than the past seven years. He acknowledged the success of the Walk-to-Read program, noting over 60 kindergarten through third grade teachers brought students up a full year of growth in literacy.

Board members expressed appreciation for the Superintendent and the great work he does in the District.

### A. **Committee Reports and Comments by Board Members**

Lisa Dean gave a reminder for the Jordan Ethnic Advisory Committee's "What I Wish You Knew" conference on January 16, 2024 at Bingham High School.

Darrell Robinson reported on the next Jordan Parent Advisory Committee meeting which will be held January 30, 2024. Dr. Anderson said he will send out a "save the date" invitation to all School Community Council chairs.

Niki George thanked everyone involved with the recent Jordan Legislative Breakfast, saying it was a big success.

President Miller reminded Board members of the USBA conference to be held January 4 through 6, 2024. She announced the Joint Legislative Committee will also hold a meeting on January 4, 2024 at Little America and she invited any Board members who are interested to contact her.

President Miller asked Board members if they wanted to send a holiday letter and all agreed. They also agreed to the following décor changes in the Board room at JATC South: 1) pictures hung on the walls of good things happening in the District (to be changed annually) and 2) removing the white board behind the dias.

**MOTION:** At 8:36 p.m., it was moved by Marilyn Richards and seconded by Lisa Dean to adjourn the meeting. The motion passed with a unanimous roll-call vote. The closed session began at 8:51 p.m.

President Miller presided and conducted. The Board of Education met in a study session to discuss the following:

**A. Portrait of a Graduate Update**

President Miller gave an update on the development of Portrait of a Graduate, sharing information with the Board about progress made thus far. She said Education Elements used community input for creating the Portrait and the next step is developing a Strategic Plan.

Darrell Robinson arrived at 4:04 p.m. and joined the meeting in progress.

Ms. Miller shared the Strategic Planning Timeline and announced another Design Day on January 25, 2024 where objectives will be refined and mission, vision, and values statements created. She explained five pillars of focus were drafted using community feedback: culture and belonging, staff and student wellness, meeting needs of diverse learners, high-quality instruction, and communication and decision making. The goal is to launch the plan in March or April of 2024 and ideas were discussed about how this might take place.

**B. Training on Standard Response Protocol**

Dr. Michael Anderson said the legislature recently approved HB61, which outlines measures schools must take to enhance safety and security, including adopting Standard Response Protocol (SRP). He invited Matt Alvernaz, School Safety Coordinator, to train Board members on SRP and inform them about steps taken to comply with State law.

Mr. Alvernaz reported that the Jordan Safety Manual and website have been updated, and training provided to administrators and school safety specialists. Monthly drills, preceded by drill preparation training, are taking place Districtwide and work is being done to train all employees on the new protocol.

Bryce Dunford arrived at 4:26 p.m. and joined the meeting in progress.

Mr. Alvernaz explained the following safety protocols and the emergency circumstances in which each would be needed: hold, secure, lockdown, avoid/deny/defend, evacuate, shelter, and reunification. He said communication to parents, students and staff following a drill or emergency must be accurate and should be timely. He noted additional resources can be found at <https://schoolsafety.jordandistrict.org> or <https://iluveuguys.org/The-Standard-Response-Protocol.html>.

Travis Hamblin stressed the importance of clear, concise, and consistent communication in a drill or emergency. He thanked local municipalities, fire departments, and law enforcement for their partnership with the District. He also said SRP training will be given to the Transportation and Auxiliary Services departments and to substitute teachers in Jordan.

### C. Results from the Dual Language Immersion (DLI) Survey

President Miller gave a brief reminder that the Board received a Spanish DLI request for Aspen Elementary School and the intent of this survey was to gauge interest in the program, even if a potential boundary change occurs.

Dr. Michael Anderson said the survey was open from December 18, 2023 through January 5, 2024. Of the 2,227 patrons at Aspen, Bastian, and Oak Leaf Elementary Schools, there were 298 responses. Additionally, 36 of 80 employees at Aspen Elementary School responded. Patrons were asked these questions and the overall results were as follows:

- 1) What is your level of interest in a DLI program at either Aspen Elementary School or the new school? (8.5)
- 2) If your student were assigned to a boundary school without a DLI program and busing was not provided, what would be your level of interest in a DLI program? (6.8)
- 3) If your child will be in first grade next year, would you be interested in having the student participate in a first grade Spanish DLI program? (8.4)

Board members discussed benefits to heritage speakers, the impact on teachers in the school where the program is placed, the effect of a boundary change on the DLI decision, and the deadline for the State DLI application.

Kaye Rizutto, DLI consultant in Teaching & Learning, mentioned the alternative to a traditional DLI program is a two-way program in which the State requires a minimum of twenty heritage speakers to enroll. The impact of a DLI program for both heritage speakers and DLI students was discussed.

**MOTION:** It was moved by Bryce Dunford and seconded by Darrell Robinson to begin the process for a one-way DLI program at Aspen Elementary School to begin in the fall of 2024 and to direct staff to begin the boundary change process immediately, with a potential vote in May of 2024.

Marilyn Richards asked about the process of establishing a dual language program and Ms. Rizutto said an application needs to be submitted to the State, parents need to be given time to apply, and a first grade teacher needs to be hired. The need to look at potential boundary change options in the next few months was also discussed.

President Miller called for a vote on the motion. The motion passed with a five to two vote as follows:

It was decided that staff will move forward in creating potential boundary change options where DLI survey information could be overlaid and Dr. Godfrey said the District would work to balance class sizes as the DLI program grows. Ms. Rizutto will submit the State DLI application and was encouraged to find a well-qualified teacher for the first grade program.

**D. Review of Administrative Policy D200 Philosophy of Instruction**

Dr. Godfrey said he had previously discussed a possible revision to Policy D200 with Board members. The policy requires advance notification to parents when guest speakers come to class. A suggestion was made to also require advance parent notification when guest speakers at assemblies are not employees of Jordan District.

Board members agreed with this addition, but requested a slight wording change to the draft version. The revised policy will be brought to the January 23, 2024 Board meeting for a vote.

**E. Board Meeting Calendar 2024-25**

Board members reviewed a draft of the 2024-25 Board meeting calendar and President Miller asked for feedback. The Board approved the calendar with the following revisions:

- The July 2024 Board meeting will be held July 30, 2024 and include a summer session earlier in the day.
- An additional tentative Board meeting will be scheduled for April 30, 2025 to discuss negotiations. It will be cancelled if not needed.

**F. Board Compliance with Open Meeting Law Training**

Paul Van Komen, Board Legal Counsel, gave a presentation on the Open Meeting Law to comply with the annual State requirements for Board members. He reviewed the following:

- The Open and Public Meetings Act (Utah Code 52-4-101 through 305)
- Requirements for an open meeting, including public notice
- Keeping written and recorded records of open and closed Board meetings
- Public participation at meetings
- Requirements for a closed meeting

Mr. Van Komen supplied Board members with a digital copy of the current USBA Open Meetings Handbook.

**G. Utah School Boards Association (USBA) Conference Debrief**

Tracy Miller, Board President, remarked how beneficial the recent USBA conference was for Board members. She invited those who attended to report on their favorite parts of the conference.

Darrell Robinson appreciated the keynote speaker, Dr. C. Shane Reese, President of Brigham Young University, and how pertinent his remarks were to the field of education. He also enjoyed classes on student courts, mental health, and the class by Jordan District on Artificial Intelligence (AI).

Marilyn Richards enjoyed the class on Embracing AI in the Classroom taught by Superintendent Godfrey and Jordan employees Jared Covili and Graham Bany. She was impressed with how Mr. Bany, a teacher at Valley High School, implements AI in the classroom. Ms. Richards also attended classes on legislative hot topics and the responsibilities of district business administrators.

Lisa Dean attended the Legislative Hot Topics class and learned strategies to build relationships with elected officials. She also learned about ways to address community mental health, enrollment strategies that work, and how to encourage students to enroll in special programs.

Niki George attended a class on student led peer courts and explained how it works. She attended a legal issues class which prompted a feeling of gratitude for Mr. Van Komen, legal counsel for Jordan.

Tracy Miller said Mr. Reece was one of the best keynote speakers USBA has had. She learned about property insurance increases in a State Risk class and indemnification in lawsuits regarding the sensitive materials bill. She thanked Dr. Godfrey, Mr. Covili, and Mr. Bany for their positive and informative AI presentation.

Dr. Godfrey attended a class that discussed employee engagement versus employee satisfaction. He said engagement is measured using a Gallup poll and other districts use this in their hiring process. He enjoyed time spent with other Board members at the conference.

John Larsen agreed with what others had mentioned and said he enjoyed the conference.

#### H. **Board and Superintendent Reports and Comments**

Marilyn Richards, Facilities Committee Chair, reported on construction of the new elementary school in Herriman. She said contractors have given assurance that the building is on schedule to open in the fall for the 2024-25 school year. She read a report from Scott Thomas, Auxiliary Services Administrator, detailing the progress on construction of the school, utilities, and parking lot.

Additionally, Ms. Richards reported on the following facilities-related items:

- The Elk Ridge pedestrian bridge will be taken down in March. Mr. Bergera is working on shuttles for students until the bridge is reinstalled.
- The Daybreak Village 9 sales agreement will be finalized in March and the design is out to bid.
- Summer Capital projects bids will be brought to the February Board meeting.
- The Board room painting project has been completed.
- Seismic reviews have not been received from the State yet. The federal grant has been approved, but there are issues with the funds.

Mr. Dunford, Finance Committee Chair, said a meeting will be held Friday to score the RFPs for an independent auditor. Currently, there is only one candidate.

Niki George, Government Relations Chair, announced that Board members are invited to lunch with legislators at the State Capitol on February 8, 2024. This will be combined with the USBA Day on the Hill. The legislator lunch with school student body presidents will be held February 22, 2024 at the Capitol. Board members discussed the repeal of R277-328 addressing educational equity in schools, and President Miller said a statement will be coming from USBA leadership soon.

Lisa Dean, Jordan Ethnic Advisory Committee (JEAC) liaison, announced that the Heroes Among Us Conference has been postponed due to forecasted weather. The What I Wish You Knew Conference will be held January 16, 2024 and all employees and Board members are invited.

Darrell Robinson, Jordan Parent Advisory Committee (JPAC) representative, said there will be a meeting on January 30, 2024 and notices have been sent. He discussed possible agenda topics and asked the Board if a third meeting should be held. Board members agreed to another JPAC meeting in the spring.

Dr. Godfrey asked the Board what topics they would like to include in the first Board Bulletin. It was decided to include the following and to send out the digital newsletter in February.

- DLI at Aspen Elementary School
- Involvement with the legislative session
- Portrait of a Graduate process and positive feedback received
- Standard Response Protocol

President Miller reported that Joint Legislative Committee (JLC) meetings will begin this Friday at 11:00 a.m. at the Granite District office. Dr. Godfrey said the agendas will be posted on the superintendent website at [www.ussaut.org](http://www.ussaut.org) and there will be a virtual meeting on Thursday nights where Board members can track the progress of legislative bills. Board members will receive a link for this meeting.

President Miller gave a reminder about the Jordan Education Foundation Donor Appreciation Luncheon on January 31, 2024 at 11:30 a.m. She said the Board is one of JEF's biggest donors.

Lisa Dean said Salt Lake County Parks & Recreation is requesting cooperation in advertising the "My County Rec Pass" that will be available to all students, ages 5-18.

Tracy Miller, Utah School Boards (USBA) representative, said the Board voted to renew Richard Stowell's contract as director of the organization. She said an email will be sent to Board members regarding a needs assessment for USBA. She reported that Jordan received the Master Board Certification Award as a district and presented the plaque to the Board.

Superintendent Godfrey said Health and Wellness Day is February 9, 2024. He said the intent is to do more for employees than ever before and with the Board's approval a meal and Swig treat will be given to each employee. Curriculum for students has also been enhanced. Dr. Godfrey announced that Jordan was asked to present on this topic at the National School Board Association conference in April. Mr. Robinson requested to attend the International Society of Technology in Education Conference in June and the Board approved this request. He also asked if the Board wants to discuss support for Governor Cox's cell phone initiative and it was recommended to add this to a future Board agenda.

As this is a big election year, President Miller briefly reviewed Policy DP381 *Employee Code of Ethics* as it pertains to campaigning. She reminded Board members to campaign outside of normal work hours and avoid using District email accounts, equipment, or the Jordan logo.

**MOTION:** At 8:34 p.m., it was moved by Marilyn Richards and seconded by Brian Barnett to go into closed session. The motion passed with a unanimous roll call vote.
