1. EXECUTIVE SESSION - BOARD ONLY

Discussion: An Executive Session was held prior to tonight's Work Session to discuss legal, personnel, and real estate matters.

2. COMMENCEMENT OF THE MEETING

Discussion: President Rice called the meeting to order at 7:04 p.m.

3. ROLL CALL

Discussion: Roll call was recorded by Board Secretary.

4. PLEDGE OF ALLEGIANCE

5. APPROVAL OF MINUTES

Discussion: The June 16th Board Meeting minutes were approved.

6. PRESENTATION

Discussion: Presenters: Brian Bingeman - Turf, Track & Court

Doug Gaby - Buchart Horn

Architects

Mr. Bingeman reviewed each of the change orders presented to the Board, beginning with the following general update on the project: Paving has been completed in preparation for the return of teachers and students, parking lots have been striped, and installation of the turf field has begun, with the expectation that the initial turf surface will be visible by the end of the week. While the project is slightly behind schedule due to the soil issues, they are making strides to get back on schedule. Mr. Bingeman shared that our noted credit for the MS Curb was (\$21,900) and was updated to be (\$22,850), reducing the net General Contractor Change Orders total to \$15,178.

The Board raised questions about design flaws, omission of items, and poor oversight of the project as a whole. The focus was predominantly on the following change orders:

- Add Emergency Egress Lighting – \$100,082
- Add Repairs to MS Parking Lights – \$20,093
- Add Downspouts to Field Houses – \$12,624
- Add Storm pipe on Adams St.–\$27,150

Several Board members addressed concerns about the lack of oversight on the project that has resulted in missed components and damage to the conduit below the MS parking asphalt during its

demolition. The primary concern is the omission of the Emergency Egress Lighting. The Emergency Egress Lighting is required by building code, and it was missed by the project management team and the vendor. The Board is looking for accountability regarding omission of the Emergency Egress Lighting. Regarding the conduit damage, Mr. Bingeman explained that when the original parking area was laid, the conduit was directly under the asphalt; there should have been 2-3 feet of stone between the conduit and the asphalt.

President Rice requested to receive a copy of the change order for the egress lighting to see the details warranting \$100,082, as that amount seems excessive.

The Change Orders will be on the August 18 Board Meeting agenda for Board approval. The Board plans to pull the three objectionable items and, if approved, will include in the motion the possibility of filing a claim against the appropriate company's errors and omissions insurance.

7. DISCUSSION ITEMS

7.A. BOARD MEMBER RESIGNATION

Discussion: President Rice shared that Director Brandy Shope has submitted her resignation from the Board.

7.B. BOARD VACANCY - PROCESS TO FILL VACANCY

Discussion: The Board discussed the following two options for how to fill the vacancy:

- Appoint someone known to be interested in joining the Board
- Open the vacancy to the WY community for submissions of Letters of Interest

We have 30 days from the approval of the resignation to fill the vacancy.

The decision is to open the vacancy to the WY community. Director Rice requested that the District communicate the vacancy to the community as quickly as possible. Depending on the volume of applicants, the Board will review submitted Letters of Interest and select a few to attend a Board Meeting and present themselves for the selection process.

7.D. CONTRACTS / AGREEMENTS

Discussion: NEW CONTRACTS/AGREEMENTS:

- **WellSpan Crisis Intervention Referral**

Agreement – This is a standard linkage agreement to streamline/improve efficiency of referrals to WellSpan's Crisis Intervention services. There is no cost to the District.

- **York Learning Center Resolution** – The resolution represents an acknowledgment of the scope and working components of the York Learning Center's Capital Project, including the funding model, and does not signify an authorization to proceed, which rests solely with the Authority Board. The YCL Capital Project Presentation is included in the attachments.

RENEWAL CONTRACTS/AGREEMENTS:

- **Aaron Solutions** – This agreement is for the toner and service for District Printers. This is a budgeted expense in the amount of \$17,000 for the year. The cost is the same as last year.
- **Austill's Educational Therapy Services Addendum** – This is an addendum to our December 22, 2022, updating contracted rates. The agreement provides outsourced Occupational, Physical, and Speech therapy for students placed in special educational settings outside the District when LIU staff are not available.
- **Community Progress Council Sponsor-to-Sponsor Agreement** – This annual agreement allows the Community Progress Council's Head Start & Pre-K Counts Programs to purchase school meals for its students and staff from the District for the 2026-2027 School Year. The Adult Breakfast Unit Price has increased to \$3.04 (\$0.34 increase) and Lunch Unit Price has increased to \$5.25 (\$1.00 increase). The Student Breakfast Unit Price has increased to \$2.54 (\$0.08 increase), and the Student Lunch Unit Price has increased to \$4.76 (\$0.16 increase). These meal rates are in line with the reimbursement they received through the National School Lunch Program. The number of days per year decreased by 4 days to 176.
- **LIU12 Tier One IT Support Services State of Work Agreement** – This agreement with LIU12 for Tier I (help desk) support services for the duration of the 2026-27 SY. LIU support will supplement existing WYASD IT staff on an "as needed" basis. The cost is \$70 per hour or \$550 per day.
- **LIU12 Title I LOA and Addendum B** – Together, this Letter of Agreement and Addendum with the Lincoln Intermediate Unit contracts the LIU to provide Title 1 non-public equitable services on the district's behalf. This confirms that the District will utilize the Lincoln Intermediate Unit for 2026-2027 Title 1

equitable services, with automatic renewals for the following 2 school years.

- **Pyramid Healthcare/Soaring Heights School –** This annual agreement for the 2026-27 school year allows for the placement of our students (K-12) with the most significant behavioral needs. Soaring Heights educates students with autism and emotional disturbance in a contracted out-of-district placement. The rate for Autistic Support/Emotional Support increased from \$350/day to \$357/day. The rate for 1:1 paraprofessional services increased from \$151.50/day to \$153/day. While we do not currently have any students scheduled to attend Soaring Heights for the coming school year, we are renewing the agreement so that it is in place should the need arise.
- **Specialized Education of PA/High Road School of York Agreement –** The agreement with High Road School of York is a renewal for two (2) prepaid placements (one less than last year) in their Emotional Support classroom. The cost increased from \$202 per day per student to \$218 per day per student.
- **Yellow Breeches Educational Center –** This item is to allow the District to utilize Yellow Breeches Educational Center as a placement option for one (1) student. This represents a reduction of two (2) placements from the prior school year. The rate per student increased from \$34,144 to \$35,510. The transportation increased from \$23,191 to \$24,119.

Ms. Holman presented and explained the WellSpan Crisis Intervention Referral Agreement.

Ms. Schlemmer provided insights into the YLC Resolution – The York Learning Center's facilities are in great need of repair and expansion. The model is to do partial renovations combined with rebuilding/expansion of the facility. Funding moves the amount we pay annually as a member organization from \$67,700 to \$100,000/year. Additionally, our fee per student will increase by \$7,200. We currently have 12 students attending YLC. These fees pay down their debt service. Our total annual increase will be \$186,000.

Director Gettys added that the current facility has the capacity for 130 students and the post-renovation capacity will be 200 students. They do great work at YLC, yet students do not want to attend there due to the current facility conditions. Non-member schools pay a

significantly higher rate and YLC expects to draw more non-member enrollments after the renovations are complete. After building a reserve for ongoing maintenance, excess funds could result in funds being returned to member schools.

7.E. DONATION

Discussion: Ms. Schlemmer presented the information on the donation received from Conductive Technologies for the WY Fall and Winter Cheerleaders.

7.F. DRIVER RECOMMENDATIONS 2026-27

Discussion: The list of proposed drivers was presented by Ms. Schlemmer. We do still have a few runs without drivers. Anyone interested is encouraged to reach out to Reliance Bus Services.

7.G. INSURANCE RENEWAL PACKAGE 2026-2027

Discussion: Ms. Schlemmer reviewed the insurance renewal package, highlighting that the Storage Tank Liability premium won't be available until October 1st. The Board will be updated at that time.

7.H. MIDDLE SCHOOL ATSI PLAN

Discussion: Ms. Holman presented the MS ATSI Plan and Board members were given a handout at their seats prior to the meeting of a user-friendly overview of the plan's details.

7.I. REDEVELOPMENT ASSISTANCE CAPITAL PROGRAM (RACP) GRANT

Discussion: Dr. Davies acknowledged that our RACP Grant application began back in 2022 and congratulated Ms. Schlemmer on continuing to pursue the grant that resulted in our receipt of the grant funds. We are partnered with York County Economic Alliance, who will act as a 'pass through' partner as required by the grant guidelines. We will receive the full award amount, less some minimal fees; there are no commissions or overhead fees to be paid out of the grant funds.

Summary

The West York Area School District's purpose is twofold: 1) create opportunities for our students to thrive, and 2) to develop world-class citizens.

WYASD is a public school entity located in south-central Pennsylvania serving approximately 3,000 students in kindergarten through 12th grade who live in the Borough of West York and the Township of West Manchester. The District maintains the following student counts per building:

- West York Area High School - 833 students
- West York Area Middle School - 649 students
- Trimmer Elementary School - 419 students
- Lincolnway Elementary School - 393 students
- Wallace Elementary School - 416 students

The West York Area School District (WYASD) wishes to contract with the Lincoln Intermediate Unit 12 (LIU) for Tier 1 (help desk) support services for the duration of the 2026-2027 school year, specifically during the beginning of the school year. LIU support will supplement existing WYASD IT staff on an "as needed" basis.

Project Description

This S.O.W. covers the following activities and deliverables.

Scope of Work

LIU will perform the following tasks.

1. Tier 1 IT Support Service - Help Desk

- Remote and onsite support of client workstations, including Chromebooks / iPads
- Workstation imaging and setup onsite support of all client device accessories
- Enrollment of client devices in a centralized management and inventory system
- Help Desk ticketing system access and monitoring

Terms and conditions of Tier One IT Support Service

- Support service must be scheduled at least two weeks in advance and is based on the availability of LIU staff.
- Maximum of one full day (8 billed hours) of support service can be provided per week.
- Service not available during the week of winter/holiday break.
- Support is available on weekdays (Monday - Thursday) from 7:30 AM - 4:00 PM, excluding dates in which the LIU offices are closed in observance of holidays.
 - Friday support is reserved for emergencies only.
 - Remote support may be available when the LIU offices are closed due to weather conditions depending on specific circumstances.
 - Weekend, after-hour, and holiday support is not covered under this agreement.
 - An addendum to this agreement can be provided for coverage during these extended hours.
- Emergency support requested outside of this timeframe will bill at \$90.00/hour and will incur travel time charges if onsite support is needed.
- Agreement covers Tier 1 (help desk) support only
- In the event that Tier 2 or Tier 3 IT support is needed, a supplemental agreement will be drafted and executed by both parties.
- Service will be invoiced monthly based on the number of hours utilized per calendar month.
- The service contract covers the period of SY26-27 (July 1, 2026 through June 30, 2027).
- Support to be provided on-site, or remotely via phone or support tools such as Microsoft Teams.
