RESOLUTION

A RESOLUTION OF THE BOARD OF SCHOOL DIRECTORS OF THE WEST JEFFERSON HILLS SCHOOL DISTRICT APPOINTING DR. JANET SARDON AS SUPERINTENDENT

WHEREAS, Dr. Janet Sardon maintains a valid Letter of Eligibility that qualifies her to be appointed as the Superintendent; and

WHEREAS, the Board of School Directors of the West Jefferson Hills School District desires to re-appoint Dr. Janet Sardon to the position of Superintendent.

NOW, THEREFORE, upon due notice, be it resolved by the Board of School Directors of the West Jefferson Hills School District as follows:

1. Janet Sardon is hereby appointed as Superintendent for a term from July 1, 2027 to June 30, 2032.
2. The Superintendent is appointed subject to the following conditions:
 - (a) She possesses the necessary qualifications to receive an appropriate commission from the Pennsylvania Department of Education, makes application for a commission with said Department, and maintains said commission in good standing during her term;
 - (b) She executes an employment agreement consistent with the requirements of 24 P.S. § 10-1073; and
 - (c) The employment agreement shall be executed prior to the start of the term.
