MANAGED SERVICES AGREEMENT

THIS AGREEMENT made and entered into this ____ day of April, 2020 between HIGHLAND TELEPHONE COOPERATIVE, INC., hereinafter referred to as the "Company, and hereinafter referred to as the "Customer".

WITNESSETH:

That for good and valuable consideration and the covenants and agreements hereinafter set forth, the parties agree as follows:

1. Company agrees to provide the following described equipment/service monthly:

This Agreement shall be for a term of sixty (60) months, commencing from date of signature. Should Customer cancel this Agreement prior to the expiration of the term, then Customer shall pay to Company all balances due under this Agreement through the end of the term. Company will provide initial instruction and training as may be reasonably necessary to employees of Customer in the operation of the equipment. All maintenance services on equipment shall be performed by the Company unless otherwise expressly authorized by Company. Customer agrees to immediately notify Company of any difficulties in the operation of the equipment. This agreement does not include applicable charges for telephone lines and broadband connectivity.

2. Customer assumes and will bear the entire risk of direct and consequential loss and damage to equipment or any part thereof from the date of delivery to the premises. Customer shall indemnify Company against and hold Company harmless from any and all claims, actions, suits, proceeding costs, expenses, damages and liabilities, including attorney's fees, claimed by any person, organization, and /or condition, directly or indirectly. This Agreement contains the entire Agreement between Company and Customer pertaining to services provided to the Customer. Any alteration or modification of the Agreement shall be in writing and signed by both parties. Customer agrees that no verbal representation of salesperson, agent, officer, or employees of the Company shall operate to vary the written terms hereof.
