**Teacher of the Month:** Amanda Kennedy (Pre-K)

**Pending Grant:** USDA CYFAR (Children, Youth, Families at Risk) Grant through the UT Ag Extension Office. This grant (pending for the 2020-2021 academic year) would fund an after-school program focused on social-emotional education for students, as well as programs for families. After-school enrichment activities may include STEM instruction for middle school students.

### **4H Mentoring Program**

Mr. John Taylor's description of the program is as follows:

"The 4-H Mentoring program is a federally funded program from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) through National 4-H Council. The purpose of the program to improve outcomes underserved youth and reduce negative outcomes, improve academic performance, and

reduce school drop-out rates through mentoring. The grant cycle will be May 2019 – April 2020. This will include 30 youth as mentees and 10 teen mentors."
