After deep reflection and research, we ask the Board to consider the following recommendations with rationales:

Morgan County School District will no longer contact trace exposures to COVID-19 positive cases. Since the onset of the pandemic in 2020, our district has worked closely with the TN Department of Health to quickly respond to, identify positives with close contacts, and communicate cases to families. It is now time to return this responsibility and authority back to public health officials.

Only students or staff with a confirmed positive COVID-19 test or those who have developed consistent COVID-19 symptoms will be asked to refrain from school attendance for up to 5 days. Parents and staff will be required to report these cases to school officials. Daily Positive Case Counts will be posted to the Morgan County Schools Facebook and website. Weekly new positive cases will be reported to the TN Department of Education District COVID Dashboard.

By modifying these quarantine practices our district feels strongly that:

1. The elimination of unnecessary quarantines will result in our students gaining a sense of overall academic stability while allowing schools to also attend to their social-emotional and physical well-being.
2. The burden placed on our administrative staff and nurses will be reduced so that their time is refocused to tasks directly related to teaching and learning and routine health needs in our schools.
3. Families will be empowered to make the best personal health choices for their household.

The following supportive measures for students who are isolated or quarantined will continue:

1. Free weekly meals will be available for pick up coordinated by our Nutrition Services.
2. Access to remote learning with the opportunity to participate live will be provided.
3. Graduation Coaches will partner with families to monitor their academics and lend attendance support.

1 *General*

2 The following guidelines shall be followed:<sup>1</sup>

- 3 1. Fundraising activities shall be authorized by the Board and shall be for the purpose of  
4 supplementing funds for established school programs and not for replacing funds which are the  
5 responsibility of the Board.
- 6 2. Fundraising companies and other salespersons shall obtain permission in writing from the  
7 Director of Schools' office in order to visit the schools.
- 8 3. Any commission payable by companies shall be paid in the form of reduced prices to the students  
9 or paid into the activity fund of the school for use by the school. No school employee shall  
10 personally benefit from any fundraising activity.
- 11 4. The principal shall obtain written approval from the Director of Schools/designee for all  
12 fundraising activities, including online fundraising activities, that involve the participation of the  
13 general student population in the marketing process of the fundraising effort. All other  
14 fundraising activities, including online fundraising activities, shall have written approval from  
15 the principal and comply with all administrative procedures issued by the Director of Schools.  
16 The authorization request shall contain the following information:<sup>2</sup>
- 17 a. A list of the proposed fundraising activities;
- 18 b. Purpose of the fundraising activity;
- 19 c. Proposed uses of funds raised;
- 20 d. Expected student involvement in fundraising activity (school-wide, individual class, or  
21 club); and
- 22 e. Margin of profit and how it is to be paid to the school.
- 23 5. The Director of Schools shall determine whether or not the activity will benefit the school,  
24 contribute to the welfare of the student body, and supplement, not replace, funds necessary to  
25 fulfill the Board's required contributions.
- 26 6. Students shall not be excused from a regular class to participate in a fundraising activity. No  
27 grade in a subject or course shall be affected by a student's participation in a fundraising activity.

1           7. No quotas shall be imposed on students involved, and their efforts shall be voluntary. Students  
2           who do not participate in fundraising activities shall not be punished or discriminated against in  
3           any way.

4           This policy shall not be construed as preventing a teacher from using instructional or informational  
5           materials even though the materials might include reference to a brand, a product, or a service.

## 6           **LOTTERIES**

7           No fundraising activity shall be conducted which distributes prizes or makes awards to winners from  
8           among purchasers of chances by means of tickets through a random selection process.<sup>3</sup>

## 9           **ONLINE FUNDRAISING**

10          Individual schools may establish school-wide online fundraising accounts. The accounts shall meet all  
11          fundraising requirements established by the Board and the *Tennessee Internal School Uniform*  
12          *Accounting Policy Manual*. The principal/designee of each school shall have access to the established  
13          fundraising account to ensure all funds are properly accounted for, and the information is recorded in  
14          the school's accounting records by the designated personnel. Online fundraising shall not be used on  
15          behalf and for the benefit of an outside party.

16          An employee shall not engage in online fundraising for educational purposes in his/her official  
17          capacity as a district employee or make any reference to non-school sponsored fundraisers, online or  
18          otherwise, that would lead another to believe such activity is an approved school fundraiser.

## 19          **FUNDRAISING FOR NONEDUCATIONAL PURPOSES<sup>4</sup>**

20          On approval of the principal, an employee may be authorized to raise and use funds for the following  
21          noneducational purposes:

- 22           1. Bereavement support;
- 23           2. Award recognition;
- 24           3. Employee morale;
- 25           4. Banquets; or
- 26           5. Other situations at the principal's discretion.

31          These funds shall be derived from vending machine revenue, donations, or **[insert additional sources**  
32          **that an employee could use to raise funds]**.

33          The Director of Schools shall develop administrative procedures regarding the receipt, disbursement,  
34          accounting, and auditing of these noneducational funds. The Director of Schools shall ensure that the  
35          procedures are consistent with board policy and state law and disseminate them to all employees.

1 All purchases of supplies, materials, equipment, and contractual services in excess of ten thousand  
2 dollars (\$25,000), including those of individual schools, shall be based on competitive bids.<sup>1</sup> These bids  
3 shall be solicited by advertisement in a newspaper of general circulation in the district. However, said  
4 newspaper advertisement may be waived by the purchasing agent in an emergency.<sup>2</sup> The purchasing  
5 agent shall advertise for bids and receive quotations. The principal shall serve as purchasing agent in  
6 each school.<sup>1</sup>

7 RFP documentation, board approval, and the finance office will review prior to any purchase(s)  
8 exceeding ten thousand dollars (\$25,000). This policy will pertain to both federal and general purpose  
9 program purchases that exceed ten thousand dollars (\$25,000).

10 All purchases of ten thousand dollars (\$25,000) or less, including those of individual schools, may be  
11 made in the open market without newspaper notice, but shall, whenever possible, be based on at least  
12 three (3) competitive bids or obtaining a sole source statement.<sup>2</sup>

13 The lowest and best bid shall be accepted, provided the Board reserves the right to eject any or all bids  
14 or any part of any bid and, if applicable, to accept that bid which is best as evidenced by reasons relative  
15 to the purpose of the purchase.<sup>3</sup> Any bid may be withdrawn prior to the scheduled time for the opening  
16 of bids. Any bid received after the time and date specified shall not be considered.

17 The bidder to whom the award is made may be required to enter into a written contract.

18 The practice of splitting an order or dividing items to be purchased in order to avoid the use of bidding  
19 or other purchasing procedures is prohibited.

## 20 **Contracted Services**

21 In some situations, certain jobs or specific work tasks may require outsourcing. Any additional work  
22 required by various school departments will require a written contract and must be approved in advance  
23 by the Director of Schools or his/her designee.

## 24 **Exemptions from Competitive Bidding**

25 Contracts for legal services, educational consultants, and similar services by professional persons or  
26 groups of high ethical standards shall not be based upon competitive bids but shall be awarded on the  
27 basis of recognized competence and integrity.<sup>4</sup>

1 Students who have met graduation requirements are expected to participate in graduation activities. If  
 2 extenuating circumstances exist at any school, the matter shall be presented to the Board prior to  
 3 graduation activities.

4 Students who do not wish to participate in graduation activities shall notify the school principal in writing  
 5 at least five (5) days prior to the day of graduation. Non-participating students shall receive their  
 6 diplomas or certificates from the principal’s office within one (1) week of the day of graduation.

7 Graduation apparel shall be determined by the administration of each school and shall be the personal  
 8 expense of each student. Any fees required for graduation shall be waived for students who are eligible  
 9 to receive free or reduced-price lunches, and in such cases, the school shall assume responsibility for  
 10 payment of fees.<sup>2</sup>

11 Graduation shall be physically accessible to all students, their parent(s)/guardian(s), and other interested  
 12 citizens.<sup>3</sup>

13 Graduation activities organized by district employees shall not be religious in nature.<sup>4</sup> The content of  
 14 any students' speeches shall not reflect the endorsement, sponsorship, position, or expression of the  
 15 school, employees, or Board.

16 The Director of Schools shall develop procedures to ensure that students are recognized at graduation  
 17 for the following achievements:<sup>5</sup>

- 18 • Honors;
- 19 • State Honors;
- 20 • State Distinction;
- 21 • District Distinction;
- 22 • Tri-Star Scholar;
- 23 • Students receiving a TN Seal of Biliteracy;
- 24 • Students voluntarily completing at least ten (10) hours of community service each semester the  
 25 student is in attendance at a public high school;
- 26 • Students receiving a gold or platinum medal on National Career Readiness Certificate; and
- 27 • Students graduating with a district-developed work ethic distinction.

1 Educational content which consists of religious themes shall be presented in a factual, objective, and  
2 respectful manner in accordance with the following guidelines:

3 1. Religious themes may be a part of the curriculum for school-sponsored activities and programs,  
4 provided it is essential to the learning experience in the various fields of study and is presented  
5 objectively;

6 2. The inclusion of religion shall be for educational purposes only;<sup>1</sup>

7 3. The emphasis on religious themes shall be only as extensive as necessary for a balanced and  
8 comprehensive study of the curriculum. Such studies shall never be used to proselytize, establish,  
9 foster, or demean any particular religion, religious tenets, or beliefs;<sup>1</sup> and

10 4. Student-initiated expressions to questions or assignments which reflect their beliefs or non-  
11 beliefs about a religious theme shall be accommodated.

1 Other than the routine transmission of administrative and personnel files, district employees are  
 2 prohibited from assisting a school employee, contractor, or agent in obtaining a new job if the individual  
 3 knows, or has probable cause to believe, that the person seeking a job change engaged in sexual  
 4 misconduct regarding a minor or student in violation of the law.<sup>1</sup>

5 These requirements shall not apply if:

- 6 1. The information giving rise to probable cause has been properly reported to the appropriate law  
 7 enforcement agency; and

- 9 2. The matter has been officially closed in one of the following ways:
  - 10
  - 11 a. The prosecutor or police have investigated the allegations and notified school officials  
 12 that there is insufficient information to establish probable cause;
  - 13
  - 14 b. The employee, contractor, or agent has been charged and either acquitted or exonerated;  
 15 or
  - 16
  - 17 c. The case remains open, and there have been no charges or indictment filed within four  
 18 (4) years of the date the information was reported to the law enforcement agency.

19 Neither the district nor the Board shall enter into, or require a current or former employee to enter into,  
 20 a non-disclosure agreement during a settlement for any act of sexual misconduct.<sup>1</sup>

21 The Director of Schools shall develop administrative procedures to enforce this policy and comply  
 22 with federal and state law.

1 Professional employees shall earn personal and professional leave at the rate of one (1) day for each half-  
2 year employed for a total of two (2) days per year. Any personal and professional leave remaining unused

4 If, at the termination of services, any employee has been absent for more days than leave has been earned,  
5 an amount sufficient to cover the excess days used shall be deducted from the employee's final salary

## 7 **PERSONAL LEAVE**

8 Subject to the following conditions, personal leave may be taken at the discretion of the employee:

- 9 1. Except in an emergency, each employee shall give the principal at least five (5) days' notice in

20 according to a school calendar adopted by the Board prior to the commencement of the

## 22 **PROFESSIONAL LEAVE**

23 Professional leave is a short, temporary absence for the purpose of attending workshops and other  
24 meetings relating to school business or serving on boards and commissions which meet during daytime  
25 hours when appointed by a mayor, city council, county executive, or county commission.<sup>4</sup>

1 Substitute teachers are those teachers used to replace teachers on leave or to fill temporary vacancies

4 Board.

5 Substitute teachers employed by third party entities shall be subject to the same unemployment benefit  
6 eligibility conditions as substitute teachers employed directly by the Board.<sup>2</sup>

## 7 APPLICATION/QUALIFICATIONS

8 Criminal history record checks and fingerprinting of applicants for substitute teaching are required.<sup>3</sup>

9 Applicants with revoked licenses or certificates according to the Department of Education shall not be  
10 hired.<sup>4</sup>

11 Qualifications for substitute teachers shall be determined by the Director of Schools in compliance with  
12 board policy, state laws, and State Board of Education rules and regulations.

13 A list of substitute teacher(s) will be prepared by the **[Director of Schools, Personnel Director, etc.]**  
14 who will maintain file(s) which may include transcripts, credentials, recommendations, and other  
15 pertinent information.

## 16 COMPENSATION

17 If employed directly by the district, the compensation of substitute teachers shall be determined annually  
18 by the Board.

19 Retired teachers serving as substitutes who do not have an active teaching license shall be paid the same  
20 as a retired substitute teacher with an active teaching license. This only applies to teachers who retired  
21 after July 1, 2011 through July 1, 2016.<sup>5</sup>

## 22 CERTIFICATION

23 When substituting for a regular teacher who has been absent for twenty (20) consecutive days, a  
24 substitute teacher shall possess a teaching certificate with endorsement in the discipline(s) to be taught  
25 or shall be a retired teacher that held the appropriate endorsement.<sup>6</sup> When substituting for a teacher  
26 without sick leave, the substitute shall be certified and paid according to the state salary schedule.<sup>1</sup>

1 Retired teachers may substitute one-hundred twenty (120) days per year without loss of retirement  
2 benefits<sup>1</sup> and may substitute for additional days if the Director of Schools certifies in writing to the  
3 Division of Retirement that no other qualified personnel are available to substitute teach.<sup>7</sup>

#### 4 **EMERGENCY NEEDS**

5 All teacher aides, secretaries, and clerks are approved substitute teachers for use in emergency situations.  
6 Emergency use shall be defined as less than a full day due to the regular or substitute teacher being  
7 unable to arrive on time or remain for the full day.

8 Said substitutes shall receive the proportionate equivalent salary regular substitute teachers would  
9 receive under similar circumstances or their regular salary, if higher; however, they shall not receive pay  
10 for both positions at the same time.

#### 11 **TRAINING AND ORIENTATION**

12 The Director of Schools shall be responsible for ensuring that there are appropriate training and  
13 development programs for substitute teachers.

#### 14 **RESPONSIBILITIES**

15 Substitute teachers shall assume the same responsibilities as the regular teacher, including but not limited  
16 to, bus duty and playground supervision.

#### 17 **RE-EMPLOYMENT/TERMINATION**

18 On an annual basis, the Director of Schools, with input from the principals, shall determine which  
19 substitute teachers performed at an acceptable level. Substitute teachers who performed below an  
20 acceptable level shall not be re-employed.

21 All substitutes shall be responsible for providing correct addresses and phone numbers and for notifying  
22 the principal and/or third-party employer if they wish to terminate their service as substitutes.

1 All full time personnel (30 hours or more per week) shall receive longevity pay as specified below:

- 2 • Longevity pay is based on the full time experience accumulated as per the previous year.
- 3
- 4 • A full time employee is considered any support employee that works more than 30 hours
- 5 per week or is considered a full time bus driver.
- 6
- 7 • All full time personnel shall receive one hundred (\$100) per year of service up to (20)
- 8 years.
- 9
- 10 • Support personnel must have been employed six (6) months, full time in a school year or
- 11 fiscal year to accumulate one (1) year of service for longevity pay purposes.
- 12
- 13 • If the employees work status changes from full time to part time (working less than 30
- 14 hours per week regularly), the employee will not be eligible for longevity the next year.
- 15
- 16 • A school year is defined as the time period beginning with the opening of school to the last
- 17 day of school as approved in Morgan County School Calendar for that year.
- 18
- 19 • A fiscal year is defined as the period beginning July 1st through June 30th of each year.
- 20
- 21 • Longevity pay or a year of experience pay is paid for one (1) support personnel position
- 22 only.
- 23
- 24 • If an employee transfers from one position to another position, longevity experience
- 25 transfer.
- 26
- 27 • All support personnel shall receive a check for the full amount due once each year in
- 28 November.
- 29
- 30 • If any support personnel quits or resigns their position, they have one year (365 days) to
- 31 return to employment and retain their accumulated longevity experience. After, one year
- 32 (365 days) they shall lose all longevity experience.
- 33
- If any support personnel is terminated from employment, they shall immediately lose all accumulated longevity experience.

1    **PROFESSIONAL PERSONNEL**

2    Professional personnel shall earn one (1) day of sick leave for each month employed during the school  
3    year, and these days shall accumulate for an unlimited number of days.<sup>1</sup>

4    Sick leave shall be defined as: illness of a teacher from natural causes or accident, quarantine, or illness  
5    or death of a member of the immediate family of a teacher, including the teacher's wife or husband,  
6    parents, grandparents, children, grandchildren, brothers, sisters, mother-in-law, father-in-law,  
7    daughter-in-law, son-in-law, brother-in-law, and sister-in-law.<sup>2</sup>

8    A signed statement listing the cause of absence shall be provided by the employee on forms furnished  
9    by the Director of Schools and shall promptly be given to the immediate supervisor in support of all  
10    claims for sick leave pay. A falsified statement shall be grounds for dismissal.

11    Documentation from a physician may be required in support of any claim for sick leave pay.

12    The principal shall notify the Director of Schools' office at once if an employee is sick beyond the limit  
13    of his/her sick leave accumulation.

14    Permanent, cumulative sick leave records for each active professional employee shall be kept in the  
15    Director of Schools' office.

16    A teacher, upon employment, may transfer his/her accumulated sick leave from another Tennessee  
17    school district, provided that the Director of Schools of the district in which the accumulated leave was  
18    held provides notarized verification.<sup>3</sup>

19    **SUPPORT PERSONNEL**

20    Support personnel shall earn one (1) day of sick leave for each month an employee is employed.

21    At the termination of the employment of any employee, all unused sick leave accumulated by the  
22    employee shall be forfeited.

23    The immediate supervisor may require documentation from a physician stating the reason for absence.

24    **SICK LEAVE BANK (if applicable)**

25    The purpose of the sick leave bank is to provide sick leave to all employees<sup>4</sup> who have suffered an  
26    unplanned personal illness, injury, or disability, and whose personal sick leave is exhausted.

- 1 To form a sick leave bank, a minimum of twenty (20) employees from the school district shall petition  
2 the Board for permission to establish a sick leave bank.<sup>5</sup> Upon approval, sick leave bank trustees shall  
3 be appointed and shall operate as the governing body of the sick leave bank and shall enact rules and  
4 regulations consistent with state law.<sup>6</sup> Employees wishing to participate shall initially give two (2) days  
5 of sick leave. These days are to be deducted from the employee's personal accumulation and donated to  
6 the sick leave bank. Donations of sick leave to the bank are nonrefundable and nontransferable.<sup>7</sup>
- 7 At any time the number of days in the sick leave bank is less than twenty (20), or one (1) per employee  
8 if there are more than twenty (20) members, or at any time deemed advisable, the trustees shall assess  
9 each member one (1) or more days of accumulated sick leave. If an employee has no accumulated sick  
10 leave at the time of assessment, the first earned days shall be donated as they are accrued by the  
11 employee.<sup>7</sup>
- 12 An employee who is a member of the sick leave bank may request an allotment of days (for the  
13 employee's personal illness only) in the manner designated by the trustees. The need for these days shall  
14 be verified by a statement from a physician.
- 15 By written notice to the trustees, an employee may withdraw from bank participation on June 30<sup>th</sup> of any  
16 year.<sup>8</sup> Membership withdrawal results in forfeiture of all days contributed.
- 17 The sick leave bank shall be operated in accordance with state law.<sup>9</sup>

1 In keeping with the educational purpose of MCS schools, all personnel are expected to dress and groom  
2 themselves with a sense of professionalism. Each employee is expected to keep his or her person and  
3 clothing clean and neat. It is expected that each employee, while exercising his or her right to dress in  
4 an individual way, will also show through his or her appearance a high degree of respect for the standards  
5 of decency, cleanliness, and style generally accepted by the school and community. The following will  
6 apply to employee dress when students are present.

7 ***Appropriate/Acceptable Attire:***

- 8 - Dress and casual shirts
- 9 - Dress and casual slacks
- 10 - Jeans
- 11 - T shirts, approved at the discretion of school administrator
- 12 - Dress and casual shoes
- 13 - Ties
- 14 - All shorts, skirts, and dresses should be worn at an appropriate length for a school setting. All items  
15 must be within three (3) inches of the top on the kneecap.
- 16 - Leggings with mid-thigh length top/dress
- 17 - Tops must cover the shoulder and must be able to be tucked into the lower apparel (pants, skirts, etc.)
- 18 - Physical education teachers may dress appropriately for the day's planned activities.
- 19 - Attire for special activities (ex: field trips, field day) is allowed per principal approval.
- 20 - Scrubs for nursing staff/therapists.

21  
22 ***Inappropriate/Unacceptable Attire:***

- 23 - Sheer, exposing, low-cut, or revealing articles of clothing
- 24 - Leggings worn as pants
- 25 - Exercise/yoga attire including sweat pants.
- 26 - The exposure of undergarments is offensive and distracting in a school environment. Therefore,  
27 "sagging" will not be permitted. To prevent such occurrences, pants must be belted at the natural  
28 waistline. Clothing must not have holes, rips, tears or cuts three (3) inches above the kneecap that  
29 exposes skin.
- 30 - Visible piercings, other than ears or nose studs.

1 If under exceptional circumstances a student is required to take non-prescription or prescription 2  
2 medication during school hours and the parent/guardian cannot be at school to administer the  
3 medication, 3 only the principal, school nurse, or staff trained in medicine administration will assist in  
4 self-administration of the medication if the student is competent 4 to self-administer medicine with  
5 assistance in compliance with the following guidelines.<sup>1</sup>

6 All prescription and nonprescription medication must have a written doctor's order on file  
7 with the school nurse that includes the following information:

- 8 1. Child's name;
- 9
- 10 2. Name of medication;
- 11
- 12 3. Name of physician;
- 13
- 14 4. Time to be self-administered;
- 15
- 16 5. Dosage and directions for self-administration (non-prescription medicines shall have label  
17 directions);
- 18
- 19 6. Possible side effects, if known; and
- 20
- 21 7. Termination date for self-administration of the medication.

22 Students with asthma shall be permitted to self-administer prescribed, metered dosage asthma-reliever  
23 inhalers if the additional information is provided by a parent/guardian:

- 24 1. Written statement from the prescribing health care practitioner that the student suffers  
25 from  
26 asthma and has been instructed in self-administration; and
- 27
- 28 2. Purpose of the medication.

29 The medication shall be delivered to the principal's office in person by the parent/guardian of  
30 the  
31 student unless the medication shall be retained by the student for immediate self-  
32 administration.

33 The principal/designee will:

---

34 1. Inform appropriate school personnel of the medication to be self-administered;

35

36 2. Keep written instructions from the parent/guardian in the student's record;

37 3. Keep an accurate record of the self-administration of the medication;

38

39 Keep all medication in a locked cabinet except medication retained by a student per physician's order;

40 Return unused prescription to the parent/guardian only; and

41 Ensure that all guidelines developed by the Department of Health and the Department of Education are  
42 followed.

43 The parent/guardian is responsible for informing the designated official of any change in the student's  
44 health or change in medication.

45 A copy of this policy shall be provided to a parent/guardian upon receipt of a request for long-term  
46 administration of medication.

#### 47 **BLOOD GLUCOSE SELF-CHECKS<sup>2</sup>**

48 Upon written request of a parent/guardian and if included in the student's medical management plan and  
49 in the Individualized Healthcare Plan (IHP), a student with diabetes shall be permitted to perform a blood  
50 glucose check or administer insulin using any necessary diabetes monitoring and treatment supplies,  
51 including sharps. The student shall be permitted to perform the testing in any area of the school or school  
52 grounds at any time necessary.

53 Sharps shall be stored in a secure, but accessible location, including the student's person, until use of  
54 such sharps is appropriate.

55 Use and disposal of sharps shall be in compliance with the guidelines set forth by the Tennessee  
56 Occupational Safety and Health Administration (TOSHA).<sup>3</sup>

#### 57 **STUDENTS WITH PANCREATIC INSUFFICIENCY OR CYSTIC FIBROSIS<sup>4</sup>**

58 Students diagnosed with pancreatic insufficiency or cystic fibrosis shall be permitted to self-manage  
59 their prescribed medication in a manner directed by a licensed health care provider without additional  
60 assistance or direction. The Director of Schools shall develop procedures for the development of an IHP  
61 for every student that wishes to self-administer.

#### 62 **STUDENTS WITH ADRENAL INSUFFICIENCY<sup>5</sup>**

63 The parent/guardian of a student diagnosed with adrenal insufficiency shall notify the school district of  
64 the student's diagnosis. Once notified, the district shall observe the following guidelines:

65 1. The district shall train school personnel who will be responsible for administering the medication  
66 for the treatment of adrenal insufficiency and any who volunteer to administer the medication; The  
67 district shall maintain a record of all school personnel who have completed this training; and  
682. If a student is suffering from an adrenal crisis, a school nurse or other licensed health care  
69 professional may administer the prescribed medication to the student. If a school nurse or other licensed  
70 health care professional is not immediately available, trained school personnel may administer the  
71 prescribed medication.

72 The Director of Schools shall develop procedures on the administration of medications that treat adrenal  
73 insufficiency, including the treatment of an adrenal crisis while on school transportation and during  
74 activities such as field trips, and recordkeeping per state law.

1 *General*

2 The district shall maintain an opioid antagonist at each school in at least two (2) unlocked, secure  
3 locations to be administered to any student believed to be having a drug overdose.<sup>1</sup> School nurses and  
4 other school personnel expected to provide emergency care to individuals shall be trained according to  
5 the Tennessee Department of Health guidelines. The school nurse or other trained school personnel  
6 may utilize the school's supply of opioid antagonists to respond to a drug overdose.

7 **PARENTAL NOTIFICATION**

8 The school district shall notify the parent(s)/guardian(s) of any student to whom an opioid antagonist  
9 has been administered.

10 **PROCEDURES**

11 In case of a suspected opioid overdose, school nurses or other trained staff shall follow the protocols  
12 outlined the Naloxone training and the instructions in the Naloxone kit:

- 13 • Call 911 and Begin CPR
- 14 • Prepare and Administer Naloxone
- 15 • Alert School Safety Team
- 16 • Continue rescue breathing if needed
- 17 • If the person's symptoms return after the initial dose of the Naloxone, an additional dose may  
18 be given after 2-3 minutes.
- 19 • Ensure the overdose victim is transported to the emergency department.

20 No school or employee of the school shall be liable for civil damages which may result from acts of  
21 omissions relating to the use of the opioid antagonist which may constitute ordinary negligence; nor  
22 shall the school personnel be subject to criminal prosecution which may result from acts or omissions  
23 in good faith administration of an opioid antagonist.
