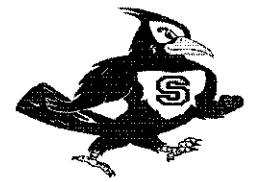

A special program was held for the parents of sophomore students during conferences. The school counselors shared information regarding a wide array of post-secondary planning topics.

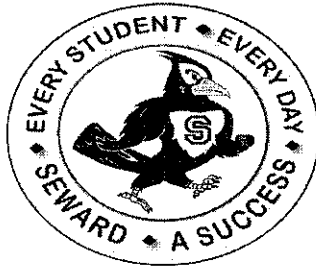

High Ability Learners (HAL)

Seward Public Schools is committed to acknowledging and fostering the unique gifts and talents of every student. One way that schools support high-achieving students is through the High Ability Learner Program (HAL). This program is designed for students who demonstrate superior academic performance and require additional challenges to meet their intellectual needs.

The next step in the process of HAL identification is the review of information from the parent, student, and teachers. Twenty-three students in grades 3rd-8th have been identified as potential High Ability Learners and questionnaires have been sent to their families and teachers to gather more information about these students..

Additionally, twenty-two 2nd graders who have demonstrated high academic achievement in the classroom and on the NWEA assessment have been identified as students who we will administer the CogAT to the week of March 24th.

Title

We have 74 students in grades kindergarten through 4th grade who are receiving Title Reading intervention during WIN time at the elementary school. And fourteen students who are receiving Title Reading at our non-public schools. Students' progress is continuously monitored.

Preschool

Currently, we have sixty-seven students in our four preschool classrooms.

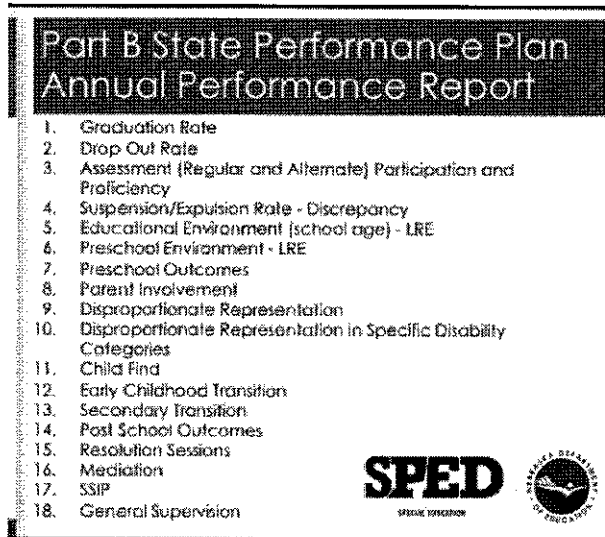
As we look ahead, planning for the 2025-2026 school year is underway. We will begin by surveying our current families to confirm if their children will be returning to preschool in the fall. Additionally, we will host an open house in March for prospective new students, particularly those turning three, who will join our morning session.

English Language Learners

The ELPA21 (English Language Proficiency Assessment for the 21st Century) is an important test designed to measure the English language proficiency of students identified as English Language Learners (ELL) or who are on monitor status for ELL. This annual assessment helps educators understand the progress of these students in their English language skills, ensuring they receive the support they need to succeed academically. For the upcoming testing window, which opens on January 27, 2025, and closes on March 14, 2025, our district will be administering the ELPA21 to six students.

Special Education

There are 18 areas that we are monitored for compliance in special education through NDE.



Currently, the state is monitoring Indicator 13 transition outcomes. Although the federal law states (IDEA) that transition planning starts at age 16, the State of Nebraska adopted the age of 14 in 2021. We have done a substantial amount of training in the last four years on transition planning through the IEP.

There are no other Special Education Reports that are due in February.

We are currently in the process of reviewing staffing and caseloads for the 2025-2026 school year.

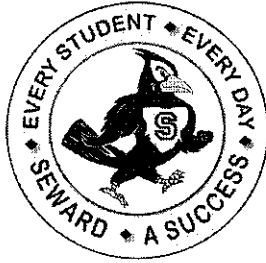

Board Members,

I hope January was a fantastic month for each of you. It was a great month for high-quality teaching and learning. The students might be disappointed there has not been any snow days, but it has been great for teaching and learning!

Curriculum

At our April Board of Education meeting, we will have our recommended math materials available for you to review. Our plan is to also have a parent open house prior to the April meeting so that we are able to provide parent input to you at the meeting. The adoption cycle has gone well so far, we have been able to make a trip with our Middle School teachers to Milford and Norris to see some of the programs we are considering in action. We are extremely grateful for the generosity of time that these school districts have shared with us and we will plan on returning the favor down the road.

Instruction

We continue to make progress with our MTSS plans for each building and guidelines that will be used district-wide. Each building has an MTSS Building Leadership team and these teams have done great work related to planning and professional development. We are at the stage now where we are sharing information with the whole staff, collecting feedback, and making revisions based on this feedback.

Staff Development

On our February Staff Development Day, we will have a variety of learning opportunities. Our Math curriculum cycle team will be diving into the sample materials that we have collected and rating these materials according to our review rubric. Each school will have some time for MTSS, Action Teams, our IXL pilot, and a full special education staff meeting. We will end the day with a district wellness committee meeting.

Assessment

Winter assessment has concluded and we have begun to arrange our Spring testing. This will include NSCAS growth for 3-8th grade students and the ACT test for our 3rd year cohort (Juniors) students.

Message From Matt

Greetings Everyone!

Happy February! I continue to visit classrooms across our district, and I am incredibly grateful for the talented teachers and staff in each of our buildings. Last week, Jon Gordon sent out the article below (to me and millions of others!), and I found it deeply meaningful on several levels.

First, over the years, I have known several people who retired from public education, and Jon is absolutely right—those retirees who had a mission, a team, and a scoreboard thrived. Those missing even one piece of that formula often struggled. Each of us should reflect on the day when we are no longer teaching, driving the bus, or fulfilling our current roles and consider what our mission will be at that stage of life.

Second, my work revolves around our mission. I feel very connected to it, as I helped facilitate the process of its creation. However, I recognize that many of you were not in the room when we developed it, and I believe it's important for everyone to understand the story behind its formation.

- **"Seward Public Schools—a district rooted in excellence"** – This is our identity. It defines what sets us apart and what we strive to be known for. The Three Things Everyone Needs to Thrive

A floundering 20-year-old, a retired CEO and a former NFL player are all struggling for the same reason. They are missing the three things everyone needs to thrive. So, what does everyone need?

1. **A Mission:** a purpose or goal that is meaningful to you and energizes you. It gives you fuel.
2. **A Team:** a group of friends, co-workers, colleagues, or teammates that help you get better and achieve the mission.
3. **A Scoreboard:** a way to measure progress and track success, growth and mastery. It gives you focus and direction.

Humans are wired to have these three things and if you don't have them, you will likely feel lost or struggle.

The 20-year-old had a mission when he was in high school, and it was to get good grades and get into college. But now while in college he has no idea what he wants to do with his life and no longer has a mission. He played sports in high school but no longer has a team or a great group of friends. For years his scoreboard was test scores to get into a good college and now that he achieved that he no longer has a scoreboard that drives him.

The retired CEO once had mission to build a world class company that dominated their industry. She had a leadership team and thousands of employees she worked with every day to achieve their mission. She had several scoreboards that let her know they were winning, growing revenue and gaining market share. But now the CEO doesn't have a mission that causes her to hop out of bed with excitement and enthusiasm. Golf is fun but it's not the same. She misses fighting the battles with her team and the relationships and bond they developed. And she no longer has a scoreboard that makes her feel like she is making progress.

The retired NFL player had a mission every day to get stronger, get better, play well and win the game. He had a mission every time he walked into the team facility. He had teammates that became friends and family. They battled against the competition together and supported each other off the field. The scoreboard was clear. Tackles, sacks, wins and losses, probowls, championships, contracts and money. Now the career is over. The mission is completed. He misses the comradery he had with his teammates and no longer has a scoreboard that gives his life meaning and focus.

All three of these people need a new mission. They need a new purpose to work towards that ignites and energizes them. They also need to build a new team. Relationships and connection are essential for well-being, longevity and happiness. And they all need a new scoreboard that propels them forward and makes them feel like they are accomplishing something meaningful.

My friend Thomas Williams is a former NFL player who joined our team of speakers and trainers a few years ago and has thrived as a result. He said ever since he left the NFL he's been searching for a team and he finally found one in us. He also said he had to create a new scoreboard in his life and career and now it's how many speaking engagements he can do and how many lives he can impact.

This is true for all of us and it's true for those you lead.

If you don't have a mission, find one and help others find theirs.

If you don't have a team, join a club, a book club or group with similar interests as you. Get involved in your church or local non-profit. Invest in relationships and build your team one person at a time.

If you don't have a scoreboard, create one. Decide what success looks like to you and your team. It could be a number you want to reach, or a goal you want to achieve or an impact you want to make.

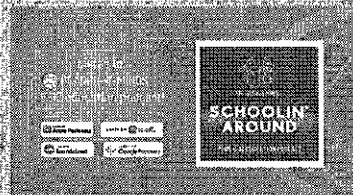
I love teaching this because once you understand the need for a mission, team and scoreboard you'll be able to see when they are missing from your life and the life of others. And once you realize they are missing you can do something about it in order to thrive and also help others thrive.
