Under LB 645, as amended, the contribution rates would be determined by the current funding ratio on the actuarial value of assets in the School Retirement Fund.

The current funding ratio is 99.91%. Beginning on July 1, 2025, the new system would be based on the most recent previous year as reported in the annual actuarial valuation report, which is released in November of each year.

If the funded ratio is less than 96%

- Employee rate: 9.75%
- Employer rate: 9.85% (101% of the employee rate)
- State rate: 2%

If the funded ratio is 96% or greater and less than 98%

- Employee rate: 8.75%
- Employer rate: 8.84% (101% of the employee rate)
- State rate: .7%

If the funded ratio is 98% or greater and less than 100%

- Employee rate: 8%
- Employer rate: 8.08% (101% of the employee rate)
- State rate: .7%

If the funded ratio is 100% or greater

- Employee rate: 7.25%
- Employer rate: 7.32% (101% of the employee rate)
- State rate: no contribution required

May is always an exciting time of year, with graduation and the end of the school year. As we reflect on the past school year, we also start planning for the next one.

### **Special Education**

Our Targeted Improvement Plan (TIP) was due May 1st, 2025. The goal of the TIP is to help schools build capacity to scale up the MTSS framework by having a system to review student data and establish a Targeted Improvement Plan (TIP). Each TIP is required to have (a) a focus for improvement, (b) a measurable goal with annual targets, (c) a student-centered, evidence-based strategy to affect the outcomes for students with disabilities, (d) a level of implementation ratings, and (e) descriptions of data used for decision-making. The TIP must be aligned to the overall general education improvement activities being implemented at the district. Our TIP is aligned with our Strategic Plan, specifically the MTSS action plan.

Our PEaK (Promoting Engagement and Knowledge) Project was also due May 1st, 2025. The PEaK project is a way to secure funding from NDE to support the implementation and evaluation of our Targeted Improvement Plans (TIPs). Funds must be used to assist with the deep implementation of evidence-based practices designed to improve the outcomes of students with disabilities. We use some of these funds to pay for stipends for our MTSS Building Leadership Team members to do some planning for the next school year this summer.

We are busy planning our joint summer program with VR. Attached is the flyer that was sent out to parents and guardians about the program. Students will have the option of attending one of the two weeks: June 2nd-5th or June 9th-12th.

Who is Eligible for the Program?

This programming is available for VR Pre-ETS students ages 14-21 who have not received their high school diploma.

The Experience will include:

- Work-based Learning Experiences - Job shadowing, workplace site visits, and obtaining transferable skills provided in an integrated setting.
- Workplace Readiness Training - Activities include training to develop interpersonal skills, independent living skills, and leadership abilities.

### **High Ability Learners (HAL)**

We are waiting on the results of the CogAT that was administered to 22 second-grade students to determine who will be recommended for HAL.

### **Title**

The number of students who have received Tier II Title Reading services has remained consistent.

We will continue to monitor their progress in the classroom and their Tier II reading intervention.

### **Early Childhood/Preschool**

The preschool teachers and I will meet this month to review all the students attending preschool in the fall to assign class placements. One requirement of a Rule 11 preschool is having more non-identified peers in the classroom than students receiving special education services. Currently, we have 43 students whose parents have confirmed they will attend our preschool in the fall.

By the end of May, our early childhood staff will complete the GOLD assessment on every student who is either on an IFSP or who attends our preschool program. NDE requires this assessment to be completed twice a year.

### **Sixpence**

Sixpence is a valuable resource for our communities, and we will continue to work to support this program in our school districts. Our budget was submitted in March and was approved. We will now complete the grant application, which is due by May 27th.

### **English Language Learners**

The ELPA21 (English Language Proficiency Assessment for the 21st Century) has been completed, and we are waiting for the results.

Jocelyn Gray and I met and completed our Annual ELL Program review. We then sent the document to our ELL committee for review. ELL is a component of our Strategic Plan. Currently, very few students are eligible for ELL services, but we want to have a plan for expansion if we need it in the future.

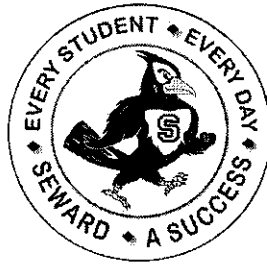

## May 2025 Board Report for Curriculum and Staff Development

---

Board Members,

The end of the school year is here and we have much to be proud of as a district. I want you to know that we could not do what we do without you. You make a difference in the lives of our students and staff and I am thankful for your service.

### **Curriculum**

Last month you approved the purchase of our math instructional materials. The teachers will be meeting as a team and with the curriculum companies to learn more about the instructional materials that they will have for the next 7 years. I will also introduce the frameworks for our curriculum writing and then the teachers will have time over the summer to complete these frameworks. We will bring our curriculum back to you in August for your approval.

### **Instruction**

Our High School implemented the John Baylor, On to College program, starting in January. All of our Juniors participated during their 5<sup>th</sup> hour. The On to College program was purchased by the Seward Foundation, and we are very thankful for their support. The program complements our quality classroom instruction by ensuring students understand key grammar rules, mathematical priorities, and reading strategies to be successful on the ACT. Early data indicates that this was well worth the investment of time and money. Again, we are thankful to the Seward Foundation for their support of our students.

### **Staff Development**

Over the next three years, it is required by NDE that each Preschool through 3<sup>rd</sup> grade teacher complete early literacy training in the Science of Reading. We were very fortunate to form a partnership with the University of Nebraska- Omaha to provide this training for our teachers. Our Kindergarten through 3<sup>rd</sup> grade teachers will complete the training during our staff development days as well as the expectation that they will complete some of the training outside of the staff development day. Our preschool teachers will participate in an online program through the University of Nebraska- Kearney.

**Assessment**

We just completed the last assessments for the school year. I am thankful to the teachers and administrators who put so much work into ensuring a successful testing experience. While these tests are one small measure of our success, they are an important tool to give us information about our programs, curriculum, and the individual needs of each child.

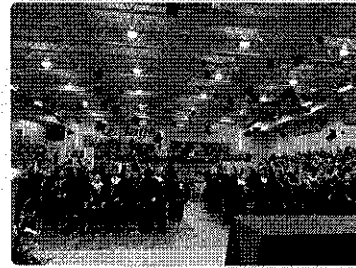

**RE: SEWARD MIDDLE SCHOOL PARKING LOT LIGHT POLE FAILURES - PE PROJECT #250427A**

Mr. Anderson:

This review letter concerns the failure of parking lot light poles located at Seward Middle School at 2401 Karol Kay Boulevard in Seward, Nebraska. Construction submittals of the poles were sent for our review and Ryan Pelster of Performance Engineering conducted a site visit to examine the failed and undamaged poles and their piers on the morning of Wednesday, April 30<sup>th</sup>.

The existing construction submittal by Lighting Specialists dated 4-28-11 were based upon engineering design by Clark Enersen Partners and indicate that WP9LE2 and WP9LE3 horizontal lamp fixtures with 1SA side arm mounting along with WP9LE4 horizontal lamp fixtures with 2SB side arm mounting were used at the top of PRA30-6188 30 foot tall 6 inch round aluminum non-tapered poles with 3/16 inch wall thicknesses by Kim Lighting. The poles used seamless round extruded aluminum of 6063-T6 alloy welded to the top and bottom of aluminum base castings of 356 alloy and a handhole with gasketed cover and ground lug was provided centered 18 inches up from the base. For the pole height and diameter four 3/4 inch diameter by 34 inch long galvanized anchor bolts with leveling nuts, flat washers and top nuts in a bolt circle diameter of 10 1/2 inches were indicated with a 3 3/8 inch projection and a 14 inch diameter two-piece cast aluminum base cover of 319 alloy and 5" inch diameter conduit opening atop a packed grout base and concrete pier.

All of the assemblies described above match what was observed on site, atop 2 foot diameter concrete piers projecting 2 feet 6 inches above adjacent grade assumed to have an embedment depth of 6 feet and reinforced with six #6 vertical bars at a 60 degree radial pattern and #4 horizontal circular closed ties at 12 inches on center with a concrete cover of 3 inches around the ties. The assemblies and piers were installed in 2013.

On the morning of Wednesday, March 18<sup>th</sup> a blizzard with recorded 50 to 70 mile per hour wind gusts along with sleet and heavy wet snow affected the site. Thirteen of the twenty one total light poles on site failed during this storm with the primary failure being brittle fracture at the base castings and rupture of the base welds of the poles to the base castings. Three poles at the eastern side of the site on the main drive failed from the pole shearing away at the handhole 18 inches from the base. Two poles at the western side of the site had visible cracks at these locations and had been marked as such. All of the existing anchor bolts appeared to be undamaged and beyond cracks less than 1/16 inches wide which are common during initial construction and for assemblies of this age the grout bases and concrete piers appeared to be undamaged as well.

The American Association of State Highway and Transportation Officials (AASHTO) Wind Map included in the existing construction submittal calls for a 50 year mean recurrence interval steady wind speed of 90 miles per hour for Nebraska. The allowable pole and fixture Effective Projected Area (EPA) value for the PRA30-6188 pole for this wind speed is listed as 4.74 which is well above the WP9LE 1SA EPA of 0.95 and WP9LE 2SB EPA of 1.9. Kim Lighting's submittal page for the PRA poles state that poles can withstand that wind load when luminaires are mounted per fixture installation instructions and due to the undamaged anchor rods and concrete piers it is evident that the failure was due to the fabrication of the poles themselves, the base castings and/or the connection welds between these elements.

Aluminum alloy 6063-T6 can exhibit brittle failure (cracking under stress without significant deformation) due to several factors:

- **Heat Treatment:** The T6 temper involves a specific heat treatment process that can introduce stresses within the material. If these stresses are not properly relieved during heat treating, they can contribute to cracking during subsequent loading.
- **Material Microstructure:** The microstructure of 6063-T6, with its dense grain structure and potential for stress raisers, can also contribute to brittle failure.
- **Applied Stress:** When subjected to bending, twisting, or other forces, 6063-T6 may experience cracks due to its inherent brittleness, especially if the applied stress exceeds the material's strength limits.

Cast aluminum alloy 356 can become brittle due to its lower tensile strength and several other factors:

- **Porosity:** During casting, gases can become trapped or shrinkage can occur, creating microscopic voids within the metal. These voids weaken the material and make it more susceptible to fracture.
- **Coarse Grain Structure:** Large, coarser grains, often resulting from slower cooling rates in large castings, are less effective at distributing stress evenly, increasing the likelihood of cracks.
- **Impurities and Inclusions:** Contaminants like oxides can form inclusions that act as stress concentrators, further exacerbating brittleness.
- **Segregated Phases:** Rapid cooling or uneven solidification can lead to the segregation of alloying elements into weaker, brittle zones, making the material prone to crack initiation.
- **Alloy Composition:** Alloying elements, like silicon, can improve castability but also contribute to brittleness if present in excess. Other elements, such as copper, magnesium, and zinc, also affect brittleness.
- **Thermal Stress:** During the casting process, thermal stresses can develop, particularly if there are rapid temperature changes or variations in cooling rates, leading to cracking.
- **Casting Defects:** Defects like porosity, shrinkage cavities, and microcracks, formed during solidification, weaken the structure and make it more prone to failure.

Poor aluminum welds can be caused by several defects that can weaken the weld and compromise the structural integrity of the joint leading to failure:

- **Lack of Fusion:** This occurs when the molten weld metal doesn't properly merge with the base metal, resulting in a weak or incomplete joint. It can be caused by insufficient heat, incorrect welding parameters, or contamination of the base metal.
- **Porosity:** Porosity, or the presence of gas pockets within the weld, weakens the joint and can lead to cracking or failure. It can be caused by impurities in the filler metal, moisture in the shielding gas, or improper welding parameters.
- **Cracking:** Cracks can develop in the weld due to excessive restraint during welding, improper heat input, or the presence of porosity or other defects.
- **Burn-Through:** This occurs when the weld puddle penetrates completely through the base metal, typically due to excessive heat or incorrect welding parameters.
- **Thermal Distortion:** Aluminum's high thermal conductivity and low melting point can cause significant distortion or warping during welding, especially if the weld is heavily restrained.
- **Improper Arc Length Control:** An excessively long arc can result in poor penetration, increased spatter, and a weak weld.
- **Dirty Base or Filler Metal:** Contamination of the base or filler metal can lead to poor weld quality, including lack of fusion, porosity, and cracking.
- **Poor Gas Coverage:** Inadequate shielding gas coverage can allow atmospheric contaminants to enter the weld pool, leading to porosity and other defects.
- **Poor Wire Feedability:** Issues with wire feed can disrupt the welding process and lead to inconsistent welds.

One pole on the eastern side of the site on the drive to the northern parking lot had previously failed. Maintenance Director Adam Dowling stated that this pole had failed at the base casting from a straight-line wind event several years ago and had been rewelded so a steel base plate reusing the existing anchor bolts and concrete pier.


