Fall Assessments:

We are in the process of giving beginning of year assessments to our students at Seward Elementary. Students in grades K-4 will take (or have taken) a literacy screener called DIBELS, which is our screening tool for the Nebraska Reads Program. This year, we chose to wait and test kindergarten students a little later, so we can begin to work with them on the skills they will be tested on. In the past, we tested them with everyone else, but found that the kindergarten data was not great because students had not been exposed to instruction. Students also took NWEA reading and math (2nd-4th) and our all school writing assessment. Instructional decisions will also be made with beginning of year data, including groupings for our WIN time (Whatever is Needed - intervention block) and enrichment groups.

The Bluejay Way:

Last year, two of our action teams joined forces and created The Bluejay Way system for our school. This system includes two new school rules: I can be safe and respectful and I can let all Bluejays learn. We also created new "Bluejay Way" posters for common areas to give student visuals about expectations. The Bluejay Way also includes a recognition program where staff can nominate students who are consistently displaying strong character traits and/or exceeding academic expectations. So far, The Bluejay Way system has rolled out wonderfully and our learning environment is very calm and productive. I appreciate the work done by both of these teams to get this program up and running.

Homecoming Week:

As usual, Seward Elementary will be joining in on the Homecoming Week festivities. We greatly appreciate the high school being willing to change the parade date so the elementary students can participate! We do not have school due to a plan day on the 9th, so the parade will be on the 5th.

The 2026-2027 is off to a great start! Students and teachers are getting settled into their schedules, and fall sports are in full swing. We are excited about the direction of the school year. Our student-led Blue Jay Leadership team has made a significant impact with their hard work and leadership of the student body. Farmers Luncheon: We will be hosting our annual farmer luncheon on Campus (Near the Greenhouse) on Friday, September 11th, from 11 a.m. to 1 p.m. We hope you can join us!

Safety Drills: We have completed three fire drills, a tornado drill, and a bus drill this school year. We do ten fire drills annually by law, one crisis drill per term, and one bus and tornado drill per semester. Our staff has done a very good job ensuring interior and exterior doors are always secure.

Parent-Teacher Conferences: We will host conferences on Wednesday, September 16th from 5:30-7:30 p.m.

Homecoming Week: Homecoming week is the week of October 5th. The BlueJay Leadership Team is planning activities for the week. We had trouble finding a date. Homecoming is historically centered around the football schedule. The NSAA schedules football (Don't get us started on why and how bad a job they do); our schedule really gave us poor options for Homecoming this year. The week of October 5th had fewer conflicts; however, the Elementary school has a planning day and no students. The high school students love to see the students at the elementary school during the parade. We discussed this with the Bluejay Leadership team and decided to start the week off with the parade so they could participate.

Freshman Orientation: We had an extremely well-attended Freshman Orientation Event (all but 1 student attended). Feedback from parents and students indicated that the information and experiences provided as part of this orientation were very well received. Most attendees commented on how they enjoyed the open house format.

NWEA Testing: We complete fall NWEA testing for grades 9-10 students on September 30th. Students will be tested in math, reading, science, and language usage. The results of these assessments will be used to guide our instruction and intervention practices and provide students and parents with an indication of their growth and progress. NWEA assessment results serve as an important barometer within our comprehensive assessment system.

ACT Testing: All Juniors will be taking the ACT on October 21. This fall will be our first time using the online testing option. Thank you to the board for allowing us to continue to offer the ACT in the fall.

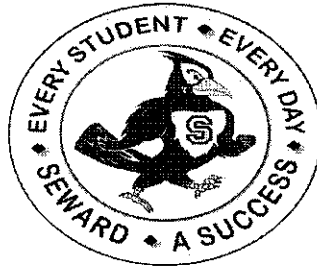

Special Education

ILCD Indicator 11, the state report documenting the number of special education evaluations completed within the 45-school-day/60-calendar-day timeline, is due on August 31st and has been submitted to NDE. We completed 13 initial evaluations for children between the ages of 3 and 21 during the 2024-2025 school year; all of our evaluations met the timeline requirements.

Our final report for Flex Funding is due on September 30th and has been submitted to NDE. The flexible funding option allows the use of a percentage of special education funds for the education of students not verified as having a disability as defined in 92 NAC 51 (Rule 51). We use this money to help fund some of our interventions at the elementary and middle schools.

We have also been busy ensuring that all accommodations for students with IEPs and 504 plans are reported, so that students can receive the appropriate accommodations for the beginning of the year NWEA assessments, the Pre-ACT, and the ACT.

We have had several new students move into our district. As of September 1, 12 new students with an IEP from their previous school district enrolled in Seward (average of 10 new students at the beginning of the year). We have 30 days from the first day of their enrollment to do any assessment that we need to do to determine eligibility for special education and to hold a new IEP if they are found eligible. We had 11 students on an IEP transfer to another school district before the start of the year, which is a little lower than average (11 on average).

Title

The elementary school is finishing the beginning-of-the-year assessments, and we will be assigning students to WIN groups based on their needs.

Preschool

Currently, we have 43 students in our preschool classes at the elementary school. Students attend Monday through Friday, following the school calendar. .This is an increase from 37 students in our preschool classes last year. There are currently 24 students in the AM class and 19 in the PM class

English Language Learners

Five students are eligible as English Language Learners, and two students will continue to be monitored this school year.

High Ability Learners (HAL)

We currently have 140 HAL students for the 2026-2027 school year. This is an increase from 127 students who were identified as HAL at the beginning of the 2024-2025 school year.

The budget for our High Ability Learner program is due on September 30th. Last year, we also used the funds to help pay for students' involvement in UNL Math Day, Hobby, Science Olympia, Quizbowls, Academic Decathlon, Battle of the Books, and a field trip for our 4th grade HAL students to the SAC Museum.

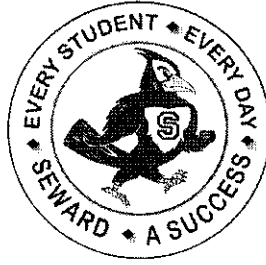

September 2026 Board Report for Curriculum and Staff Development

Board Members,

Another school year is off and running! It has been a great start; I am proud of the conversations we are having about literacy. Even though our data is significantly better than the nation's literacy data, we still have work to do and we need to ensure that all of our students leave our buildings with the best literacy skills possible.

Curriculum

The Business and PE/Health teachers have had time to explore and implement their new curriculum. I am hearing positive things from our personal finance course as well as in our physical education programs. I have started to receive samples of Spanish curricular resources and our plan is to start reviewing these resources and the music curriculum in October.

Instruction

Our strategic plan calls for our content teachers to be trained in adolescent literacy and literacy across the content areas. We are happy to provide this training for our secondary teachers this year as well as follow up literacy training for our elementary staff. The middle school staff will be trained in Keys to Literacy in a way that includes both in-person and online training. Our expectation will be that teachers identify opportunities to bring literacy into their classroom through various vocabulary, comprehension, and student interaction opportunities.

Staff Development

We feel like we have a great staff development program, but there are special areas that we feel like we can grow in. This year we are going to be working with our PE teachers to provide them professional development that they find meaningful and impactful. The ESU 6 has helped us organize a PE tour where teachers from across ESU #6 will come and observe our teachers. Our teachers will then share what they are teaching, why they are teaching it, etc. The other teachers will offer feedback and suggestions on other lessons that they have taught using the same standards. In the Spring our teachers will be able to go to another school to learn in a similar manner.

Assessment

Beginning of year assessments have gone well. We are currently screening our students using the DIBELS (Grades K-4 Literacy) and NWEA(Grades 2-10 Literacy and Math) assessments. This data will inform teachers about where the students are beginning the year and where additional support or enrichment may be needed.

NSCAS and ACT scores from the 25-26 school year are currently in Embargo status, but in the coming months I will be able to share this information with the school board.

Be Hungry

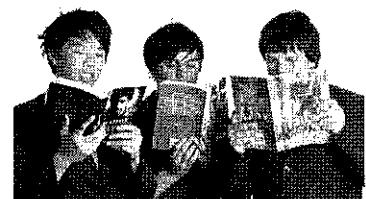
- Have a great desire to continuously learn, improve, grow, and dream.

With the parade and pep rally moving to Monday of Homecoming Week this year, our team is working to create energy and excitement throughout the entire week and ensure that each activity is well-supported by the student body.

The Bluejay Leadership Team also had the opportunity to assist with New Student Orientation. We hosted a booth featuring Seward Jays Customs merchandise and introduced a new interactive board in the school lobby designed to engage students and help build school spirit.

Seward Jays Customs has continued to grow as one of our team's initiatives. This year, we have partnered with the middle school to create Top Time shirts, allowing students to bring their creative shirt ideas to life. This project has been a fun way to connect with our younger students and supports one of our goals for the year: building a stronger sense of community and school culture across the elementary, middle, and high schools. Seward Jays Customs has also sold approximately 60 Seward blankets so far this school year.
