



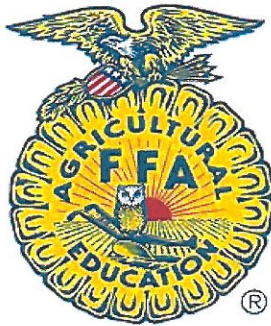

I am writing to follow up addressing the school board at the December board meeting about adding ten days to my extended contract. The current contract is thirty days. I have been averaging over thirty days however I don't mind that.

The main reason I am asking about adding days is to fully incorporate the new Y.I.E.L.D. (Youth Involvement = Leadership Development) program in which we are partnering with United Farmers Cooperative. This exciting program involves matching an FFA member with a farmer and planting a 1 and ¼ acre corn plot with the student being involved with all segments of the process. This includes decisions on all inputs along with harvest and marketing of the grain. There will also be communication and education with UFC field experts. The farmer then donates a percentage of the yield to the FFA chapter. This income will help with expenses for both FFA and the classroom. We are looking at a projected income of \$15,000 to \$25,000 per year. The past year with the program just starting in late August produced over \$8000 with more farmers and members participating in 2013.

This will require weekend days during the school year along with primarily summer involvement and field inspections along with the student's recordkeeping. I will need to keep contact with the student and participating farmer as well as UFC during the summer along with planting and harvest times. This will require days above and beyond days already being utilized in the summer.

This program is a wonderful opportunity for our FFA and the community. I am most excited about career exploration and the hands on learning but this will be an expanded time commitment also.

Duties and Reimbursement of Expenses

Committee Duties:

1. To attend and participate in the July 20, 2013 meeting of the Committee.
2. To attend and participate in one of NASB's Fall Area Membership Meetings in August, September, and October, 2013.
3. To attend and participate in the NASB Delegate Assembly to be held as part of the State Education Conference in Omaha on November 13-15, 2013.
4. To attend and participate in the Legislative Issues Conference in January or February, 2014.
5. To attend and participate in Legislative activities or hearings when scheduled by NASB staff.
6. To attend and participate in any other special meetings of the Legislation Committee which may be called. Such special meetings may be held in person, by phone or electronic means.
7. To receive, consider, and act upon legislative resolution and position statement proposals submitted by member boards, officers, and directors.
8. To meet and provide advice, instructions, and interpretations of legislative resolutions.

Expense Reimbursement:

1. Legislation Committee meetings held as part of another NASB meeting: No expenses will be reimbursed. (Example: the November 13-15 State Education Conference.)
2. Legislation Committee meetings not held as part of another NASB meeting: Expenses will be reimbursed in accordance with the provisions listed, below. (Example: the annual July meeting.)

Mileage: The reimbursement rate for personal automobile travel shall be the state mileage reimbursement rate for designated events and approved travel. (Current rate is 56.5 cents per mile)

Lodging: Single rate.

Meals: Actual cost up to a maximum amount established annually by the Board of Directors.

3. Legislative Issues Conference held in January or February: Complimentary registration fee for Monday only.

Expense claims must be submitted on the standard expense form supplied by the Association. Receipts for lodging and meal expenses are required.

REPORT ON NRCSA LEGISLATIVE FORUM—FEBRUARY 20, 2013

Education Committee Chair Kate Sullivan:

- ~LB 407 will ultimately be the TEEOSA bill—establishes basic allowable growth at 1.5% next year and 2.5% thereafter
- ~Early Childhood Education will be addressed this session
- ~LB 408 on the way to acceptance—certification date to June 1—improvement hoped in the future
- ~LB 640 (Hadley's TEEOSA bill) doesn't address emergency funding
- ~LB 496 addresses innovative funding of lottery funds as incentive/supports for reorganization
- ~a motion will be made today to kill LB 405 and 406 (income/sales tax reform)

NCSA Executive Director Mike Dulaney:

- ~LB 553 develops a second-tier retirement program—we now have a major shortfall that needs fixed with increased contribution by state and decreased benefits for new hires— need to determine how to handle classified staff—employee contribution has increased 3 times since last state increase
- ~while waiting for governor to arrive, Dr. Dulaney discussed problem with schools with nearby college campus having higher percentage of teachers with advanced degrees getting larger TEEOSA amounts

Governor Heineman:

- ~started with essentially same message as earlier speeches—his budget calls for 5% increase to each of TEEOSA and special ed--Medicaid is killing his budget
- ~he wants organizations like NRCSA to stand behind him to fight increases in Medicaid costs
- ~good question/answer session of over 30 minutes—he said much more that I agreed with than at other sessions (I heard many similar comments during break)

Revenue Committee Chair Senator Galen Hadley:

- ~says major debate in Legislature will be between tweaking TEEOSA and reducing it
- ~feels that Senator Chambers' presence will mean far fewer bills will be passed this year-(a bill discussion that “took three hours (yesterday) would have been done in five minutes last year”)

NDE report by Bryce Wilson:

- ~gave rapid-fire run-though of most education bills . . . keep checking the newsletter
- ~many of the bills will never get out of committee—many that do will involve budget issues that Mr. DeWaard will have to deal with later this year.

Speaker of the Legislature Senator Greg Adams:

- ~mostly general statements about the session—655 bills introduced with basic issues being budget, downward adjustment in TEEOSA, necessity of prioritizing budget—Medicaid is biggest elephant in the room

Property Tax Administrator Ruth Sorensen:

- ~a part of dept. of revenue—she is the state assessor in charge of county assessors
- ~ag. land assessed at 69-76%--classified as irrigated, dryland, or grassland—in eastern part of state values are up 40%—all classifications and all areas are up double-digits

Agriculture Committee Chair Ken Schilz:

- ~major problems loom when ag land values drop (and they surely will)
- ~get out of the way of farmers and ranchers with dumb corporate laws that leave the playing field uneven (like a bill up this year to preclude spraying 2-4-D within four miles of grapevines) . . .
