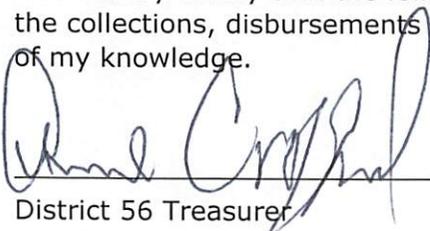

North School Student/Staff Updates:

Spring Parent-Teacher Conferences: Conferences are Tuesday, March 10 & Thursday, March 12. Parents sign up online to schedule a conference with their child's classroom teacher. During conferences, teachers will discuss academic and behavioral progress. Additionally, the Scholastic Book Fair will be set up in the libraries at both elementary buildings. The book fair serves as a fundraising opportunity to help restock our libraries with more great books for students!

Book Opportunities for All Students! Every Kindergarten – 5th grade student will receive a FREE book this year thanks to generous local support! A \$4,000 grant from our local Elks Club will provide a book for every 1st–5th grader at Falls City and Sacred Heart Schools. Through the Diana Kotich Memorial Scholarship, each kindergarten student will receive a book.

Spring Reading Club – Final Session Update: Our Spring Reading Club has officially wrapped up! This semester we had 9 staff members tutoring 34 K–2 students. The final student data point will be collected in April during the DIBELS assessment window. We have seen great benefits and growth in students who participated. First Grade Field Trip: On Thursday, March 19, our first grade students will be traveling to the Discovery Center and Planetarium in St. Joseph, Missouri for a field trip. We would like to thank P.I.E. for sponsoring this wonderful learning opportunity for our students.

2026-2027 Kindergarten Round-Up – Friday, March 20: We are anticipating 56 incoming kindergarteners for Kindergarten Round-Up this year! The day will be structured into four sessions, during which Mrs. Leyden and North School staff will meet with parents to share important information. Incoming kindergarteners will participate in a kindergarten readiness pre-assessment and ESU 4 health screenings to help ensure a smooth transition into school.

SRSS Data Collection: From March 23–27, 2026, K–2 teachers will complete the Student Risk Screening Scale (SRSS-IE). Many districts across Nebraska use the SRSS-IE as an evidence-based and efficient universal screening tool to proactively identify students who may need additional behavioral or social-emotional support. This screening helps educators identify both internalizing behaviors (such as anxiety) and externalizing behaviors (such as bullying or aggression). The process aligns with the Nebraska Multi-Tiered System of Supports (NeMTSS) framework and supports schools in improving student outcomes while fostering a positive school climate.

Each purchase supports our school library and allows us to update our books on a consistent basis.

Elk's Book Grant: The Elk's Club has generously supported literacy for our learners through a \$4,000 book grant again this year. This grant will put an age-appropriate book into the hand of every 1st-5th grade student. The books are purchased through the school's book fair, which will also help support our library.

Spring SRSS Data: At the end of March, teachers will fill out a Student Risk Screener Scale (SRSS) over each student in their class. This allows our team to ensure that all social-emotional and/or behavioral needs are being met. Mrs. Witt has been completing tier 1 and 2 counseling services for Mrs. Erickson during her maternity leave to ensure student needs continue to be met.

Education, School Finance, and Governance Bills – 2026 Session

School Finance & Funding

LB1038 – Changes to School Funding and Property Taxes

- Redirects property tax relief funds into the TEEOSA formula and lowers the maximum levy.
 - Impact: Increases state share of school funding and reduces reliance on property taxes.

LB1208 – Budget Requirements Under TEEOSA

- Adds additional financial reporting requirements for districts under the state aid formula.
 - Impact: Districts must submit expanded budget reporting.

Literacy & Instruction Programs

LB1050 – Nebraska Reading Improvement Act Changes

- Requires earlier identification of struggling readers and intervention plans.
 - Impact: Schools must implement structured reading support programs.

School Operations & Safety

LB463 – Cardiac Emergency Response Plans

- Requires districts to adopt cardiac emergency response plans and ensure AED access.
 - Impact: Staff training and possible AED purchases may be required.

Student Discipline

LB1053 – Student Suspension for Younger Grades

- Allows suspension of students in Pre-K through grade two in serious safety situations.
 - Impact: Provides districts additional disciplinary options.

LB1201 – Classroom Library Grant Program

- Creates grants for classroom libraries and literacy engagement materials.
- Impact: Districts could receive funding for additional reading resources.

School Governance

LB1243 – Part-Time Enrollment

- Allows homeschool and private school students to enroll part-time in public school classes.
 - Impact: May increase participation in electives and career programs.

LB960 – Student Representation on School Boards

- Allows non-voting student members on school boards.
 - Impact: Increases student voice in governance.

Curriculum Policy

LB1024 – History of Communism Instruction

- Requires instruction on communism history in social studies.
 - Impact: Districts may need curriculum updates.

LB691 – Ten Commandments Display

- Requires Ten Commandments displays in schools.
 - Impact: Schools must install approved signage.

Student Activities & Athletics

LB605 – Transgender Student Participation Policy

- Requires districts to create policies governing participation in athletics.
 - Impact: Districts must establish participation guidelines.
