1. Call to Order

President Tom Bredvick called the June 14, 2021 MPS Board of Education meeting to

Loretta Hauxwell, Brad Hays, and Teresa Thomas; Absent: Dennis Berry, and Mike  
Langan.

Mr. Bredvick reminded those present of the Open Meetings Law on the entryway table

2. Reports, Communications & Public Participation

Under Public Participation Melissa Cary discussed the health measures currently being  
proposed by the State. She is trying to be proactive and is at the meeting to voice her  
opposition to the proposed health standards. She is attempting to stop this at the state  
level. She stated that some school board have passed resolutions stating they disagree  
with the new health standards. She would like McCook School Board to consider a  
similar resolution.

Also speaking was Stacey Sandall. She provided a handout outlining her opposition to the wearing of masks by students. She requested the school board pass a resolution that there will be no masks worn by McCook Public School students in the 2021-2022 school year.

### 4. Reports from Staff Members and Committees

Brad Hays reported on the Committee on American Civics. The committee met prior the board meeting at a public meeting. In the public forum there was no public participation. The main duty of the American Civics Committee is to review all of the Social Studies curriculum.

### 5. Board and Administrative Comments

Mr. Norgaard stated he has contacted three architectural firms and will have a meeting with them on July 1. The purpose of the meeting is to discuss potential upcoming projects and to prepare them to present to the Board of Education.

He also commented on Summer School. There are 76 Central Elementary Students and 159 McCook Elementary Students at Summer School. There are also 6 students at the Jr High, and 25 at the Sr. High. There are several staff involved. We are thankful for their assistance in providing summer school for our students. Summer school goes for four weeks, four days per week, and three hours per day.

Mr. Brazell provided several updates.

Emergency Paid Sick Leave Act, under the American Rescue Plan provided \$4,482.50 in payroll tax refund to MPS. The refund is based upon staff that were unable to work due to the pandemic.

Summer Lunch Program is off to a good start. MPS is serving approximately 520 students per day.

ESSRS III amounts have been made public. MPS will receive \$1,660,351.

He also reported on several projects in the district.

- o Wieland find drainage project is completed. But still need some sod or seed in specific areas

- Most of the new carpet being installed is completed or will be completed in the near future.
- The remodeling of Mr. Mays old room (new Health room) and Mrs. Janes room are progressing nicely.
- The roof over the theater and English Wing are complete except for the flashing. The junior high south wing roof should be completed this week.
- The District, via W-Design, is advertising for bids for the Junior High air handlers. The bids will be go out soon and are due on July 2.

He also asked the board to approve the transfer of funds to the activity account later in the agenda in the amount of \$40,000. This is to cover lost revenue due to the pandemic.

Mr. Gross reported that the district will be updating our printers and copiers with Eakes. Currently we are in the 4<sup>th</sup> year of a 5 yr lease. There will be an annual savings of \$3,500.

He also reported the district is taking bids to upgrade and add Audio Visual equipment in several locations in the district. The AV upgrades will be using ESSERII and ESSERIII funds.

Under board comments. Loretta Hauxwell stated she will be absent next month. She also thanked the community members for their comments tonight.

Tom Bredvick also thanked the community members for coming forward with their concerns and addressing the School Board. The items are not on the agenda and therefore cannot take action tonight.

**College, Career, and Civic Ready** The school provides every student with opportunities that focus on career preparation aligned with the Nebraska Career Education Programs of Study that consider graduation requirements, postsecondary expectations, and career cluster choices.

The school provides opportunities on all of the following topics: career preparation, programs of study that consider graduation, programs of study that consider post-secondary requirements, and career cluster choices. These opportunities are offered to all students throughout the year. There is clear and updated documentation on offering such opportunities.

Narrative:

Health Careers Class is taught to juniors and seniors who have a strong desire to pursue a health career. Along with classroom work, students go to Community Hospital once a week to shadow and interact with a different health professional each week. Second-semester students go once a week to other health-related businesses to receive information on that career. Businesses that have been toured in the past include the following: Red Willow Animal Clinic, The Work Ethic Camp, Lifetime Eye, U Save Pharmacy, McCook Family Planning, Michaelis Chiropractic among others. In March each year the group goes to Lincoln and Omaha to visit educational programs and other health-related facilities that are not available in Southwest Nebraska.

The America's Promise Grant enables students to participate in the Health Careers Tour. Grant money helps to provide for lodging and mileage for students to have exposure to post-secondary options for health career-related fields of study.

Senior students attend a tour of local businesses. This is a great opportunity for students to see what goes on "behind the scenes" in many of the local establishments. This is also another way for students to see careers that are available to students in the local community.

Seniors sign up and attend County Government Day to learn about different roles at the Red Willow County Courthouse.

EducationQuest information about college readiness is presented to all students. An EducationQuest employee also does a web ex program with students and parents regarding financial issues facing college-bound students. EducationQuest representatives also come to McCook and spend two days with parents registering them for FAFSA applications.

National Guard recruiters presented to students about careers in the military and provided students with the opportunity to experience a sample obstacle course. Recruiters are also on campus several times a month to visit with students and answer questions about career options available to them..

Art club classes complete and tour art exhibits both at McCook Community College and the Art Guild in McCook.

We currently have 16 students working in the community to receive approved work-study credit. These jobs help students decide on career paths.

Information Technology I courses are taken by all 9th-grade students and include a career exploration component.

**Narrative:** Citizenship Exam: Every student that graduates from McCook High School will take the U.S. Citizenship and Immigration Services Test, earning a score of 80% or better. This is in accordance with 79-724.

4. Partnering with families to encourage good hygiene practices and to keep their children home when ill.
5. Maximizing space in classrooms and other areas where students congregate .
6. Promoting mitigation strategies such as keeping students home when sick, staying hydrated, healthy sleeping & exercise habits, and proper nutrition .
7. Using mouth coverings on students who come to school ill or have a persistent cough.

McCook Public Schools does not intend to require students to wear masks for the 2021-2022 school year. The District reserves the right to adjust our plans based on health directives as issued by the State of Nebraska.
