Superintendent's Update

Shared with the Corvallis School Board during the January 6, 2022 meeting.

COVID-19 Vaccine Clinics

Over the last year, CSD has partnered with Benton County Health Department, Corvallis Boys and Girls Club, and Samaritan Health Services to host 12 COVID-19 vaccine clinics. To support attendance, CSD family support staff conducted intensive outreach and follow up with families. Between the 12 clinics we were able to provide 1,246 COVID-19 vaccinations.

We also have an upcoming clinic at Cheldelin Middle School on Friday, January 14 from 3:00 - 7:00 pm. This location was chosen based on data provided by Benton County Health Department showing geographical areas in Corvallis where there are low rates of COVID-19 vaccination among CSD students. We are working with Benton County, the vaccine outreach team, and DevNW to promote this upcoming event.

Garfield Community Tour

The Garfield Elementary community tour has been postponed due to COVID-19 concerns. Once a new date has been selected, we will share that information.

Promise of Oregon Campaign

Corvallis School District was nominated by our school board chair, Sami Al-Abdrabbuh, and selected as 1 of 4 school districts in Oregon to participate in the Promise of Oregon campaign. The campaign's goal is to build support for public education through student voices.

One of our CSD students from Linus Pauling will be featured this week as the Promise of Oregon Project kicks off their statewide public education support campaign. Each week, different students from across Oregon will be featured. Corvallis will have 24 students highlighted across the span of the campaign. The selected students will be featured on the [campaign website](#) and on the Promise of Oregon [Facebook](#), [Twitter](#), and [Instagram](#) accounts.

We will also be sharing the posts on our CSD [Facebook](#) and [Twitter](#) accounts so please watch for and help us celebrate our CSD students from both Linus Pauling and Kathryn Jones Harrison.

2022 Local Option Levy

In the fall of 2016, Corvallis voters approved the current local option levy which has provided the Corvallis School District with additional funding over the past 5 years. The current levy will expire June 30, 2022 and renewing the levy would extend funding for another 5 years.

To aid the district in prioritizing how local option levy funds would be used if the levy passes, we have distributed a survey to gather public input from community members, parents/guardians, and district staff. The survey is available in [English](#) and [Spanish](#) online and paper copies are available in the front offices of all Corvallis schools and at the district office. To communicate this opportunity, the survey information has been shared with district families and staff through ParentSquare, on our district website, and through the local media.

So far we have received 696 responses. The survey closes on Thursday, January 13, 2022.

Staffing Supports for our Schools

We are doing all we can to keep our schools open. To address potential staffing shortages due to the potential spread of COVID-19, the following supports for staffing are being put into place:

- HR is working with Edustaff to assign 1 full day classified sub for the month of January per building
- HR has shared a list of student teachers in each building that can work as licensed substitutes
- Any secondary teacher subbing during their prep period will be compensated per the CEA contract

COVID-19 Impact on Extracurricular Activities

Decisions about extracurricular activities are made locally. It is important that families and communities understand the relationship between exposure and cases during extracurricular activities. If unvaccinated students are exposed during extracurricular activities, they are not able to Test to Stay for in-person learning.

Athletics in Corvallis School District

The nine athletic directors from the Mid-Willamette Conference met yesterday to add additional prevention measures into place for extracurricular activities. The requirements are outlined below:

Masks

Masks must be worn at all times unless a student-athlete is participating in a drill or competition.

Masks must be worn in locker rooms at all times by all individuals.

Spectators

Masks must be worn by all spectators. Those who do not consistently wear a mask will be asked to leave the venue.

No food will be allowed in the gym in order to keep masking in place. If anyone wishes to eat at an event, they must do so elsewhere and 6 feet away from other individuals.

Outlook

The Mid-Willamette Conference will continue to reassess the number of cases and compliance in the coming weeks.

District administrators will also reevaluate the preventative strategies to maintain athletics in our schools.

Other Extracurricular Activities

Masks

Masks must be worn in accordance with current district guidelines.

Spectators

Masks must be worn by all. Those who do not consistently wear a mask will be asked to leave the venue.

No food will be allowed in the venue, in order to keep masking in place. If anyone wishes to eat at an event, they must do so elsewhere and 6 feet away from other individuals.

Outlook

District administrators will reevaluate the preventative strategies to maintain extracurriculars in our schools.

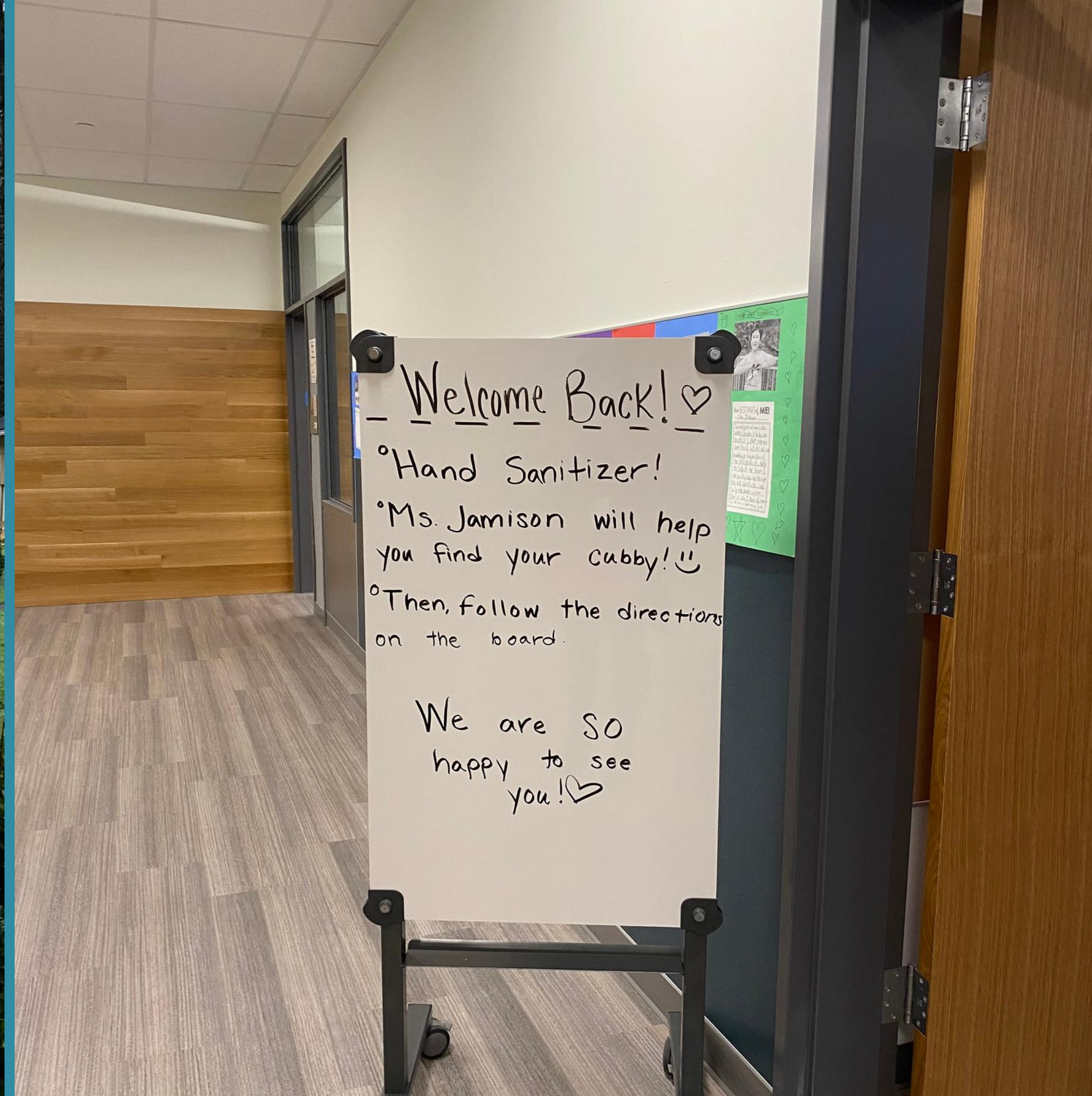
Bessie Coleman Highlights

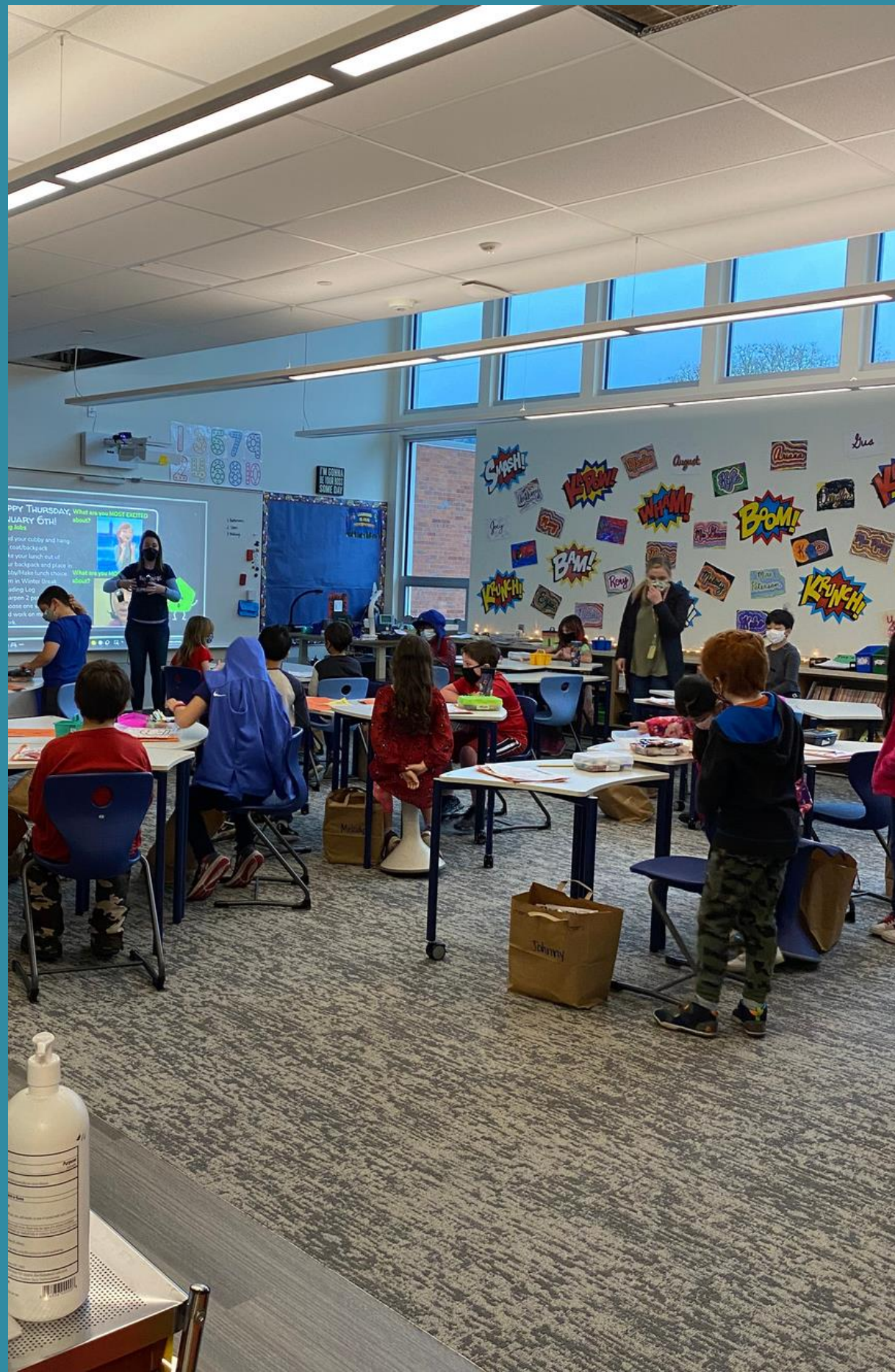
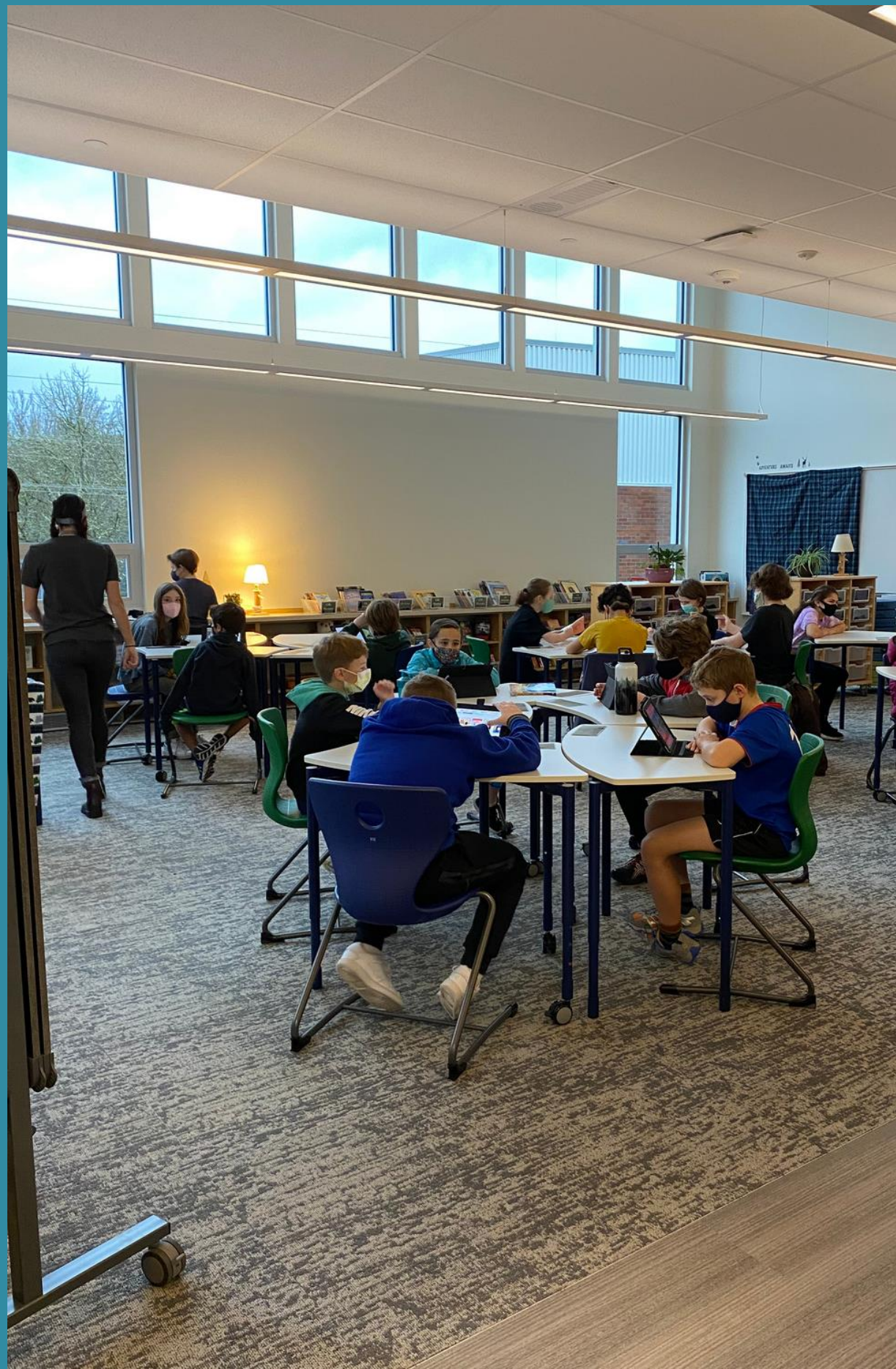

Public Comment at School Board Meetings

This option is available when *Public Comment* is an item on the agenda. At this time, Board meetings are held virtually and there will be no in-person public comment. To offer comments via telephone during designated meetings:

- A. Email Board Secretary Kim Nelson at kimberly.nelson@corvallis.k12.or.us by noon on the day of the meeting.
- B. Provide your name, home address, and the telephone number you will be calling in on.
- C. You will be provided a telephone number and meeting access code.
- D. At the time designated on the agenda, call the number provided and enter any required access codes.
- E. You will be “in the waiting room” until it is your turn to provide comments; at that time, you will be admitted to the virtual meeting.
- F. When you provide public comment, your name, address, and comments are matters of public record; however, students and staff do not need to provide their addresses.
- G. Keep your comments within the specified time allotted, usually three minutes, to allow time for others to comment. Please be respectful of those who wish to comment after you.
- H. Direct your comments to the School Board. The Board Chair will refer questions or requests for action to staff for response at a later date.
- I. If you read from a prepared statement, you may choose to email your written comments to Kim Nelson at kimberly.nelson@corvallis.k12.or.us to post online with the informational packet of the meeting and to file with the official minutes of the meeting. It is not required, however.
- J. Speakers may offer objective criticism of District operations and programs but the Board will not hear complaints concerning individual District personnel.
 - Complaints shall be handled following the steps outlined in Board Policy KL and Administrative Regulation KL-AR, copies of which are available at <http://policy.osba.org/corvall/kl/index.asp>.
 - Complaints regarding budget, programs, or other District issues also should be handled by first following the steps outlined in policy KL.
- K. Undue interruption or other interference with the orderly conduct of Board business cannot be allowed.
 - Defamatory or abusive remarks are always out of order.
 - The Board Chair may terminate a speaker’s privilege of address if, after being called to order, the speaker persists in improper conduct or remarks.

On behalf of the Franklin School PTA, I would like to thank you for the opportunity to include the following written testimony regarding the Corvallis School District Bond Program as it pertains to school building infrastructure funding, and more specifically, how funds have been allocated towards Franklin School.

We are very appreciative that the Corvallis community places a high value on education. The community's approval of the nearly \$200 million capital construction bond in 2018 was an emphatic indication of the community's support for our school district, families, and students. The district and its contractors have executed on a generational opportunity to transform aging schools and provide more equitable opportunities for district students. We applaud the district for successfully undertaking and executing on such an expansive effort. We are also thankful for the district's and the Corvallis School Board's commitment to equitable access to an inclusive and rigorous learning experience and outcome for our district families.

Franklin School celebrated its 26th year of operation this past fall. We believe Franklin School in part represents the district's commitment to diversity by offering a unique educational pathway for families who are interested in a different educational experience, especially at the middle school level. Franklin School represents inclusion by offering admission spots to any family in the district, independent of their neighborhood of residence. Franklin School often has a waitlist for elementary classes and a lottery overseen by the district is employed for student selection when demand exceeds classroom capacity.

The long-range facilities planning process, the subsequent school design guidance meetings, and Design Advisory Committee engagement were challenging for Franklin families. The design principles developed during design guidance meetings do not seem to have been wholly applied to Franklin. The Franklin Design Advisory Committee met twice with district staff. The DAC members provided input that was selectively addressed, and district staff made final design decisions and went to bid without DAC review and input. In short, the process was not transparent.

The bond program allocation to Franklin School is deficient relative to all other schools in the district that are slated for meaningful upgrades. Even with an expanded total budget, Franklin's funding allocation remains at four percent of the total bond program budget. While other schools benefited from substantial funding increases over

the three years of bond planning and design, Franklin was not afforded the same benefits. Similar to how we started, Franklin School's bond allocation remains the lowest in the district outside of Corvallis High School and Linus Pauling Middle School, two buildings completed in the mid-2000s.

The low funding level is apparent in the Bond Promises and the budget modifications we have been provided. We will be the only school in the district with a combined gym-cafeteria. We will not be provided with new playground equipment or a new covered play shed. Irrigation and landscape systems will not be upgraded, and there is no indication of covered bike parking. Each of these items has been provided for nearly every other elementary school undergoing construction. We believe these are inequities that impact our students' educational experience and may affect the future longevity of the school as prospective parents assess higher quality facilities elsewhere in the district.

We would appreciate your review of the attached document and response to our areas of concern and proposed solutions. We understand that expanding Franklin School's scope at this point will be constrained by dwindling bond reserves. However, to meet the district's value of honoring diversity, equity, and inclusion principles, we believe the district and the Board need to address the concerns we have outlined.

The Franklin School PTA looks forward to collaborating with the district and the board to develop solutions.

On behalf of the Franklin School PTA, I am submitting the following written testimony regarding the planned bond program expenditures for Franklin School. We congratulate the Corvallis School District on its thus far successful implementation of the capital construction bond approved by Corvallis voters in May 2018.

Despite the district's overall success with implementing the bond projects, the bond program has been a bittersweet experience for Franklin School parents and educators. Like previous long-range planning undertaken by the district in 2002 and 2008, the Franklin School building was again considered for closure during the 2017 planning. Franklin PTA members and parents participated in the long-range planning and the district elected to preserve the Franklin School building and undertake a major remodel on the building. Primary elements of the remodel include upgrading mechanical systems, improving emergency communications and lighting systems, constructing a secure front entry, addressing seismic concerns, converting old locker rooms into two middle school science classrooms, replacing windows, upgrading finishes in hallways and shared spaces, and other secondary treatments including installing a new flagpole.

The Franklin Design Advisory Committee met twice to review plans and provide input for the Franklin School remodel. The was expecting to meet a third time to finalize plans, but time constraints for the bidding process meant the team was not included in key decisions that informed the final project design.

The following document includes Franklin School teacher and staff concerns, and Franklin PTA and parent concerns. These requests and observations are based on a review of the design plans and presentation slide decks provided by the district this past November and December. School building budgets have been adjusted disproportionately as additional construction funds have been acquired, Franklin School's adjustments have been minimal. Bond reserve funds have been used to cover cost overruns associated with rising labor and material costs, but school fund allocations have also been adjusted to expand playgrounds in the case of Lincoln and Bessie Coleman. As we near the onset of demolition work while other school projects come to a close, we believe the district has not afforded Franklin School an equitable allocation of bond funding. This observation is apparent in the areas of concern and possible solutions we present.

Franklin School Teacher and Staff Concerns

The district presented the project design to Franklin School teachers and staff for comments on November 17, 2021. Table 1 includes areas of concern and possible solutions that were provided by the teaching staff to the Franklin School PTA.

Franklin PTA and Parent Concerns

The Corvallis School District Facilities Department provided the Franklin School sequencing plans and overall floor plan (plans dated 11-02-2021) to the Franklin DAC on December 2, 2021, and electronic versions of the bid/permit design plans (plans dated October 21, 2021, with mark-up sheets) were provided to Troy Brandt on December 14, 2021, following a request for the plans submitted on November 17, 2021. Franklin PTA members reviewed the plans and we have also tracked the other bond projects being completed around the district. Table 2 includes Franklin PTA and Franklin School parent concerns regarding the Franklin School design plans.

Table 3 provides a summary comparison of the Table 2 features across the district's elementary schools based on our review of publicly available design plans or implemented projects. The childhood elementary and secondary school experience is more than academics, but includes physical activity, playground socialization, and emotional development that comes through playground experiences. A deficiency in one or two of the Table 3 categories would be explainable, deficiencies in all six categories infringes on Franklin School's student's equitable access to play opportunities and outdoor experiences. Given the district's statement to the Franklin DAC members that no funds would be allocated for playground facilities, perhaps this outcome should not be surprising.

Bond Program Allocation

Since the original allocation of the Bond Program funds included in the district’s report to the Corvallis School Board on December 31, 2018, Franklin School’s allocation has remained the lowest of the district’s elementary schools, and Franklin’s allocation was only greater than Corvallis High School and Linus Pauling Middle School, two structures that were replaced in the mid-2000s. A common refrain for limiting further investment in the Franklin School building is the age of the building which is the second oldest in the district. However, a recent response by the Wenaha project manager to the Corvallis School Board regarding the Franklin School buildings’ longevity, suggests the school building upon its roof replacement and other upgrades has the potential for another 30 years of use. The district also calculated that investing in Franklin School’s infrastructure was a more cost-effective plan than closing the school and distributing students among the neighborhood schools. The district could have opted to build a new building for Franklin as suggested in the 2008 long-range facilities planning or move Franklin to the Harding School campus. Building a new school was likely not economically feasible with the replacement of both the Lincoln School building and the former Hoover School building. We do not know if the district considered moving Franklin School students to Harding School and College Hill students to the Franklin School building although a Franklin parent made the suggestion to the superintendent’s office.

Franklin’s initial allocation of \$8,897,336 was 4% of the overall 2018 bond cost of \$199,916,925. Bond premium and other funding sources acquired by the district since 2018 have expanded the total bond budget to \$257,797,382 as of the October 31, 2021 update provided by the district to the Corvallis School Board. Franklin’s guaranteed maximum price approved by the Corvallis School Board during the December 16, 2021 meeting was for \$11,207,604, or a 26% increase over Franklin’s original allocation. Although undoubtedly a substantial sum, Franklin’s allocation remains 4% of the overall bond funds. Franklin also had the smallest monetary increase of all schools but Cheldelin and Linus Pauling, and Franklin’s allocation is 57% of the \$19.6 million average budget allocated to all of the other schools in the district. Even with removing the two replacement schools’ costs, Franklin’s budget was 71% of the remaining schools’ average budget. Franklin’s 2021 allocation is 64% of Mt. View’s (a smaller school with declining enrollment) allocation, and 65% of College Hill’s (the district’s alternative learning program with a current enrollment of 120 students) allocation.

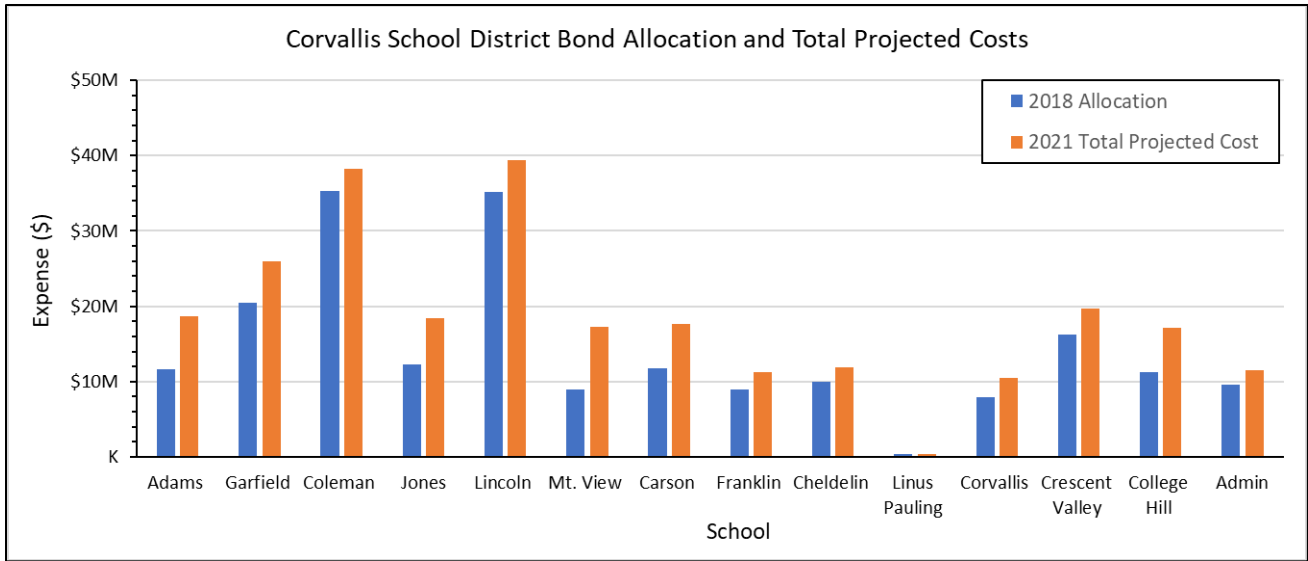


Figure 1. A comparison of school construction budgets comparing the December 31, 2018 allocation and the October 31, 2021 bond update. Franklin School had the smallest dollar increase between the 2018 and 2021 values except for Cheldelin and Linus Pauling.

Figure 1 includes a comparison of the 2018 allocation and 2021 total projected costs for the district schools. Table 4 includes the values presented in Figure 1 plus the percent change between the two reporting periods.

Bond Allocation Standardized by School Enrollment

Franklin School enrollment is constrained by the size of the school building. Elementary grades are represented by one class per grade while middle school grades each have two classes. Franklin School typically has more family demand for elementary enrollment than space to accommodate the demand, including 2021 when there were 32 students waitlisted for enrollment between kindergarten and 5th grade. While Franklin School’s enrollment was down in 2021 (like other district schools), it was the only elementary or middle school in the district with higher actual enrollment relative to the projected enrollment (CSD Fall 2021 Enrollment Report). Franklin School’s 2021 enrollment represented 5% of district students and 8% of the district’s elementary and middle school students

who attended in-person class on October 1, 2021. One percent of Franklin School students left Franklin School to attend Corvallis Online in 2021, a considerably lower number compared to other district schools. Franklin and other schools undoubtedly lost students to homeschooling and private schooling due to uncertainty surrounding Covid and parents’ curriculum concerns. While the 2021 enrollment is just a snapshot of student attendance at Franklin School, Franklin School’s current enrollment is comparable to other schools in the district.

We used school enrollment to standardize the bond program expenditures by school. We used both the average enrollment based on the 2011, 2016, and 2021 values presented by the district in the Fall 2021 Enrollment Report, and the current or planned capacity for each elementary school as provided in the publicly available bond project descriptions for each school. Table 5 includes a comparison of the bond allocation for each elementary school and the associated cost per student at each elementary school relative to the cost expended per Franklin School student using the average enrollment and the current or planned capacity. In short, bond projects at the other district elementary schools expended an average of \$36,512 more per student based on the three-year average enrollment, and \$22,943 more per student based on current or planned capacity, relative to funds expended per Franklin School student. Removing Coleman and Lincoln expenditures reduces average values to \$21,751 and \$9,934 for average enrollment and current or planned capacity, respectively. College Hill’s per student cost is \$110,988 relative to each dollar spent for a Franklin student.

We value our district’s emphasis on inclusivity and diversity. By upgrading Franklin School’s remodel to reflect equity with our other district schools, the district is honoring its commitment to its core values. Franklin’s student body is comprised of students from every neighborhood school in Corvallis, a feature that directly promotes student diversity and inclusion.

We understand the many hurdles the district and its contractors have had to navigate over the past three years. Implementing a \$250 million dollar infrastructure improvement package is a generational opportunity for our district and community. Despite these great opportunities, we must also acknowledge the planning and funding deficiencies that, from our perspective, are disproportionately falling on our school and students. After reviewing the Franklin School designs, visiting other schools in the district, and reviewing the funding allocation figures, we believe the district has not equitably allocated bond program funds for Franklin School.

We would appreciate your consideration in addressing our areas of concern and potential solutions.
