ACKNOWLEDGEMENT OF WOMEN'S HISTORY MONTH

Resolution Number 22-0204

WHEREAS, the Corvallis School District recognizes and pays tribute to the significant contributions made in our community by all people who identify as women and girls, which includes trans women and girls; and

WHEREAS the Corvallis School District affirms that students, families, staff, and community members should be valued for all aspects of their identities; and

WHEREAS, Women's History Month grew out of local efforts in Santa Rosa, CA began by the Education Task Force of the Sonoma County Commission on the Status of Women by establishing Women's History Week in 1978 for the Sonoma School District and community; and

WHEREAS, International Women's day has occurred globally since 1911 in an effort to celebrate the social, economic, cultural, and political achievements of women; and

WHEREAS, women historically have been denied rights to vote, own property, and serve in political offices and other leadership positions until the twentieth century; and

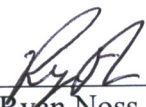

Background

School District Nursing is a very specialized form of public health nursing that promotes student health and ensures academic access for students experiencing both chronic and acute medical needs. School District Nursing in Oregon is guided by the Oregon State Board of Nursing as well as professional organizations such as; the National School Nurses Association, Oregon School Nurses Association, and the American Nurses Association. Local and Federal law also guides the practice of school nursing.

School District Nurses are the healthcare leaders in our schools that bridge healthcare and education, provide healthcare coordination, advocate for quality student-centered care, and collaborate to design systems that allow individuals and communities to develop their full potential (ANA & NASN, 2011).

In Oregon, school districts are required to have one registered nurse for every 225 medically complex students, one registered nurse for every 125 medically fragile students,

and one registered nurse or one licensed practical nurse under the supervision of a registered nurse, for every nursing dependent student. In addition to the required registered nurse-to-student staffing ratios, it is encouraged to have a registered nurse for every 750 students in the school district (ORS 336.201).

In the 2023-24 school year, ODE and OSNA released a standardized student acuity scoring tool encouraging school district nurses to utilize this tool in an attempt to more accurately recognize and categorize the health needs of students in Oregon. The CSD nurses used this acuity scoring tool when determining student acuity for the 2023-24 school year. The following student acuities were obtained.

CSD Student Population Health

According to the *Health Complexity Report - Benton County: March 2023*, a total of 28.6% of children in Benton County experience some level of chronic medical complexity. Of that total, 10. 6% have a complex chronic medical complexity and 18% have a non-complex chronic medical complexity. [Health Complexity in Children – Benton County](#).

In addition to district-employed nurses, the school district contracts two part-time agency nurses to provide direct 1:1 care to one specific student.

Staff Training Provided by District Nursing for School Year 2024-2025

In January 2022, the district nurses began training to become American Health Association (AHA) CPR instructors, and ultimately all five nurses became AHA Basic Life Support CPR instructors. By doing this, the CSD nursing department obtained the knowledge and certification required to teach Heartsaver CPR and First Aid courses to district employees.

The District Nurses are utilizing a format that includes both asynchronous and synchronous learning modalities, giving CSD staff flexibility in completing their CPR/First Aid certifications. In addition to training staff, the CSD Nurses have had the privilege to certify 20 high school students in both CPR and First Aid in the 2024-25 school year. In addition to CPR and First Aid training, nursing staff also provides Epinephrine, Glucagon, and Medication Basics training to staff throughout the school year.

Delegations and Other Medical Trainings

Delegation of nursing care is necessary in the school setting to meet the needs of students when there is not a nurse available to provide nursing care in all buildings. This school year in the Corvallis School district there are currently 10 students whose care requires a nursing delegation, which is an increase from 7 students whose care required delegation during the 2023-24 school year.

The process for nursing delegation is done per the Oregon Nurse Practice Act, Division 47. The CSD nurses also provide direct care when the nurse determines that care may not be safely delegated to school staff. There is currently one student in the district who has a nurse perform a medical procedure daily that cannot be delegated to school staff.

In addition to state-mandated and delegation training, CSD nurses provide many staff training opportunities that cover other health needs such as seizures, how and when to administer seizure rescue medications, hemophilia training, etc. Currently, we have several students with a seizure diagnosis that require staff trained in seizure response and how to administer seizure rescue medications. These students require trained staff present for all school activities, including bus riding and field trips.

Medication Safety and Access to Health Room

The CSD nursing team recognizes medication safety as a high priority in our schools to keep our students safe and in school. The nursing team has made it a priority to regularly audit medications in the school health rooms to ensure accurate documentation, medication dosing, and medication tracking. District Nurses also provide support to the Health Rooms in each building, which give care to any student who has an injury or illness during the school day.

Narcan access in schools

In response to the fentanyl crisis in Oregon. The Corvallis School District has made naloxone kits accessible in all school buildings. District Nursing is responsible for tracking and maintaining naloxone within the buildings. District nursing also trains staff on the recognition of an opioid overdose as well as when and how to administer Narcan/naloxone as a part of Heartsaver CPR/First Aid/AED training. This training is available to all CSD staff and coaches.

Health Screenings

Vision Screenings: State-mandated vision screenings were conducted at all elementary schools. Vision screenings are conducted in partnership with the Lions Club.

Dental Screening: Sealants, fluoride, and silver diamine fluoride (SDF) are offered on an opt-in basis, with parent consent at all elementary schools for all grades. At Franklin and LPMS we offer dental screenings to middle school students as well.

Conclusion

While total student enrollment has been decreasing, the number of students with health-related needs continues to increase. Supporting the acute and chronic health needs of our students is vital to improving student attendance, academic outcomes, and graduation rates within our school district. The CSD nurses strive to meet the individual healthcare needs of all students in our schools but are met with challenges related to the

increased number of students with health needs, increasing complex medical needs of our students, reduction in nursing FTE and other staffing constraints, and laws that address the delivery of medical care in the school setting. Supporting school health and nursing services will better equip the Corvallis School District to maintain a healthy community as well as support education outcomes.

2026/2027 School Year Calendar - First Read

NO ACTION REQUIRED

Background

School Board Policy IC/ICA—School Year/School Calendar directs the Superintendent to establish a school calendar that gives consideration to input from staff, families, and the community.

A staff survey was administered in December that included a proposal to change the start of school to before Labor Day in the 2026-2027 school year. 278 staff responded, and 74.1% supported it starting before Labor Day in the 2026/ 2027 school year. This proposed change was brought to staff because of the late Labor Day holiday in September 2026.

The proposed calendar deviates from previous Corvallis School District calendars, with school beginning the week before Labor Day.

From family surveys about the school-year calendar, we have learned that families prefer:

- A unified K-12 calendar that is easy to understand.
- Attaching non-school days to weekends or other holiday breaks.
- Spreading breaks and non-school days evenly throughout the school year.
- A calendar that prioritizes student learning days and a 5-day school week.
- Aligning the school calendar with OSU and surrounding district calendars.

The proposed 2026-2027 calendar fulfills these family preferences. However, it is not feasible to align it with the calendars of other districts, as our calendars are approved and published before theirs.

Recommended key dates for the 2026-2027 school year are in the table below.

Theater Diversity Advisory Committee Report **NO ACTION REQUIRED**

The Theater Diversity Advisory Committee (TDAC) was created in 2021 to implement DEI Guidelines for Theater in the Corvallis School District. The committee is composed of parents, community members, and students who represent diverse backgrounds and have an interest in improving the district's theater programs. They are engaged for feedback on show selection, audition processes, casting guidelines, and helping to build an inclusive and inviting culture.

Since February of 2024, we have welcomed new members with diverse backgrounds and strong experiences in theater outside of our district as well as deep knowledge of DEI strategies. As a committee we are focusing on sustainable practices that ensure Diversity, Equity, and Inclusion in our theater programming is an integral part of the program. One strategy to ensure sustainability of the committee is the election of a chairperson to help ensure that we are focussing our efforts on the most impactful work. This spring's focus will be updating the "DEI Guidelines for Theater".

In the 2024/25 school year TDAC has continued monitoring and observing processes that were implemented in the 2023/24 school year including show selection, casting, and audition rubrics, and observations of auditions. This year we celebrated changes made to the audition process as a result of last year's TDAC feedback. Changes included increased communication about the audition and casting rubrics and clearly communicated expectations for all participants at auditions.

In the 2023/24 TDAC encouraged staff to increase participation for students with diverse backgrounds. As a result, the district offered scholarships to students at our Title I schools (Garfield, Letitia Carson, Lincoln, and Mt. View) for our STAGES Summer Camp. We were excited to find that participation at auditions increased from all four Title I schools and from our Latine students.

History of Osborn Aquatic Center



1977 - Osborn was built with a bond levy passed by the Corvallis School District. This bond was put to voters in collaboration with the City of Corvallis to support aquatic recreation in our community.

1998 - Corvallis School District passed a Facilities Improvement Bond to update the interior pool and build Otter Beach.

Osborn Aquatic Center is considered one of the top 5 pools on the west coast.



It has an indoor 50-meter pool.

The deck space is larger than most.

It has 50 meters of observation deck.

It draws teams from all over the West Coast for competition.

Operating Agreement

Upon completion of the renovation in 1999, the City and District entered into an operating agreement.

- Daily Operations
- Maintenance
- Capital Planning

Capital maintenance was intended to be covered by a reserve fund established with remaining bond funds. The agreement was not clear on who would fund ongoing capital maintenance.

In 2019, the district began sending the City \$100,000 annually to help with capital maintenance expenses.

Structural Failure Overview

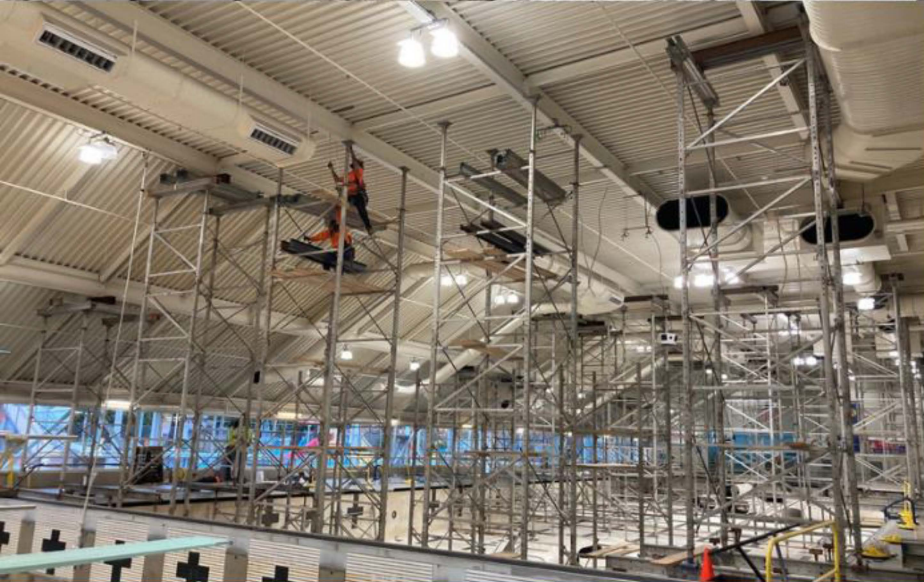


Where the interior coated steel connects to the roof exoskeleton has significant corrosion that could lead to catastrophic structural failure.

The City hired a shoring company to secure the roof structure to avoid collapse.

An engineering report provided by the City of Corvallis has outlined potential repair strategies ranging from \$2.5-4.5 million.

Additional concerns are now raised about the pool liner, pumps, and overall infrastructure of the indoor pool system.



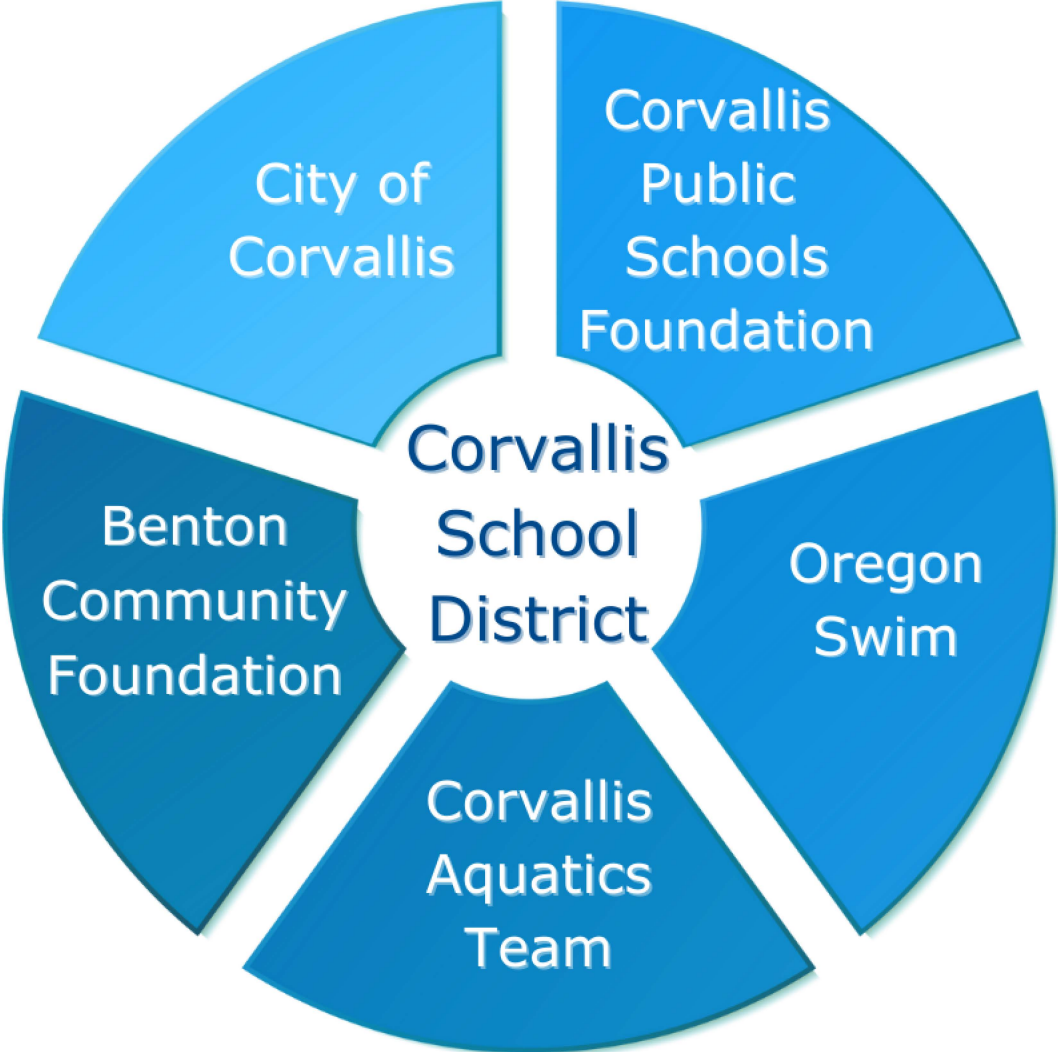
District Resources
