The State released the second round of categorical payments for the end of this month but he doesn't expect to receive it because the Comptroller has not released it. An impact fee check was received for 7 homes for \$46,000.00 the district is currently 2 houses up from last year.
 - 4.2 Final Tax Levy for the year 2011 - Dr. Rabenhorst briefly reviewed the tax levy. There were no changes in the final levy.

- 4.3 Policy 2:250 Access to District Records - The Board approved the updated policy on FOIA requests set a fee to charge for recurrent requesters and commercial purposes
- 4.4 Board Policy 6:150 Home and Hospital Instruction - This policy has been updated to reflect recent changes to the law making it easier to receive home and hospital instruction
- 4.5 District Improvement Plan - Esther reviewed the District Improvement Plan.

- 5.1 Board Committee Reports –DLT discussed new SOC website creator. Ideas for the teachers' morale booster were discussed. The teachers would like another health fair but it is too late in the year to plan. The district will plan a health fair for next school year and each building will host a lunch for teachers on the May institute day. They also reviewed the proposed calendar. The last attendance day for students must now be at least 1/2 day and we have complied with that new law. The staff appreciation lunch will be held that afternoon after the students leave. A brief discussion was held regarding AESOP and how the preferred substitutes are called. They are gathering climate survey information to go out February.
Block Schedule Study - this committee has worked very hard to come up with a solution for the new schedule. The committee prefers a modified block because it allows for students to have more class choices. There are two models being studied, the modified block from Minnesota and the traditional schedule from Geneva. The committee will have a recommendation in January.
Foundation - getting ready for spring grants. They are looking to revamp Trivia Schmivia and increase participation.
