Elementary Handbook Changes

Lost and Found

The lost and found is kept in a clearly marked container. Please label all items of clothing that a child removes during the course of a day (e.g., sweaters, mittens, hats, boots, gym shoes, etc.); proper labeling will help keep your child's things out of the lost and found. The schools donate all unclaimed lost and found items to charity after fall conferences and after the last day of school.

Lunch

Your children may bring their lunch from home, or they may participate in our hot lunch program. All District #301 schools will be using an on-line payment system. Money can be sent to school in an envelope with the child's name, grade and teacher's name on it or by going to the website and paying with a credit or debit card.

Students who do not have a lunch or lunch money will be given a lunch or substitute sandwich and milk. Students will be billed for this lunch and a lunchroom staff member will contact parents regarding money owed.

Items Brought to School

- Due to student allergy and school safety issues pets are not allowed in the school building or outside of a vehicle while on school grounds.
- Students should not bring electronic games, trading cards and the like to school. While cell phones are discouraged, if you deem a cell phone necessary for your child it must be turned off and kept in a backpack while at school and on the bus. Music devices must be kept in the student's backpack before exiting the bus. We discourage children from bringing toys as they may become lost or damaged. The school is not responsible for items of this nature that are brought to school.
- No gum is allowed at school.
- With regard to food, commercially prepackaged items that are clearly labeled with all ingredients are required. This applies to all school sponsored events.
- Birthday treats should be in the form of a non-food item. Items such as birthday pencils or bringing in a favorite story to read are preferable options. Classroom teachers may provide you with a suggested list of alternatives to help you plan. The School Board of Central School District #301 recognizes the importance of emphasizing Good Sportsmanship in all aspects of school related activities. With this thought in mind, the following fundamentals of good sportsmanship are recommended for all fans, spectators, participants, coaches, staff members, and parents:

1. Gain an understanding and appreciation for the rules of the event/contest.
2. Exercise positive behavior at all times.
3. Recognize and appreciate skilled performances regardless of affiliation.
4. Exhibit respect for all spectators, participants, coaches/sponsors, and officials.
5. Openly display respect for the opponents at all times.

Unacceptable behavior shall include, but not be limited to, the following types of conduct and such conduct as may be designated unacceptable from time to time by policy of the Board of Education:

1. Disrespect to referees, coaches, or other school personnel supervising the activity.
2. Fighting, intimidation of, or attempt to intimidate, referees, coaches, players or participants, or spectators.
3. Throwing debris or littering the playing field or facility.
4. Verbal abuse or use of profane or obscene words or gestures during a game or activity.
5. Behavior or conduct that is disruptive to the activity or event.

Any athlete or coach engaging in any of the above types of conduct may be suspended from competition for a period of time depending on the severity of the unacceptable behavior.

Acceptable Behavior

Central School District #301 will not tolerate any violations of the above "Fundamentals of Good Sportsmanship" by anyone before, during, or after any interscholastic contest or other school related activity in our district or any other place our students are participating. If anyone has a concern regarding any part of our athletic or activity program, they must comply with the following procedures:

1. Call or notify the appropriate coach/advisor or administrator of your concerns or inquire during normal school hours. Prior to, during, or after an event or practice is NOT the proper time to raise concerns or questions about a program, coaching decision, or administrative policy.
2. A meeting at a mutually agreed upon time will be scheduled to discuss/address the concerns or questions. All persons involved will be encouraged to attend the meeting.
3. A written report or summary of the meeting will be forwarded to all persons attending the meeting.

Violations - Consequences

Violations of any of the above "fundamentals of Good Sportsmanship" or "Acceptable Behavior" guidelines may result in any or all of the following consequences:

1. Possible immediate removal from the contest or activity.
2. Possible denied admission to school events for periods of one week to one year by a school district administrator.
3. Appeals of denied admissions may be made to the Superintendent and the Board of Education.

5. Any student who engages in conduct such as fighting, malicious damage to property, vandalism, theft or other activities which may reasonably be considered to be illegal or not in keeping with normal standards of behavior may be suspended from participation in the athletic and/or activities program.

Change: Would follow 6. Tobacco Abuse Penalties

7. Non-Acceptable Conduct Offense - Range of Possible Discipline Action

- a. Conference with student and coach; parent and coach; parent, coach, student and Athletic/Activities Director
- b. Temporary suspension from practice/contests
- c. Suspension for one-third of season by contests
- d. Suspension for remainder of season
- e. Suspension for remainder of season and up to one-third of next season
- f. Monetary restitution for vandalism, destruction of property

New category – clarifies Non-Acceptable Conduct and creates possible punishments.

Page 41 – Currently Reads

4. Criteria for earning an athletic letter

c. All members of a team that make a valuable contribution are determined by the coach to a varsity conference championship will receive a varsity letter. Fresh-Soph champions will receive Fresh-Soph letters on the same basis as varsity

Awards are based on coaches discretion and athletic policies.

1. Page 5
 - a. Add: **Disclaimer**
School rules published in this handbook are subject to such changes as may be needed to ensure continued compliance with federal, state or local regulations and are subject to such review and alteration as becomes necessary for the routine operation of the school. Not all behavior can be written and inserted in a guidebook; however, we expect students to follow reasonable rules and not violate the rights of others.
 - b. Rationale: To provide a clear statement that allows for mid-year changes that may be necessary.
2. Page 9 Morning Entrance to the building
 - a. Currently reads: Students may not enter the building until 7:20 a.m. without special permission of a teacher or administrator.
 - b. Change to: **Students may not enter the building until 7:10 a.m. without special permission of a teacher or administrator.**
 - c. Rationale: Time needs to move ahead due to the changing of the bell schedule.
3. Page 9 Student Dress
 - a. Currently reads: "Shorts and skirts and athletic shorts may be worn but must be approximately mid-thigh."
 - b. Change to: **Shorts and skirts may be worn but must be below the fingertips when standing.**
 - c. Rationale: The description is vague. The change becomes a continuation of what students have enforced at the middle schools.
4. Page 13 ID Cards
 - a. Add: **ID cards are also necessary to check out materials from the LMC, as well as purchase lunch.**
 - b. Rationale: Clarification & updated technology
5. Page 13 Authorized & Unauthorized Items
 - a. Remove #1 Allowing gum chewing & consequences for breaking the rule.
 - b. Rationale: This rule is no longer relevant, and has not been an issue. The separate consequences are unnecessary and can be covered under 'misconduct'. (The rule was added in the 80's after gum chewing had been banned.)
6. Page 13 Authorized & Unauthorized Items #3b
 - a. Remove: With the exception of cell phones, electronic devices may be used in the commons from 7:30 a.m. to 7:55 a.m.
 - b. Rationale: The bell schedule change will remove this 'free' time.
7. Page 14 Authorized & Unauthorized Items
 - a. Move the sections titled 'Consequences for accidental violations' and 'Consequences for purposeful violations' to the Actions & Punishments section

- b. Rationale: Basic information regarding electronic devices would stay under this subsection. Moving this portion makes more sense, as it will be with other consequences & school rules.

8. Page 14 Note regarding Camera Cell Phones or Other Electronic Devices with a Camera Feature

- a. Currently reads: Use of the camera feature on a cell phone or other electronic device in a restroom or locker room will result in a ten day suspension from school and possible recommendation for expulsion.”
- b. Change to: Use of the camera feature on **ANY** electronic device in a restroom or locker room **may** result in up to a ten day suspension from school and possible recommendation for expulsion, **depending upon the content & intent of the photo.**
- c. Rationale: To clarify the rule.
- d. Add: **Students actively participating in the taking of photos in a restroom or locker room will also receive consequences depending upon the content & intent of the photo.**

9. Page 14 Consequences for accidental violations (cell phones & electronic devices)

- a. Add to ‘third violation’ and ‘further violations’: **“and parent to pick up the device”**
- b. Rationale: Working with parents & encouraging them to help the school with responsible use of student electronic devices during school hours.

10. Page 14 Consequences for purposeful violations (cell phones & electronic devices)

- a. Add to ‘second violation’, ‘third violation’, and ‘further violations’: **“and parent to pick up the device”**
- b. Rationale: Working with parents & encouraging them to help the school with responsible use of student electronic devices during school hours

11. Page 14 Student Driving to School

- a. Add: **“Permits cannot be shared among students (except siblings when both qualify).”**
- b. Rationale: to clarify

12. Page 15 Student Driving to School #2

- a. Currently reads: “The application for such a permit must be accompanied with an explanation of why the permit is needed...”
- b. Change to: “The application for such a permit must be **filled out completely and signed by the student and parent/guardian.** “
- c. Rationale: The process has changed & the wording needed to be adjusted.

13. Page 18 Chronic or Habitual Truancy

- a. Currently reads: “...such attendance for ten percent or more of the previous 180 days...”
- b. Change to: “...such attendance for **five** percent (5%) or more of the previous 180 days...”
- c. Rationale: Change in IL School Code

14. Page 19

- a. Add: **Fox Valley Career Center & Off Campus Fox Valley Students**
Students enrolled in classes through the Fox Valley Career Center are responsible for attending these classes. Excessive absences will result in consequences ranging from a warning up to removal from the class.

- b. Rationale: There is currently nothing listed in the handbook to cover Fox Valley attendance. Clarification was needed.

15. Page 19 Academics

- a. Currently reads: "Participation in the graduation ceremony is a privilege. Seniors who demonstrate inappropriate behavior and conduct, or who exhibit poor attendance (absent 20 days or more) may be denied the privilege of participating in graduation ceremonies."
- b. Change to: "Participation in the graduation ceremony **and other senior-related activities** is a privilege. Seniors who demonstrate inappropriate behavior and conduct, or who exhibit poor attendance (**chronic truancy**) may be denied the privilege of participating in graduation ceremonies **and other senior-related activities.**"
- c. Rationale: Clarification

16. Page 20 Correspondence & Summer School Courses

- a. Currently reads: "No more than two Carnegie units of correspondence or summer school course credit may be applied toward graduation at Central High School."
- b. Change to: **"Students who wish to bring in more than two (2) Carnegie units of correspondence or summer school course credit to apply toward graduation at Central High School must meet with their counselor and submit a transcript(s). Credit requires principal approval."**
- c. Rationale: Our district does not offer summer school for credit recovery. Students who might be able to graduate 'on time' often have to return to CHS for an additional semester or year. Students would be able to take courses over the summer that would help them stay with their peers, graduate on time and help to decrease the chances of a student dropping out.

17. Page 22 Academics

- a. Currently Reads: "Schedule Changes"
- b. Change to: **Course Registration and Schedule Changes**
- 1. Students will register courses for the upcoming school year in February of the current school year;**
 - 2. Students will be permitted to make changes to their course requests up until five (5) days after the last day of student attendance for the school year. Students should contact their counselor in person, by phone, or by e-mail to request such changes;**
 - 3. Students will be mailed a copy of their schedule during the summer with their registration materials;**
 - 4. Unless a schedule change is necessary because a student either 1) failed a course, or 2) needs a course in a particular area in order to graduate, all other requests to change a schedule after this point will require:**
 - a. **Permission from the teacher whose class the student wishes to drop**
 - b. **Permission of the teacher whose class the student wishes to add**
 - c. **Permission from the student's counselor**
 - d. **Permission of the student's parent**
 - e. **Approval by the principal or his/her designee**
 - 5. Students can obtain course change request forms from their counselor.**
- c. Rationale: Schedule changes must be more limited than in past years so that course registration numbers do not vary greatly from what was approved before the school year.

18. Page 26 Handbook & Other Regulations #15a

- a. Add: **"It is the responsibility of students and parents to read & understand the contents of the handbook."**
- b. Rationale: clarification

19. Page 27 Late Arrivals to School

- a. Remove: "Parents shall be contacted upon a student's 2nd tardy during a given semester."
- b. Rationale: With the use of the Parent Portal, parents have access to daily attendance, including tardies. Currently students are contacted directly at their third tardy, which parents can also see when accessing the Parent Portal.

20. Page 27 4th & 5th tardy

- a. Currently reads: "...and parent phone call"
- b. Change to: "...and **parent notification.**"
- c. Rationale: Parents currently receive written notification when this occurs.

21. Page 27 6th – 9th tardy

- a. Remove: "...and no credit for day..."
- b. Rationale: This is not in the best educational interest of students.

22. Page 28 Temporary Classroom Removal (TCR)

- a. Remove: "Reasons why a student may be assigned to the TCR room include, but are not limited to the following:" Eight reasons are listed after this statement.
- b. Rationale: It is unnecessary to give specific reasons, as TCR is described as an alternative to other forms of discipline.

23. Page 28 Out of School Suspension (OSS) #2

- a. Currently reads: "...present at any school activity or event and is prohibited from being on school property."
- b. Change to: "...present at any **district** activity or event and is prohibited from being on **district** property."
- c. Rationale: clarification

24. Page 28 Out of School Suspension (OSS)

- a. Add: **Mentor Program**
Students who opt to enter a mentoring program will receive support for completing missing daily work and assignments. Teacher mentors will also serve as a social/emotional guides as necessary. Students will have an option of choosing from a list of mentor teachers. The student and mentor will:
 - 1. Arrange to meet on the first day a student returns from their suspension.**
 - 2. Create future meeting dates based on the need of the student and the length of suspension.**
 - 3. Report the day(s) and length of time for the meeting(s) to the Dean of Students.**
 - 4. Create an environment of support and personal responsibility.**
- b. Rationale: After piloting a mentor program this year, it was seen as a positive way to assist our students academically as well as socially & emotionally after coming off a suspension.

25. Page 30 Saturday School #14
- a. Currently reads: "...re-assignment of the Saturday School and an assignment to TCR."
 - b. Change to: "re-assignment of the Saturday School **and assignment to the next two (2) regularly scheduled Saturday Schools.**"
 - c. Rationale: This has proven to be a more effective consequence than TCR.
26. Page 31 Actions & Punishments #3 Possession or smoking of cigarettes or other forms of tobacco on school property
- a. Change title to: **Cigarettes and/or other forms of tobacco on school property**
 - b. Change to: **Possession on school property:**
 - 1st offense - Four hour Saturday School & ticket may be issued by Liaison Officer**
 - 2nd offense – One day suspension & ticket will be issued by Liaison Officer.**
 - Each repeated offense will result in a suspension of up to ten days & a ticket will be issued by Liaison Officer for each offense**
 - Smoking or using tobacco products on school property:**
 - 1st offense- One to three day suspension & ticket will be issued by Liaison Officer**
 - 2nd offense- Three to five day suspension & ticket will be issued by Liaison Officer**
 - Each repeated offense will result in a suspension of up to ten days & a ticket will be issued by Liaison Officer for each offense**
 - c. Rationale: Separating the consequences for being in possession of and actually using cigarettes or tobacco on school property.
27. Page 31 Actions & Punishments #5 Possession of weapons, parts of weapons or look-alike weapons on school property or within 1000 feet of school property.
- a. Change to: **Possession of weapons or parts of weapons on school property or within 1000 feet of school property will result in a 10 day suspension. Student may be recommended for expulsion depending upon the severity and intent.**
 - b. Change to: **Possession of look-alike weapons on school property or within 1000 feet of school property will result in a Saturday School or may result in up to a ten day suspension. Student may be recommended for expulsion depending upon the severity and intent.**
 - c. Rationale: **Separation of the consequences reflects difference between the two items.**
28. Page 31 Actions & Punishments #9 Disrespect/Disobedience towards teachers and/or staff
- a. Currently reads: "1st Offense- Saturday School or suspension and parent conference or expulsion depending upon severity of the act."
 - b. Change to: **Verbal and/or written warning up to a suspension** depending upon severity of the act.
 - c. Currently reads: "2nd Offense- Repeated instances of gross disrespect which disrupt the learning environment may result in more serious consequences including OSS and recommendation for expulsion."
 - d. Change to: **Repeated instances of gross disrespect which disrupt the learning environment will result in progressive consequences.**

- e. Rationale: For these adjustments, it allows for greater flexibility and a progressive approach

29. Page 35 Central Chemical Use Policy #1 Being under the influence...

- a. Currently reads: Ten (10) day Out of School suspension...
- b. Change to: **Up to** ten (10) day Out of School suspension.
- c. Rationale: No changes are to be made to #1

30. Page 35 Central Chemical Use Policy #2 Use or possession of...

- a. Currently reads: Ten (10) day Out of School suspension and school board hearing to consider expulsion. Student will be recommended to the Board of Education for expulsion.
- b. Change to **Up to** ten (10) day Out of School suspension.
- c. Remove: "and school board hearing to consider expulsion"
- d. Rationale: redundant with next sentence
- e. Change to: Student **may** be recommended to the Board of Education for expulsion.
- f. Rationale: Allows for responsiveness to different situations & consistent wording

31. Page 37 Interrogation and Search of Students

- i. Change title to **Student Questioning and Search**
- b. Add statement: **Refusal to cooperate with a search based on reasonable suspicion will result in consequences.**
- c. Rationale: Clarification

32. Page 40 Attendance at Events #2

- a. Add: **No student will be admitted one hour after a dance begins.**
- b. Rationale: To clarify and tighten rules around dances.

We appreciate your assistance as we work together to provide the appropriate accommodations for you and your students. With the limited space comes many perks. Because the hotel will be virtually exclusive to WLC students, staff and advisors this provides a greater degree of security and allows for uninterrupted use of the conference space.

Travel to the Conference

Driving directions

From Downtown Washington – Take Interstate 395 South across the 14th Street Bridge. Exit US Route 1 South. Turn right on 20th Street, then turn right on Eads Street. The hotel is 1 block on the right.

From North – Take Interstate 95 South to D.C. Beltway to Interstate 495 to Virginia. Exit 395 North and take Exit 8C (Crystal City) through 6 lights to Eads Street.

From West – Take 66 East to Route 110 (National Airport). Proceed to Route 1 South (Crystal City). Turn right on 20th Street, then turn right on Eads Street.

From South – Take I-95 North to 395 North and take Exit 8C (Crystal City) through 6 lights to Eads Street.

Arriving by Plane

If you are flying into Ronald Reagan Washington National airport, WLC staff will be located in the baggage claim areas, should you need assistance. The staff is there to provide information, and to help you locate ground transportation. **It is not necessary for you to locate the staff if you already know how to find the ground transportation. Should you have difficulty locating our staff (this is possible, as they may be helping a large group), simply follow the airport signs to "Ground Transportation" and take the complimentary hotel shuttle.** The information on how to find WLC staff is as follows:

- A WLC staff person will be stationed at the baggage claim information screens between baggage claims 6&7 on the lower level from 10 a.m. – 4 p.m. on Tuesdays.
