BOE Meeting

1. Roll Call

3. Public Open Forum
 - 3.1 Recognition of Visitors- Dr. Stirn welcomed all guests
 - 3.2 Public Comment – Kathy Windsor asked the board to review and reconsider board policy 7:40 Nonpublic school students, including parochial and home schooled students. Her daughter is home schooled and attends PKMS for physical education and choir. Her daughter wants to try out for the play but Board policy requires students to attend a minimum of 50% of the time in school in order to participate in athletics and extracurricular activities. Leanne Larsen commented her views on males participating in female sports and believes that it takes away from girls and the effect it will have on women's sports. Dave Chapman announced the exemplary employees for October and November and Linda Finn asked about the JV cheer team and if the girls will be able to cheer or not going forward.
4. Action Items
 - 4.1 Consent Agenda – Business Manager Pflug reviewed revenues and expenditures. Revenues are currently at 39.43% compared to 34.04% a year ago. Expenditures are at 29.61% as compared to 24.08% a year ago. The District has not received impact or transition fees. The board will discuss and act on a resolution regarding estimated amounts to be Levied
 - 4.2 Approve Tentative Tax Levy – The district will request \$44,200,000 in the 2019 tax levy for next year's operating expenses. We expect to receive only \$43,722,000 of that amount. The levy will cause taxes to increase slightly due to a slight increase in EAV and the estimated new housing coming in lower than anticipated.
 - 4.3 Accept Donation to Lily Lake Grade School – The Golden K Kiwanis donated \$770.00 in memory of long time teacher Ellen Krichbaum.
 - 4.4 Approve the Boys Cross Country Overnight Trip – The high school boys' cross-country team qualified for the State IHA competition in Peoria, Illinois. Approval is requested for the trip.
5. Information Items
 - 5.1 Committee Reports- CCC – The committee discussed grading practices and what is in a grade. Members were surveyed and will not meet again until January.
DLT – Member Brown is the board member representative. Dr. Stirn followed up on the enrollment presentation and discussed options for the future. The one thing affecting the district is growth. Currently, Howard B. Thomas Grade School is experiencing the fastest growth. One option would be a referendum after the bond and interest is reduced in 2026. If the district could hold off building a school until then, the taxpayers would not see much of a tax increase. The committee also discussed district wide fundraising, Toys for Tots and the 20/21 draft calendar which closely follows this years' calendar. They also discussed Veterans Day activities, and how the schools all did a nice job with their activities. Moving forward the DLT will begin to work on "Portrait of a Graduate" what are the key components graduates should have.
The Foundation – Trivia 2019 was a success, they are already looking at next year. The theme will be TV series through the decades. The foundation has an anonymous donor who will match funds up to \$10,000. When we raise \$10,000. They are also looking for another family event in the spring.
 - 5.3 Illinois Report Card Data – Dr. Mongan reviewed the district's Illinois Report Card with the Board. The report card included score trends and data for students and cohorts at the elementary, middle school, and high school level.

- 5.4 2020-2021 Draft Calendar – The draft calendar follows the majority of the other Fox Valley area calendars as well as the Mid Valley Special Education Cooperative. Member Nolan asked that administration look at trimesters for the elementary level and the possibility of earlier fall conferences.
- 5.5 Board of Education Committee Assignments – Dr. Stirn passed out the list of committee assignments they are as follows: Central 301 Education Foundation – Laura Rabe and Christina Johnson; Curriculum Coordinating Council (CCC) – Eric Nolan; District Leadership Team (DLT) – Stewart Brown; Emergency Preparedness Committee (EPC) – open.
- 5.6 Enrollment Report – the enrollment report will be pulled from the Student Information System in the Illinois State Board of Education website. Growth will be updated the first of each month to the last day of each month. The district continues to see growth.

Subject: Approval of 2019 Tax Levy
Date: December 16, 2019

Enclosed is the 2019 tax levy resolution to be approved by the Board. The levy figures are unchanged from what was presented to you at our last board meeting. Even though the request calls for an approximate 4.64% increase in the operating funds over last year's extension, we are anticipating only an estimated 3.5% increase in actual dollars received. Our bond payments will be \$7,497,500. Total EAV is estimated to be approximately \$755,000,000 and new construction is estimated at \$11,769,000. With these assumptions we are anticipating our Total School Tax Rate to increase from \$6.71 to \$6.78 for this levy year.

A resolution is attached for adoption along with the formal levy documents, (Truth in Taxation Certificate, Tax Levy Summary Sheets, and Certificate of Tax Levy form). These will then be delivered to both the Kane and DeKalb County tax extension offices before the December 31st deadline.

**RESOLUTION PROVIDING FOR THE LEVY OF TAXES BY
THE BOARD OF EDUCATION OF CENTRAL COMMUNITY
UNIT SCHOOL DISTRICT 301, COUNTIES OF KANE AND
DEKALB, ILLINOIS, FOR THE FISCAL YEAR BEGINNING
JULY 1, 2019 AND ENDING JUNE 30, 2020.**

BE IT RESOLVED BY THE BOARD OF EDUCATION OF CENTRAL COMMUNITY UNIT SCHOOL DISTRICT 301, COUNTIES OF KANE AND DEKALB, ILLINOIS, AS FOLLOWS:

Section 1. Recitals. It is found and declared by the Board of Education (*The "Board of Education"*) of Central Community Unit School District 301, Counties of Kane and DeKalb, Illinois (the "*District*"), as follows:

- a. The District is a school district duly created, organized and validly existing under the 1970 Illinois Constitution and the laws of the State of Illinois.
- b. The District is authorized under the provisions of Section 17-2 of the School Code to levy *ad valorem* property taxes annually upon all of the taxable property of the District for education purposes, for operations and maintenance purposes, and for transportation purposes.
- c. The District is authorized under the provisions of Section 20-3 of the School Code to levy *ad valorem* property taxes annually upon all of the taxable property of the District for the purpose of providing moneys for a working cash fund.
- d. The District is authorized under the provisions of Section 7-171 (b)(2) of the Pension Code, to levy *ad valorem* property taxes annually upon all of the taxable property of the District for the purpose of making contributions to the Illinois Municipal Retirement Fund.
- e. The District is authorized under the provisions of Section 21-110 of the Pension Code to levy *ad valorem* property taxes annually upon all of the taxable property of the District for social security.
- f. The District is authorized under the provisions of Section 17-2.11 of the School Code to levy *ad valorem* property taxes annually upon all of the taxable property of the District for the purpose of altering or reconstructing school buildings or permanent, fixed equipment, or installing security systems or equipment, or making certain repairs, for fire prevention, safety, energy conservation, disabled accessibility, school security and specified repair purposes.
- g. The District is authorized under the provisions of Section 17-2.2a of the School Code to levy *ad valorem* property taxes annually upon all of the taxable property of the District for special education purposes.
- h. The District is authorized under the provisions of Section 17-2.5 of the School Code and Section 9-107 of the local Governmental and Governmental Employees Tort Immunity Act, Chapter 745, Act 5, Illinois Compiled Statutes, as amended (the "Tort Immunity Act"), to pay the cost of certain settlements or judgments, certain insurance, certain educational, inspectional

and supervisory services directly relating to loss prevention and reduction, certain bonds and certain risk management plan costs, all as defined in the Tort Immunity Act.

i. The Board of Education has determined to levy *ad valorem* taxes under the authority of the School Code, the Pension Code, and the Tort Immunity Act upon all of the taxable property of the District for such purposes, in the respective amounts set forth in Section 2 below, for the fiscal year of the District beginning July 1, 2019 and ending June 30, 2020.

Section 2. Levy of Taxes.

For the fiscal year of the District beginning July 1, 2019 and ending June 30, 2020, there are levied upon all of the taxable property of the District *ad valorem* taxes in the following amounts for the following purposes:

Section 3. Certificate of Levy. The President and the Secretary of the Board of Education, and the other officers and employees of the District, are authorized and directed to prepare, and the President and the Secretary of the Board of Education are authorized and directed to execute, on behalf of the District, the necessary certificate of levy certifying the amounts of taxes, including the taxes levied in Section 2 above, levied by the Board of Education of the District for the fiscal year of the District beginning July 1, 2019 and ending June 30, 2020, a copy of which Certificate of Tax Levy is attached hereto as Exhibit 1.

Section 4. Filing of Certificate of Tax Levy With County Clerks. The Secretary of the Board of Education is authorized and directed to cause said certificate of levy to be filed in the respective offices of the County Clerks of the County of Kane and the County of DeKalb, Illinois, as soon as practicable after adoption of this Resolution, but in no event later than the last

Tuesday in December 2019, along with a copy of the Certification of Compliance with the Truth in Taxation Law and any other additional levies, and resolutions authorizing such additional levies, adopted by the Board of Education for 2019.

Section 5. Additional Authority. The President, the Treasurer, the Secretary, and the other officers and employees of the District are authorized to execute and deliver on behalf of the District such other documents, agreements and certificates and to do such other things consistent with the terms of this Resolution as such officers and employees shall deem necessary or appropriate in order to effectuate the intent and purposes of this Resolution.

Section 6. Conflicting Resolutions. All resolutions and orders or parts of resolutions and orders in conflict with this Resolution are repealed to the extent of such conflict.

Section 7. Severability. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Resolution, which shall continue in full force and effect.

Section 8. Effective Date. This Resolution shall be in full force and effect immediately upon its adoption by the Board.

Students

Nonpublic School Students, Including Parochial and Home-Schooled Students

Part-Time Attendance

The District accepts nonpublic school students, including parochial and home-schooled students, who live within the District for part-time attendance in the District's regular education program on a space-available basis. Requests for part-time attendance must be submitted in writing to the Building Principal of the school in the school attendance area where the student resides. All requests for attendance in the following school year must be submitted before May 1.

A student accepted for partial enrollment must comply with all discipline and attendance requirements established by the school. He or she may participate in any co-curricular activity associated with a District class in which he or she is enrolled. The parent(s)/guardian(s) of a student accepted for partial enrollment must pay all fees; ~~pro-rated~~ on the basis of a percentage of full-time fees. Transportation to and/or from school is provided on regular bus routes to or from a point on the route nearest or most easily accessible to the non-public school or student's home. This transportation shall be on the same basis as the District provides transportation for its full-time students. Transportation on other than established bus routes shall be the responsibility of the parent(s)/guardian(s).

Students with a Disability

The District accepts for part-time attendance those children for whom it has been determined that special education services are needed, are enrolled in nonpublic schools, and otherwise qualify for enrollment in the District. Requests must be submitted by the student's parent(s)/guardian(s). Special educational services shall be provided to such students as soon as possible after identification, evaluation, and placement procedures provided by State law, but no later than the beginning of the next school semester following the completion of such procedures. Transportation for such students shall be provided only if required in the child's Individualized Educational Program on the basis of the child's disabling condition or as the special education program location may require.

Extracurricular Activities, Including Interscholastic Competition

A nonpublic school student is eligible to participate: (1) in interscholastic competition, provided his or her participation adheres to the regulations established by any association in which the School District maintains a membership, and (2) non-athletic extracurricular activities, provided the student attends a District school for at least one-half of the regular school day, excluding lunch. A nonpublic student who participates in an extracurricular activity is subject to all policies, regulations, and rules that are applicable to other participants in the activity.

Assignment When Enrolling Full-Time in a District School

Grade placement by, and academic credits earned at, a nonpublic school will be accepted if the school has a Certificate of Nonpublic School Recognition from the Illinois State Board of Education, or, if outside Illinois, if the school is accredited by the state agency governing education.

A student who, after receiving instruction in a non-recognized or non-accredited school, enrolls in the District will: (1) be assigned to a grade level according to academic proficiency, and/or (2) have academic credits recognized by the District if the student demonstrates appropriate academic

proficiency to the school administration. Any portion of a student's transcript relating to such instruction will not be considered for placement on the honor roll or computation in class rank.

Notwithstanding the above, recognition of grade placement and academic credits awarded by a nonpublic school is at the sole discretion of the District. All school and class assignments will be made according to School Board policy 7:30, *Student Assignment*, as well as administrative procedures implementing this policy.
