3.1 Recognition of Visitors - Dr. Stirn welcomed all guests

3.2 Dave Chapman announced the exemplary employees for January and February.

4. Action Reports

4.1 Consent Agenda - Business Manager Pflug reviewed revenues and expenditures. Revenues are currently at 45.51% compared to 39.34% a year ago. Expenditures are at 47.74% compared to 46.07% a year ago. The District impact fees for 10 home starts totaled \$55,106.02. Transition fees received totaled \$5700.02. Update on the 2020 Food Service Grant is still in review. The School Maintenance Grant was submitted to the ROE on February 14, 2020 and they submitted to the State for approval.

Treasurer's Report - Business Manager Pflug indicated payables for February are typical.

4.2 2020-2021 Revised School Year Calendar – When the calendar was approved in January Reduce 1 teacher work day to reach 182 teacher work days, excluding emergency days. Revised calendar “Draft B+”. Student days were okay, but teacher work days were 183 days. Took back to DLT for revisions. Didn’t want to lose school improvement days in November. Changes will be put at the end of year. There will be 2 half days, first would be Wednesday May 19th – half day students and staff recognition in the afternoon. On Thursday May 20th – half day students and in the afternoon teacher’s would wrap up their records.

4.3 Paving Bid - Director Polowy reviewed the bid. The district is going with Schroeder Asphalt Services Inc. The whole bus lot is going to be paved and the turnaround at PKMS will be concrete for half of that turn. Most of the central campus will be paved.

- 4.4 Lunch Fee Increase for 2020-2021 – Director Mirenda reviewed pricing change recommendation from the USDA. The increase is part of the USDA requirement called the “Paid Lunch Equity”. They want to make sure school districts have the paid lunch prices plus their reimbursement rate which needs equal or come close to a free lunch reimbursement. Adult lunches have been raised due to a food cost increase.
- 4.5 FFA Donation – Buddy Haas reviewed the donation. The donation was in part recognition of being named a model of excellence. Donation is from the National FFA Organization for the CHS FFA department to help offset the cost of various FFA activities, to grow leaders, build communities and strengthen the agriculture community.
- 4.6 CHS Dance Team Overnight Trip to IHSA - The team attended the sectional competition in Bloomington IL. The team did an outstanding job. They won sectional on day one, but did not make day two.
- 4.7 FFA Overnight Trip – Approval is needed for 10 students and 1 chaperone to attend the FFA Ag Legislative Day in Springfield, IL from Tues. March 2nd to Wednesday March 3rd. FFA members will go to the capital to deliver commodity baskets to different legislators, and representatives and senators as a thank you for supporting Ag education. The FFA members will be sitting with a panel of legislators and representatives throughout the entire state to be able to have conversation of the current state of agriculture in the state of Illinois, and be able to share stories.
- 4.8 CHS Cheer Team Overnight Trip to IHSA – The team attend State competition in Bloomington. They did a great job, but did not make the second day competition.

5. Information Items

- 5.1 Committee Reports – CCC met to follow up on grading practices, how they are being utilized in the district. How people are coming to them within their teams, buildings, cross buildings. Completed a survey that will be going out to all teachers next week for the half SIP day with an introduction that will be sent out as well. We will stratify some of the data between all buildings. Hopefully we will have this data by next month. DLT-discussed calendar and came up with revision to present to the Board. Revisited the terms that are used to Paint that Portrait of a Graduate and what characteristics we would like them to have. Spent time talking about the Words and Humility and decided to stay with it. Foundation – had Andy Minehart join regarding investments we have with the education foundation. Talked about the possibility of having an endowment fund, and ideas to increase our financial stability. How gifts of stock could be given or bequeath to the foundation. Talked about branding and will bring back questions in response with one of our members in more detail. The website is being updated. Spent time on scholarship applications. Currently have three (3) scholarships that the foundation is promoting and one is very significant at \$2,000. Information was pushed out to the community on the scholarships that are available. Spent time talking about

our next fundraiser event. Possibly have something towards the beginning of the year to kick off the school year. Talking about money coming into the foundation and how it is going out to the schools. How to help with innovative programming at other levels. Proposal to raise funds for equipment for students at elementary level that could be tied into the LMC.

- 5.2 Comparative School Report Card Data – This was on agenda last month and brought back for any questions.
 - 5.3 Spring 2020 Board Retreat Date – Looking at the month of April. The meeting should last between 3-4 hours. Possibly a dinner meeting or a Saturday morning. Will circle back to this after some discussion.
 - 5.4 Board Meeting Location Change – The BOE meeting will be moved to the district office for the March meeting. Will be informing the community and press as well.
 - 5.5 Enrollment Report – Report shows comparatives across our district from 2019 to 2020 and the various schools to where we were a year ago. We are growing at a modest rate of around 3% which is typical. Number of permits from the city of Elgin appears to be coming in at the same rate as previous years.

JOINT AGREEMENT

FOR OPERATION OF THE FOX VALLEY CAREER CENTER

WHEREAS, the school districts which are parties to this agreement all maintain a school system for the education of students attending the kindergarten through twelfth grades inclusive, and

WHEREAS, it is not economically practical for each of said individual school districts to finance and operate an adequate program of career, vocational and technical education for grades eleven and twelve, and

WHEREAS, Paragraph 10-22.31a of the School Code of Illinois (105 ILCS 5/10 – 22.31a) authorizes and empowers boards of education of Illinois school districts to establish joint educational programs as follows:

JOINT EDUCATIONAL PROGRAMS. To enter into joint agreement with other school boards to establish any type of educational program which any district may establish individually, to provide the needed educational facilities and to employ a director and other professional workers for such a program. The director and other professional workers may be employed by one district which shall be reimbursed on a mutually agreed basis by other districts that are parties to the joint agreement. Such agreements may provide that one district may supply professional workers for a joint program conducted in another district.

and

WHEREAS, in order to provide enrollments large enough to support and justify such a program of vocational education it is necessary and desirable that said districts enter into joint and cooperative agreement to provide the needed facilities and personnel as authorized by the aforesaid section of the School Code.

NOW, THEREFORE, for and in consideration of the mutual promises and agreements of the respective school districts which are parties to this agreement, it is hereby agreed between them as follows:

ARTICLE I

I - 1 The name of this vocational/career center shall be the Fox Valley Career Center (FVCC).

I - 2 Purposes:

The purpose of the FVCC is to help students develop the college, career and technical knowledge, skills and attitudes they need in order to pursue successful careers, advanced training or education immediately after high school or later.

After graduation from high school, the students should also be adequately prepared to enter employment or appropriate programs in community colleges, technical schools, or universities.

I - 3 Membership

Membership in this joint agreement shall consist of (1) the Batavia Public Schools, Dist. #101, Batavia, Illinois; (2) Central School Dist. #301, Burlington, Illinois, (3) Kaneland Community Unit School Dist. #302, 47W326 Keslinger Road, Maple Park, Illinois; (4) Geneva Community Unit School Dist. #304, Geneva, Illinois; (5) St. Charles Community Unit School Dist. #303, St. Charles, Illinois; (6) West Aurora School District #129, Aurora, Illinois. Other school districts may be admitted in accordance with Article V of this agreement.

ARTICLE II – ORGANIZATION AND OPERATION

II - 1 ADMINISTRATIVE DISTRICT. The administrative district for the operation of the program shall be Community Unit District #302, Kane and DeKalb Counties, Illinois, and such administrative district through its Board of Education, hereafter referred to as the Administrative Board, is hereby authorized and empowered:

- (a) To provide the physical facilities, including building, fixtures and equipment, required to set up and establish the program.
- (b) To name and designate a director who shall be a member of the staff of the administrative district and who shall cooperate in the operation with the superintendents who are members of the advisory board as hereinafter set forth.
- (c) To hire and engage teachers and personnel as may be necessary.
- (d) To apply for and receive all payments from state and federal sources which may be available from time to time as grants, contributions or reimbursements from any state or federal agency or department, either for capital outlays or operating expenses.
- (e) To receive contributions or donations to the program of cash, fixtures, equipment or supplies for any similar purpose, from any private individual, firm or corporation.

- (f) To pay all of the expenses and operating costs of the program.
- (g) To do and perform any and all other acts necessary for the establishment and maintenance of the program.

The director and all teachers or other employees shall be considered for all legal purposes as employees of the administrative district and subject to all of the rules and regulations made applicable by law to the employees of such district.

In view of the fact that the buildings, and most of the fixtures and equipment shall be provided by the administrative district, it is understood and agreed that all such property that is used in this vocational center shall at all times and for all purposes be and remain the property of the administrative district.

II - 2 **ADMINISTRATIVE STRUCTURE.** The superintendents of the member school districts shall constitute the Board of Directors which shall make and approve policy and act as liaison to the Boards of Education of participating districts. The Kaneland Superintendent shall serve as Chairperson of the Board of Directors. Such board may elect one of its members to serve as vice-chairperson and shall hold such meetings for the conduct of its business as from time to time may be deemed advisable. Any decision of such board shall be by a majority vote.

In accordance with Section II – 1 of this agreement, a Director of the Center, shall be employed. The duties of the Director shall be determined by the Board of Directors and the Administrative Board. The FVCC Director shall serve as secretary to the Board preparing the necessary materials for the Board of Directors meetings and maintaining records and information resulting from such meetings.

II - 3 **ADVISORY COMMITTEES.** Separate advisory committees shall be organized for each occupational area. They shall represent a diversity of industry from the small and relatively simple firm to complex international corporations. The teachers are to be directly involved with and meet with their occupational committee. Minutes of the advisory committee meetings shall be kept. The primary function of local advisory committees is to advise and counsel the educational system's administration and instructional staff in planning, implementing and maintaining vocational and technical educational programs. Some specific functions might be to:

1. Provide important communication between the educational systems and the community.
2. Review the goals and objectives of the local and technical education program.

3. Make recommendations to administrators regarding students for instructional facilities.
4. Assist in the preparation of a local philosophy of vocational and technical education.
5. Aid in continuous review of the content and organization of the instructional program in keeping with the occupational needs of the community, area or state.
6. Advise the administration relative to setting up qualifications of instructors.
7. Suggest criteria for selection of students.
8. Assist in locating training stations for cooperative students.
9. Assist in the development and recommendation of an equitable financial support system.
10. Assist in planning of a student placement program.
11. Support state and national legislation affecting vocational and technical education.
12. Assist in long-term program planning.
13. Assist with a continuous appraisal of occupational opportunities in the communities served.
14. Assist in the identification of needed research in career, vocational and technical education.

ARTICLE III – PROGRAM

III - 1 The Administrative Board, in cooperation with the Board of Directors, shall contract for and otherwise provide as necessary for personnel, sites, and physical facilities required to house and support the educational and related activities of the Center.

III - 2 The Administrative Board, in cooperation with the Board of Directors, shall establish career, vocational and technical education programs and related services that it deems necessary for the effective operation of the Center, consistent with all project proposals and specification as approved by the Illinois State Board of Education and in the interests of the participating school districts.

III - 3 The Administrative Board, in cooperation with the Board of Directors, shall approve the employment of such personnel as it deems necessary to support the programs and services and shall establish employment and personnel policy consistent with Illinois law.

III - 4 The Administrative Board, in cooperation with the Board of Directors, shall establish policies which maintain the principle of community involvement consistent with the intents and purposes of the cooperating districts, project proposals and specifications, and approving authorities granted various local, state and federal agencies by law.

III - 5 Finance

(a) **TUITION COSTS.** Based on gross operating costs, participating districts will be billed 1) First semester tuition amount based on the number of students enrolled on the eleventh day of first semester 2) The second semester tuition based on the number of students enrolled on the eleventh day of second semester. 3) Final tabulation for additional revenues needed or refunds for excess money collected will take place in June.

(b) **FINANCIAL RECORDS.** The administrative district shall maintain an accounting system accurately showing all receipts and disbursements for capital expenditures as well as ordinary operating costs. Such system shall be maintained in such manner that capital and operating expenses of the vocational program will be shown entirely separate from the other educational activities of the administrative district, so that in particular the operating costs of the program can be determined with exactness and thus prorated fairly among the participating district. The administrative district shall submit a summary statement of receipts and disbursements for both capital expenditures and operating costs to all participating districts in the form of an annual financial audit.

(c) **FACILITY AND ADMINISTRATIVE COSTS.** In addition to all costs related to educational programs and services, the FVCC budget shall include its direct or pro rata share of all relevant on-going facility-related costs (e.g., trash removal, utilities, snow removal, custodial services, regular repairs, etc). Costs for major facility improvements or repairs shall be reviewed with the Board of Directors and recouped through a payment schedule acceptable to the Board of Directors and administrative district. The budget shall also include the FVCC's direct or pro rata share of costs for professional and administrative services provided by the administrative district.

(d) A tentative budget shall be prepared and presented by the Director at the regular May meeting of the Board of Directors. The tentative budget shall be approved by the Board of Directors for recommendation to the Administrative District. The budget will be adopted by the Administrative District in accordance with statutory requirements. Once the budget has been adopted by

the Board of Directors and the Administrative District, it may be adjusted via transfers between line items not exceeding in the aggregate 10% of the total fund budget. Both the Board of Directors and the Administrative District must approve any such transfer. The Budget as approved shall be binding on the participating districts and also on the Administrative District.

ARTICLE IV – TRANSPORTATION

IV - 1 Each participating district shall furnish transportation for the pupils of that district to and from the Career Center in a manner prescribed by the Board of Education of the participating district.

ARTICLE V – PROCEDURES FOR ADMISSION OR WITHDRAWAL OF A SCHOOL DISTRICT FROM THIS JOINT AGREEMENT

V - 1 FVCC operates on a year to year basis, but any participating district may terminate its participation consistent with the School Code of Illinois (105 ILCS 5/10 – 22.31a). Notice of such intent must be given, in writing, to the Board of Directors and to the administrative district by January 31 in the calendar year prior to the year in which the withdrawal becomes effective. Any district which begins participation at the beginning of a school year shall be obligated to continue such participation for the entire school year on the terms and conditions herein set forth.

All tuition charges and obligations of the district withdrawing from the joint agreement must be paid upon withdrawal and all capital assets such as buildings, equipment and facilities used at the Center or as a part of the joint agreement are, and shall remain the property of the administrative district.

V - 2 If the Board of Directors and administrative district deem it advisable, and if facilities are available, other school districts in the area may be permitted to participate in the program upon such terms and conditions as the Board of Directors and the administrative district shall then determine.

ARTICLE VI – PROVISION FOR AMENDMENTS

VI - 1 It is further understood that this agreement may be amended or supplemented at any time by an agreement in writing signed by all of the participating districts.

ARTICLE VII – MISCELLANEOUS

VII - 1 **CREDITS FOR GRADUATION.** Each participating district shall determine its own basis for giving credit for courses attended by any of its students at the Career Center conducted under the auspices of this program.

IN WITNESS WHEREOF, the school districts which have agreed to participate in the initial operation of this program have hereunto caused this agreement to be executed by their duly authorized officers.

LAND CASH INTERGOVERNMENTAL AGREEMENT

WHEREAS, the County of Kane, Illinois, on behalf of itself, its officers, agents, and employees, through its ordinances has required contributions to the County of Kane by developers so that the County of Kane may, in turn, make those contributions available to the school and/or park districts or other eligible entities that are impacted by the subdivision improvements; and

WHEREAS, such contributions may be in land or in cash and, when transferred or paid over to the school and/or park districts, inure to the benefit of said districts; and

WHEREAS, the County of Kane is willing, at its discretion, to continue seeking contributions of land and money but requires a commitment from the districts that are benefited by the receipt of such contributions that those districts will: (a) acknowledge that the requirement that such developer contributions be made and the manner in which they are made are totally within the discretion of the County of Kane; (b) the districts that benefit from the contributions will bear the cost of defending and indemnifying against any and all lawsuits or legal actions of any kind challenging the appropriate amount of the contributions, the time at which they are to be made, the purpose for which said contributions are used, or any other aspect of the contributions; and (c) that a benefited district will comply with the terms of a final and nonappealable judicial determination by a court of competent jurisdiction rendered in connection with said actions; and

WHEREAS, the County of Kane is willing, in its discretion, to pay over or require contributions only upon execution of this agreement;

NOW, THEREFORE, IT IS AGREED between the County of Kane on behalf of itself and its board members, officers, agents, and employees and Central Community Unit School District 301 a government body within the State of Illinois, (hereinafter referred to as the "Benefiting District"), in consideration for the payment of money or the transfer of land to the Benefiting District, which the County of Kane from time to time may within its discretion cause to be made

by developers, that:

1. Except as otherwise provided in the Kane County Code, the County of Kane is not obligated to cause the payment of money or the transfer of land to the Benefiting District. The Benefiting District recognizes that the County of Kane may, at its sole discretion, amend its ordinances or its practices with respect to the collection or distribution of developer contributions to the Benefiting District.
2. In the event a lawsuit or any other legal action is instituted against the County of Kane, the Kane County Regional Superintendent of Schools, the Benefiting District, and/or any board members, officers, agents, or employees of any of the foregoing which challenges the appropriateness, amount, timing, use, or any other aspect of a developer contribution that, has been paid or is due pursuant to the Kane County Code to the Benefiting District, the Benefiting District agrees to defend and indemnify and hold the County of Kane, the Kane County Board members, the Kane County Regional Superintendent of Schools, and any agent or employee thereof, in their individual and official capacities, harmless and make whole the County of Kane, the Kane County Board members, the Kane County Regional Superintendent of Schools, and any agent or employee of either for any and all claims by any developer, subdivider, land owner, or any other person or entity arising out of the application for or use of such funds including but not limited to any judgments for compensatory damages, punitive damages, and/or attorney's fees.
3. In the event that a final and nonappealable judicial determination is made by a court of competent jurisdiction that contributions of land or money received by the Benefiting District are, in whole or in part, unwarranted, illegal, or excessive, the Benefiting District shall promptly pay any and all judgment amounts obtained against the County of Kane, the Regional Superintendent of Schools, the Benefiting District and/or any board members, officers, agents, or employees of either. In the event that a judicial determination requires the payment of damages, either compensatory or punitive, and/or for the attorneys' fees of the plaintiff's attorneys, in addition to the return of contributions held to be unwarranted, illegal or excessive,

the Benefiting District shall pay all such additional amounts.

4. In further consideration of the continued payment by the County of Kane to the Benefiting District of the subject contributions of land or money, the Benefiting District agrees that its obligations under paragraph two and three of this Agreement shall extend to both past and future cash and land contributions.

5. The parties are not aware of any pending or threatened lawsuit or other legal action challenging a developer contribution under the Kane County Code. The parties shall promptly notify each other in the event any such lawsuit or any other legal action is initiated. Such notice shall be directed to the Chairman of the Kane County Board and to the President and Superintendent of the Benefiting District.

6. No claim as a third party beneficiary under this Agreement by any person, firm, or corporation shall be made, or be valid, against the County or the Benefiting District.

The district has partnered with the Kane County Sheriff's Office and developed an MOU to allow the department to notify the school district and identify children that have been present for police interactions and otherwise exposed to violence or trauma. Notification shall be given by sending an email stating "Handle with care, the child's name, approximate age, school attended id know and the approximate time of the event. This notification will be sent to Kate Vincent and the Director and Assistant Director of Student Support Services.

Memorandum of Understanding (MOU)

Notification of Exposure to Trauma

I. PURPOSE

The Larger Project. To further implement, an initiative aimed at addressing children's exposure to violence and trauma. Childhood exposure to violence and trauma, without the right supports, is often associated with increased risk of poor outcomes in emotional, behavioral and physical health over the life span. Children exposed to violence and trauma are also at a higher risk of poor school related outcomes and are more likely to enter the criminal justice system later in life, which can contribute to generational cycles of violence and system involvement. This project directly addresses the goal of mitigating these negative impacts of exposure to trauma when it does occur, by providing support and on-site, trauma focused interventions by school staff and/or mental health providers, if necessary, to children identified by local law enforcement and school personnel.

Notification of Exposure to Trauma. Acknowledging the collaborative work already underway in the community around trauma and specifically around social and emotional health within the school system, this Memorandum of Understanding ("MOU") will focus on notification to the school system by law enforcement when a child is exposed to trauma in the home or in the community to enable the child's school to handle the child with care upon his or her arrival at school the next school day following the incident. For the purpose of this MOU, the phrase "exposed to trauma" shall be construed broadly and by way of example and not by way of limitation, shall mean and include any event where a child, experiences or is involved in, or is questioned relative to, any of the following: the abuse of a family member, loved one, or pet; abuse or neglect; child custody, visitation or support or other domestic relations controversy where there is law enforcement intervention; community violence; the commission of a crime; loss of a family member or friend; an overdose; the arrest of a family member; racism or any other form of discrimination; homelessness; mental illness and /or substance abuse by a parent or caregiver; hospitalization or family illness; incarceration of a parent or family member; sudden, unexpected or frequent changes in caregiver, school, program or home life; natural disasters; or similar acts or experiences. Should a law enforcement officer be uncertain as to whether or not to give notice to the school, judgement should be exercised in favor of notification.

II. THE KANE COUNTY SHERIFF'S OFFICE AGREES TO:

- A) Send a notification to Central School District #301 Identifying children that have been present for police interactions or otherwise exposed to violence or trauma in the community following the notification protocol as outlined below.

- B) Notification shall be given by sending an email stating “**Handle with care, the child’s name, approximate age, school attended if known, the approximate time of the event**” to Handlewithcare301@central301.net
- C) Notifications will contain no specific information about the incident in order to maintain privacy of the student and their family.
- D) Otherwise, maintain the confidentiality of students and their families.

III. CENTRAL SCHOOL DISTRICT #301 AGREES TO:

- A) Receive notifications, as described in section II A and B above from LE and disseminate them to the designated point persons within each school by forwarding to them the HWC e-mail notification from LE.
- B) Upon receipt of a Handle with Care notification identifying a child who has been exposed to trauma, the designated point persons within each school will then disseminate the notification to appropriate teachers, social workers, guidance counselors, and any other relevant staff.
- C) Provide identified students who are exhibiting behaviors that are not consistent with their normal manner a safe person and space where they can receive additional supports, such as postponing a test, accepting a missed assignment, or allowing the student to rest if he or she is having a hard time focusing or staying awake, but otherwise not addressing the child about the incident.
- D) Determine need for on-going counseling or other intervention if the student is not currently involved with mental health services.
- E) If necessary, the school may contact parents or guardians to obtain appropriate consents for on-going mental health services for the student.
- F) Provide education on trauma informed care to all school personnel, parents and guardians, as requested and/or as required by law.
- G) Maintain the confidentiality of student's information, including but not limited to academic records, health records, and mental health services. Notifications may be maintained for any purposes consistent with the purpose of this MOU, but shall not be part of any student's permanent record.

IV. TERMINATION, ADDITIONAL AGENCIES, AND LIABILITY

- A) The Kane County Sheriff’s Office has the right to cancel this MOU within 30 days with written notice to the other parties. Should the Kane County Sheriff’s Office terminate this MOU, then the MOU shall remain in effect for all other agencies.
- B) Each party shall be responsible for the actions committed by that party and its agents. No party assumes any liability for any actions committed by any other party. However, each party to this Agreement agrees to cooperate fully with the other party in the defense of claims, pursuant to these provisions. This cooperation will include, but is not limited to, the following:
 - 1) Immediate notification to the other party of any accident or incident resulting in personal injury, damage or having the potential for liability;

- 2) Immediate notification to the other party of any claim made against it alleging liability;
- 3) Permit a party of this Agreement to conduct a parallel independent investigation of any incident, and/or
- 4) Make personnel and records available for purposes of the investigation or defense of any claim and/or legal proceeding to the extent permitted by law.

Please note that, as written, your request would require the District to search through thousands of responsive records to determine what information is exempt under FOIA. For example, the District's initial query for *all* staff and student District email addresses for emails originating within the District and coming into our network from outside sources from the past 12 months produced almost 36,000 emails. It would take an excessive amount—likely days or weeks—of staff and/or attorney time to analyze, review, and redact all of the responsive materials to comply with your request as well as confidentiality laws. Because of the size and anticipated burdens of this project, we must invite you to confer with us in an attempt to reduce the request to more manageable proportions. Unless you reduce the request to a manageable scope and provide more specific search criteria and possibly a narrower date range, we believe that compliance with your request would disrupt the duly-undertaken work of the District in violation of the purposes of the FOIA statute. *See* 5 ILCS 140/1. Thank you for writing to Central Community Unit School District No. 301 with your request for information, dated and received by the District on February 27, 2020, pursuant to the Illinois *Freedom of Information Act*, 5 ILCS 140/1 *et seq.* Specifically, you requested:

Copies of all emails containing the word "Trump" from the past 12 months.

On March 2, 2020, the District invited you to narrow your request because as written it is unduly burdensome. The District has not heard back from you, and as such the District now denies your request pursuant to FOIA Sections 3(g) and 3.1(a)(iii). *See* 5 ILCS 140/3(g), 3.1(a)(iii). The burden of fulfilling this request - namely, requiring that personnel with the necessary competence and discretion to analyze, review, and redact all individually identifiable information concerning students and staff from the thousands of pages of responsive documents – outweighs any public interest in the information. *See* 2018 PAC 54844 (public interest did not outweigh burden of locating and redacting all individually identifiable information from numerous letters to parents granting testing accommodations). Accordingly, your request is deemed “unduly burdensome” within the meaning of FOIA Section 3(g). *See* 5 ILCS 140/3(g). Moreover, the District believes that the burdens on the District outweigh any commercial interest in the information. Should you renew your request with a narrowed scope, we will process it within the applicable FOIA timeframe starting from the date of your renewed, narrowed request.

The District classifies you as a commercial requester based on the association of your email address with Locality Labs LLC, which appears to be a for-profit LLC engaged in the business of selling data to third parties. Your request thus appears to be for the purpose of sale, resale, solicitation, or advertisement. At this time, we have no evidence that your request falls into the category of news media. Therefore, the District invites you to submit justification for news media status, but until the District receives this justification, it will treat this request as a request for commercial purposes.

To the extent you believe you have been improperly categorized as a commercial requester, you have a right to have that determination reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a).
