BOE Meeting

1. Roll Call
2. Pledge of Allegiance
3. Public Open Forum
 - 3.A Recognition of Visitors – Vice-President Nolan and Superintendent Mongan welcomed attendees and those watching remotely.
 - 3.B Recognition of 2023 INSPRA Communications Contest Award of Merit – Communications Director Rodewald recognized Mr. Bradley Starks on earning the 2023 INSPRA Communications Award of Merit for the video of senior students opening and reading letters written to themselves as second graders.
 - 3.C Public Comments – Public comments were shared regarding concerns about the topics on the Board agendas and having decisions made by committees and staff members, plans for the new high school and the structure of the Steering Committee, and student privacy and safety with the proposed new high school design.
4. Action Items
 - 4.A Consent Agenda– Business Manager Pflug reviewed the revenues and expenditures. The District received \$138,819.68 for 15 home starts in August and \$77,817.32 for 11 home starts in September, but did not receive any transition fees. Bills payable reports are typical for October.
 - 4.B Approve Boys Golf Overnight Trip – Principal Podgorski shared that the CHS Boys Golf Team traveled to the IHSA Golf State Playoffs in Bloomington October 5-7, 2023. They qualified as a team and finished 9th in the class 2A competition.
 - 4.C Approve FFA Overnight Trip – Principal Podgorski shared that the FFA students will travel to Indianapolis October 31 to November 4, 2023 for the National FFA Vet Science Competition and Convention.
 - 4.D Approval of EL Sullivan Consulting contract to engage the community in a collaboration to determine the future of our school district and possible construction of a new high school to alleviate enrollment and overcrowding concerns for now and in the future. They will provide a partnership to help us conduct community engagement. – Superintendent Mongan explained that this organization can help us better communicate with our community. This would not replace our internal communications, but add additional elements to respond to the community's questions in effective ways. The Board approved moving forward with a contract as long as we have the flexibility to adjust elements based on the District's needs.
5. Information Items
 - 5.A Discussion of Challenges with Rohrsen Road Property - Mr. Glen Eriksson from Ericksson Engineering presented information regarding the floodplain on the District's property on Rohrsen Road and the challenges it presents for construction of a possible high school. While we can possibly have the map changed, it would likely take at least a year, pushing back any potential

construction on the property.

- 5.B Discussion of Possible Sale of Plato Center Property - Superintendent Mongan shared that there has been interest expressed in purchasing the District's property in Plato Center. Currently the District is maintaining this property but it is not large enough to build a modern elementary school. As a school district we can sell directly to a government agency but would have to do a bid process if selling to a private buyer. The Board will vote on this at the next Board meeting.
 - 5.C. Enrollment Report - Superintendent Mongan explained that we adjusted the enrollment report to better reflect the students being served both in and out of District schools.
 - 5.D Facilities Update - Facilities Director Polowy shared that all permits are in place for the CHS addition and they are currently putting foundations in. They have done some value engineering to try to stay under budget. The District Office remodel project slowed due to delays with materials and vendors but should be completed soon. We will have a bid next month for electrical work for generators at PV and LL.
 - 5.E Athletics and Activities Update - Principal Podgorski shared that the football team is still in the running for playoffs and they are wrapping up fall sports with senior nights. The CHS band's Bring the Noise concert was sold out and choir and chorale concerts were held last week. The fall play will be at the end of the month and winter sports meetings are getting started.
 - 5.F CHS AP Honor Roll Award - Principal Podgorski shared that CHS won two awards from the College Board. The AP Equity Access Award is for underrepresented students proportionally passing AP tests. The AP Access Award reflects seniors taking AP courses, getting college credit from AP tests, and taking 5 or more AP classes during their high school career. We don't currently require students in AP courses to take the corresponding tests, but that could be discussed in the future.
 - 5.G STEAM Update - Curriculum Director Birkmeier presented an update on the STEAM program rollout at the elementary level for this school year. They are focusing on integrating multiple content areas including math and the arts. Teams are made up of 5-7 teachers in each building who train and support other building teachers. Students are engaging in STEAM activities such as coding robots.

RE: Board Financial Report

- The Revenue and Expenditure Summary Reports are included in your Board Packet. Revenues are currently at 37.02% compared to 35.28% a year ago. Expenditures are at 28.76% as compared to 27.62% a year ago.
- The district received impact fees for October in the amount of \$123,632.15 for 13 home starts. No transition fees came in this month.
- The bills payable reports for both Central 301 and Northern Kane are typical for the month of November. Included this month is payment for the Series 2006 Bond of \$6,805.000 to US Bank.
- Tonight, the board will discuss and act on a resolution regarding the estimated amounts to be levied for 2023.
- The 2024 School Maintenance Project Grant will be submitted upon approval at tonight's board meeting. This grant application will be used to purchase and install an emergency backup generator for Prairie View Grade School to support critical systems i.e., well, boilers, heat pumps and critical technology. This state grant is for \$50,000 with a minimum match of \$50,000 with local funds out of the O&M and/or Capital Projects Funds. The total estimated cost of the project is \$300,000 and if approved by ISBE will be installed June 2024.

Attached is information relating to the proposed 2023 tax levy. The Board will be asked to adopt a tentative tax levy resolution for the next school year. In December, a truth in taxation public hearing will be held prior to the regular board meeting and then the Board will be asked to adopt the final tax levy.

Enclosed is an analysis of the history of district EAV and new construction numbers, the estimated 2023 EAV, estimated tax rate, and the increase in new dollars over the previous year's extension. We are anticipating approximately \$3,706,834 in new operating dollars, which is a 7.28% increase. There will be an increase in the debt service extension as our bond payments increase from \$8,745,400 to \$8,918,450. The total operating and debt service extension will be approximately \$63,524,857 if the estimated total EAV is close to \$1,017,300,000 and new construction is near \$21,645,000, which are the most recent numbers provided by the Kane County Tax Extension officer.

As in past years, it is necessary to request a higher amount than what we anticipate receiving to ensure full access to dollars that are generated through new construction EAV. The law provides that a district cannot receive more than what it is entitled. A district cannot receive more than what was requested in each fund.

Since the proposed operating extension is more than a 5% increase, we are required to publish a Truth in Taxation notice and conduct a public hearing.

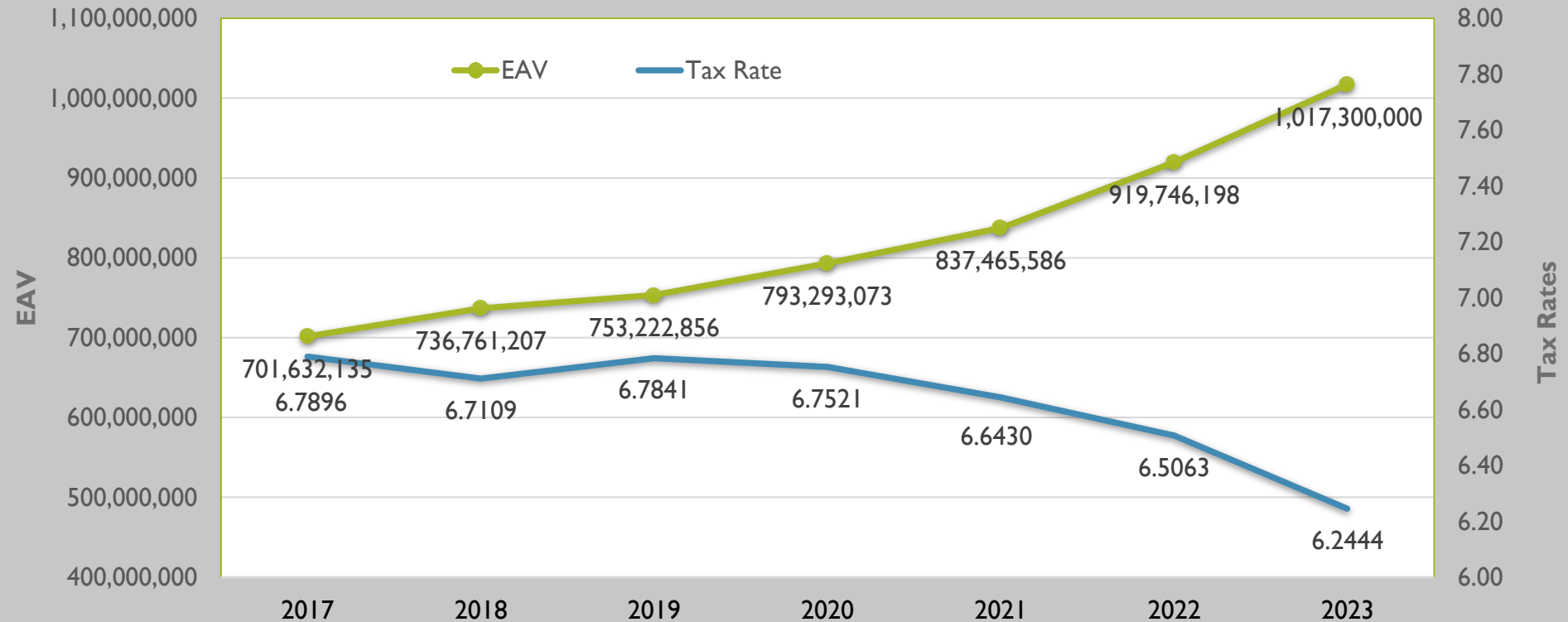

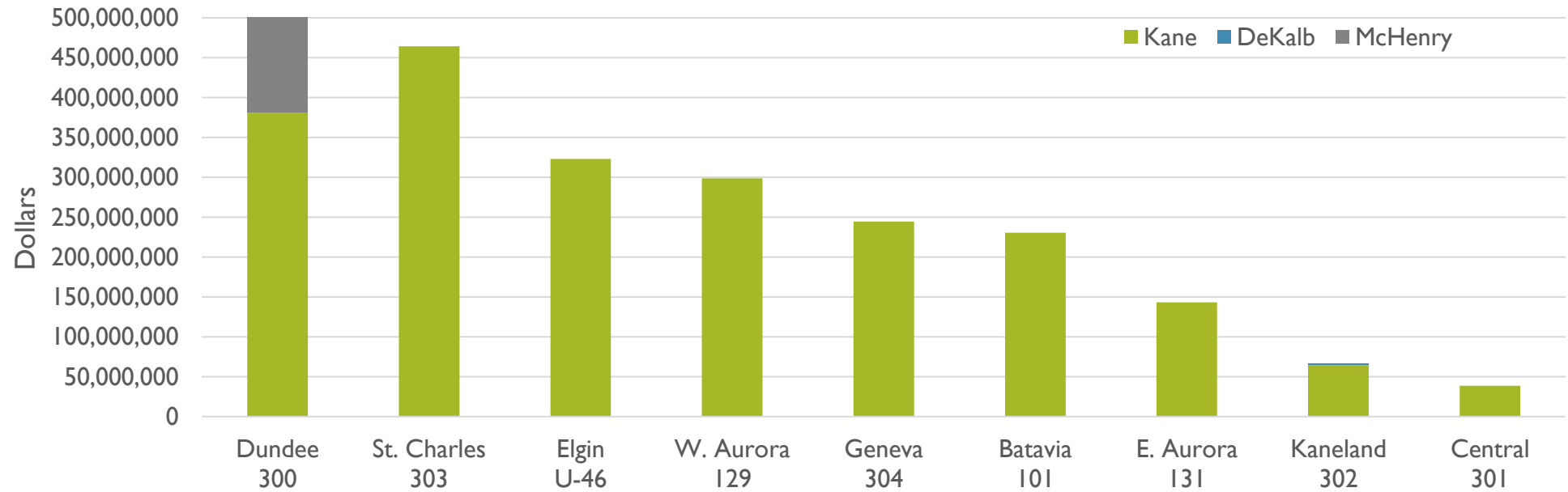

**RESOLUTION ESTIMATING AGGREGATE
LEVY FOR THE YEAR 2023**

WHEREAS, Board of Education of Central Community Unit School District No. 301, Kane and DeKalb Counties, Illinois (the “Board of Education”), is empowered to levy taxes on the real property within Central Community Unit School District No. 301, Kane and DeKalb Counties, Illinois (“the School District”); and

WHEREAS, pursuant to the *Truth in Taxation Law*, 35 ILCS 200/18-55 *et seq.*, the Board of Education must determine the estimated amounts of taxes necessary to be levied for the year not less than twenty (20) days prior to the adoption of the aggregate tax levy; and

WHEREAS, the corporate and special purpose property taxes (i.e., “aggregate levy”) extended or abated for 2022 were **\$50,899,573**; and

WHEREAS, the property taxes extended for debt service and public building commission leases for 2022 were **\$8,832,856**; and

WHEREAS, if the estimate of corporate and special purpose property taxes to be levied is more than 105% of the amount extended or estimated to be extended, plus any amount abated by the taxing district prior to extension, upon the final aggregate levy of the preceding year, exclusive of election costs, public notice shall be given and a public hearing shall be held.

NOW, THEREFORE, Be It Resolved by the Board of Education of the Central Community Unit School District No. 301, Kane and DeKalb Counties, Illinois, as follows:

Section 1: The proposed corporate and special purpose property taxes to be levied for 2023 are **\$54,951,500**. This represents an **7.96%** increase over the previous year.

Section 2: The estimated property taxes to be levied for debt service and public building commission leases for 2023 are **\$8,918,450**. This represents a **.97%** increase over the previous year.

Section 3: The estimated total property taxes to be levied for 2023 are **\$63,869,950**. This represents a **6.35%** increase over the previous year.

Publication of notice of said hearing shall be in an English language newspaper published in the District not more than fourteen (14) days nor less than seven (7) days prior to the public hearing, as well as on the District’s website, according to the requirements of the *Truth in Taxation Law*. The notice shall be in substantially the form shown in Exhibit A attached hereto.

Section 5: That all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed, and this Resolution shall be in full force and effect immediately and forthwith upon its passage.

Our Director for CHS plays, musicals, and sponsor for drama club, Christine Heckman, is requesting the approval of an overnight trip for the 2024 All State Production: *She Kills Monsters*. Here is the information regarding student selection and participation in the 2024 Illinois High School Theatre Festival All State Production of *She Kills Monsters*.

Last year three Central High School students participated in this event after being chosen based on various skill sets to help with the performance of *Shrek*.

All State Production

The IHSTF All State Production serves as the capstone performance at the Festival in January. Participation in the production is a highly selective process for which students must audition (for performance) or interview (for technical theatre areas). The application process opens to all Illinois rising sophomores, juniors, and seniors in May of the previous year. Students complete an application form, which includes a director's recommendation and a principal's recommendation. Students schedule an initial audition or interview and subsequently, may move onto a callback, which is the next stage in selection. From this point, the show is cast and the crew is selected. The students will rehearse or create the technical aspects of the show over several weekends leading up to the tech week (which are intensive day-long rehearsals coordinating performers and technical aspects of the show: set, lighting, costumes, sound, etc.).

At the festival, the All State Production runs several evenings, serving as a capstone performance, showcasing some of the most talented high school theatre students from across the state.

WHEREAS, the Board of Education (the "*School Board*") of Community Unit School District Number 301, Kane and DeKalb Counties, Illinois (the "*District*"), has considered the existing school facilities and the improvements and extensions necessary to be made thereto in order that the same will adequately serve the educational needs of the District; and

WHEREAS, the School Board does hereby find and determine that it is necessary and in the best interests of the District that the School Board be authorized to build and equip a new high school building, including construction of career technical education labs, fine arts spaces, a college/career center, special education classrooms, collaborative spaces and secured entryways and installation of emergency response systems therein, build and equip an athletic stadium, a field house and athletic fields on the new high school site and improve said site (the "*Project*") at an estimated cost of \$195,000,000; and

WHEREAS, the School Board does hereby find and determine that the Project is needed to provide a quality educational program; and

WHEREAS, there are insufficient funds on hand and available to pay the costs of the Project; and

WHEREAS, before the School Board can provide the Project and borrow money and issue bonds for such purpose, a proposition therefor (the “*Proposition*”) must be submitted to the voters of the District and be approved by a majority of the voters of the District voting on the Proposition at an election to be held in and for the District; and

WHEREAS, it is deemed advisable, necessary and in the best interests of the District that the Proposition be submitted to the voters of the District at an election to be held and conducted in accordance with the general election law:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of Community Unit School District Number 301, Kane and DeKalb Counties, Illinois, as follows:

Section 1. Incorporation of Preambles. The School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Need for Project. It is necessary and in the best interests of the District that the School Board be authorized to provide the Project, and that it is necessary and in the best interests of the District that money be borrowed and in evidence thereof bonds of the District be issued therefor to the amount of \$195,000,000.

Section 3. Submission to Voters. The Proposition shall be submitted to the voters of the District in accordance with the general election law at the general primary election to be held on Tuesday, the 19th day of March, 2024, between the hours of 6:00 o’clock A.M. and 7:00 o’clock P.M. on said day (the “*Election*”).

Section 4. Voting Precincts and Polling Places. The Election shall be held in the voting precincts and at the polling places established by the County Boards (the “*County Boards*”) of

The Counties of Kane and DeKalb, Illinois (the “*Counties*”), for voters of the District at the Election.

Section 5. Election Notice. The County Clerks of the Counties (the “*County Clerks*”) shall give notice of the Election, including the Spanish translation thereof as deemed by the County Clerks to be required by law (the “*Notice*”), in accordance with the general election law by (i) publishing the Notice once not more than 60 nor less than 10 days prior to the date of the Election in a local, community newspaper having general circulation in the District, and (ii) posting a copy of the Notice at least 10 days before the date of the Election at the principal office of the County Clerks.

REAL ESTATE PURCHASE AGREEMENT

THIS AGREEMENT is made and entered into this 20th day of November, 2023, by and between Marilyn Maas; Kenneth R. Maas; Carol J. Lindstrom; Alan H. Maas; Leslie H. Maas, individually and as Trustee of the Leslie H. Maas Trust No. 101 dated May 9, 2011, and Roger C. Maas, individually and as Trustee of the Roger C. Maas Living Trust dated January 11, 2012 (collectively, “Seller”) and the Board of Education Central Community Unit School District No. 301, Kane County, Illinois (“Purchaser”) (Seller and Purchaser may be collectively referred to as the “Parties”).

WITNESSETH:

WHEREAS, Seller currently holds title to the parcel of real estate located at 09N636 Illinois Route 47, Elgin, Kane County, Illinois and further identified as P.I.N.s 05-29-100-001, 05-29-300-002, 05-29-200-003, 05-20-300-007, and 05-30-200-009, which is legally described on Exhibit “A” attached hereto and made a part hereof (said real estate, together with all improvements, fixtures, easements, appurtenances and benefits pertaining thereto being hereinafter referred to as the “Real Estate”); and

WHEREAS, Purchaser desires to purchase the Real Estate from Seller, and Seller desires to sell the Real Estate to Purchaser, upon the terms and conditions hereinafter set forth; and

WHEREAS, Purchaser has the authority to acquire the Real Estate pursuant to Section 10-22.35A of the School Code (105 ILCS 5/10-22.35A).

NOW, THEREFORE, in consideration of the mutual covenants and promises of Seller and Purchaser, and other good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, Seller and Purchaser hereby covenant and agree as follows:

1. **Sale and Purchase.** Seller agrees to sell and Purchaser agrees to purchase the Real Estate on the terms and conditions herein set forth at a price of FIVE MILLION TWELVE THOUSAND TWO HUNDRED AND FIFTY DOLLARS (\$5,012,250) (“Purchase Price”), plus or minus prorations at the time of Closing, as hereinafter defined. Within three business days of the last party to execute this Agreement, Purchaser shall pay the sum of FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000) as earnest money (“Earnest Money”). The Earnest Money shall be applied to the Purchase Price at the Closing. The Earnest Money shall be held by the Title Company, as hereinafter defined, in a strict joint order escrow, for the mutual benefit of the parties, and may be invested, at Purchaser’s request and expense, in an interest bearing account or similar investment and all interest earned thereon shall be paid to Purchaser at the Closing. The cost of the escrow shall be split equally between the parties. In the event that this Agreement is terminated or the transaction herein described is not consummated for a reason other than a default of the Purchaser, all such Earnest Money, together with all interest earned thereon, shall be refunded to Purchaser, but such refund shall not preclude the exercise of other remedies including, but not limited to, the remedy of specific performance. Purchaser shall pay the balance of the Purchase Price, as adjusted by prorations as described herein, at the Closing.

2. **Conveyance.** At the Closing (defined in Paragraph 6 below), Seller shall convey or cause to be conveyed to Purchaser or Purchaser's nominee by recordable warranty deed (as to individual titleholders), and Trustees' Deeds (as to trust titleholders), the Real Estate, subject only to (a) general real estate taxes not due and payable as of the date of the Closing; (b) acts of Purchaser; and (c) those exceptions that, in Purchaser's opinion, will not interfere with its intended use of the Real Estate (the "Permitted Exceptions") and by this reference incorporated herein.

3. **Survey.** Purchaser may, at its option and expense, obtain a survey of the Real Estate prepared by an Illinois registered land surveyor in accordance with the current minimum standard detail requirements for ALTA/NSPS land title surveys, which is dated not more than six (6) months prior to the date of the Closing ("Survey"), showing all corners staked and no encroachments, measurements of all lot lines, and showing all easements, building line set backs, fences, and any improvements on the Real Estate and distances thereof to all lot lines. If requested, Seller agrees to provide at the Closing an affidavit verifying that no changes in improvements have been made since the date of the Survey. If the Survey shows other than Permitted Exceptions or encroachments from adjacent property, then these shall be considered defects in the title to the Real Estate. Provided that Purchaser has provided evidence of the cost of the Survey, Sellers will provide a credit at Closing of \$3,250, to account for the partial cost of the Survey.

4. **Evidence of Title.** Seller shall deliver, or cause to be delivered, to Purchaser within ten (10) days from the date of the last party to execute this Agreement, a current title commitment from Chicago Title Insurance Company (or such other title insurance company acceptable to Purchaser) ("Title Company") for a current ALTA owner's title insurance policy, providing extended coverage (provided that Purchaser has obtained an ALTA survey) by deletion of the general exceptions that would otherwise be included in such title insurance policy, in the amount of the Purchase Price, together with copies of all instruments containing or creating covenants, conditions, easements and restrictions affecting the Real Estate. The aforesaid commitment shall show title in the intended grantor or in Purchaser, subject only to (1) the title exceptions set forth in Paragraph 2 hereof; and (2) title exceptions pertaining to liens or encumbrances of a definite or ascertainable amount which may be removed by the payment of money at the Closing and which the Seller will so remove at that time by using the funds to be paid to Seller hereunder. The Seller shall provide to Purchaser a title policy at closing in accordance with this Paragraph. All costs of obtaining the aforesaid commitment and owner's title policy shall be paid by Seller.

5. **Correction of Defects.** If the title commitment or the Survey herein required discloses unpermitted exceptions that adversely and materially affect marketability of title, Seller shall have thirty (30) days from the date of delivery of the title commitment or survey, as the case may be, to have the exceptions removed from the title commitment or to have the title insurer commit to insure against loss or damage that may be occasioned by such exceptions, and, in such event, the Closing shall be extended to a date fifteen (15) days after delivery of the corrected commitment or the time specified in Paragraph 6 hereof, whichever is later. If Seller fails to have the exceptions removed, or in the alternative, to obtain insurance against loss or damage that may be incurred by the Purchaser from such exceptions within the specified time, Purchaser may terminate this Agreement or may elect, upon notice to Seller within ten (10) days after the expiration of the thirty (30) day period, to take title as it then is with the right to deduct from the Purchase Price liens or encumbrances of a definite or ascertainable amount.

6. **Closing.** The Closing of the transaction herein described (the “Closing”) shall be thirty (30) days after the expiration of the Due Diligence Period provided in Paragraph 12, or as mutually agreed (or on the date to which such time is extended by reason of Paragraph 5 or Paragraph 11 hereof, whichever date is later) at the offices of the Title Company or at such other location as the parties hereto mutually agree, through a New York Style closing; provided, however, that title is delivered in accordance with Paragraph 2 hereof. The transaction herein contemplated may, upon election of either party, be closed through an escrow with the Title Company, in accordance with the general provisions of the usual form of New York Style Escrow Agreement then in use by said company, with such special provisions inserted in the escrow agreement as may be required to conform with this Agreement. Upon the creation of such an escrow, anything herein to the contrary notwithstanding, payment of the consideration and delivery of the deed shall be made through the escrow and the cost of said escrow shall be equally divided between Seller and Purchaser.

7. **Delivery of Possession.** Seller shall deliver possession and control of the Real Estate on the day of the Closing.

8. **Closing Adjustments.** Seller will provide evidence satisfactory to Purchaser at the Closing that all general real estate taxes for which bills have been issued have been paid in full. Purchaser shall receive a credit at the Closing for general real estate taxes and any other applicable charge levied against the Real Estate not yet due or payable or due but not yet paid. The amount of any general real estate taxes not then ascertainable shall be credited on the basis of One Hundred Ten Percent (110%) of the amount of the most recently ascertainable taxes, and shall include the date of the Closing. In the event that more than one year of general real estate taxes is not then ascertainable, the amount of any general real estate taxes for the second year shall be an additional One Hundred Ten Percent (110%) over the prior year’s estimated amount. All prorations shall be final. Seller shall pay the amount of any stamp tax imposed by law by the State of Illinois, the County of Kane, and any municipality, on the transfer of title.

9. **Covenants, Representations.** To induce Purchaser to enter into this Agreement, Seller hereby covenants, and represents to Purchaser as of the date hereof and as of the date of Closing that, to the best of Seller’s knowledge, without independent investigation having been made:

- A. **Authority of Seller.** Seller has full power to execute, seal, acknowledge and deliver this Agreement, and to consummate each and all of the transactions contemplated hereby, including, but not limited to, conveying good and marketable fee simple title to the Real Estate.
- B. **Violation of Laws and Restrictions.** Seller has not received any notice relating to any violations of applicable laws, ordinances, statutes, rules, regulations and restrictions pertaining to or affecting the Real Estate.
- C. **Notice of Legal Proceedings.** Seller has not received any notice relating to any legal actions, suits, or other legal or administrative proceedings, including pending assessments, condemnation, eminent domain, or quiet title cases, pending or threatened, against the Real Estate, except for the partition action currently pending

between the respective Sellers and located in the Circuit Court of Kane County, Illinois under Case No. 2023 CH 000018.

- D. Leases, Tenancies and Encumbrances. There are no contracts, covenants, financing statements, leases, tenancies or other agreements that affect the Real Estate and which will survive the Closing other than those set forth in Exhibit "B", true and complete copies of which have been heretofore delivered to Purchaser. Seller shall be fully responsible for payment and satisfaction of any and all obligations, liabilities, expenses and accruals relating to or affecting the Real Estate which were incurred or accrued or where the underlying act or omission giving rise to any claim or cause of action occurred prior to the date of the Closing.
- E. Compliance with Laws. Other than acts of Purchaser, there are no conditions existing with respect to the Real Estate which violate any law, rule, ordinance, regulation, agreement, covenant or private restriction applicable to the Real Estate, including, but not limited to, regulations relating to building, zoning, safety, or health codes or regulations.
- F. Hazardous Materials. Neither Seller nor, to the best of Seller's knowledge, any other person has ever caused or permitted any "Hazardous Material", as hereinafter defined, to be placed, held, located or disposed of on, under or at the Real Estate, or any part thereof or into the atmosphere or any watercourse, body of water or wetlands that are part of the Real Estate or run through the Real Estate, nor has the Real Estate ever been used as a treatment, storage or disposal (whether permanent or temporary) site for any Hazardous Material. Seller further represents that no underground storage tanks have been located on the Real Estate, the Real Estate has never been used as a dump for any waste material, the Real Estate and its prior uses comply with, and at all times have complied with, any applicable governmental law, regulation or requirement relating to environmental and occupational health and safety matters and Hazardous Materials. Seller's representations shall be deemed to survive the Closing.

For purposes of this Agreement, "Hazardous Material" means and includes any hazardous substance, waste, gas, particulate matter, or any pollutant or contaminant defined as such in (or for purposes of) the *Comprehensive Environmental Response, Compensation and Liability Act*, any so-called "Superfund" or "Superlien" law, the *Toxic Substances Control Act*, or any other federal, state or local statute, laws, ordinance, code, rule, regulation, order or decree regulating, relating to, or imposing liability or standards of conduct concerning any hazardous, toxic or dangerous waste, substance or material, as now or at any time hereafter in effect (collectively, the "Statutes"), or any other hazardous, toxic or dangerous waste, substance or material.

- G. Foreign Status of Seller. Section 1445 of the Internal Revenue Code (the "Code") does not apply to this transaction in that Seller is not a nonresident alien, foreign corporation, foreign partnership, foreign trust or foreign estate (as those terms are defined in the Code and Income Tax Regulations). On or before the date of the Closing Seller shall provide Purchaser with an affidavit of compliance with Section 1445, as set forth in the

Code and applicable Regulations. If Seller fails to provide the necessary affidavit and/or documentation of exemption on or before the date of Closing, or if Purchaser has reason to believe such affidavit is false or incorrect, Purchaser shall have the right to proceed with the withholding provisions as set forth in Section 1445 of the Code.

- H. Notice of Action. From the date hereof through the Closing, Seller shall promptly comply with and forthwith give notice to Purchaser of all notices received by Seller relating to the Real Estate given pursuant to any threatened or actual litigation or any state, city, or municipal law, ordinance, regulation, or order, and shall comply with the requirements of any authority, state, city or municipal department or other governmental entity having jurisdiction over the Real Estate or the use thereof.
 - I. Prohibition on Encumbrances. Between the date of this Agreement and the Closing Seller shall not: (i) create, incur or suffer to exist any mortgage, lien, pledge or other encumbrance in any way affecting the Real Estate; or (ii) enter into any contracts or agreements pertaining to the Real Estate without first obtaining the written consent of Purchaser.
 - J. Encroachments. No building or other improvement encroaches onto the Real Estate, nor does any building or improvement which is part of the Real Estate encroach upon any adjacent property or easements of others, or on any public right of way.
 - K. Severability of Liability for Breaches under this Paragraph. The Sellers shall be severally and in no case jointly, liable for breach of a covenant, representation or warranty under this Paragraph 9. In no event shall one or more Sellers be liable under this Paragraph 9 for another Seller(s) breach of a covenant, representation or warranty under this Paragraph 9.
10. **Provisions with Respect to the Closing**. At the Closing, Seller shall deliver (in addition to the Deed referred to in Paragraph 2 above) to the Purchaser the following fully executed documents ("Closing Documents"), all in form and substance reasonably satisfactory to Purchaser:
- A. A non-foreign affidavit in accordance with Section 1445 of the Internal Revenue Code;
 - B. An ALTA statement in customary form;
 - C. Affidavit of Title in customary form;
 - D. Closing Statement executed by the parties;
 - E. Applicable Real Estate Transfer Declarations;
 - F. Warranty Deed and Trustees' Deed (where appropriate) in customary form conveying the Real Estate to Purchaser subject only to the Permitted Exceptions;

- G. A Seller's Certificate reaffirming the representations Seller has made in Paragraph 9 hereof, subject to the provisions of Section 11.A;
- H. Personal Gap undertaking; and
- I. All such further conveyances, assignments, confirmations, satisfactions, releases, powers of attorney, instruments of further assurance, approvals, consents and any and all such further instruments and documents as are reasonably necessary, expedient or proper to complete any and all conveyances, transfers, sales and assignments herein provided relating to the Real Estate.

11. **Conditions to Purchaser's Obligations to Close.** Purchaser shall have no obligation to consummate the transaction provided for by this Agreement (but Purchaser shall be entitled to consummate the transaction provided hereby) unless each and every one of the following conditions shall have been satisfied:

- A. The continued validity in all respects of the aforesaid representations of Paragraph 9 shall be a condition precedent to Purchaser's obligation to close the transaction contemplated hereby. If any of said covenants shall not be valid and correct at any time during the period from the date hereof through the date of the Closing, then Purchaser may, at Purchaser's option, terminate this Agreement and receive a refund of the Earnest Money described herein, together with interest accrued, and there shall thereafter be no further liability on the part of Purchaser hereunder, or, Purchaser may elect to close the transaction without any waiver or limitation of the remedies available to Purchaser hereunder or under law. All representations made by Seller under this Agreement shall survive the Closing for a period of six (6) months from and after the date of Closing.
- B. This Agreement shall not have been previously terminated pursuant to any other provision hereof.
- C. The Seller shall be prepared to deliver to Purchaser all instruments and documents to be delivered to Purchaser at the Closing pursuant to the terms and provisions hereof.
- D. No eminent domain or condemnation proceeding shall have been initiated which might result in the taking of any part of the Real Estate. Seller shall immediately notify Purchaser in writing of the occurrence of any eminent domain proceedings, or the receipt of a written notice stating that such an action is contemplated. Purchaser agrees that it will not initiate, or benefit from, any such action.
- E. There shall have been no material change in, damage to, or casualty suffered by the Real Estate. In the event of any casualty the provisions of the *Uniform Vendor and Purchaser Risk Act* of the State of Illinois shall be applicable to this Agreement.
- F. Title and Survey shall have been delivered in satisfactory condition in accordance with the terms of Paragraphs 3 and 4 above.

In the event that any of the conditions above set forth have not been satisfied, then, at the election of Purchaser, and subject to the provisions of this Paragraph 11, this Agreement shall terminate, and the Earnest Money herein deposited and all interest earned thereon shall be refunded to Purchaser, and all parties to this Agreement shall be relieved of all further rights, duties and obligations under this Agreement, except to the extent that the failure to satisfy a condition was caused by a breach of this Agreement.

12. **Due Diligence – Purchaser’s Right to Terminate.**

- A. As soon as reasonably possible, but not later than seven (7) days after the date of the last party to execute this Agreement, Seller shall deliver to Purchaser the following items related to the Real Estate, to the extent in Seller’s possession: (i) engineering or environmental reports; (ii) recorded documents; (iii) leases, licenses, and any lesser facilities use agreements; and (iv) surveys.
- B. Anything in this Agreement to the contrary notwithstanding, the Purchaser shall have sixty (60) days from the date of the last party to execute this Agreement (the “Due Diligence Period”) to conduct a Phase I environmental study and such other reasonable tests, studies and examinations as Purchaser may deem necessary or appropriate to determine, in its sole and absolute judgment, the acceptability of the Real Estate for purchase by the Purchaser (the “Due Diligence”). The Purchaser and its agents shall have the right to enter upon the Real Estate for the purpose of inspecting the Real Estate in accordance with this paragraph at reasonable times and upon reasonable notice. The Purchaser may waive any portion of the Due Diligence Period, upon written notice to Seller.
- C. The Purchaser understands and agrees that all such inspections and reviews shall be conducted in a manner so as to provide a minimum of disturbance to the Real Estate. Prior to entry on to the Real Estate to conduct the Due Diligence, Purchaser shall furnish Seller with a Certificate of Insurance covering property damage and liability insurance with regard to persons entering the Real Estate or conducting testing at the Property. Purchaser shall restore the Real Estate to the condition in which it existed prior to the conducting of said testing, and shall indemnify Seller as to all property damage and liability occasioned by such entry and testing.
- D. If, after undertaking such efforts, the Purchaser, in its sole discretion, determines that for any reason it shall not proceed with the acquisition of the Real Estate, the Purchaser may, by written notice to the Seller given not later than the expiration of the Due Diligence Period, notify the Seller of the Purchaser’s inability to satisfy itself with respect to the Real Estate and its election to declare this Agreement cancelled and null and void. In such event, the Purchaser shall be entitled to a refund of its Earnest Money, together with any interest or earnings thereon, if any.
- E. Unless Purchaser provides written notice to the Seller before the expiration of the Due Diligence Period that Purchaser elects to terminate this Agreement, it shall be conclusively deemed that the Purchaser has waived Purchaser’s contingencies provided

in this Section 12, that Purchaser accepts the Property in its then AS-IS, WHERE-IS condition (including but not limited to its physical condition, zoning restrictions, rights of way of record, and municipal restrictions or requirements as to occupancy and use), and that Purchaser will proceed to Closing subject only to the conditions in Section 11 above. If under this Section 12, the Purchaser terminates this Agreement, this Agreement shall thereupon be null and void, and neither Purchaser nor Seller shall have any further right, liability or obligation hereunder, except for those obligations that specifically survive termination.

- F. The Purchaser's satisfaction of itself of the matters set forth in this Section shall be done for the Purchaser's own account and not as a representative or agent of the Seller.

13. **Disclosure Statement.** In accordance with 50 ILCS 105/3.1, prior to execution of this Agreement by the Purchaser, the Seller, an authorized trustee, corporate official or managing agent, represents and warrants that it has submitted a sworn affidavit to the Purchaser disclosing the identity of every owner and beneficiary having an interest, real or personal, in the Real Estate, and every shareholder entitled to receive more than seven and one-half percent (7.5%) of the total distributable income of any corporation having any real interest, real or personal, in the Real Estate. Alternatively, if Seller is a corporation whose stock is publicly traded, an affidavit sworn by an officer or the corporation of its managing agent must be submitted to the Purchaser stating that there is no readily known individual having a greater than seven and one-half percent (7.5%) interest, real or personal, in the Real Estate. The affidavit shall be substantially similar to Exhibit C, which is attached hereto and incorporated herein by reference.

14. **Notices.** Any notices and communications required to be given under this Agreement shall be in writing and, except as otherwise expressly provided, shall be either (i) mailed by U.S. registered or certified mail, return receipt requested, postage prepaid, (ii) sent by nationally recognized overnight delivery service with proof of delivery, or (iii) personally delivered by hand against receipt therefor to the parties at the address set forth below, or such other address as any party may designate to the others by notice hereunder. All such notices shall be deemed to have been received on the date of personal delivery, or, if mailed, on date of deposit with the U.S. Postal Service or a nationally recognized overnight delivery service.

Words of the masculine, feminine or neuter gender shall mean and include the correlative words of other genders, and the words importing the singular number shall mean and include the plural number and vice versa. Words importing persons shall include firms, associations, partnerships (including limited partnerships), trusts, corporations, joint ventures, and other legal entities, including public bodies, as well as natural persons. The terms “include,” “including” and similar terms shall be construed as if followed by the phrase “without being limited to.”
17. **Business Days.** If the date for Closing, or performance of an obligation falls on a Saturday, Sunday or holiday, the date shall be deferred until the first business day following. OUR UNIQUE DATA GATHERING PROCESS

Our team of data experts are sought after nationally for their ability to accurately model public opinion and predict voter behavior, conducting data work for hundreds of clients including school districts, municipalities, colleges, and other government entities and civic organizations. This includes conducting nearly 250 surveys in the Chicagoland region.

These experts have developed a three-track process by which we gather data during community engagement, helping us engage as many district residents as possible while giving the board and administration the scientifically accurate data needed to make decisions.

- **Intuitive**: Nowadays, unfortunately, most people make decisions based on their intuition-their immediate, gut reactions. We must track the community's intuitive feelings throughout this process to know where people stand before being educated. We use several methods to gather this data, primarily scientific surveys.
- **Informed**: The more people become informed, the more they tend to be supportive. We need to identify how individuals feel after being educated so we can predict how public opinion will change as they learn more. We gather this data through multiple methods, especially a community committee.
- **Passionate**: Strongly passionate individuals in the community can influence others to their position. As a result, it is vital we identify the level of passion within segments of the community supporting or opposing specific things. This data is gathered throughout, though one of the best methods is through public forums.

A CONDENSED VERSION OF OUR PROVEN COMMUNITY ENGAGEMENT APPROACH

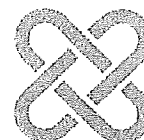
Our approach is based on the tried-and-true engagement funnel to maximize community engagement and arrive at a consensus. This version of our program has been condensed to allow for time constraints while still engaging the public and providing the district as much helpful information as possible.

Phase 1: Engagement begins by making the public aware of the effort and educating them on the district's challenges and opportunities.

Phase 2: We then work with the district and district's experts to break the plan down into individual projects, infrastructure solutions, and solutions. We gather feedback from the community on these items to help inform next steps in this process. Meanwhile, our data experts gather information from previous efforts to include with this new community feedback.

Phase 3: Using the data gathered, we finalize and publicize the plan. We then develop informational messaging and prepare for community education.

Phase 4: We conduct a community education program to educate the public on the plan, answer their questions, and motivate people to vote so their voices are heard.

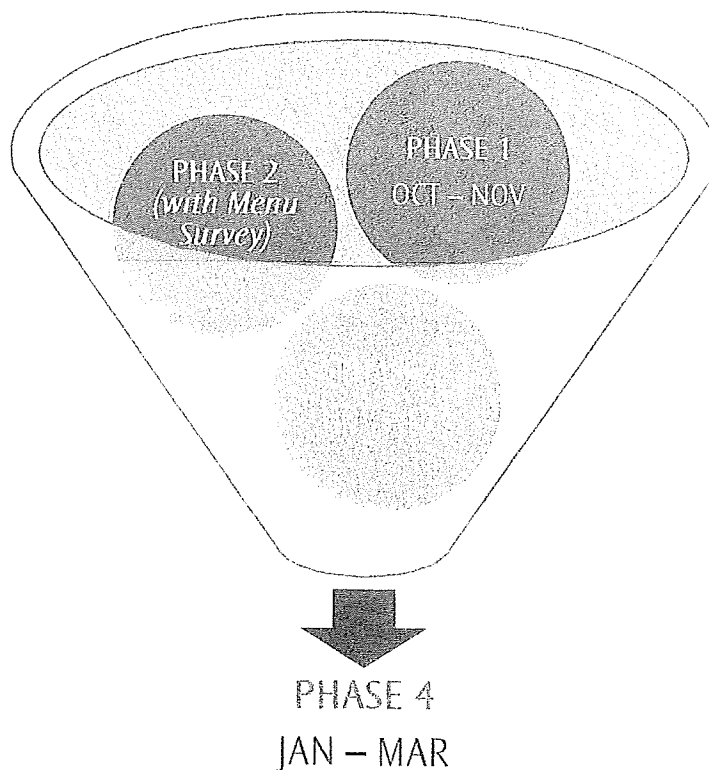


COMMUNICATIONS & MARKETING

This plan will utilize the district's current communications channels, including newsletters, emails, social media, fliers, and articles. The plan will also include paid channels such as detailed mailings, interactive tele town halls, and social media boosts, if budget allows since these channels have associated costs.

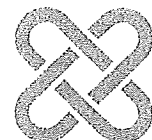

PROJECT COST

Note on Services: Covered in this Agreement is the cost of our time, expertise, and travel expenses, and the cost for surveys. Not covered is any additional paid outreach the district wishes to pursue, such as mailings, texting, digital ads, etc. Should these services be needed, we will provide pricing and a detailed budget for the district to approve prior to any expenditures.

TERMS

- All pricing good for 45 days from date of proposal.
- Agreement terms are from date of signature until project completion.
- Billing will be made by invoice. The District will pay invoices in accordance with the *Local Government Prompt Payment Act*, 50 ILCS 505/. EOS will send invoices on a monthly basis, which invoices will include fees for any projects completed to date.
- Client will be billed based on determination between EOS and D301, to be agreed upon in writing.
- Client will reimburse EOS for mutually agreed upon expenses (other than travel and survey costs and expenses, which are included). Expenses will be included on the following invoice. Proper documentation of each expense will be available at any time upon request.
- D301 and EOS each reserve the right to terminate this Agreement with 10 days' notice without cause. The District may set a termination date to allow EOS to complete a project currently in process but commence no other project work after the notice of termination. Upon termination, D301 will owe EOS only for services performed up to the effective date of termination.

CONDITIONS

- Completion of projects contingent on timely communication from client.
- During the term of this Agreement, EOS and its employees will not perform services, whether compensated or voluntary under the employment of EOS or independently, that shall conflict with any activities of D301 or cause to sully the goodwill of, or put into disrepute, D301 or its agents or clients.
- In the performance of its services, EOS shall comply with all laws applicable to the performance of such services and otherwise applicable to D301, its board members and employees, including, but not limited to, the State Ethics Act and laws governing lobbying, political activities, election interference, and the use of public funds, as well as laws governing automated phone, email, and text messaging. EOS shall comply with any D301 Board Policies regulating ethics and gift bans.
- All information and materials related to D301 and its operations are the property of D301 and will be treated as confidential information; EOS will not disclose any confidential information during or after the terms of this Agreement.
- Both parties agree that the duties and services outlined in this Agreement do not include any type of lobbying and/or government relations activities with the State of Illinois. If both parties agree that lobbying services are needed, then a separate and independent agreement would be executed and both parties would register with



handicap unrelated to ability, military status, or an unfavorable discharge from military service.

- d. That it will send to each labor organization or representative of workers with which it has or is bound by a collective bargaining or other agreement or understanding, a notice advising such labor organization or representative of EOS's obligations under the Illinois *Human Rights Act* and the Department's Rules. If any such labor organization or representative fails or refuses to cooperate with EOS in its efforts to comply with such Act and Rules, EOS will promptly so notify the Department and D301 and will recruit employees from other sources when necessary to fulfill its obligation thereunder.
 - e. That it will submit reports as required by the Department's Rules, furnish all relevant information as may from time to time be requested by the Department or D301, and in all respects comply with the Illinois *Human Rights Act* and the Department's Rules.
 - f. That it will permit access to all relevant books, records, accounts and work sites by personnel of D301 and the Department for purpose of investigation to ascertain compliance with the Illinois *Human Rights Act* and the Department's Rules.
 - g. That it will include verbatim or by reference the provisions of this clause in every subcontract it awards under which any portion of the contract obligations are undertaken or assumed, so that such provisions will be binding upon such sub. In the same manner as with other provisions of the Agreement, EOS will be liable for compliance with applicable provisions of this clause by such sub; and further it will promptly notify D301 and the Department in the event any sub fails or refuses to comply therewith. In addition, EOS will not utilize any sub declared by the Illinois Human Rights Commission to be ineligible for contracts or subcontracts with the State of Illinois or any of its political subdivisions or municipal corporations.
- This typewritten Agreement constitutes the entire Agreement of the Parties and supersedes all prior or contemporaneous written or oral negotiations, correspondence, understandings, and agreements, between the Parties respecting the subject matter hereof. Any changes, additions, stipulations, or deletions including correcting lining out by any party to this Agreement or signator to this Agreement will not be considered agreed to or binding on any party unless such modifications have been initialed or otherwise approved in writing by all parties to this Agreement. No waiver of any of the provisions of this Agreement shall be deemed, or shall constitute, a waiver of any other provisions, whether or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless executed in writing by the party making the waiver.

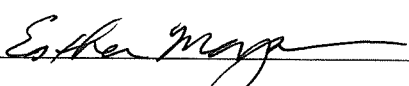

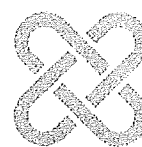

RE: Draft Calendars for the 2024-2025 and 2025-2026 School Years

Included with this memo are two (2) draft calendars for both the 2024-2025 and 2025-2026 school years. These calendars were developed in a committee composed of district and school level administrators representing each grade level and various departments after receiving responses from parents and staff members. The committee carefully reviewed the calendars of our district partners, including D300 (Algonquin), D303 (St. Charles), D304 (Geneva), U-46 (Elgin), D302 (Kaneland) and D101 (Batavia), as well as the feedback received from families and staff through surveys shared with them in October. These calendars reflect our efforts to consider impacts to students participating in regional and special education programs, as well as the preferences of our school community.

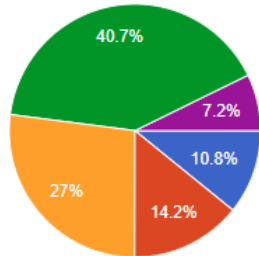
We had a good response rate to our calendar feedback surveys, with 329 responses from our staff and 1,426 responses from our families. Some data from these surveys is displayed below. Additionally, draft calendars were shared with district staff last week for further feedback, which was then considered before presenting these final drafts to the Board.

One change to note is the possible shift to trimesters for our elementary schools. We feel that moving to a trimester system provides staff with additional time to assess progress of a student in grades K-5. Specifically, challenges have been noted with our specials courses where teachers do not see students daily, but rather 45 minutes one time a week or 30 minutes two or three times a week. We will continue to have a quarter and semester calendar for our middle schools and high school.

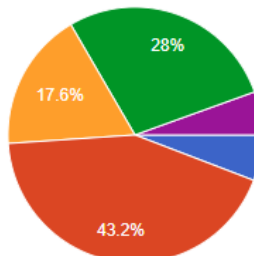
