Brady Langemo gave the AD/DOS report - Girls Basketball - Currently 0-6, 9-12: 18, JH:12; Boys Basketball - Currently 1-4, 9-12: 21, JH: 18; Cheerleading - 7-12: 11 (Cheering at JV and V games again this year). Fall Activities Awards Night - Volleyball & Football hosted their awards night; Cheerleading is still looking for a date. Triple “A” Applications have been turned in and the winners are – Leveah Kiecker and Bergen Howard. One Act Play - Rehearsals are underway for *The Bear*. Other - Leadership Conferences - Team Up conference with Craig Hillier: 5 sophomores - MSHSL conferences presented by S.A.L.T: 12 9th-12th graders. Softball field update: All our agrilime has been delivered. In the spring we will install bases and spread/level the agrilime and it’ll be playable. Esports: 10 individuals out, hosting a live competition with WAO 12/17 (this meet needed to be cancelled per WAO).

Approve payment of bills Brekken moved to approve the payment of bills with computer check numbers #51093-51185 in the amount of \$1,034,824.66; activity check number #20002-20007 in the amount of \$8,367.42; wire payments in the amount of \$221,677.82 and MSDLAF Transfers - Redemptions in the amount of \$795,000. Seconded by Strom. Motion carried.

Tracy McGlynn gave the Finance Officer report Food Service - We are currently at 47.08% in elementary, 46.98% at the secondary level and 47.03% overall (prior year 49.56%). Enrollment - Our K-12 enrollment as of Dec 1 was 442, up one from the last meeting (prior year 422). A complete breakdown is available in your packet. Levy Certification. You will be asked to certify the 2024 payable 2025 levy at this meeting. Budget Revisions - In your board packet you will find the revised budget summary that I put together, entitled 2024-25 Revised Budget, along with all the changes that have been made to the budget. With all the revisions so far, the district is looking at a \$320,671 loss for this year in the General Fund. The revised budget is based off 440 K-12 ADM, 3 EC students, and 15 VPK students. This is the budget proposed for approval. The

overall budget of all funds pulled together from the 2024-25 Revised Budget shows a loss of \$259,357. This is a decrease of \$83,195 from the original budget (loss of \$342,552). Other • Our ESEA Title application in MEGS on MDE requires a Fall Amendment to our original application. This is an additional requirement with the new MEGS program. Mr. Reiersen and I have worked on completing the application and budget sections, respectively, which are due December 15th each year.

Aaron Cook gave the Superintendents - 24 Pay 25 Levy a. Certified levy is the same as the proposed levy. Overall, a 4.19% increase b. Majority of increase comes from higher ADM count then on previous levies and there is no negative deduction for the lease levy. Budget update - The revised budget is up for approval. While we are better off than the original projections we are still at a large deficit of \$320,671 in the general fund b. The projected year end unassigned general fund account balance would be 18% of our expenditures. State Budget Forecast - Current projections show a \$616M surplus for this biennium. \$1.1B less than previously anticipated. Tails budgets show a projected deficit of \$3.5B to \$5.1B. Current law has inflationary increase between 2% and 3% increase to general education revenue formula. World's Best Workforce Information a. Institutional Effectiveness committee is examining current goals. Expect proposals for new goals to be brought forward at the January meeting. Presentation part of TNT meeting. Resolutions- Resolution to reduce- Needed yearly in case reductions are recommended. Combined Polling Place - Needed yearly in case of special election.
