## District Profile Summary for the World's Best Workforce Plan

Carlton School District serves approximately 270 students across two school sites: South Terrace Elementary (Preschool–Grade 6) and Carlton High School (Grades 7–12). The district is proud of its close-knit community and diverse student population. Notably, 18% of our students identify as American Indian, enriching our schools with cultural heritage and perspective.

Our district is committed to inclusive education, with over 90 students receiving special education services. Thanks to our district's small size, we are able to offer more individualized instruction and support, helping all learners thrive. Additionally, roughly 3 out of every 7 students (42.9%) qualify for free or reduced-price meals, and we work diligently to ensure equitable access to nutrition, academic support, and comprehensive services.

This unique environment allows us to build strong relationships with students and families, fostering a supportive and effective learning community that aligns with the goals of the World's Best Workforce initiative.

#### **Grandparents & Special Friends Day**

We had a wonderful turnout for our annual Grandparents and Special Friends Day, with approximately 200 special guests attending the event. Students and their guests enjoyed visiting classroom learning stations, exploring the Book Fair, and stopping by the photo and cookie area set up in the large gym. It was a great afternoon filled with smiles, laughter, and meaningful connections across generations.

#### **Physical Education Highlights**

In October, students completed their biking unit with Ms. G. This unit focused on developing safe biking skills, traffic awareness, and overall fitness. The lessons went very well, and students demonstrated a strong understanding of key safety concepts.

More recently, students participated in five skating sessions at the Four Seasons complex. These sessions were a big success, giving students an opportunity to practice balance, coordination, and perseverance while having fun.

#### **Enrollment Update**

#### **Social-Emotional Supports**

Our school therapy dog continues to visit twice a month, providing students with comfort and emotional support. Each grade level has identified students who participate in these positive sessions held in the sensory room. These interactions have been very well-received and continue to foster a calm and supportive school environment.

#### **Assessment and Literacy Initiatives**

In the coming weeks, we will administer the Read Basix CAPTi screener to

identified students who were flagged during our initial FastBridge reading screening process.

Read Basix is a diagnostic literacy assessment that creates a detailed student reading profile, identifying specific strengths and areas for growth in key reading domains such as word recognition, vocabulary, sentence processing, reading fluency, and comprehension.

The results will help our teachers tailor instruction and interventions to meet individual student needs and support continued reading growth. No preparation is required from home for this assessment.

### **Looking Ahead**

We are looking forward to our Winter Concert on Thursday, December 18th, with performances scheduled for 9:30 AM and 2:00 PM. Students have been practicing diligently, and we are excited to welcome families and community members to celebrate the season with us through music and student performance.
