 - Gas service has been connected
 - HVAC startup completed
 - Installation of ceiling grid and vinyl tile flooring will accelerate

Attendance Zone Planning

- ▣ A committee of Board members and staff members have been meeting with Bob Templeton and his staff to narrow down attendance zone options.
- ▣ Two proposals for elementary zones and two proposals for middle school zones will be published this week.
- ▣ A public hearing on attendance zones will be scheduled for next week.
- ▣ A called Board meeting will be scheduled for the week of January 29th to approve attendance zones.

Technology Upgrades

- ▣ A great deal of work was accomplished over Christmas break, including:
 - HS: installed 99 network cables for the surveillance cameras and 56 network cables for the access points (this will allow us to have an access point in every classroom), and replaced the main fiber and copper switches which will allow us to move data up to 10Gbs (we were at 1Gbs).
 - MS: installed 74 network cables for the surveillance cameras and 59 network cables for access points, we have replaced the main fiber and copper switches which will allow us to move data up to 10Gbs (we were at 1Gbs)

Technology Upgrades (Cont'd)

- Elementary Schools: Started installing network cables in the ES campuses. Will schedule some after hour work on these campuses to install the network cables for the 55 surveillance cameras. Simply ran out of time during the break. We also placed the ES campus fiber switches to enable 10Gbs.
- Very pleased with the progress on these projects and expect the work to be completed very soon.

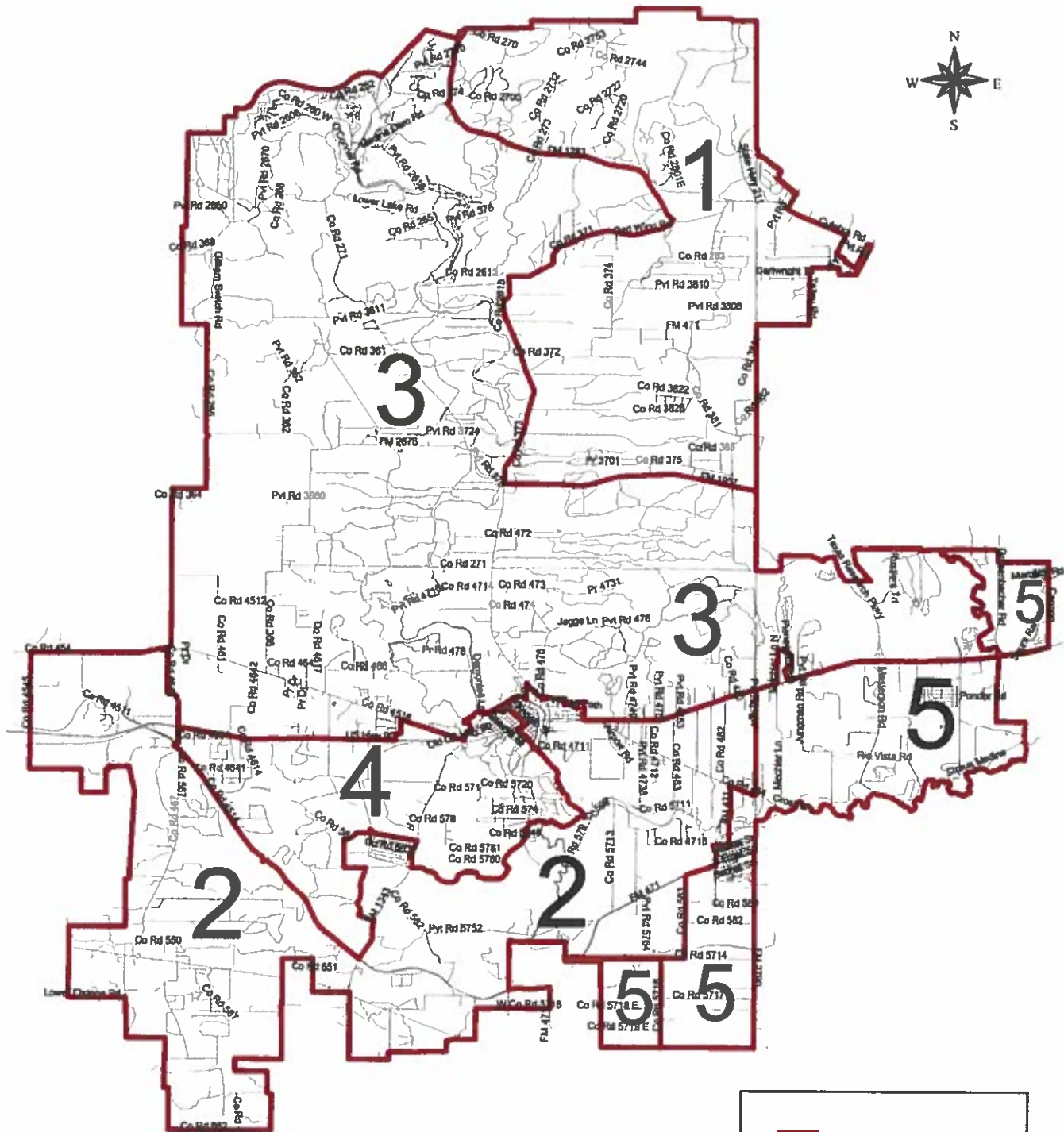

2018-2019 Constitution

This document's purpose is to develop a set of uniform guidelines for the cheerleading squads/mascots of Medina Valley High School. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken. Each circumstance will be evaluated on a case by case basis.

Section 1: Organization Goals

- A. To promote school spirit and pride.
- B. To display leadership qualities at all times.
- C. To promote physical fitness.
- D. To promote the ideals of friendliness and sportsmanship.
- E. To act as an ambassador of Medina Valley High School and its community.
- F. To promote the MVHS activities by attending games, decorating school locker rooms, hallways, making banners and signs, and decorating for pep rallies and community events to foster goodwill.
- G. To compete for the Texas UIL State Spirit Championship
- H. To foster positive self-esteem by teaching responsibility, dependability, cooperativeness, and discipline.

Section 2: Membership

- A. Each cheerleader and mascot will give his/her time to participate in required activities throughout the year. Cheerleaders/Mascots must be dedicated to the squad to rightfully represent MVISD. Cheerleaders/Mascots must make every attempt to attend every cheerleading event. Failure to attend a scheduled activity will result in an infraction as stated in Section 12: Discipline Management. If a cheerleader misses one cheer event, without a written excuse from coaches, doctors, etc., they will receive 1 demerit. If continuous, may be dismissed from the squad.
- B. Membership is open to students in grades 9-12, who have demonstrated academic eligibility in accordance with UIL guidelines. who have demonstrated academic success, possessing passing grades with a 70 or higher. Grades and attendance will be verified. There is no legal entitlement to being a cheerleader/mascot. This activity falls within the category of extracurricular activities, participation in which is a privilege and not a right.
- C. Cheerleading season starts May 1, 2018 after tryouts and does not end until the sports seasons end in May of 2019; this includes play-off games during the summer. If a cheerleader quits or is dismissed from the squad, she forfeits the cheerleader privileges and may not tryout the consecutive year.
- D. All cheerleaders/mascots must follow the rules of the Medina Valley Code of Conduct & its Student Handbook, the Cheer Constitution, and its honor code at all times. By signing this contract, both parent and cheerleader/mascot are agreeing to abide by the above state school publications.
- E. Each cheerleader/mascot is expected to maintain a high level of academic achievement. If the squad member cannot maintain academic eligibility in accordance with UIL guidelines~~grades above a 70% in each of their classes~~, the cheerleader will be placed on academic probation for the grading period. Members will have an opportunity for reinstatement at the end of each progress report. Only one academic probation period will be allowed each school year. ~~If the average is not raised by the end of the grading period, the cheerleader/mascot will be dismissed from the squad.~~
- F. Per UIL policy, members on academic probation must attend and participate in all practices, but may not attend games, pep rallies, or other scheduled appearance events. They are not allowed to be in uniform and may not be on the field/court during the probationary period.
- G. Cheerleaders/mascots and the cheer sponsor will work together to set goals for earning money towards various expenses incurred for cheer orientated activities. Fundraisers help to minimize out of pocket expenses and

increase team spirit among cheerleader/mascots. Failure to participate will result in out-of-pocket expense depending on the purpose of the fundraiser. District administration must approve all fundraisers before they can begin.

Section 3: Designation of Cheerleading Squads

2018-2019 JV Spirit Squad

- A. The JV Spirit Squad will comprise of 9th – 10th grade students who try out and meet membership requirements. The squad will consist of no more than 10~~12~~ cheerleaders. 9th grade students are only eligible for the JV Spirit Squad.
- B. The JV Spirit Squad will attend and support junior varsity athletics~~all events deemed appropriate by the sponsor(s) and administration~~. They will also perform at the UIL State Spirit Championship, some pep rallies, community events, and 3rd quarter of varsity home games upon approval from sponsor(s).

2018-2019 Varsity Spirit Squad

- A. The Varsity Spirit Squad will comprise of 10th – 12th grade students. This squad will consist of 12-20 cheerleaders who try out and meet membership requirements. The varsity squad will attend and support varsity athletics, regional and state competition, and a variety of other community events. They are the leaders of pep rallies, varsity games, and any other activities involving MVHS representation.
- B. A Varsity cheerleader/mascot qualifies for a letterman jacket upon completion of one year on Varsity Cheer squad. A Cheer squad year begins at tryouts and ends when the spring sports seasons end. ~~in summer of 2017. The cheerleader/mascot will be fitted in late spring semester.~~

2019-2020 Realignment of Spirit Squads

- A. A Freshman Spirit Squad will be introduced and comprise of 9th grade students. This squad will consist of a maximum of 10 members and support freshman athletics. The Freshman squad will also perform at some pep rallies, community events, and during the 3rd quarter of the homecoming football game.
- B. The Junior Varsity Spirit Squad will consist of 10th and 11th grade students. This squad will consist of a maximum of 10 members and support junior varsity athletics. The JV squad will also perform at the UIL Spirit State Championship, some pep rallies and community events, and the 3rd quarter of all home varsity football games
- C. The Varsity Spirit Squad will consist of 10th - 12th grade students. The squad will consist of [redacted] cheerleaders and support varsity athletics. The varsity squad will attend regional and UIL Spirit State Competition and a variety of other community events. They are the leaders of pep rallies, varsity games, and any other activities involving MVHS representation.

Section 4: Tryouts

- A. On March 9, 2018, a panel of impartial judges will determine squads based on [redacted] skills: Appearance, Jumps, Cheer, Crowd Involvement, Dance, Running Tumbling, and Standing Tumbling. Each category will be allotted a predetermined amount of points. Points from all judges will be combined with the score from Administrator Recommendations for an overall score. Scores will be used to determine rankings within the Spirit Squads. Candidates must meet the following criteria in order to tryout:
- B. Tryouts are judged by three experienced outside judges and scores calculated by authorized school administrators and/or personnel. Professional judges with outstanding credentials and references will be hired for tryouts. They will be instructed to judge the candidates solely on the criteria listed on the score sheet (see Page 12).

Tryout Eligibility

- A. ~~The MVHS Cheerleaders will primarily compose of the following students: Junior Varsity Squad (9th – 10th grade) and Varsity Spirit Squad (10th – 12th grade).~~ Tryouts are open to all current and future MVHS students who meet the below criteria. Any transfer students will be evaluated based on their academics and attendance in order to determine whether they meet the MVHS requirements.
- ~~Attendance at the Pre-Tryout Parent Meeting~~~~mandatory tryout parent meeting~~ for both candidates and parents on February 20, 2018 at 5:30 pm in the MVHS Library. If parent is not in attendance, the candidate cannot proceed with tryouts. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken.
 - Due no later than February 23, 2018 is the entire Cheer Tryout Packet signed by cheerleader and parent. **No late applications will be accepted. All papers must be turned in, in order to tryout.**
 - Acceptable academic standing ~~in accordance with UIL guidelines of a 70% or higher in all courses is a prerequisite to try out for the squad.~~ Current grades, attendance, and discipline will be pulled by campus administration. Any inaccuracies with grades, attendance, and discipline must be cleared up before February 23, 2018 (6W4). They will NOT be revisited afterwards.
 - Attendance and participation in the entire cheer tryout clinic to be held on Wednesday, March 7th.

Ineligibility

- A. Candidates will be considered ineligible to participate for the following reasons:
- Excessive ~~unexcused~~ absences. Students must meet the 90% attendance requirement.
 - Any disciplinary placement to Alternative School Placement (DAEP) or
 - Two or more In School Suspensions (ISS) assignments for the 2017-2018 school year.
- B. Student with 5 or more other disciplinary referrals will be allowed to try out, but will be placed on a probationary status through the first three calendar weeks of the 2018-2019 school year.
- C. Students must be present in all class periods the entire week of tryouts. Any excused or unexcused absence for any class period will result in forfeiture of tryout eligibility. Attendance will be verified.

Tryout Clinic

- Tryout material will be taught at the mandatory tryout clinic to be held March 5-7 from 4:30 - 6:00 pm in the practice gym of the high school.
- The candidate must be at the clinic each day, in its entirety in order to tryout. Late arrivals will result in forfeiture of cheerleader candidacy.
- Tryout clinic attire should be athletic clothing, cheer appropriate shoes (no sandals, boots, slippers, or keds), and hair needs to be pulled up securely so that it does not need to be redone. Food will not be allowed; water bottles are encourage.
- The tryout clinic is closed to cheer candidates only.
- Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken.

Tryout Appearance

- A. ~~Judges will be looking for an All-American look.~~ Clothing and hair for tryouts will consist of the following. No jewelry will be permitted at tryouts. ~~Clothing for tryouts will consist of the following.~~

- a. Solid ~~black, orange or white~~ tee-shirt (no midriff showing); no sleeveless shirts. *Small* athletic brand emblems are allowed (Nike, UA, etc.); however, no Varsity Spirit or cheer emblems will be allowed.
- b. Solid black, shorts. *Ex: Nike Pros, track style shorts, or traditional soffee shorts. See emblem guidelines above.*
- c. White socks (no emblem or striping) and athletic shoes
- d. ~~Cheer Shoes or Tennis shoes (any athletic shoe/NO Keds).~~
- e. Clean ponytail with solid ribbon. No bows, flyaways, or loose hair. ~~No jewelry will be permitted at tryouts.~~
- f. ~~Hair is to be pulled back out of the cheerleaders face with white, orange or black ribbon. No hair bows will be allowed, just plain simple ribbon. Judges will be looking for an All American look. No excessive makeup, no glitter, and no nail polish shall be worn.~~

Day of Tryout Procedures

- A. ~~Candidates need to report to the back gym beginning at 8:30 am to check-in. Following check-in, candidates will~~ Upon dismissal from 1st period, candidates will head straight to the back gym to change stretch and warm-up. Parents are not allowed in any part of the tryout areas.
- B. ~~Back gym doors will open at 9:30 am and cheerleaders will be checked in and given their numbers. Candidates will not be permitted in the back gym prior to 9:30 am.~~
- C. Doors will be locked at 9:00 am sharp. Any cheerleader who arrives after 9:00 am will not be allowed to tryout. Tryouts will begin around 9:30 with the JV candidates first, followed by the Varsity candidates. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken. ~~immediately following the middle school candidates.~~
- D. When a participant has completed the individual tryout process, they will be escorted to ~~the back gym~~ get their personal items, and then must wait until all candidates have been judged.
- E. ~~Callback~~-The judges may ask candidates to return to the gym at the end of the tryouts to perform any or all of the materials a second time. All candidates should remain on standby until dismissed by an administrator.
- F. Following the conclusion of tryouts, candidates must proceed to class to finish out the remainder of their class schedule for the day. Attendance will be verified.

~~Tryouts are judged by three experienced outside judges and scores calculated by authorized school administrators and/or personnel. Professional judges with outstanding credentials and references will be hired for all tryouts. They will be instructed to judge the candidates based only on appearance and the master of the skills that they see demonstrated during tryouts.~~

Team Assignments

- A. The squads will be determined based on the cheerleader's scores from tryouts and the Citizenship Score (grades, attendance, discipline) completed by their administrators. The maximum number of Varsity cheerleaders is 20. The top sophomores, juniors and seniors with the highest combined score may make the Varsity squad. A natural break in the varsity scores may be used to determine a cut-off point. The maximum number of JV cheerleaders is 10. The JV squad may consist of the top 10 freshmen and sophomores with the highest scores. Neither juniors nor seniors can make the JV cheer squad.
- B. Results will be handed out to candidates in the form of a letter on the day of tryouts, after scores are finalized. Candidates are not allowed to open letters until they have left school campus. Those that do not adhere to this rule will forfeit their position on the cheer squad.

Parents and Tryouts

- A. Parents are responsible for transportation for their child to and from the cheerleading clinic and tryouts as well as all practices and events thereafter. ~~The student must be at the clinic in its entirety in order to tryout. Late arrivals will result in forfeiture of cheerleader candidacy.~~
- B. Parents are *not allowed* in the **building during** ~~pre-tryout cheerleading clinic or~~ the official tryouts. Parents may not videotape or photograph any part of the tryout process. ~~at the conclusion of the tryout clinic, candidates will be given a link to the tryout material and music.~~
- C. After tryout results are given, parents must conduct themselves in an appropriate manner, reflecting sportsmanship and good character.
- D. Parents are allowed to view their child's score, but not the score of any other contestant. Parents will have **15 school days** ~~until end of school day on March 24, 2017~~ to view scores with the cheer sponsor/ administrator. After the close of business ~~on the 15th day~~ for the listed date, score sheets will be shredded.
- E. All judges' decisions are final. There is no legal entitlement to being selected as cheerleader/mascot, and therefore decisions are indisputable.

- ~~C. The squads will be determined based on the cheerleader's scores. The maximum number of Varsity cheerleaders is 20. The top sophomores, juniors and seniors with the highest scores may make the Varsity squad. A natural break in the varsity scores may be used to determine a cut-off point. The maximum number of JV cheerleaders is 10-12. The JV squad may consist of the top 10-12 freshmen and sophomores with the highest scores. Neither juniors nor seniors can make the JV cheer squad.~~

Candidates are not allowed to open letters until they have left school campus. Those that do not adhere to this rule will forfeit their position on the cheer squad.~~

New Team Information

- A. The cheerleaders/mascots and their parents will have a mandatory New Team Meeting on Wednesday, March 21, 2018 at 5:30pm in the high school Library.
- B. The chosen cheerleaders/mascots will have a mandatory uniform and camp wear fitting on March **19th beginning with varsity cheerleaders at 4:00pm and JV candidates at 5:30pm** ~~23rd beginning at 3:15 PM~~ in room 308. ~~Appointments will be made to expedite the fitting process and~~ parents are welcome to attend this event to ensure proper sizing.
- C. Spring/Summer practice schedule is as follows: **March 26, 28; April 2, 4, 9, 11, 16, 18, 23, 25, 30; May 14, 16, 21, 23, 30; June 4, 6, 11, 13, 18, 20, 25, 27; August 6, 7, 8, 13, 14, 15, 20, 21, 22.** ~~29; April 5, 12, 19, 26, May 3, 10, 17, 24, 31, June 5, 6, 7, 8, 9; August 8, 9, 10, 15, 16, 17.~~ Failure to attend Spring/Summer practices will result in demerits and possible removal from future performances as deemed necessary from the coach.
- D. The cheerleader's first fundraiser will be the Kiddie Camp is scheduled for June **8-9, 2018.** ~~7-9, 2017.~~ Kiddie Camp participation and attendance is mandatory to be on the Medina Valley Cheerleading squad. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken. Each cheerleader is encouraged to register a minimum of 5 campers.
- E. The cheerleaders will attend **UCA Camp at UT Austin in June (dates to be determined).** ~~NCA Resort Camp at T Bar M Resort in New Braunfels, TX.~~ Camp is mandatory to be on the Medina Valley Cheerleading Squad. A cheerleader must attend all four days of camp. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken. Mascots will not attend camp.

- F. The parent is responsible for transportation to and from camp. A district vehicle will be driven by the coach to provide those who need alternative transportation arrangements. ~~cheerleader must arrive at camp with the squad via school bus, but a cheerleader may leave camp with their parent/guardian, if they have turned in a ride pass two weeks prior to the event.~~ Per UCANCA policy, parents are only permitted to attend camp during All-American tryouts and for final evaluation and awards.
- G. New Varsity camp, uniforms, practice wear, and accessories are estimated to be \$1500. JV and returning Varsity expenses are estimated to be \$1000. This is just an estimate of what cost will be this year and a detailed report will be discussed at the New Team Meeting. Failure to pay the remaining balance by the noted date of July 9, 2017 may result in removal from the team. The estimated payment schedule is as follows:
 - a. March 28th-29th – Camp wear + New Uniform - online payment to Varsity
 - b. April 25th-12th - \$375.00\$375-415.00 camp payment – check payable to MVHS

Section 5: CAPTAINS & MASCOTS

~~Tryout &~~ Selection of Cheerleading Captain(s)

- A. The Captain(s) will be selected with careful consideration by the coach. Factors considered include tryout score, grades, attendance, behavior, choreography, leadership qualities, interview, squad recommendations, & teacher recommendations. (Please note that some teachers may request not to do the recommendation.)
- B. The Junior Varsity squad will have one captain and the Varsity Squad will have up to two Captains. Varsity captain candidates must meet at least one of the following criteria: (1) a former varsity squad member for 1 year (2) a former JV captain, or (3) a cheer program spirit or social officer.
- C. ~~The Captain(s) will be selected with careful consideration by the coach. Factors considered include chosen based on tryout score, grades, attendance, behavior, choreography, leadership qualities, interview, team recommendations, & teacher recommendations. (Please note that some teachers may request not to do the recommendation.)~~
- D. Captain candidates are expected to complete an application, interview, and choreograph and teach a 30 second (approx. 6-8 counts) dance with stunt incorporation. The total time to teach is 2 practices. Captain applications will be available at the New Team Meeting.
- E. Captains will be announced on or before the first day of cheer camp. ~~perform a cheer followed by a 1 minute dance/tumbling routine to be performed before the judges. The cheer should lead straight into the dance and a transition cheer/chant is allowed but not required. Time limit for the entire performance is 1:30.~~
- F. Captains are expected to attend a mandatory captain's leadership camp August 8 - 10th. Failure to attend will result in removal from the position of captain.

Responsibilities and Duties of Cheerleading Captain(s)

- A. The captain(s) will serve as the team's most dedicated leader, motivator, organizer, and choreographer.
- B. The captain(s) of Varsity may find it difficult to participate in any other activity due to the large amount of time needed for planning and executing events.
- C. Captains must attend all events without fail. Even if there is another conflict, the captain must attend the event when the other has ended.
- D. Captains must be ready to attend any event at a moment's notice, and know that cheer must come first, as they are leaders of the team.
- E. Cheer captains can be removed at the discretion of the committee for failing to meet criteria. All decisions are indisputable.

Responsibilities and Duties of Mascot

- A. The purpose of the mascot is to build spirit at athletic events and serve as an ambassador for MVISD. Mascots do not have to be enrolled in the cheer class period and will not attend camp.
- B. Only one mascot will be chosen for the 2017-2018 school year. The Mascot must be at the Varsity events from beginning to end. The mascot may find it difficult to be in band, dance team, or any other Varsity sport, and fulfill their obligation of being mascot.
- C. The mascot does not have the same financial commitments as cheerleaders; however, the mascot will have the option to purchase warm-ups and spirit wear to match the cheer team. Optional items must be purchased at the same time as the cheer team's order.

Tryout & Selection of Mascot

- A. Mascots are selected through a tryout process. All current 9, 10 and 11 grade students are eligible to try out for mascot. Incoming 8th graders are not eligible to try out for mascot. If there are no candidates trying out for mascot the director/coach may select qualified individuals to fill the position.
- B. Mascot candidates must prepare a 1:30 routine, choreographed to music. The skit must be in good taste and for all audiences. Mascots will be judged on the following criteria: Characterization, crowd interaction, use of props/music, choreography, and overall impression.
- C. Mascot candidates may have two assistants to help set up and take down, but they cannot be part of the skit itself.
- D. Props can be used and are encouraged. Props are limited to 5. No water guns, confetti, balloons, fire extinguishers, or noise making devices are allowed as a prop. If any part of the costume is taken off, it must be put down immediately or it becomes a prop.
- E. Points from all judges will be combined for an overall score. Scores will be used to determine rankings for Varsity mascot. All judges' decisions are final. If a person violates these rules they will have points deducted at the judge's discretion.

Section 6: Attendance Requirements

- A. If any other activities or opportunities are chosen by the coaches, the coaches shall decide if the event is mandatory or optional. Reasonable notice of all such activities/opportunities will be given for mandatory events, and as early as possible for others.
- B. If a cheerleader/mascot drops out of cheerleading before the cheerleading season ends, he/she cannot tryout the following year.
- C. The expectation is that cheer comes before work. Missing an event or practice due to work is not considered a valid excuse. This includes morning and afternoon practices. Note: A calendar of scheduled events will be distributed by so that cheerleaders who are employed can schedule their work around their cheer events.

Section 7: Honor Code, Safety, Medical Release

- A. Any cheer parent that has a concern or complaint about the program needs to follow the chain of command: (1) Coach, (2) Program Administrator, (3) Associate Principal, and finally (4) Principal. The coach and administration will always govern the MVHS Honor Code. The administration or sponsor will impose all consequences for all cheerleaders/mascots. Parents will be informed when a cheerleader/mascot is on probation or has committed a serious offense.
- B. A merit/demerit system will be implemented to ensure effectiveness and fairness in Spirit Squads regarding behavior, academics, participation, and performance on/off school grounds throughout the duration of membership. Some infractions may be given a warning or additional conditioning in place or a demerit.

Safety

- A. Cheerleader/mascots must follow safety instructions at all times. Not following safety instructions could result in suspension or dismissal from the squad. Lack of focus in practice or in games, i.e. laughing, yelling, crying, or pouting while stunts are being performed will not be tolerated at any time. This is the most serious offense as other cheerleader/mascots' safety and well-being is at stake.
- B. Discipline for dropped stunts at a game or event will result in stunt group conditioning: stadiums, pushups, frog jumps, etc. This is to encourage proper form, technique, and progression of skills.
- C. The coach will restrict performance of specific skills from individuals or stunt groups if proper form and technique has not been demonstrated in practice.

Medical Release

- A. Per UIL Policy, injuries with a doctor's note must be honored by the coach and a medical release is required for return to active participation. Cheerleaders and parents should be in communication with doctors, trainers, and the coach to ensure proper restriction guidelines and an estimated medical release to return to active participation.
- B. Injuries, illnesses, and routine doctor's appointments during a performance week may result in a change in position for formations, stunts, and performances. Placement back in formations, stunts, and a performance event is at the discretion of the coach.

Section 8: Appearance, Camp/Practice Wear, and Uniforms

- A. **Cheerleaders are expected to maintain an athletic, All-American look throughout the year.** Make-up should be kept to a minimal level; absolutely *no glitter, face paint, or excessive makeup in uniform*. Nail polish will be neutral and nails kept short while in uniform. Hair can be colored or highlighted in a natural way, and must follow the Student Code of Conduct for Dress Code and Grooming. All female cheerleaders will wear their hair out of their face in a similar style, i.e. ponytail, half-up, side twist or braid. No bangs or loose hair by the ears.††
- ~~B.~~ Jewelry, other than small pearl studs, is not part of the uniform and may not be worn during practice, performances, or pictures to be used for school purposes. Cheerleaders will not be able to perform with any type of jewelry other than small pearl studs. Covering jewelry will not be accepted; it must be taken off.
- C. Uniforms must be worn in their entirety: shell, skirt, bodyliner(when required by the coach), no show socks, and cheer shoes. In addition to jewelry (other than pearl studs), certain items may NOT be worn at any time when in uniform. Such items include but not limited to: homemade necklaces, bracelets, anklets, sunglasses, nail polish, non-cheer shoes (flip flops, Crocs, UGGs, etc., pajama pants, rolled shorts / skirts, jeans, and/or sweats under skirt.
- D. Failure to comply with the uniform rules will result in removal from the activity until the problem has been corrected and the appropriate discipline will be assessed as stated in the constitution. Designated hairstyles and makeup are considered part of the uniform look.
- E. The coach will choose the camp clothes and uniforms to be worn during the year. Cheerleading uniforms will only be worn for events as designated by the coach.
- F. Cheerleaders are responsible for ownership and care of personal camp clothes and uniforms. Lost items will require the cheerleader to purchase replacement items. Cheerleaders cannot lend or give their cheer clothes to any person who is not a cheerleader.
- G. Cheerleaders/mascots are responsible for purchasing their uniforms, camp clothes, accessories, and shoes.

Section 9: Liabilities

- A. By the very nature of the activity, cheerleading carries a risk of physical injury. In the event of an injury requiring medical attention, cheerleaders will not be allowed to practice or participate without physician clearance. Physician clearance must be on file with both the coach and athletic trainer.
- B. Cheerleader/mascots are not permitted to engage in any stunts without sponsor present. The sponsor is not liable for any accidents or injuries that may occur while these stunts are being performed.
- C. Proper supervision and safety equipment is to be used at all times. Failure to do so may result in disciplinary action.
- D. The sponsor is not responsible for providing transportation to and from practice or home games. Parents must make arrangements for these activities. Pick up must be no later than *15 minutes* after the scheduled event or practice is over. Demerits for late pick up will be issued.
- E. Out of town events will follow Medina Valley ISD guidelines for transportation/absences. ~~Cheerleader/mascots, who participate in other sports, must attend events planned by the cheerleading sponsor that do not take place at the same time as their athletic or UIL events. For example, if a varsity cheerleader/mascot is also a JV basketball player, and there is a home game he/she must make it to the cheer event. It is the cheerleader's responsibility to fulfill his/her duties in both activities. If the cheerleader misses any games (which do not conflict with the other athletic or UIL events) they will receive 2 demerits.~~

Section 10: Regarding Cheerleading/Mascots and Extracurricular Activities

- A. The coach of the 2017-2018 cheerleading squads empathizes with all students who would like to participate in both cheerleading and sports events. ~~Cheerleader/mascots, who participate in other sports, must attend events planned by the cheerleading sponsor that do not take place at the same time as their athletic or UIL events. For example, if a varsity cheerleader/mascot is also a JV basketball player, and there is a home game he/she must make it to the cheer event. It is the cheerleader's responsibility to fulfill his/her duties in both activities. If the cheerleader misses any games (which do not conflict with the other athletic or UIL events) they will receive 2 demerits. These guidelines were developed based on prior experience and input of cheerleaders and parents.~~
- B. Should a cheerleading class be offered, cheerleaders are required to be enrolled in the class period to perform at pep rallies and events.
- C. Spirit Squad cheerleader/mascots must attend scheduled morning and/or afternoon practices in order to perform at games, pep rallies, etc. If a cheerleader misses a practice during a pep rally week, the cheerleader will not be able to perform in the pep rally that week.

Section 11: Cheerleader/Mascot, Coach, and Parent Expectations

Cheerleader/Mascot Fair Play Code:

- A. I will participate because I want to, not because my parents or coaches want me to.
- B. I will follow all rules and cheer in the spirit of the game.
- C. I will control my temper since fighting and disrespect can spoil the activity for everyone.
- D. I will respect my opponents.
- E. I will do my best to be a true team player.
- F. I will remember that winning isn't everything. Having fun, improving my skills, making friends, and doing my best are also important.
- G. I will acknowledge all good performances by both my teammates and my opponents.
- H. I will remember that coaches are there to help me. I will accept their decisions, show them respect and understand they have given their time to be with me.

Parents Fair Play Code:

- A. I will remember that young people participate for THEIR enjoyment, and not to entertain me.
- B. I will not have unrealistic expectations and will understand that doing one's best is as important as winning. I understand that ridiculing an athlete for making a mistake is not acceptable behavior.
- C. I will respect the judges' decisions and will encourage all participants to do the same.
- D. I will respect and show appreciation for coaches and understand that they have given their time to provide activities for our young people.
- E. I will encourage cheerleaders/mascots and coaches to play by the rules and to resolve conflicts without resorting to hostility or violence.
- F. I will show respect for my squads opponents because I realize there would be no competition without them.
- G. I will not use bad language and will not harass cheerleaders, mascots, coaches, judges, or other spectators.
- H. I will always show good sportsmanship since young people learn best by example.

Coach Fair Play Code:

- A. I will treat each cheerleader as an individual, remembering the large range of emotional and physical development for the same age group.
- B. I will not show favoritism to specific cheerleaders on my squad.
- C. I will stress the fact that cheerleading is a team effort and teach leadership and team building to foster positive team relationships.
- D. I will teach each cheerleader the rules and fundamentals of cheerleading.
- E. I will do my best to provide a safe playing situation for my cheerleaders.
- F. I will do my best to organize practices that are fun and challenging for all my cheerleaders.
- G. I will use those coaching techniques appropriate for each of the skills that I teach.
- H. I will practice open communication with team members, coaches, team moms and parents.

Section 12: Discipline Management

Procedure for the Issuance of Demerits and Merits

- A. Demerits and merits will be issued as infractions / incentive occur
- B. Demerits and Merits will be based on coach observations.
- C. Only the coach will approve and assess demerits and merits.
- D. Demerits will be documented and require a cheerleader and parent signature.
- E. Demerits can only be removed by earning merits.
- F. It is the responsibility of the cheerleader to submit supporting documentation to earn merits, i.e. report card, attendance reports, etc.

Merits

- A. Earning straight "A's" on a report card – 2 merits
- B. Earning perfect attendance for a 3 week grading period – 1 merit
- C. Special assignments and projects requested by the coach.

Demerits

- A. This is a 10-demerit system with probationary periods prior to dismissal:
 - a. A member will be placed on a 1 event probation once accumulating 4 demerits.
 - b. A member will be placed on a 3 week probation once accumulating 7 demerits.
 - c. Once 10 demerits have been accumulated; the member is officially dismissed from the organization by the director and the campus principal.

- Insubordination – failure to abide to coach’s or captain’s direction

- Wearing sunglasses, nail polish, non-uniform jewelry, or chewing gum in uniform
- Visiting with non-members, including parents, without director(s) permission
- Foolish jesting, horseplay at games, pep rallies, and other events
- Students remaining on campus past the scheduled pick-up time
- Use of a cell phone on school grounds or scheduled events
- Wearing uniform incorrectly or to an unscheduled event
- Discipline referral from any school staff, for any reason
- Public display of affection at any time (including hickies)
- Stunting while not under direct sponsor supervision
- Eating at a game and/or practice without permission
- Any violation of the MVISD Student Code of Conduct
- Not knowing cheers, chants, and dances
- Unsportsmanlike conduct
- Late paperwork
- Late payment
- Truancy (per class period)
- Anything the director(s) deem(s) a minor infraction

Probation & Suspension

- A. The purpose of probation is to serve as an intervention and warning. Reasons for probation include: Ineligibility due to failing grade, ISS or off campus suspension, 5 or more conduct and/or discipline referrals, excessive absences, accumulation of 7 demerits, documented bullying, other reasons as deemed necessary by the principal/designee and the director(s).
- B. The coach and administration will govern the MVHS Honor Code. The administration or coach will impose all consequences for all cheerleaders/mascots. Parents will be informed when a cheerleader/mascot is on probation or has committed a serious offense.
- C. Violations of the Code of Conduct resulting in a disciplinary consequence such as In-School Suspension, Off-Campus Suspension, etc. will be handled as follows:
 - a. **1st offense:** Student will be ineligible for participation for three (3) calendar weeks from the date of the offense
 - b. **2nd offense:** Dismissal from the Squad for the remainder of the semester or 12 calendar weeks (whichever is longer)
 - c. **3rd offense:** Dismissal from the Cheer Program

- d. If the cheerleader/mascot is enrolled in cheer class, they will receive a grade of 50 for the semester. If a cheerleader/mascot is dismissed from the squad for any reason, they may not tryout for cheerleader/mascot the following year and forfeit any cheerleading awards.

Immediate Dismissal

Dismissible Offenses

- Cheerleader who does not attend an event for the sake of protesting a disciplinary action imposed by the sponsor(s) and or administrator(s) Dismissal from the Squad
- Cheerleader who confronts the cheer sponsor(s) in a hostile manner at any school activity or outside of school will face immediate Dismissal from the Squad.
- Cheerleader who confronts the cheer sponsor(s) in a hostile manner by phone will face immediate Dismissal from the Squad.
- Any cheerleader and/or parent who confronts (face-to-face, by phone, or via electronic communication) a sponsor(s) and/or teammate(s) for the purpose of hostile questioning, harassment, and/or unbecoming conduct will face Dismissal from the Squad.
- Cheerleaders are prohibited from bullying of any kind, i.e. (school, cyber, social network, etc.) offense warrants a 3 week suspension. If continuous, may be dismissed from Squad.
- Cheerleaders are prohibited from illegal activities such as drinking, drug use, etc. Dismissal from the Squad.

2018-2019 Constitution**

This document's purpose is to develop a set of uniform guidelines for the cheerleading squads/mascots of Medina Valley Middle School. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken. Each circumstance will be evaluated on a case by case basis.

Section 1: Organization Objectives and Goals

- A. To promote school spirit and pride.
- B. To display leadership qualities at all times.
- C. To promote the MVMS activities by attending games, decorating school locker rooms, hallways, making banners and signs, and decorating for pep rallies and community events to foster goodwill.
- D. To foster positive self-esteem by teaching responsibility, dependability, cooperativeness, and discipline.
- E. To promote physical fitness.
- F. To promote the ideals of friendliness and sportsmanship.
- G. To act as an ambassador of Medina Valley Middle School and its community.
- H. To foster positive self-esteem by teaching responsibility, dependability, cooperativeness, and discipline.
- I. ~~The Middle School mascot shall strive to promote self-esteem, responsibility, organization skills, as well as creativity. The mascot in itself is a community icon and is responsible for making a name as the mascot.~~

Section 2: Membership

- A. Each cheerleader and mascot will give his/her time to participate in required activities throughout the year. Cheerleaders/Mascots must be dedicated to the squad to rightfully represent MVISD. Cheerleaders/Mascots must make every attempt to attend every cheerleading event. If a cheerleader/mascot misses one event, without a written excuse from coaches, doctors, etc., they will receive 1 demerit. ~~If continuous, may be dismissed from the squad.~~
- B. Membership is open to 7th and 8th grade students who have demonstrated academic eligibility in accordance with UIL guidelines. (Section E) ~~success, possessing passing grades with a 70 or higher. Grades and attendance will be verified. There is no legal entitlement to being a cheerleader/mascot. This activity falls within the category of extracurricular activities, participation in which is a privilege and not a right.~~
- C. Cheerleading season starts May 1, 2018 after tryouts and does not end until the end of football season. ~~sports seasons end in January of 2018.~~ If a cheerleader/mascot quits or is dismissed from the squad, she forfeits the cheerleader/mascot privileges and may not tryout the consecutive year.
- D. All cheerleaders/mascots must follow the rules of the Medina Valley Code of Conduct & its student handbook, the cheer constitution, and its honor code at all times. By signing this contract, both parent and cheerleader/mascot are agreeing to abide by the above state school publications.

- E. **NEW (From UIL website)** A student who receives, at the end of any grading period (after the first six weeks of the school year), a grade below 70 in any class (other than an identified class eligible for exemption) or a student with disabilities who fails to meet the standards in the Individual Education Plan (IEP) may not participate in extracurricular activities for three school weeks. An ineligible student may practice or rehearse, however. The student regains eligibility after the seven calendar day waiting period has ended following a grading period or the three school week evaluation period when the principal and teachers determine that he or she has earned a passing grade (70 or above) in all classes, other than those that are exempted.
- F. Per UIL policy, members on academic probation must attend and participate in all practices, but may not attend games or other scheduled events. They are not allowed to be in uniform and may not be on the field/court during the probationary period.
- G. Cheerleaders/mascots and the cheer sponsor will work together to set goals for earning money towards various expenses incurred for cheer orientated activities. Fundraisers help to minimize out of pocket expenses and increase team spirit among cheerleader/mascots. Failure to participate will result in out-of-pocket expense depending on the purpose of the fundraiser. District administration must approve all fundraisers before they can begin.
- H. **NEW** Attendance
 - a. All students who participate in school activities must be in regular full-day attendance the day the activity is scheduled.
 - (a) Full-day attendance is from the beginning of the first hour and remaining until the close of the last hour of classes.
 - b. To participate in a practice, a student must attend school **1** hours.
 - (a) This must be fully documented with the Attendance Secretary.
 - c. If a member is ill and misses ANY activity, he/she must be at HOME or seeking medical appointments.
 - d. If a member misses ANY practice, he/she will automatically be replaced by an Alternate for that particular performance.
 - (a) An absence must be documented by the parent in writing with the Attendance Secretary.
 - (b) All doctor appointments, etc. should be scheduled so they do not interfere with team activities.
 - e. If any other activities or opportunities are chosen by the coaches, the coaches shall decide if the event is mandatory or optional. Reasonable notice of all such activities/opportunities will be given for mandatory events, and as early as possible for others.
 - f. If a cheerleader/mascot drops out of cheerleading before the cheerleading season ends, he/she cannot tryout the following year. When a cheerleader/mascot commits to the team it is for the entire cheerleading season.

Section 3: Designation of Cheerleading Squads and Mascot

Middle School Cheer Squad

- A. The Middle School Cheer Squad will comprise of ~~eight~~ **six** 7th graders and ~~eight~~ **six** 8th graders who try out and meet membership requirements. The squad will consist of no more

than ~~16~~ 12 athletes from the try outs. The Middle School Cheer Squad will attend all middle school football games. ~~events deemed appropriate by the sponsor(s) and administration.~~ They will also perform at no more than 4 pep rallies.

Mascot

- A. The Mascot will either be a 7th or 8th grade student who tries out and meets the mascot requirements. The mascot will consist of the student who scores the highest on their tryout. The mascot will attend all events deemed appropriate by the sponsor(s) and administration. They will also perform at no more than half of the pep rallies.

Section 4: Tryouts

- A. On April 20, 2018, a panel of impartial judges will determine the squad based on the individual athlete's knowledge, skills, and abilities in the areas of: tumbling, jumps, cheer technique, crowd leading, dance, and appearance. ~~the scores of each individual trying out. The judges will be separated and will score the contestants on execution and technique in the following categories: Tumbling, Dance, Jumps, Cheer, Crowd Involvement, and Appearance. Each category will be allotted a predetermined amount of points. Points from all judges will be combined for an overall score. Scores will be used to determine rankings within the Cheer Squad. Candidates must meet the following criteria in order to tryout.~~ The only peoples allowed in the gym during try outs will be the judges, an administrator, and staff assigned by the administrator. *Note: Any skill that is performed at tryouts is expected to be performed throughout the duration of the 2018-2019 cheer season. Failure to perform a skill that was executed at tryouts will lead to the cheerleader sitting out of future performances and games.
- B. Tryouts are judged by three experienced outside judges and scores calculated by authorized school administrators and/or personnel. Professional judges with outstanding credentials and references will be hired for tryouts. The judges will be instructed to judge the candidates solely on the criteria listed on the score sheet. (See Page 12.)

Tryout Eligibility

- ~~A. The MVMS cheerleaders will primarily compose of 16 12 cheerleaders from 7th or 8th grade. The cheer squad is open to all who tryout and meet the criteria. Tryouts are open to all current and future MVMS students who meet the below criteria. Any transfer students will be evaluated based on their academics and attendance in order to determine whether they meet the MVMS requirements.~~
 - a. Attendance at the Pre-Tryout Parent meeting for both candidates and parents on TBA at 5:30 in the MVMS Cafeteria. If parent is not in attendance candidate cannot proceed with tryouts. Should there be any extenuating circumstance that arises, that is out of the control of the active participate, situations may be reviewed at the discretion of the cheer coach and/or administrator to determine the appropriate action taken.
 - b. Due no later than TBA is the entire Tryout Application Packet signed by cheerleader and parent. If you know you will not be at school due to a school absence, the application must be in before the deadline. **No late applications will be accepted. All papers must be turned in to Mrs. Clark, in order to tryout.**
 - ~~c. All cheerleader candidates will also have teacher recommendations that must be completed. Athletes will be responsible for getting teacher recommendations turned in. It is not the teacher's responsibility to turn in their teacher recommendation. Unacceptable teacher evaluations will be brought before campus administration and reviewed on a case by case basis to determine tryout eligibility.~~

- d. Acceptable academic standing in accordance with UIL guidelines ~~of a 70% or higher in all courses is a prerequisite to try-out for the squad~~. Current grades, attendance, and discipline will be pulled by campus administration. Any inaccuracies with grades, attendance, and discipline must be cleared up before TBA deadline. They will NOT be revisited afterwards.
- e. Each candidate must try out for either cheerleader or mascot, but not both.

Ineligibility

- A. Candidates will be considered ineligible to participate for the following reasons.
 - a. Excessive ~~unexcused~~ absences. The athlete must be present at school for at least 90% of the time.
 - b. Any disciplinary placement (ISS or OSS) to Alternative School Placement (DAEP) for the 2017-2018 school year.
- B. Student with 5 or more infractions will be allowed to try out, but will be placed on a probationary status through the first three calendar weeks of the 2018-2019 season.
 - ~~a. The administration and coach may deem a contestant ineligible to try out for excessive past disciplinary problems.~~

Tryout Clinic

- A. Tryout material will be taught at the mandatory tryout clinic to be held on April 16th – 19th in the middle school gym.
- B. The candidate must be at the clinic each day in order to tryout.
- C. Tryout clinic attire should be athletic clothing, cheer appropriate shoes (no sandals, boots, slippers, or keds), and hair needs to be pulled up securely so that it does not need to be redone. Food will not be allowed; water bottles are encouraged.
- D. Tryout clinic is closed to cheer candidates only.
- E. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer coach and/or administrator to determine the appropriate action taken.

Tryout Appearance

- A. Clothing for tryouts will consist of the following.
 - a. Solid white tee-shirt (no midriff showing); no sleeveless shirts. *Small* athletic brand emblems are allowed (Nike, Under Armour, etc.); however, no Varsity Spirit, Nfinity or cheer emblems will be allowed.
 - b. Solid black shorts (no spandex). Ex: Nike, Under Armour, track style shorts, or traditional soffee shorts
 - c. White, no show socks.
 - d. Cheer Shoes or Tennis shoes (any athletic shoe/NO Keds).
 - e. No jewelry will be permitted at tryouts.
- B. ~~Hair is to be pulled back out of the cheerleaders face (if length permits)~~ Clean ponytail (No flyaways, or loose hair) with white, orange or black bow.
- C. ~~Judges will be looking for a All-American look~~. No excessive makeup, no glitter, and no nail polish shall be worn.

Day of Tryout Procedures

- A. Doors will open at 7:30am, and cheerleaders will be checked in and given their numbers.
- B. Cheerleaders will head straight to the gym to stretch and warm-up. Parents are allowed in the gym until 7:50.
- C. Doors will be locked at 8:00am sharp. Any cheerleader who arrives after 8:00am will not be allowed to tryout.

- D. At 8:05am, all participants will be escorted from the gym to the holding room until they are called to the gym to tryout.
- E. When a participant has completed the tryout process, they will be escorted back to the holding room to get their personal items, and then must proceed to class to finish out the remainder of their class schedule for the day.

Team Assignments

- A. The squad will be determined based on the cheerleader's scores. The maximum number of Middle School cheerleaders is ~~16~~ 12. The squad will consist of ~~eight~~ six 7th graders and ~~eight~~ six 8th graders from the try outs.
- B. Results will be handed out to candidates in the form of a letter ~~at 4:30pm on the day of tryouts, after scores are finalized~~, in front of the 7th grade building doors. Parents are expected to drive up to the Administrator waiting by the doors, retrieve their envelope, and proceed with driving off campus to open the envelope. Those that do not adhere to this rule will forfeit their position on the cheer squad.

Parents and Tryouts

- A. Parents are responsible for transportation for their child to and from the cheerleading clinics and tryouts as well as all practices and event thereafter. ~~The student must be at the clinic in its entirety in order to tryout. Late arrivals will result in forfeiture of cheerleader candidacy.~~
- ~~B.~~ Parents are *not allowed* in the ~~building during the~~ tryout clinic or the official try-outs. Parents may not videotape or photograph any part of the tryout process. ~~at the conclusion of the tryout clinic, candidates will be given a link that has the cheer and dance on it.~~
- C. After tryout results are given, parents must conduct themselves in an appropriate manner, reflecting sportsmanship and good character.
- D. Parents are allowed to view their child's score, but not the score of any other contestant. Parents will have ~~until March 24, 2017 to view scores with the cheer sponsor/ administrator~~ 15 school days to view scores with the cheer coach/administrator. ~~After the close of business on the 15th day, score sheets will be shredded.~~
All judges' decisions are final. There is no legal entitlement to being selected as cheerleader/mascot, and therefore decisions are indisputable

New Team Information

- a. The cheerleaders/ mascots and their parents will have a mandatory New Team Meeting on ~~TBA~~ in the MVMS Cafeteria.
- b. The chosen 2017-2018 cheerleaders/mascot will have a mandatory uniform and camp wear fitting on ~~TBA~~. Parents are welcome to attend this event to ensure proper sizing.
- c. Spring/Summer practice schedule is as follows: ~~TBA~~. Failure to attend Spring/Summer practices will result in demerits and possible removal from future performances as deemed necessary from the coach.
- d. The cheerleaders will attend ~~TBA~~. Camp is mandatory to be on the Medina Valley Cheerleading squad. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the cheer sponsor and/or administrator to determine the appropriate action taken.
- e. The parent is responsible for transportation to and from camp. Per NCA policy, parents are only permitted to attend camp during All-American tryouts and for final evaluation and awards.
- f. New Varsity camp, uniforms, practice wear, and accessories are estimated to be \$1,000. Returning 8th grade cheerleader expenses are estimated to be \$900. This is just an estimate of what cost will be this year and a detailed report will be discussed at the New Team

Meeting. Failure to pay the remaining balance by the noted date of July 9, 2017 may result in removal from the team. The estimated payment schedule is as follows:

- a. TBA – Camp wear + uniform - online payment to Varsity
- b. TBA - \$389.00 camp payment – check payable to MVMS
- c. TBA – Game day accessories - online payment to Varsity
- d. TBA– Final payment - online payment to Varsity

Section 5: Mascots

Responsibilities and duties of Mascot

- A. The purpose of the mascot is to build spirit at athletic events and serve as an ambassador for MVISD.
- B. Only one mascot will be chosen for the 2018-2019 school year. The Mascot must be at the sporting events from beginning to end.
- C. The mascot does not have the same financial commitments as cheerleaders; however the mascot will have the option to purchase warm-ups and spirit wear to match the cheer team. Optional items must be purchased at the same time as the cheer team's orders.

Tryout & Selection of Mascot

- A. Mascots are selected through a tryout process. All current 6th and 7th grade students are eligible to try out for mascot.
- B. Mascots will need to perform a 60-90 seconds skit to choreographed music. The skit must be in good taste and for all audiences. Mascots will be judged on the following criteria: characterization, crowd interaction, use of props/music, choreography, and overall impression.
 - a. Mascots may have two assistants to help set up and take down, but they cannot be part of the skit itself.
 - b. Props can be used and are encouraged, but you are limited to five. No waterguns, confetti, balloons, fire extinguishers, or noise making devices are allowed as props. ~~Pompons are considered one prop.~~ If any part of the costume is taken off, it must be put down immediately or it becomes a prop.
 - c. If a person violates these rules they will have a point deduction.

Section 7: Honor Code, Discipline Management, & Safety

- a. Any cheer parent that has a concern or complaint about the program needs to follow the chain of command: (1) Coach/Athlete, (2) Coach/Athlete & Parent, (3) Coach & VP/Athlete & Parent. The coach and administration will always govern the MVMS honor code. The administration or sponsor will impose all consequences for all cheerleaders/mascots. Parents will be informed when a cheerleader/mascot is on probation or has committed a serious offense.
- b. The following demerit system will be implemented to ensure effectiveness and fairness in Spirit Squads regarding behavior, academics, participation, and performance on/off school grounds throughout the duration of membership. Some infractions may be given a warning or additional conditioning in place or a demerit.

Safety

- A. Cheerleader/~~mascots~~ must follow safety instructions at all times. Not following safety instructions could result in suspension or dismissal from the squad. ~~Cutting-up~~ Lack of focus in practice or in games, i.e. laughing, yelling, crying, or pouting while stunts are being performed will not be tolerated at any time. This is the most serious offense as other cheerleader/~~mascots~~' safety and well-being is at stake.

- B. Discipline for dropped stunts at a game or event will be result in stunt group conditioning: stadiums, pushups, frog jumps, etc. This is to encourage proper form, technique, and progression skills.
- C. The coach will restrict performance of specific skills from individuals or stunt groups if proper form and technique has not been demonstrated in practice.
- D. For each athlete's safety, a practice cannot be held without a coach present.

Medical Release

- A. Per UIL policy, injuries with a doctor's note must be honored by the coach and a medical release is required for return to active participation. Cheerleaders and parents should be in communication with doctors, trainers, and the coach to ensure proper restriction guidelines and an estimated medical release to return to active participation.
- B. Injuries, illness, and routine doctor's appointments during a performance week may result in a change in positions for formations, stunts, and performances. Placement back in formations, stunts, and a performance event is at the discretion of the coach.

Section 8: Appearance, Camp/Practice Wear, and Uniforms

- A. Cheerleaders are expected to maintain an athletic **All-American** look throughout the year. Make-up should be kept to a minimal level; absolutely *no glitter, face paint, or excessive makeup in uniform*. Nail polish will be neutral and nails kept short while in uniform. Hair can be colored or highlighted in a natural way, and must follow the Student Code of Conduct for Dress Code and Grooming. All female cheerleaders will wear their hair out of their face in a similar style, i.e. ponytail, half-up, side twist or braid. No bangs **or loose hair by the ears**.
- B. Jewelry is not part of the uniform and may not be worn during practice, performances, or pictures to be used for school purposes. Cheerleaders will not be able to perform with any type of jewelry. Covering jewelry will not be accepted; it must be taken off.
- C. Uniforms must be worn in their entirety: shell, skirt, mid-drift (when required by the coach), white or no show socks, and cheer shoes. In addition to jewelry, certain items may NOT be worn at any time when in uniform. Such items include but not limited to: homemade necklaces, bracelets, anklets, sunglasses, nail polish, non-cheer shoes (flip flops, Crocs, UGGS, etc.), pajama pants, rolled shorts / skirts, jeans, and/or sweats under skirt.
- D. Failure to comply with the uniform rules will result in removal from the activity until the problem has been corrected and the appropriate discipline will be assessed as stated in the constitution.
- E. The sponsor will choose the camp clothes and uniforms to be worn during the year. Cheerleading uniforms will only be worn for events as designated by the sponsor.
- F. Cheerleaders are responsible for ownership and care of personal camp clothes and uniforms. Lost items will require the cheerleader to purchase replacement items. Cheerleaders cannot lend or give their cheer clothes to any person who is not a cheerleader.
- G. Cheerleaders/mascots are responsible for purchasing their camp clothes and shoes.
- H. Cheerleaders are expected to be in uniform and dress identically. Failure to do so will result in non-performance until the problem has been corrected or issuance of demerit(s) as deemed appropriate by the coach.

Section 9: Liabilities

- A. By the very nature of the activity, cheerleading and gymnastics carry a risk of physical injury. In the event of an injury requiring medical attention, cheerleaders will not be allowed to practice or participate without physician clearance. Physician clearance must be on file with both the coach and athletic trainer.

- B. Cheerleaders are not permitted to engage in any stunts without sponsor present. The sponsor is not liable for any accidents or injuries that may occur while these stunts are being performed.
- C. Proper supervision and safety equipment is to be used at all times. Failure to do so may result in disciplinary action.
- D. The sponsor is not responsible for providing transportation to and from practice or home games. Parents must make arrangements for these activities. Pick up must be no later than 15 minutes after the scheduled event or practice is over. Demerits for late pick up will be issued.

Section 10: Regarding Cheerleading/Mascots and Extracurricular Activities

- A. The sponsor of the 2018-2019 cheerleading squad empathizes with all students who would like to participate in both cheerleading and sports events. **Cheerleaders, who participate in other sports, must attend events planned by the cheerleading coach that do not take place at the same time as their athletic event or UIL events. For example, if a cheerleader is also a volleyball player, and there is a home game she must make it to the cheer event. It is the cheerleader's responsibility to fulfill her duties in both activities. If the cheerleader misses any games (which do not conflict with the other athletic or UIL events) they will receive 2 demerits. ~~These guidelines were developed based on prior experience and input of cheerleaders and parents.~~**
- B. Spirit Squad cheerleader/~~mascots~~ must attend scheduled morning or afternoon practices in order to perform at games, pep rallies, etc. **If a cheerleader misses a practice during a pep rally week, the cheerleader will not be able to perform in the pep rally that week.**

Section 11: Cheerleader/Mascot, Coach, and Parent Expectations

Cheerleader/Mascot Fair Play Code:

- A. I will participate because I want to, not because my parents or coaches want me to.
- B. I will follow all rules and cheer in the spirit of the game.
- C. I will control my temper since fighting and disrespect can spoil the activity for everyone.
- D. I will respect my opponents.
- E. I will do my best to be a true team player.
- F. I will remember that winning isn't everything. Having fun, improving my skills, making friends, and doing my best are also important.
- G. I will acknowledge all good performances by both my teammates and my opponents.
- H. I will remember that coaches are there to help me. I will accept their decisions, show them respect and understand they have given their time to be with me.

Parents Fair Play Code:

- A. I will remember that young people participate for THEIR enjoyment, and not to entertain me.
- B. I will not have unrealistic expectations and will understand that doing one's best is as important as winning. I understand that ridiculing an athlete for making a mistake is not acceptable behavior.
- C. I will respect the judges' decisions and will encourage all participants to do the same.
- D. I will respect and show appreciation for coaches and understand that they have given their time to provide activities for our young people.
- E. I will encourage cheerleaders/mascots and coaches to play by the rules and to resolve conflicts without resorting to hostility or violence.
- F. I will show respect for my squads opponents because I realize there would be no competition without them.
- G. I will not use bad language and will not harass cheerleaders, mascots, coaches, judges, or other spectators.
- H. I will always show good sportsmanship since young people learn best by example.

Coach Fair Play Code:

- A. I will treat each cheerleader as an individual, remembering the large range of emotional and physical development for the same age group.
- B. I will not show favoritism to specific cheerleaders on my squad.
- C. I will stress the fact that cheerleading is a team effort and teach leadership and team building to foster positive team relationships.
- D. I will teach each cheerleader the rules and fundamentals of cheerleading.
- E. I will do my best to provide a safe playing situation for my cheerleaders.
- F. I will do my best to organize practices that are fun and challenging for all my cheerleaders.
- G. I will use those coaching techniques appropriate for each of the skills that I teach.
- H. I will practice open communication with team members, coaches, team moms and parents.

Procedure for the Issuance of Demerits.

- A. Demerits will be issued as infractions / incentive occur
- B. Demerits will be based on coach observations.
- C. Only the coach will approve and assess demerits.
- D. Demerits will be documented and require a cheerleader signature.

Demerits

- A. This is a 10-demerit system with probationary periods prior to dismissal:
 - a. A member will be placed on a 1 event probation once accumulating 4 demerits.
 - b. A member will be placed on a 3 week probation once accumulating 7 demerits.
 - c. Once 10 demerits have been accumulated; the member is officially dismissed from the organization by the coach and the campus principal.

Probation

- B. The purpose of probation is to serve as an intervention and warning. Reasons for probation include: Ineligibility due to failing grade, ISS or off campus suspension, 7 or more conduct and/or discipline referrals, excessive absences, accumulation of 7 demerits, documented bullying, other reasons as deemed necessary by the principal/designee and the director(s).

Suspension

- A. Violations of the Code of Conduct resulting in a disciplinary consequence such as In-School Suspension, Off-Campus Suspension, etc. will be handled as follows:
- a. **1st offense:** Student will be ineligible for participation for three (3) calendar weeks from the date of the offense
 - b. **2nd offense:** Dismissal from the Squad for the remainder of the semester or 12 calendar weeks (whichever is longer)
 - c. **3rd offense:** Dismissal from the Cheer Program
 - a. ~~If the cheerleader/mascot is enrolled in cheer class, they will receive a grade of 50 for the semester.~~ If a cheerleader/mascot is dismissed from the squad for any reason, they may not tryout for cheerleader/mascot the following year and forfeit any cheerleading awards.
 - d. The sponsor and administration will govern the MVMS honor code. The administration or sponsor will impose all consequences for all cheerleaders/mascots. Parents will be informed when a cheerleader/mascot is on probation or has committed a serious offense.

2018-2019 Constitution

This document's purpose is to develop a set of uniform guidelines for the Top Cat Dance Team of Medina Valley High School. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the dance director and/or administrator to determine the appropriate action taken. Each circumstance will be evaluated on a case by case basis.

Section 1: Organization Goals

- A. To promote school spirit and pride through dance.
- B. To display leadership qualities at all times.
- C. To promote physical fitness.
- D. To promote the ideals of friendliness and sportsmanship.
- E. To act as an ambassador of Medina Valley High School and its community.
- F. To promote the MVHS activities by attending games and performing at community events to foster goodwill.
- G. To compete with other teams at local dance competitions.
- H. To foster positive self-esteem by teaching responsibility, dependability, cooperativeness, and discipline.

Section 2: Membership

- A. Each Top Cat will give his/her time to participate in required activities throughout the year. Top Cats must be dedicated to the team to rightfully represent MVISD. Top Cats must make every attempt to attend every dance event. Failure to attend a scheduled activity will result in an infraction as stated in Section 12: Discipline Management. Membership is open to students in grades 10-12, who have demonstrated academic eligibility in accordance with UIL guidelines and completed Dance 1. Top Cat season starts May 1, 2018 after tryouts and does not end until the sports seasons end in May of 2019; this includes play-off games during the summer. If a Top Cat quits or is dismissed from the team, he/she forfeits the Top Cat privileges and may not tryout the consecutive year.
- B. All Top Cats must follow the rules of the Medina Valley Code of Conduct & its Student Handbook, the Top Cat Constitution, and its honor code at all times. By signing this contract, both parent and Top Cat are agreeing to abide by the above state school publications.
- C. Each Top Cat is expected to maintain a high level of academic achievement. If the team member cannot maintain academic eligibility in accordance with UIL guidelines, the Top Cat will be placed on academic probation for the grading period. Members will have an opportunity for reinstatement at the end of each progress report. Only one academic probation period will be allowed each school year.
- D. Per UIL policy, members on academic probation must attend and participate in all practices, but may not attend games, pep rallies, or other scheduled appearance events. They are not allowed to be in uniform and may not be on the field/court/stage during the probationary period.
- E. Top Cats and the dance director will work together to set goals for earning money towards various expenses incurred for dance orientated activities. Fundraisers help to minimize out of pocket expenses and increase team spirit among Top Cats. Failure to participate will result in out-of-pocket expense depending on the purpose of the fundraiser. District administration must approve all fundraisers before they can begin.

Section 4: Tryouts

- A. On March 29, 2018, a panel of impartial judges will determine Top Cat Dance Team membership based on the individual candidate's knowledge, skills, and abilities in the areas of Appearance, Dance Technique, and Performance Quality. Tryouts are judged by three experienced outside judges and scores calculated by authorized school administrators and/or personnel. Professional judges with outstanding credentials and references will be hired for tryouts. They will be instructed to judge the candidates solely on the criteria listed on the score sheet (see Page 12).

Tryout Eligibility

- A. Tryouts are open to all current and future MVHS students who meet the below criteria. Any transfer students will be evaluated based on their academics and attendance in order to determine whether they meet the MVHS requirements.
 - a. Attendance at the Pre-Tryout Parent Meeting for both candidates and parents on March 8, 2018 at 5:30 pm in the MVHS Library. If parent is not in attendance, the candidate cannot proceed with tryouts. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the Top Cat director and/or administrator to determine the appropriate action taken.
 - b. Due no later than March 8, 2018 is the entire Top Cat Tryout Packet signed by Top Cat and parent. **No late applications will be accepted. All papers must be turned in, in order to tryout.**
 - c. Acceptable academic standing in accordance with UIL guidelines. Current grades, attendance, and discipline will be pulled by campus administration. Any inaccuracies with grades, attendance, and discipline must be cleared up before March 8, 2018 (6W4). They will NOT be revisited afterwards.
 - d. Attendance and participation in the entire Top Cat tryout clinic to be held March 26-29, 2018.

Ineligibility

- A. Candidates will be considered ineligible to participate for the following reasons:
 - a. Excessive absences. Students must meet the 90% attendance requirement.
 - b. Any disciplinary placement to Alternative School Placement (DAEP) or
 - c. Two or more In School Suspensions (ISS) assignments for the 2017-2018 school year.
- B. Student with 5 or more other disciplinary referrals will be allowed to try out, but will be placed on a probationary status through the first three calendar weeks of the 2018-2019 school year.
- C. Students must be present in all class periods the entire week of tryouts. Any excused or unexcused absence for any class period will result in forfeiture of tryout eligibility. Attendance will be verified.

Tryout Clinic

- A. Tryout material will be taught at the mandatory tryout clinic to be held March 26-29 from 7:00-8:00 am in the practice gym of the high school.
- B. The candidate must be at the clinic each day, in its entirety in order to tryout. Late arrivals will result in forfeiture of Top Cat candidacy.
- C. Tryout clinic attire should be athletic clothing, Top Cat appropriate shoes (no sandals, boots, slippers, or keds), and hair needs to be pulled up securely so that it does not need to be redone. Food will not be allowed; water bottles are encouraged.
- D. The tryout clinic is closed to Top Cat candidates only.

- E. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the Top Cat director and/or administrator to determine the appropriate action taken.

Tryout Appearance

- A. Clothing and hair for tryouts will consist of the following. No jewelry will be permitted at tryouts.
 - a. Solid black tee-shirt (no midriff showing); no sleeveless shirts. *Small* athletic brand emblems are allowed (Nike, UA, etc.); however, no Varsity Spirit or Top Cat emblems will be allowed.
 - b. Solid black, dance pants or capris. Ex: Capezio, Bloch, Danskin, Target, Walmart brands, etc. See emblem guidelines above.
 - c. White or black no show socks and Jazz Shoes or Jazz sneakers
 - d. Clean ponytail with solid ribbon. No bows, flyaways, or loose hair.
 - e. No excessive makeup, no glitter, and no nail polish shall be worn.

Day of Tryout Procedures

- A. Candidates need to report to the back gym beginning at 8:30 am to check-in. Following check-in, candidates will stretch and warm-up. Parents are not allowed in any part of the tryout areas.
- B. Doors will be locked at 9:00 am sharp. Any Top Cat Candidate who arrives after 9:00 am will not be allowed to tryout. Tryouts will begin around 9:30. Should there be an extenuating circumstance that arises, that is out of the control of the active participant, situations may be reviewed at the discretion of the Top Cat director and/or administrator to determine the appropriate action taken.
- C. When a participant has completed the individual tryout process, they will be escorted to the back gym and then must wait until all candidates have been judged.
- D. The judges may ask candidates to return to the gym at the end of the tryouts to perform any or all of the materials a second time. All candidates should remain on standby until dismissed by an administrator.
- E. Following the conclusion of tryouts, candidates must proceed to class to finish out the remainder of their class schedule for the day. Attendance will be verified.

Team Assignments

- A. The Top Cat Dance Team will be determined based on the Top Cat's scores from tryouts and the Citizenship Score (grades, attendance, discipline) completed by their administrators. The maximum number of Top Cats is 20. The top sophomores, juniors and seniors with the highest combined score may make the Top Cat Dance Team. A natural break in the scores may be used to determine a cut-off point.
- B. Results will be handed out to candidates in the form of a letter on the day of tryouts, after scores are finalized. Candidates are not allowed to open letters until they have left school campus. Those that do not adhere to this rule will forfeit their position on the Top Cat Dance Team.

Parents and Tryouts

- A. Parents are responsible for transportation for their child to and from the Top Cat clinic and tryouts as well as all practices and events thereafter.
- B. Parents are *not allowed* in the building during the official tryouts. Parents may not videotape or photograph any part of the tryout process.
- C. After tryout results are given, parents must conduct themselves in an appropriate manner, reflecting sportsmanship and good character.

- D. Parents are allowed to view their child's score, but not the score of any other contestant. Parents will have 15 school days to view scores with the Top Cat director/ administrator. After the close of business on the 15th day, score sheets will be shredded.
- E. All judges' decisions are final. There is no legal entitlement to being selected as Top Cat, and therefore decisions are indisputable.

New Team Information

- A. The Top Cats and their parents will have a mandatory New Team Meeting on Wednesday, March 21, 2018 at 5:30pm in the high school Library.
- B. The chosen 2018-2019 Top Cats will have a mandatory uniform and camp wear fitting on April 20th beginning at 4:15 PM in room 300/Dance Studio. Appointments will be made to expedite the fitting process and parents are welcome to attend this event to ensure proper sizing.
- C. Spring/Summer practice schedule is as follows: Spring/Summer practice schedule is as follows: April 24, 26; May 1, 3, 8, 10, 15, 17; 22, 24, 29, 31; June 1 (performance); August 13, 14, 15, 16, 17, 20, 21, 22, 23, 24. Failure to attend Spring/Summer practices will result in demerits and possible removal from future performances as deemed necessary from the director.
- D. The dancer's first fundraiser is a catalogue and popcorn sale scheduled for April 19-May 3, 2018. Our second fundraiser will be Kiddie Camp August 16, 2018. Kiddie Camp participation and attendance is mandatory to be on the Medina Valley Top Cat Dance Team. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the dance director and/or administrator to determine the appropriate action taken. Each dancer is encouraged to register a minimum of 5 campers.
- E. The Top Cats will attend Crowd Pleasers Dance Camp August 13, 14, 15 and 16 at Medina Valley High School.. Camp is mandatory to be on the Medina Valley Top Cat Dance Team. A Top Cat must attend all four days of camp. Should there be an extenuating circumstance that should arise, that is out of the control of the active participant, situations may be reviewed at the discretion of the Top Cat director and/or administrator to determine the appropriate action taken.
- F. The parent is responsible for transportation to and from camp. A district vehicle will be driven by the director to provide those who need alternative transportation arrangements. Per Crowd Pleasers policy, parents are only permitted to attend camp for final evaluation and awards.
- G. Camp, uniforms, practice wear, and accessories are estimated to be \$1000. This is just an estimate of what cost will be this year and a detailed report will be discussed at the New Team Meeting. Failure to pay the remaining balance by the noted date of August 17, 2018 may result in removal from the team. The estimated payment schedule is as follows:
 - a. April 30th – Camp wear + New Uniform – check payable to MVHS
 - b. May 30th - \$216.00 camp payment – check payable to MVHS
 - c. June 30th – Uniform payment – check payable to MVHS
 - d. July 30th – Game Day Accessories – check payable to MVHS

Section 5: CAPTAINS

Selection of Top Cat Officers

- A. The Top Cat Dance Team will have one Captain, one Co-Captain, one Lieutenant, and one Social Officer.
- B. The Officer(s) will be selected with careful consideration by the Director. Factors considered include tryout score, grades, attendance, behavior, choreography, leadership qualities, interview, Top Cat Dance Team recommendations, & teacher recommendations. (Please note that some teachers may request not to do the recommendation.)
- C. Officer candidates are expected to complete an application, interview, and choreograph and teach a 60 second (approx. 12 8-counts) dance with formation incorporation. The total time to teach is 2 practices. Officer applications will be available at the New Team Meeting.
- D. Officers will be announced on or before the last day of the academic school year.
- E. Officers are expected to attend a mandatory leadership camp August 9 - 10th. Failure to attend will result in removal from the position of officer.

Responsibilities and Duties of Top Cat Dance Team Officer(s)

- A. The officer(s) will serve as the team's most dedicated leader, motivator, organizer, and choreographer.
- B. The officer(s) of Top Cats may find it difficult to participate in any other activity due the large amount of time needed for planning and executing events.
- C. Officers must attend all events without fail. Even if there is another conflict, the captain must attend the event when the other has ended.
- D. Officers must be ready to attend any event at a moment's notice, and know that Top Cat must come first, as they are leaders of the team.
- E. Top Cat officers can be removed at the discretion of the committee for failing to meet criteria. All decisions are indisputable.

Section 6: Attendance Requirements

- A. If any other activities or opportunities are chosen by the director, the director shall decide if the event is mandatory or optional. Reasonable notice of all such activities/opportunities will be given for mandatory events, and as early as possible for others.
- B. If a Top Cat drops out of Top Cat Dance Team before the Top Cat season ends, he/she cannot tryout the following year.
- C. The expectation is that Top Cats comes before work. Missing an event or practice due to work is not considered a valid excuse. This includes morning and afternoon practices. Note: A calendar of scheduled events will be distributed by so that Top Cats who are employed can schedule their work around their Top Cat events.

Section 7: Honor Code, Safety, Medical Release

- A. Any Top Cat parent that has a concern or complaint about the program needs to follow the chain of command: (1) director, (2) Program Administrator, (3) Associate Principal, and finally (4) Principal. The director and administration will always govern the MVHS Honor Code. The administration or director will impose all consequences for all Top Cats. Parents will be informed when a Top Cat is on probation or has committed a serious offense.
- B. A merit/demerit system will be implemented to ensure effectiveness and fairness in Top Cat Dance Team regarding behavior, academics, participation, and performance on/off school grounds throughout the duration of membership. Some infractions may be given a warning or additional conditioning in place or a demerit.

Safety

- A. Top Cats must follow safety instructions at all times. Not following safety instructions could result in suspension or dismissal from the Top Cat Dance Team. Lack of focus in practice or in games, i.e. laughing, yelling, crying, or pouting while stunts are being performed will not be tolerated at any time. This is the most serious offense as other Top Cats' safety and well-being is at stake.
- B. Discipline for dropped stunts at a game or event will result in stunt group conditioning: stadiums, pushups, frog jumps, etc. This is to encourage proper form, technique, and progression of skills.
- C. The director will restrict performance of specific skills from individuals or stunt groups if proper form and technique has not been demonstrated in practice.

Medical Release

- A. Per UIL Policy, injuries with a doctor's note must be honored by the director and a medical release is required for return to active participation. Top Cats and parents should be in communication with doctors, trainers, and the director to ensure proper restriction guidelines and an estimated medical release to return to active participation.
- B. Injuries, illnesses, and routine doctor's appointments during a performance week may result in a change in position for formations, stunts, and performances. Placement back in formations, stunts, and a performance event is at the discretion of the director.

Section 8: Appearance, Camp/Practice Wear, and Uniforms

- A. Top Cats are expected to maintain an athletic, All-American look throughout the year. Make-up should be kept to a minimal level; *absolutely no glitter, face paint, or excessive makeup in uniform unless instructed by the director as part of the event uniform*. Nail polish will be neutral and nails kept short while in uniform. Hair can be colored or highlighted in a natural way, and must follow the Student Code of Conduct for Dress Code and Grooming. All female Top Cats will wear their hair out of their face in a similar style, i.e. ponytail, half-up, side twist or braid unless instructed by the director as part of the event uniform. No fly away hairs.
- B. Jewelry, other than sparkle studs, is not part of the uniform and may not be worn during practice, performances, or pictures to be used for school purposes. Top Cats will not be able to perform with any type of jewelry other than sparkle studs. Covering jewelry will not be accepted; it must be taken off.
- C. Each uniform must be worn in their entirety as decided by the director. In addition to jewelry (other than sparkle studs), certain items may NOT be worn at any time when in uniform. Such items include but not limited to: homemade necklaces, bracelets, anklets, sunglasses, nail polish, non-Top Cat shoes (flip flops, Crocs, UGGs, etc., pajama pants, rolled shorts / skirts, jeans, and/or sweats under skirt).
- D. Failure to comply with the uniform rules will result in removal from the activity until the problem has been corrected and the appropriate discipline will be assessed as stated in the constitution. Designated hairstyles and makeup are considered part of the uniform look.
- E. The director will choose the camp clothes and uniforms to be worn during the year. Top Cat uniforms will only be worn for events as designated by the director.
- F. Top Cats are responsible for ownership and care of personal camp clothes and uniforms. Lost items will require the Top Cat to purchase replacement items. Top Cats cannot lend or give their Top Cat clothes to any person who is not a Top Cat.
- G. Top Cats are responsible for purchasing their uniform pieces, camp clothes, accessories, and shoes.

Section 9: Liabilities

- A. By the very nature of the activity, dancing carries a risk of physical injury. In the event of an injury requiring medical attention, Top Cats will not be allowed to practice or participate without physician clearance. Physician clearance must be on file with both the director and athletic trainer.
- B. Top Cats are not permitted to engage in any stunts without director present. The director is not liable for any accidents or injuries that may occur while these stunts are being performed.
- C. Proper supervision and safety equipment is to be used at all times. Failure to do so may result in disciplinary action.
- D. The director is not responsible for providing transportation to and from practice or home games. Parents must make arrangements for these activities. Pick up must be no later than *15 minutes* after the scheduled event or practice is over. Demerits for late pick up will be issued.
- E. Out of town events will follow Medina Valley ISD guidelines for transportation.

Section 10: Regarding Top Cat Dance Team and Extracurricular Activities

- A. The director of the 2018-2019 Top Cat Dance Team empathizes with all students who would like to participate in multiple extracurricular events. Top Cats, who participate in other events, must attend events planned by the Top Cat director that do not take place at the same time as their athletic or UIL events. For example, if a Top Cats is also a JV basketball player, and there is a home game he/she must make it to the Top Cat event. It is the Top Cat's responsibility to fulfill his/her duties in both activities. If the Top Cat misses any games (which do not conflict with the other athletic or UIL events) they will receive 2 demerits.
- B. Should a Top Cat Dance Team class be offered, Top Cats are required to be enrolled in the class period to perform at pep rallies and events.
- C. Top Cats must attend scheduled morning and afternoon practices in order to perform at games, pep rallies, etc. If a Top Cat misses a practice during a pep rally week, the Top Cat will not be able to perform in the pep rally that week.

Section 11: Top Cats, Director, and Parent Expectations

Top Cat Dance Team Play Code:

- A. I will participate because I want to, not because my parents or director want me to.
- B. I will follow all rules and dance in the spirit of the game.
- C. I will control my temper since fighting and disrespect can spoil the activity for everyone.
- D. I will respect my opponents.
- E. I will do my best to be a true team player.
- F. I will remember that winning isn't everything. Having fun, improving my skills, making friends, and doing my best are also important.
- G. I will acknowledge all good performances by both my teammates and my opponents.
- H. I will remember that director is there to help me. I will accept their decisions, show them respect and understand they have given their time to be with me.

Parents Fair Play Code:

- A. I will remember that young people participate for THEIR enjoyment, and not to entertain me.
- B. I will not have unrealistic expectations and will understand that doing one's best is as important as winning. I understand that ridiculing an athlete for making a mistake is not acceptable behavior.
- C. I will respect the judges' decisions and will encourage all participants to do the same.

- D. I will respect and show appreciation for the director and understand that they have given their time to provide activities for our young people.
- E. I will encourage Top Cats and director to play by the rules and to resolve conflicts without resorting to hostility or violence.
- F. I will show respect for my Top Cat Dance Team opponents because I realize there would be no competition without them.
- G. I will not use bad language and will not harass Top Cats, directors, judges, or other spectators.
- H. I will always show good sportsmanship since young people learn best by example.

Director *Fair Play Code:*

- A. I will treat each Top Cats as an individual, remembering the large range of emotional and physical development for the same age group.
- B. I will not show favoritism to specific Top Cats on my team.
- C. I will stress the fact that Top Cat Dance Team is a team effort and teach leadership and team building to foster positive team relationships.
- D. I will teach each Top Cat the rules and fundamentals of dance.
- E. I will do my best to provide a safe playing situation for my Top Cat .
- F. I will do my best to organize practices that are fun and challenging for all my Top Cats.
- G. I will use those directing techniques appropriate for each of the skills that I teach.
- H. I will practice open communication with team members, director, team moms and parents.

Section 12: Discipline Management

Procedure for the Issuance of Demerits and Merits

- A. Demerits and merits will be issued as infractions / incentive occur
- B. Demerits and Merits will be based on director observations.
- C. Only the director will approve and assess demerits and merits.
- D. Demerits will be documented and require a Top Cat and parent signature.
- E. Demerits can only be removed by earning merits.
- F. It is the responsibility of the Top Cat to submit supporting documentation to earn merits, i.e. report card, attendance reports, etc.

Merits

- A. Earning straight “A’s” on a report card – 2 merits
- B. Earning perfect attendance for a 3 week grading period – 1 merit
- C. Special assignments and projects requested by the director.

Demerits

- A. This is a 10-demerit system with probationary periods prior to dismissal:
 - a. A member will be placed on a 1 event probation once accumulating 4 demerits.
 - b. A member will be placed on a 3 week probation once accumulating 7 demerits.
 - c. Once 10 demerits have been accumulated; the member is officially dismissed from the organization by the director and the campus principal.

TWO DEMERITS – Serious Infraction

- Failure to attend a performance event
- Treating a _____ disrespectfully
- Leaving without director(s) permission
- Insubordination – failure to abide to director’s or captain’s direction
- Saturday School / After School Detention Assignment
- Anything else the director(s) deem(s) as a more serious infraction:

ONE DEMERIT – Minor Infraction

- Failure to attend required practices or meetings
- Out of uniform at a practice or performance – includes hair, tights, shoes, bow, makeup
- Any visible piercings (other than sparkle studs) or any visible tattoos at required events
- Using phone or restroom during scheduled practices or events without permission
- Wearing sunglasses, nail polish, non-uniform jewelry, or chewing gum in uniform
- Visiting with non-members, including parents, without director(s) permission
- Foolish jesting, horseplay at games, pep rallies, and other events
- Students remaining on campus past the scheduled pick-up time
- Use of a cell phone on school grounds or scheduled events
- Wearing uniform incorrectly or to an unscheduled event
- Discipline referral from any school staff, for any reason
- Public display of affection at any time (including hickies)
- Stunting while not under direct director supervision
- Eating at a game and/or practice without permission
- Any violation of the MVISD Student Code of Conduct
- Not knowing dances
- Unsportsmanlike conduct
- Late paperwork
- Late payment
- Truancy (per class period)
- Anything the director(s) deem(s) a minor infraction

Probation & Suspension

- A. The purpose of probation is to serve as an intervention and warning. Reasons for probation include: Ineligibility due to failing grade, ISS or off campus suspension, 5 or more conduct and/or discipline referrals, excessive absences, accumulation of 7 demerits, documented bullying, other reasons as deemed necessary by the principal/designee and the director(s).
- B. The director and administration will govern the MVHS Honor Code. The administration or director will impose all consequences for all Top Cats. Parents will be informed when a Top Cat is on probation or has committed a serious offense.
- C. Violations of the Code of Conduct resulting in a disciplinary consequence such as In-School Suspension, Off-Campus Suspension, etc. will be handled as follows:

- a. **1st offense:** Student will be ineligible for participation for three (3) calendar weeks from the date of the offense
- b. **2nd offense:** Dismissal from the Top Cat Dance Team for the remainder of the semester or 12 calendar weeks (whichever is longer)
- c. **3rd offense:** Dismissal from the Top Cat Dance Team
- d. If the Top Cat is enrolled in Top Cat class, they will receive a grade of 50 for the semester. If a Top Cat is dismissed from the Top Cat Dance Team for any reason, they may not tryout for Top Cat Dance Team the following year and forfeit any Top Cat Dance Team awards.

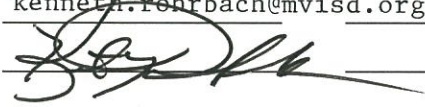
